- 6. All written motions, reports or communications to the conference shall be passed to the Secretary to be read to the conference.
- 7. All demonstrations of approval or disapproval during the progress of debate shall be deemed out of order.
- 8. No member of the conference shall leave during a session without having first been excused by the Chairman.
- 9. The delegates' meeting shall be the first business and shall not be upen to the public.

Meeting opened by singing, and prayers were offered by Bro. August Knapp, Bro. Tompkins, Bro. Kennedy and Sr. Bradt.

Committee on Discipline reported the work completed, and were dismissed with a vote of thanks.

Fund for needy Saints report read and accepted.

Committee for fund for needy Saints were elected as follows; Wm. Shoemaker, Joseph Lott and Grove Ellis, for a term of three years.

District Supt. reports. Elder Harry Moore's report from Eastern division read, and motion carried that the same be accepted.

Elder S. N. Bennett, District Supt. of Western division was not present, and no report was given.

Motion carried that a committee be appointed to wait on Bro. Bennett, for a report from Western division; Melvin Rock, Wm. Shoemaker and Albert Wilson were appointed.

Harry M. Moore was elected in place of Asa Valentine, whose term of office had expired, as one of the trustees of General work.

Question "Shall we have one or two Dist. Elders for coming year, owing to the lack of workers?"

The question was discussed and motion carried that the two Districts be consolidated, and one District Elder be appointed over the same.

Meeting opened with song and prayer. Roll call of delegates and workers.

The names of Melvin Rock, Wm. Shoemaker and Albert Wilson were presented by Chairman and motion carried that they be members of the General Board for the ensuing year.

The names of Verna Hamlin, Louise Shelp, Grace Robinson, Mary Howard, and Albert Wilson present ed by chairman and motion carried that they be members of the Missionary Board.

The question, "Shall we allow our Dist. Elder, Bro. Moore, to continue as Sup't. at Keyserkill?" was discussed and decided that he should attend to his duties as District Elder alone.

The question, "Shall we as a people permit unsaved children to act in the following offices in our Sunday Schools; Sec'y., Treas. and organist?" was discussed and a motion carried that the question be divided.

The motion was then carried that the appointing of organist in our Sunday Schools be left to the discretion of the Sunday School Boards.

The discipline provides that all officers of the Sunday School be members of the Mission.

The question, "Shall preacher's wives act as delegates to our yearly meeting?" was answered from the Chair as follows: "Under no consideration should she act as delegate," and the motion was carried that no member of the preacher's family from the charge he is serving, should come to Conference as delegate.

The question was asked, "Shall workers holding credentials act as delegates?" Motion carried that no worker holding credentials act as delegate to Conference.

The question was asked, "Who should pay moving expenses of the preacher called to another appointment?" Advised by Chair that the Official Board who calls preacher attend to the moving expenses.

"Should the matrons of the various Homes be supported by the receipts for these Homes?" Answered in the affirmative by the Chair.

Ida Chamberlain asked if she should use receipts of Home to pay a bill of nearly seven dollars contracted by her before entering the Home.

Motion carried that the Conference pay it, and a free will offering of \$17.28 was given.

Motion carried that we adjourn until 9:30 A. M. Thursday.

Thursday, March 20, 9: 30. A. M.

Meeting opened with singing and prayer. Roll call of delegates and workers.

District Elder of Western district reported that he had not completed his financial report, but would present same later.

Motion carried that Bro. Bennett be given time to make out his report.

Motion carried that Sister Barnes' letter be accepted as read and that the General Secretary reply.

Motion carried that we accept Bro. Darling's letter, as read and that the General Secretary reply.

Minutes of the previous meetings read and accepted.

The committee who were appointed to wait on Bro. Bennett for report from Western division reported that he promised to appear at Conference with report, and were dismissed.

Question, "What shall workers do with regards to working with their hands, in connection with their Spiritual work? Ans. "The Discipline provides for this question."

Motion carried that all people requesting children

from our Orphan's Homes be recommended by preacher in charge.

Motion carried that we adjourn until 2 P. M. Thursday 2 P. M.

Meeting opened with singing and prayer. Roll call of delegates and workers.

"What shall we do with the workers holding credentials and continuing at secular labor?"

Motion carried that the Gen. Board investigate, and all workers holding credentials and not free to do their spiritual work be requested by Sec'y. to submit their credentials.

Question, "What is the duty of a Class leader?" Ans. by Chair.: "The duty of a Class leader is to keep a strict account of his class by visiting, and encouraging the young, especially, to pray and testify."

Question, "Should the Class meeting be entirely devoted to prayer?" Ans. by Chair., "No, the Class meeting is for prayer and testimony."

Question, "Is it the duty of incoming or outgoing preacher to appoint Class leader?" Ans. by Chair. "The duty of outgoing preacher."

Question, "What is the duty of District Elder?" Ans. by Chair.; "He is to instruct his workers, take charge of his regular meetings, and watch carefully financial conditions."

Question, "Should a preacher's wife transfer her church letter from one charge to another, as she is moved?" Ans. by Chair.; "Yes, and the letter should be signed by the Sec'y. of the local board."

Question, "Shall we allow a worker that has been

dealt with and dismissed from us to pray and testify in our meetings?" Ans. by Chair.; "Allow no dismissed worker to take any part in meetings only as a penitent."

Question, "What shall we do with our missionaries who are called?" The Conference was requested to prove earnestly that God might send to us a holy man and the to go with our young workers; was also suggested that all readers of the "News from Home" be requested to pray to that end.

Motion carried that we adjourn until 9:30 Friday. Friday. 9:30. A. M.

Motion carried that we adjourn until 2:30 P. M. Friday 2:30 P. M.

Roll call of delegates and workers.

Question, "What is the duty of a credentialed worker when absent from Conference?" Ans. by Chair,; "Every worker being unable to be at first roll call should present a reasonable excuse."

Question, "What stand should we take on preaching against popular music?" Ans. by Chair.; "Any class of music that tends to destroy spirituality, should be preached against."

The reports from the following works and Sunday Schools were read and accepted; Albany; Binghamton; Brookdale S. S.; Brooky Hollow; Conesville; Sutton Hollow; Keyserkill; Union Valley; Schenectady; Oneonta; Grovenors Corners; North Troy; Lestershire and Cortland.

Motion carried that Brookdale report be audited and accepted by Gen. Board.

Homer Orphanage report read and accepted.

Binghamton Refuge report read and accepted.

Motion carried that Gen. Sec'y. financial report be accepted with present indebtedness added.

Missionary report accepted as read.

District Elder's report from Western division accepted with understanding that \$24.62, which was received from Binghamton work, be added.

Motion carried that Camp meeting report be accepted by General Board.

Question, "Shall we as workers report all receipts from Mission and out-side sources? The voice of the Conference was unanimous in the affirmative.

Evangelistic Services.

Every evening during Conference, Rev. Geo. Kunz of Syracuse brought messages of truth from the Word of God. His sermons inspired our hearts, and souls were saved and sanctified.

The reports from the work showel god conditions, both spiritually and financially. The delegate's report of Albany work showel receipts for year \$2523.76, building in good repair. Indebtedness at last report, \$4800. Paid on same this year \$600. Present in debtedness \$4200. The Supt. reported work in good condition spiritually. The Sunday School report

showed an average attendance of 14. Two girls were sent to the Rescue Home at Binghamton during the year.

Indebtedness on Binghamton Mission at last report was \$4000, receipts \$2151.77 for year. The property was reported to be in fairly good condition and the Supt's report was one of victory spiritually. The Sunday School has had an average attendance of 36 during the year and God is blessing.

The Brookdale S. S. report was read and showed an average attendance of 30.

Brooky Hollow reported receipts \$373.92 for year, building in good repair with indebtedness at last report of \$174, paid on same \$100, present indebtedness \$74. The saints are blessed and walking in harmony. The Sunday School has had an average attendance of 28.

Conesville property was reported in good condition with no indebtedness. Receipts during year \$70.27. Spiritual condition fair. S. S. has an average attendance of 15.

Cortland owns no property, but God is blessing. Receipts during year \$500.40. The S. S. has had an average attendance of 17, and reports lots of courage for the coming year.

Grovenor's Corners reports receipts \$267.65 for year. Property in good condition with an indebtedness at last report of \$398, paid on same this year, 148, present indebtedness of 250. Spiritual condition was reported good, with now and then one being saved.

Keyserkill reported receipts for year, \$601.59 with \$96.62 present indebtedness on property. During the

year a neat little chapel was built and the work is being blessed as never before. The Sunday School has had an average attendance of 23.

The work at Lestershire has not, as yet, been organized, but there is a little band of saints there and conviction is on hearts.

North Troy reported \$402.30 received during the year with work in good condition. A revival spirit is felt.

Oneonta, tho' not organized, reported \$336.81 received during the year. The spiritual condition was reported good by the Supt.

Sutton Hollow receipts during the year were \$57.39. Spiritual condition fairly good.

Union Valley, Bumptown and Vawter own no property, but have received \$409.17 during year. Spiritual condition taken all together is good.

The work at Schenectady reported receipts for year \$861.71. Property improved since last report. Indebtedness then \$2264.00. Paid on the same \$543.12 present indebtedness, with street assessments, \$2632.22. The spiritual condition is good and improving. The Sunday School has had an average attendance of 9.

Bro. and Sr. Miller w o have been in the Rescue Home the past year reported victory and the blessing of God on the Home. There have been 15 girls in the Home during the year and there are ten at present. There are three babies with us now. The spiritual condition of the girls is fairly good. Money received during year \$652.14. Bro. Miller and some of the girls have worked in the laundry and turned their

money into the Home.

Sr. Hill reported that God's blessing had been, and is still, on the girl's Orphanage, now at Binghamton. There are nine girls in the Orphanage at present. Two of the girls who have been in the Orphanage during the year have been adopted into good homes. The Orphanage has received in cash \$527.05 during the year.

No written report was given from Boy's Orphanage. There has been \$1751.56 paid in to Gen'l. Work for Gen'l. Fund. \$21.00 was paid in for fund for needy saints. The Missionary Board reported \$307.65 in treasury.

The "News from Home" report was not given in full but there has been \$278.03 paid in.
