MINUTES OF THE FIFTH ANNUAL CONVENTION OF THE APOSTOLIC HOLINESS CHURCH, OF PENNSYLVANIA, Inc.

MARCH 5, 1918. 8.30 A. M.

The first business session of the Fifth Annual Convention was called to order by the chairman, Rev. George S. Owen.

Devotional exercises were conducted by the Superintendent.

Enrollment of Preachers and Delegates.

It was then moved and seconded that the first three rows of seats shall constitute the conference bar. Carried.

By motion a copy of the printed Minutes of last year's Convention was placed in the hands of the delegates, and thus dispensed with the reading of the Minutes.

It was moved and seconded that the Chair appoint all Committees. Carried.

It was moved and seconded that we elect officers on Friday morning. Carried.

The Superintendent then gave a verbal report.

By motion this report was accepted, with the understanding that a written report appear on the Minutes.

Committee on Minutes reported and was accepted.

Motion, supported and carried that we have the Minutes of this Convention printed.

It was then moved, seconded and carried that we adopt the same financial plan as last year to cover the expenses of printing the Minutes, by the Preachers and delegates ordering the number of copies needed for their churches.

It was moved and seconded that preachers' wives attending the Convention be allowed in the Conference bar. Carried.

The Chair appointed the following Auditing Committee: W. J. Crider, W. E. Straub, R. M. Harding. This Committee to report in the morning session.

After discussion it was moved and seconded that we dispense with the resolution adopted last year with reference to the Nominating Committee for the State Officers, and leave the nomination to the conscience of each individual. Carried.

The Chair appointed the following Committee on Minutes:

D. A. King, J. L. Sutton, W. J. Crider.

By motion it was decided that we pay ten cents per copy, straight, for the Minutes.

After a discussion with reference to the Bethel Herald, it was moved and seconded that we continue the publication of the Bethel Herald. Carried.

It was moved and seconded that we do away with the Board of Directors of the Bethel Herald, and put the publication of the paper in the hands of the State Council. Motion carried.

It was moved and seconded that we proceed to the election of an Editor for the Bethel Herald. Carried.

The Chair appointed Sister Simons and Sister Deitrich as tellers.

The nominees for Editor were Brothers King, Owen and Gardner.

Election resulted in Brother King being elected.

It was moved and seconded that the Property of the Printing Press be transferred from the Board of Directors of the Bethel Herald to the State Council, that the State Council satisfy the Brethren who have forwarded the money for the Press. Carried.

By motion, Rev. Stanton, Pastor of the Free Methodist Church, was invited into the Conference bar.

It was moved and seconded that we solicit the Convention to see what we can do toward the support of the Bethel Herald. Carried.

Monthly pledges were then taken to the amount of eleven dollars and twenty-five cents.

The following Committee on Resolutions was appointed by the Chair: Francis Lishman, R. W. Ives, W. E. Straub.

It was moved and seconded that the surplus money received through the Churches by the Secretary of the Board of Directors of the Bethel Herald for the moving of the Printing Press be applied on the debt for the Press. Carried.

It was moved and seconded that we appoint a day in our Convention and Camp Meeting specifically to raise an offering for our State work. Carried.

By motion we adjourned to meet at 8.30 Wednesday morning.

March 6, 1918. 8.30 A. M.

The second session was opened with Devotional exercises. Roll Call.

Minutes of the previous meeting were read and adopted.

It was moved and seconded that we reconsider our action on election of officers and have the election on Thursday morning instead of Friday morning. Carried.

By motion Rev. J. R. Gardner was appointed as Convention

Reporter.

The Assistant Superintendent, Rev. H. A. Saneholtz, who has recently visited all the Churches in the State, gave a verbal report, stating that the work in general is in a good condition.

By motion this report was accepted.

The Chairman reported that he made a change on the Committee on Resolutions by appointing Bro. Diehl in place of Bro. Straub.

Motion that we as a Convention go on record as disapproving the inviting of any preachers into the pulpit in any local Church without consulting the Pastor in charge, and that we also disapprove the action of any Worker attempting to start a Work in the territory occupied by a Pastor, without the consent of said Pastor. This motion was supported and carried.

A paper on Doctrines and Reforms was read to the Convention by Rev. D. A. King. Same was accepted to be placed on the Minutes.

Brother King offered his resignation as Editor of the Bethel Herald.

It was moved and seconded that we accept his resignation. Motion was defeated.

After discussion it was moved and seconded that we reconsider the vote of resignation. After reconsideration the resignation was accepted.

It was then moved and seconded that the matter of Editorship be placed in the hands of the State Council to report in tomorrow

morning's session. Carried.

The following Preachers and Delegates then reported: Bro. Lishman, Sister Yoder, Wm. Munson, Mrs. Zimmerman, Bro. Owen, Bro. Dubendorf, Ruth Bartholomew, Bro. Crider, Bro. King, Sister Young, Bro. Ives, Bro. Wolfe.

By motion we adjourned.

The third session was called to order by the Chairman. Devotional exercises.

Nominees for State Superintendent were Brothers Sutton, Saneholtz, Crider, King, Owen. Bro. Saneholtz was elected.

Also that it was discourteous to the present Editor. Thus we believe that this body owes an apology to the present Editor.

It was then moved and seconded that we as a State Convention ask Bro. Owen to reconsider his statement of yesterday and accept the Editorship of the Bethel Herald. Carried.

It was moved and seconded that we as a Convention, Preachers and delegates, pledge our co-operation to the Editor of the Herald. Carried.

Resolution was adopted by rising vote.

3. Inasmuch as we, the Committee on Resolutions, see the great need of advancing the work of full salvation in Pennsylvania, be it therefore

Resolved, That this Convention recommend to the State Council the need of Apostolic Holiness Bands, and that they be urged to organize such Bands.

By motion this resolution was adopted.

4. Whereas, the office of the State Secretary is the most strenuous office connected with the State Work, requiring sacrifice, time, thought and attention, and

Whereas, the present Secretary, Rev. Carrie A. Yoder, has held that office so faithfully and self-sacrificingly since the organization of the State Work, and

Whereas, she does not receive any remuneration for the same, be it therefore

Resolved, That this Convention pay her ten dollars out of the Treasury. Signed, Francis Lishman, R. W. Ives, J. B. Diehl.

By motion this resolution was adopted.

By motion Sister Zimmerman and Sister Siglin were excused from the afternoon session.

By motion we adjourned to meet in the afternoon at 4 o'clock.

By motion we adjourned to meet Saturday morning.

PAPER ON DOCTRINES AND REFORMS AS READ TO THE CONVENTION BY REV. D. A. KING

We deem it of first importance that we be united among ourselves, having taken by the grace of God an uncompromising stand against all sin, having come out from the world, and therefore, looking according to the saying of Jesus, that the world will hate us; and having not only the influence of the fashionable, formal, worldly churches of the day against us, as well as the opposition of modern popular holiness professors, we deem it an imperative necessity that we be united among ourselves. If we are united, what can stand against us? But if we divide, we shall destroy ourselves; the work of God, and the souls of our people. That we may, let us see wherein we are united:

- 1. The great end of our faith is the salvation of souls. No earthly interest can bear any comparison to this, therefore our labors in private and in public should be directly calculated to save souls and build them up in faith and holiness. We should make no conditions of salvation that are not found in the Word of God.
- 2. In particular we believe cordially in the doctrine of Entire Sanctification, and that it is a second, definite, instantaneous work of grace, subsequent to regeneration, attainable by faith.
- 3. We believe that God does still answer prayer for the hearing of the body, according to James 5:15: "And the prayer of faith shall save the sick." The Word of God is too plain, and too many instances have occurred among us for us to call this truth in question. But we do not believe that any one has the power to heal whoever he pleases, nor is the gift of healing to be sought after as a distinct, specific blessing. This, with all other spiritual gifts God divides to every man severally as He, God, wills.
 - 4. We believe in the Pre-millennial coming of Jesus Christ.
 - 5. While we hold to being led by the Spirit, we do not believe that any one is so fully led that he is not liable to make mistakes. The Spirit of God can not err, but we can, and we may think we are led by the Spirit when we are not. God's Spirit never leads contrary to His Word, nor in a way to supercede the the necessity of diligently searching the same that we may know the mind of the Lord.
 - 6. We believe that modern spiritualism in its various forms

and phases, including the tongue's delusion, is of the devil.

- God Almighty, the maker of the heavens and of the earth, is not responsible for the existence of Alcohol, for not one drop of it can be found in anything He has created. It is the product of fermentation and distillation and therefore of decay and rot. product of hell and earth is in the market under license as a beverage for man. Its demoralizing, brutalizing, pauperizing, crime producing, soul damning influence and effects are universally known and acknowledged. The licensed saloon, therefore, is crimson handed crime against every principle of benevolence, humaneness and religion. We protest against the liquor traffic in all its forms. believe that voice and vote should go hand in hand. It was the stone in the hand of David, through the power of God, that the Philistine giant was slain, and we with the sling of faith and smooth stone of ballot, through the mighty power of God, will be able to slay the giant Alcohol. As a Church, we pledge fidelity to God and the measures that are used to abolish the liquor traffic.
- 8. Tobacco is a deadly, poisonous weed, constantly avoided by all creatures, except three, the tobacco worm, the Siberian goat and man. This nasty, sickening and degrading tobacco habit is still alive. No user of this weed can justly claim to have "a conscience void of offence toward God and man," for he certainly gives much offence in squirting his nicotine juice on side walks and floors, and in puffing his blue smoke in the face of clean, decent ladies and gentlemen. We must continue to bombard this cesspool of nastiness as long as its sickening odors declare its existence.
- 9. We should maintain our position against all oath bound secret societies. We believe they are one of the most deeply laid devices of the devil, and a parasite to the church, the state and the home. Secrecy is a combined force posing as religious in character, but in reality is Anti-Christian.
- 10. Empires may crumble, Kingdoms may fall, nations may change, but Roman Catholicism is always the same. We regard it as a relentless foe to civil and religious liberty. It would arrogate to itself the control of our government, abolish our free school system and trample under foot the doctrines of the Bible.
- 11. We believe that plain, modest apparel is essential to a deep religious experience. This is no time to give encouragement to suprfluity of apparel. We protest against all tendency to world-

liness in dress, as the wearing of short sleeves, low necked dresses, peekaboo waists and transparent hosiery. We also recommend plainness of dress for our children.

- 12. Our Manual is plain as to Baptism—modes and subjects. We stand by it and will allow no one to make their personal conviction an issue in the Church.
- 13. "The powers that be are ordained of God." The Bible gives us no license to be anarchistic and unpatriotic. There is danger in these days of not only offending our government by adverse criticism, but also offending God through ignorance of the Scriptures. Our government has very graciously provided for conscientious objectors to be exempt from bearing arms, and none of us are forced by the hand of the government to take life without our consent, but this does not license us to rebel against the necessary and reasonable laws and decrees which our government may see fit to establish.
- 14. We will cherish the most cordial love and sympathy for each other, we will be more careful in believing reports to the prejudice of a brother, and when we hear them we will not relate them to others nor lay them up against him until we have his explanation. We will endeavor to keep the unity of the Spirit in the bonds of peace, that we consistently pray and believe for those baptisms of the Spirit so necessary to carry on the work of the Lord among us.

Praying the great Head of the Church to give us mutual forbearance, and a patient. kind, teachable, gentle disposition with all the fruits of the Spirit.
