

PROCEEDINGS OF THE TWENTY-SIXTH PENNSY-LVANIA ANNUAL CONFERENCE OF THE HOLINESS CHRISTIAN CHURCH

The 26th Session of The Penna. Annual Conference of The Holiness Christian Church convened at Pottstown, Pa., April 8th, 1919.

The Conference was called to order at 2:10 P. M. by P. E.

Rev. H. F. Lessig.

Singing, "I remember Calvary," followed by prayer by P. E. Rev. H. F. Lessig. Thanking God for the rising of The Penna. Annual Conference 26 years ago, and praying that this Conference Session may be the best we have thus far experienced. Amens. After which the Presiding Elder read Scripture lesson from Acts i-2. The subject being "United Efforts." An earnest discourse was given on the subject, and the scene of the Upper Room was plainly brought to view.

Followed by singing, "He's the One."

Roll Call. By motion absentees were excused.

The minutes of last half day's session of the Conference of

1918 were read, and by motion were received as correct.

By motion the name of Rev. H. P. Jones, deceased, be dropped from the Conference Roll and it be referred to the Committee on Resolutions. Carried.

Letters of greetings were read-from Rev. C. C. Brown, Genl. Supt. of the Holiness Christian of U. S. A.; and Revs. C. M. Emerson, of Mable, Pa.; Isaiah Martin, of Trenton, N. J., and Adam E. Fields, of Weatherly, Pa. And favorable action was taken inreference to same and the secretary was instructed to return greetings.

On motion we go into election of officers. Carried.

By motion, this Annual Conference favor a special session of The General Conference of the Holiness Christian Church to be held in one of the Western States. Carried.

On motion, we elect a Conference Evangelist. Mrs. Ella J.

Nace was elected.

On motion, each local church keep a strict church record of all functions performed during the year, viz.: Membership, when members were received, and by whom, and how dismissed. Converted, Sanctified, Baptized, Consecrated, Marriages, and Deaths, and that all the above be properly enrolled. Carried.

Thursday afternoon session. Preceded by 30 minutes devotional exercises. Rev. B. Hevalow, of Weatherly, Pa., in charge.

The Conference was called to order by H. F. Lessig, chair-

man, at 1:45 P. M.

6. We recommend Mary E. Roley, after due examination, for evangelistic license to remain in the home missionary work.

Report of Committee on Ways and Means:

1. We recommend that the president, secretary and treasurer of the Burial Association be paid the sum of \$5.00 each for service rendered for 12 months ending March 31, 1919.

2. We recommend that each member of the Burial Association be assessed 10 cents to defray running expenses in said association during this coming year and the same to be paid within 60 days from date of this Conference.

3. We recommend that the Conference Treasurer be paid \$5.00 for service rendered for 12 months, ending March 31,

IQIQ.

4. We recommend that Presiding Elder be paid all official expenses during this Conference year, and that each charge lift a free-will offering on his quarterly rounds, and that offering be not less than \$5.00 and carfare.

5. We recommend that there be two offerings lifted in each church and Sunday School this Conference year for Home Missionary Work, one in the month of June and one in the

month of November.

6. We recommend that the Committee on Publication be

paid 30 cents per hour, and carfare for their work.

7. We recommend that each charge pay at least 25 cents per member into the Annual Conference Treasury this Conference year to defray running expenses of the Conference.

8. We recommend that each charge pay at least 10 cents per member for the General Conference, the same to be sent to

the Annual Conference Treasury.

o. We recommend that there be a free-will offering lifted

at the annual campmeeting for the Presiding Elder.

10. We recommend that if the Home Missionary Board so decides that the money in the Home Missionary Treasury be used to open new work.

II. We recommend that each member of this Conference pay at least \$5.00 in the campmeeting treasury by July 15, 1919. Collection for Conference Secretary, \$18.00. Thanks. Adjourned. Benediction by H. F. Lessig.

Conference called to order at 1:30 P. M.
Roll Call. By motion absentees were excused.
Minutes of previous session were read and approved.
