CONFERENCE PROCEEDINGS

FIRST SITTING

The Eighth Annual Conference of the Arizona District of the Pilgrim Holiness Church was convened at the call of Supt. Crosser. Rev. Willard Metz, Pastor of the host church, welcomed the annual conference.

M. E. Waddell led the assembled group in singing, "I Will Sing the Wondrous Story." District Trustee, H. C. Fridenmaker and Rev. Duane Watkins, led in prayer.

Supt. Crosser introduced Dr. Hawkins as presiding officer.

Dr. Hawkins read a portion of scripture from Numbers 13, using as his subject, "Pattern for Progress."

He indicated that God, who had enabled so greatly in times past, would even today grant great and mighty deliverances unto His people. He stated "We shrink from the tasks that overwhelm us. God's true people have always known that He will make a way through. God's people have always been in the minority. We must choose to be with the minority in the right instead of the majority in the wrong."

He emphasized that any progress that we may have must come from our love for God. The glory of God is all important. He further emphasized that we cannot sit still with the love that God has dropped into our hearts. Our hearts are aflame with a holy passion. This passion necessitates a great burden for the work. This great burden placed on our hearts leads to a vision. A vision to see the impossible accomplished comes as a direct result of passion and burden. Then comes a method of operation for the glory of God. Progress depends upon our motives, prayer, genuine concern, how well our efforts are planned and how well we present the message of Christ. He closed his address by stating "May God give us of the spirit of Caleb and Joshua, 'Let us go up at once and possess it'."

The roll of ministers and delegates was called.

A motion carried to seat Rilla Stone as a delegate from the Calvary Church.

A motion also carried to designate the platform and the first three rows of seats on both sides of the church as the conference bar.

By motion, the schedule of sessions was set as follows: 9:00-11:30 a.m., 1:30-5:00 p.m., 7:00 p.m. until business is completed.

A motion to accept the transfer of Rev. Melvin Lockard, an ordained minister from the Pittsburgh District and Miss E. Louise Van Metre, from the California District, carried with a hearty "Amen."

Bruce Collins and Marvin Wainscott were appointed as ushers to distribute conference reports.

District Superintendent Crosser presented his annual survey to the conference and was received by a standing vote of appreciation.

The auditor's report was read and approved.

Rev. M. E. Waddell, acting District Treasurer, read the financial report. A motion to accept this report carried.

Denzel Clouse presented the corporation financial statement. Motion carried to approve.

A motion carried for the Statistician to read the totals of the Statistical report. Approved as read.

The Sunday School Promotional Secretary, Herman E. Underwood, gave a summary of accomplishments in this department across the District. This good report was received by motion carried. He presented the Rita Manor church with the Decade of Progress Ship as the annual Conference Award.

The Pastors of the conference gave a resume of personal labors as well as reporting on the state of the local church.

Prayer was offered for Rev. Brown, absent from conference due to illness.

A motion carried to extend the first sitting to hear the conclusion of pastors reports.

A motion also carried to accept the pastoral reports with a hearty "Amen."

H. G. Baker, Secretary of the Educational and Examining Board, read the committee report which was approved as read.

Superintendent Crosser appointed the ministers of the Council with H. G. Baker to comprise the Ordination Council.

After announcements, the first sitting was recessed with a prayer of dismissal by Arville Parker.

SECOND SITTING

The second sitting of the conference was called to order by singing "He's A Wonderful Saviour To Me." Prayer was offered by M. E. Turner.

The minutes of the first sitting were approved as read.

The Conference Action Committee reported through its secretary, Rev. Herman E. Underwood.

Resolutions #1, 2, 3 were adopted by motions carried.

Superintendent Crosser presented a Merit Award to each of the following churches: Tempe, Westside and Yuma.

M. E. Turner, Denzel Clouse, Melvin Lockard and Duane Watkins were appointed as tellers.

The General Secretary of Church Extension read the following names as nominees of the General Board for District Superintendent: Harold Crosser and M. E. Waddell. Reverend Harold R. Crosser was elected on the first ballot.

Ballots were cast for Assistant District Superintendent with the election of M. E. Waddell on the third ballot after a motion to vote on the three highest carried.

The Equalization of Travel Committee distributed and collected the travel reports.

Reverends John Dunn, H. G. Baker and M. E. Turner were the Council nominees for District Secretary. John Dunn was elected on the first ballot.

A ballot for District Treasurer was cast using the Council nominees, Reverends Melvin Lockard, Charles and Mr. Denzel Clouse. Mr. Denzel Clouse was elected on the third ballot.

A ballot was cast for Advisory member to the Council. Melvin Lockard was elected on the third ballot after a motion to elect one of the three highest.

A ballot for a three year term as member of the Educational and Examining Board was cast. Council nominees were Duane Watkins and Charles Cooper. Charles Cooper was elected on the first ballot.

Council nominees for a three year term on the Board of Trustees were Charles Long and Kenneth Artz. Charles Long was elected on the first ballot.

Superintendent Crosser read the committee appointments for the new conference year.

Invitations were accepted to host the annual conference, April 28, 1964 from the Calvary and First Churches of Phoenix.

It was moved and carried that the Council be authorized to approve the minutes of the second sitting of the annual conference.

A final resolution from the Conference Action Committee was read from the floor by M. E. Turner as follows: BE IT RESOLVED that by a rising vote we express our appreciation to Dr. R. C. Hawkins for his expeditious and effecient chairmanship of the annual conference, to the Trinity Church and pastor for their hospitality and to District Superintendent H. R. Crosser for his faithful and effective leadership. Motion carried with everyone standing.

An appropriate memorial service was given by the Memoirs committee in honor of deceased members and friends. Their report concluded with a memorial prayer offered by Superintendent Crosser.

Conference recessed until 3:45 p.m.

Conference reconvened at the appointed time for the purpose of ordaining John H. Miller to the ministry. M. E. Waddell led the assembly in singing "A Charge To Keep I Have." H. R. Crosser led in prayer. Passages of Scripture were read by M. E. Turner, M. E. Waddell and John A. Dunn. Superintendent Crosser presented the ordinand to the conference and Doctor Hawkins. The ordination charge was given by Dr. R. C. Hawkins after which the ordination council laid their hands upon the ordinand as H. G. Baker offered prayer. The conference sang "Blest Be The Tie That Binds" as they congratulated Reverend and Mrs. John Miller.

Conference adjourned with the prayer of dismissal given by Reverend Charles L. Cooper.

CONFERENCE REPORTS

ADDRESS OF THE DISTRICT SUPERINTENDENT TO THE DISTRICT CONFERENCE SESSION--MAY 21, 1963

To our esteemed General Secretary of Church Extension,
and to faithful ministers, delegates, and friends of the

eighth annual conference of the Arizona-New Mexico District, Greetings.

Some days ago I came upon this beautiful quotation, "HE will silently plan for thee." If this be true of individuals, I am confident it is also happening in behalf of the church of Jesus Christ which is to be the bride of the Lord.

God is planning at all times for the advancement of His cause here on earth. Through the office work of the Holy Spirit, consecrated and dedicated men and women become the instrumentality through which the holy effort progresses.

We are pleased to believe that the Arizona-New Mexico District of the Pilgrim Holiness Church is in divine order--that approximately seven years ago God gave direction and men arose to do the divine bidding. What has happened since has been clearly blessed with the touch of the supernatural. The pillar of cloud and the pillar of fire have led the way.

The year just closed has been anointed of the Holy Spirit. I believe it can be said that we have done our best to find the will and the way of God and walk accordingly.

At the last International Conference, Arizona-New Mexico was given the distinct honor of having its leader elected to a General Office. After the elevation of our District Superintendent, Reverend O. D. Emery, to the position of Secretary of General Sunday Schools and Youth, the ranks closed quickly and the necessary adjustments were made. I can only be deeply grateful at the kindness of our people to me personally and the general feeling of equanimity and goodwill that has prevailed since. You have been generous and magnanimous. Thank you for all of your help and cooperation.

The plans and programs of Last year's conference have been pursued vigorously by both the local churches and the district. It is evident that much intercession and prayer have salted the goals established by the Pattern of Progress. Let it also be said that our people have faced the fact that faith without works is dead.

God's work would not be what it is unless there were oppositions and problems. The things that distress us invariably provide the moral fibre and stamina for another frontal assault in the direction of victory. One of our big tasks this year has been to attempt to set our financial

house in order. As we move into the second year of activity on the Advanced Level we must more and more assume financial obligations that were at one time originally carried by the General Church. It is hoped that the financial program being proposed to this conference will be a big step in the direction of fiscal maturity through the systematic caring for District operation, the liquidation of indebtedness, and the expansion of the work.

Perhaps our greatest need is a continual train of holy intercession flowing heavenward and a full realization of the fact that prayer is "eternal time." To this end I will be formulating a program for monthly days of fasting and prayer for revivals in our day among the Pilgrims of Arizona-New Mexico.

A careful check of statistics reveals the following with regard to our pattern of progress goals:

1. We were striving for a 10% gain in both church membership and Sunday School average attendance. The membership increase is 85 or 20.9%. With one exception every church had membership growth.
2. The Sunday School increase is 87 or 10.4%. A new attendance record for any one day was set by this arm of the church with more than 1,200 in attendance last Christmas Sunday.
3. We also were reaching for a 10% increase in finances. Including the factor that 1961-1962 was a ten-month year, we have shown a gain of \$8,951.23 or 10.3%.
4. According to a list from the Advocate Office this district stands first in subscriptions with 66% of its adult membership taking our official publication.

The Phoenix Paradise Valley effort which was sponsored by Phoenix First and reported last year as a branch Sunday School, has been organized into a fellowship. A full schedule of services is being conducted under the courageous leadership of Rev. and Mrs. Lowell Downey. Another year should produce a full organization.

Several churches have taken steps to enlarge their effectiveness.

The very fine Tucson, Rita Manor Church has been finished and was dedicated after International Conference.

Phoenix, First has purchased a new commercial lot on 3rd street next to the church and is discussing plans for new

construction.

Tucson, Parkview is completing a nice new Sunday School unit.

The task of refinancing the district indebtedness as well as the indebtedness of six of our churches has also been a major matter.

Last year a system of awards for local churches that met the standards of the pattern of progress was established. At an appropriate time during this conference these awards will be presented. Nine churches reached or surpassed their membership goal, eight their Sunday School goal, eight the financial goal. It appears that six paid their 15% budget in full with excellent participation by all in the three denominational offerings.

Two of our finest workers in the district have recently decided to take a year's leave of absence from the work. Rev. and Mrs. Meredith Turner love Arizona and we are expecting them to return. Their labors of love in establishing the Prescott Church are deeply appreciated. They have also made contributions on the District level. Faith Turner has done a grand piece of work leading the District Missionary organization.

As to our task and the future we must each one personally, from time to time, climb the mountain of vision for this great Southwestern Empire. We have just begun to touch the edges of what can be done in Phoenix and Tucson. Of this we must be persuaded. If we falter or hesitate, the day will be lost.

Five of the ten largest cities in Arizona (Mesa, Flagstaff, Glendale, Douglas, and Scottsdale) remain to be entered. Three of these are in the greater Phoenix area. Several of these cities must be entered quickly if we are to reap the harvest God means us to have.

This year we have taken the state of New Mexico to our hearts. Plans have been made to open our first work in Albuquerque and it is a great joy to tell you that Reverend Dale Rummel who for 14 years has been pastor of Denver First will be the new pastor. The target date for the launching of the work is the latter part of July.

This following strategy for New Mexico has been presented

to the District Council and meets with their approval. Three prime areas have been chosen: 1) Albuquerque, 2) Clovis-Roswell-Carlsbad, 3) Las Cruces. Pilot churches will be started in each of these regions. The rate of growth and the providential openings that come to us will dictate further effort and the openings of additional churches.

By the General Conference of 1966 there should be at least one church in each of these prime areas. To this end the District Council has approved the opening of a church in one of the two remaining areas during the new conference year.

For the year ahead let us carefully follow the Pattern of Progress as set up by this conference last year with 10% goals the very minimum in every area of the work. Let us do everything for the greater glory of God and the salvation of souls. Then in the words of a great leader of other years we can cry FAITH AND ACTION--THE FUTURE IS OURS.

SUPERINTENDENT'S PERSONAL REPORT

It has been a joy to serve the Lord another year and answer his call to service. I have had responsibilities as a pastor for three months and as District Superintendent nine months.

In the performance of my duties I have ministered 109 times and made 102 pastoral calls. I have held two revivals and one weekend meeting in the district and have seen 23 seek salvation and 12 seek sanctification, and prayed with five for healing. I have conducted 10 prayer services, five communion services, and 16 board meetings. I have officiated or assisted at three funerals, baptized five adults, dedicated one child and performed one wedding ceremony.

I have conducted six District Council Meetings, three Youth Council Meetings, and one Sunday School Committee meeting as well as presiding over the 1962 District Youth Conference, the Ministerial meeting, the Indoor Camp, and the installation of one new pastor. Eight annual meetings have been conducted and three call-pastor meetings. I assisted in two dedication services—one in Arizona and the

My salary has been paid in full.

It has been a great joy to do God's work here in the South-western United States under the banner of the Pilgrim Holiness Church. Thank you for all your kindnesses, love, and cooperation.

The Rally Day attendance exceeded the previous years attendance by 14% with a total of 1,047 as compared to 916.

All records were shattered on Christmas Sunday with an attendance of 1,220.

Once again we held a District Wide Handicap with an average attendance of 979. Tucson, Trinity captured the banner with Phoenix, West a close second. The winning pastor and superintendent was Willard Metz and Bruce Collins.

The Decade of Progress Ship was awarded to the Tucson, Rita Manor Church again this year.

Sunday Schools with the largest numerical gains are: Tucson, Trinity - 26, Phoenix, Paradise Valley - 21, Tucson Rita Manor - 14, Phoenix, West - 11 and Tucson, Parkview with 11.

Sunday Schools with the highest percentage gains were: Tucson Trinity - 63%, Tucson Rita Manor - 36%, Tucson Parkview - 28%, Yuma - 24%, Phoenix West - 19%. Other Sunday Schools above the 10% were: Phoenix Bethel - 13%, Tempe - 11%, Calvary 10%.

MAY 21, 1963

1. BUDGET

BE IT RESOLVED that #2 under Budget, page 26 of "Standing Resolutions of Previous Conferences" and item #2 under "1962 Report of the Conference Action Committee" be deleted and BE IT RESOLVED that the following financial plan be adopted:

1. That each church pay monthly to the District Treasurer 15% of all regular church offerings and regular Sunday School offerings, and that the 15% will not apply to monies raised for the building fund, land fund or any special offerings raised for a department supported by these budgets. No other exceptions are to be made.
2. That the 15% District Budget be disbursed as follows: \$6,640.00, District Operation (Proposed budget to be presented in detail). The remaining amount to be applied to the General United Stewardship Fund until paid in full.

BE IT FURTHER RESOLVED that district support for Central Pilgrim College be raised through an annual tour of the district by C. P. C. representatives.

BE IT FURTHER RESOLVED that we establish a Contingency Fund for International Conference delegate expense, this money to accrue from 10% of the pastor's tithe, to be forwarded to the District Treasurer from the local church.

BE IT FURTHER RESOLVED that each church raise a special offering for District Indebtedness, this financial drive to be conducted in October. (Carried)

STANDING RESOLUTIONS OF PREVIOUS
CONFERENCES

LOCAL CHURCH

1. The local churches shall provide modern cooling, cooking and heating facilities for the parsonage, the type of facilities to be suitable to the locality where the parsonage is situated, and all churches in the conference shall pay the utilities for the parsonages.
2. Each local church is urged to raise a subscription list to the Pilgrim Holiness Advocate equal to its total membership.
3. Each local church shall have a Public Relations Chairman, who will submit copy of local news events to district publications and local newspapers.
4. BE IT RESOLVED that all local indebtedness involving an expenditure of more than \$500, where financing is involved, be approved by the District Council. (1960)

5. BE IT RESOLVED that all non-Pilgrim Evangelists must first have the approval of the District Superintendent or the District Council before being called for evangelistic activity in our churches. (1960)

6. BE IT RESOLVED that no church may borrow from its pastor, nor may any pastor underwrite loans for a church so as to make himself legally responsible as an individual, without the prior consent of the District Council. (1961)

CONFERENCE

1. The district council and the following committees and boards shall meet one day prior to the Annual Conference to take care of such work as they have at hand. Conference Action Committee and the Educational and Examining Board.

2. In order that the relatives and friends may know the set time for the ordaining of ministers, BE IT RESOLVED, that the Ordination Service take place at 4:00 p.m. the first day of Conference. (1957)

3. The Educational and Examining Boards shall be combined and this Board shall consist of three members, one being elected for a period of three years, one for a period of two years and one for one year.

4. There shall be a memoirs committee which shall annually list departed members by name, date of decease, and church, for inclusion in the Conference Journal. In the case of ministers, there shall be a picture and a brief resume of ministerial labors.

5. BE IT RESOLVED that the district furnish credential forms to each local church conference delegate and alternate to be filled out and signed by the pastor and the church secretary, and sent to the district secretary at least 30 days prior to Conference. (1959)

6. BE IT RESOLVED that the District Trustees and the Statistician be made permanent members of the District Conference. (1959)

7. INASMUCH as there is such close correlation between the work of the Resolutions Committee and the Ways and Means Committee: THEREFORE BE IT RESOLVED that there be an appointment of a Conference Action Committee of 5 members, which would combine the functions and capacities of the Resolutions

and the Ways and Means Committees. (1960)

8. BE IT RESOLVED that there be an appointment of a Building Appraisal Committee: (competent in the field of Appraisal) the function of which shall be to set the value of all church property. BE IT FURTHER RESOLVED that the appointment of this committee be made bi-annually, for the purpose of making a general appraisal of all local church and district property bi-annually. AND BE IT FURTHER RESOLVED that all properties acquired between these appraisals shall be carried as tentatively appraised by the District Council, until the next general appraisal. (Revised 1961)

9. INASMUCH AS Resolution #6, p. 16 of the 1960 Conference Journal carried and provides that all resolutions and ways and means actions be classified both in presentation and in publication. BE IT RESOLVED that the following general classification, "Report of the Conference Action Committee" and "Standing Resolutions of Previous Conferences", be applied to all past and present conference legislation and BE IT FURTHER RESOLVED that the present "Standing Rules" heading be abolished, and legislation of previous conferences currently listed under this heading be classified under "Standing Resolutions of Previous Conferences" and, BE IT FURTHER RESOLVED that the following specific classifications be applied to all past, present and future legislation: LOCAL CHURCH, CONFERENCE, DISTRICT SUPERINTENDENT, MINISTERIAL, DISTRICT COUNCIL, BUDGET, CAMP, SUNDAY SCHOOL, YOUTH, MISSIONARY ORGANIZATIONS. (1961)

10. WHEREAS the District Council has recommended the moving of the Arizona-New Mexico District into the "ADVANCED LEVEL," THEREFORE BE IT RESOLVED that this conference approve the promotion of the Arizona-New Mexico District into the "ADVANCED LEVEL STATUS." (1962)

11. BE IT RESOLVED that the conference year of the Arizona-New Mexico District shall begin April 1 and end March 31 the following year, and that all reports be sent to the District Statistician by April 15. (1962)

12. WHEREAS the District Conference expenses for pastors and delegates is to be paid by the local churches, and WHEREAS this creates a disadvantage for the churches at greater distances from the place of conference, THEREFORE BE IT RESOLVED that the total expense for District Officers, pastors and

delegates be pro-rated and paid on a basis similar to the General Conference system, for automobile travel. (1962)

13. WHEREAS the District Superintendent has presented the Quadrennial Pattern for Progress for the 1962-66 period to all pastors and churches of our district, THEREFORE BE IT RESOLVED that the Pattern for Progress be adopted by the Conference. BE IT FURTHER RESOLVED that the following goals be adopted as the Local Church and Conference Goals for the coming year: 1. Pattern for Progress Growth Standards - 10% Sunday School Gains, 10% Church Membership Gains, 10% Local Church Financial Gains. 2. Fostering of Youth Society, Women's Missionary Society, Men for Missions, and creation of Christian Youth Crusades. 3. Lay Visitation Evangelism in each Local Church. 4. New Missions, Branch Sunday Schools and Prayer Meetings throughout the District. 5. Use of Probationary and Junior Membership programs. 6. Payment of all budgets in full and by the month. (1962)

DISTRICT SUPERINTENDENT

1. BE IT RESOLVED that the District pay \$200.00 per month on salary of the District Superintendent; BE IT FURTHER RESOLVED, that the District Superintendent be remunerated for meals and lodging incidental to travel. (Revised 1963)

MINISTERIAL

1. Before licensed or ordained ministers coming from other churches shall be received into the local church, the pastor shall consult with the District Superintendent and Council regarding said minister.

2. Each pastor is to be granted a two weeks vacation with full salary.

3. INASMUCH as several of our districts have a group hospitalization, surgical, and medical insurance plan, and since a number of the district pastors have expressed a desire for such a plan, BE IT THEREFORE RESOLVED that we accept the Blue Cross, Blue Shield group hospitalization, surgical and medical plan. AND BE IT FURTHER RESOLVED that the churches pay \$5.00 per month to be applied to the pastor's premium, and the district pay \$5.00 per month to be applied to the District Superintendent's premium. This

resolution is recommended first for discussion by the committee with the added recommendation that the lay delegation be given the privilege of discussion. (1959 - Revised 1962)

4. BE IT RESOLVED that when ministers come to this district from other denominations, that the Executive Officer of the transferring minister be contacted by the District Superintendent asking for a recommendation, to be in the hands of the District Council at least 30 days prior to moving date. AND BE IT FURTHER RESOLVED that the transferring minister be interviewed by the District Council prior to reception of his credentials. (1959)

DISTRICT COUNCIL

1. BE IT RESOLVED that laymen may serve on the District Council. (1959)

2. BE IT RESOLVED that each council member be paid 5 cents per mile for travel expense to and from council meetings and that when several members travel in one car, the driver be paid an additional one cent per mile for each council member travelling with him. (Amended 1961)

3. WHEREAS those who serve as District Secretary and District Treasurer must devote considerable time to their duties, and INASMUCH AS other districts comparable in size to our district pay their Secretary and Treasurer token remunerations, THEREFORE BE IT RESOLVED that the District Secretary and the District Treasurer each be given an honorarium of \$50 per year. (1962)

BUDGET

1. BE IT RESOLVED that all monies raised in local churches for district, general or Bible College purposes be disbursed through the District Treasurer, and only such monies as are processed accordingly may be credited to the local churches on the District Treasurer's report.

ALSO SEE CURRENT LEGISLATION.

CAMP

1. WHEREAS it appears that the cost of owning and maintaining a camp ground is prohibitive; BE IT RESOLVED, that the Conference instruct the Council to take steps to dispose of the real property on the camp ground and that the proceeds be applied as follows: 1. Satisfy the claims of cabin owners, 2. Camp ground indebtedness, 3. Balance if any to be put in a Camp Fund. (1960)

SUNDAY SCHOOL

1. BE IT RESOLVED that the work of the District Sunday School Board be financed by offerings from the District Camp Sunday School and Sunday School conventions, and BE IT FURTHER RESOLVED if a need for additional funds for this Board arises, a request shall be made to the District Council for appropriations. (1961)

YOUTH

1. INASMUCH AS the need for activity among our youth is so great, THEREFORE BE IT RESOLVED that at least six Zone Youth Rallies be held during the conference year in each Zone, with the responsibility of planning and implementing these rallies to be cared for by the elected Zone committee. (1961)

ANNUAL CONFERENCE of the WOMEN'S MISSIONARY SOCIETY MAY 20, 1963

Meeting opened by congregational number "Jesus Saves" led by Mrs. Lois Waddell. Mrs. Wilma Dunn sang a solo, "The Touch of God." Devotions were conducted by Mrs. Mary Mills, Society President of Phoenix First Church, who read Psalm 23 and impressed upon us the need of having the Holy Spirit in our Societies. Mrs. Norma Parker prayed for God's direction in the business meeting.

Rev. Harold Crosser, District Superintendent, presided over the business meeting. After the roll call, the first four pews and platform was established as the bar.

Minutes of the last annual meeting were read by the Secretary, Ruth Ann Cooper, and approved.

Mrs. Faith Turner, President, read her report and received a rising vote of thanks and approval.

The treasurer's report was read and approved.

Resolutions for the coming year were presented to the conference by the secretary. The following were approved:

Since the individual fee for Youth Camp has been set at \$12.95 and since it is the desire of the Missionary Societies to help reduce this amount, THEREFORE BE IT RESOLVED that the missionary project for the month of May be to raise \$125.00 to be applied to District Youth Camp workers' fees, thus reducing the amount of the fee for the campers.

Reverend Crosser informed the conference of those receiving the Scholarship Fund. 1961-1962 --Marjorie Artz of Tempe and Merle Renshaw of Phoenix First. 1962-1963 --Nell Rose Mills of Phoenix First.

The 1963-64 goals were presented by the president and approved.

WOMEN'S MISSIONARY SOCIETY
PRESIDENT'S REPORT

Mr. Chairman, and members of the Annual Missionary Conference of the Arizona-New Mexico District of Pilgrim Churches, I submit to you the following report of the activities of the Women's Missionary Society of the Arizona-New Mexico District for this past conference year, April 1962 through March 1963.

It has been a good year, one of increased vision and burden for our missionary work, both at home and abroad. Last year we reported nine active adult societies and one partially organized, with a total membership of one hundred and fifty-nine. This year we have twelve active adult societies with a total membership of two hundred and five. Last year, subscriptions to our World Missions Bulletin totaled thirty five. This year subscriptions totaled eighty nine.

The pledge of one hundred and twenty dollars (\$120.00) made for the scholarship fund at Central Pilgrim College was met in full plus \$53.79. The final figure for our district educational project amounted to \$173.79.

Our second district project was a love offering taken in the month of February for needed repairs and equipment at Bethel, one of our youngest churches. The offering met with a good response and amounted to \$96.62.

In January our district was honored with the visit of Miss Orpha Case from Africa and Rev. M. L. Peterson from the West Indies. Traveling with the missionaries was our Missionary Society Director, Miss Ruth Meeks from Headquarters in Indianapolis. Their work among us as they visited our local groups was climaxed by our first Women's Missionary Convention in this district held January 8th and 9th at Phoenix First Church.

We are sorry to report a loss in our Junior Societies both numerically and financially. One of our previously stronger societies was inactive this year, but is already making plans to reorganize and get back into action. At present we have five Junior Societies with a total of 66 members.

In conclusion, may I present the following statistical report:

DISTRICT YOUTH CONFERENCE
MAY 20, 1963

Crosser for his fine leadership, the members of the District Youth Council for their splendid work and all of you throughout the district who have helped in the development of a Christ-centered program for our youth.
