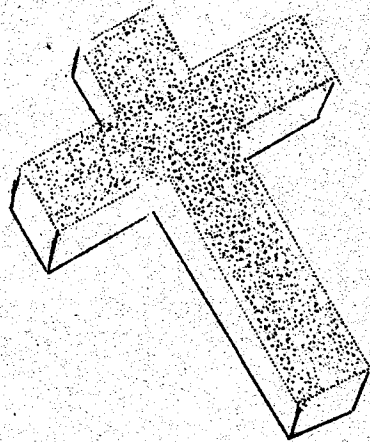

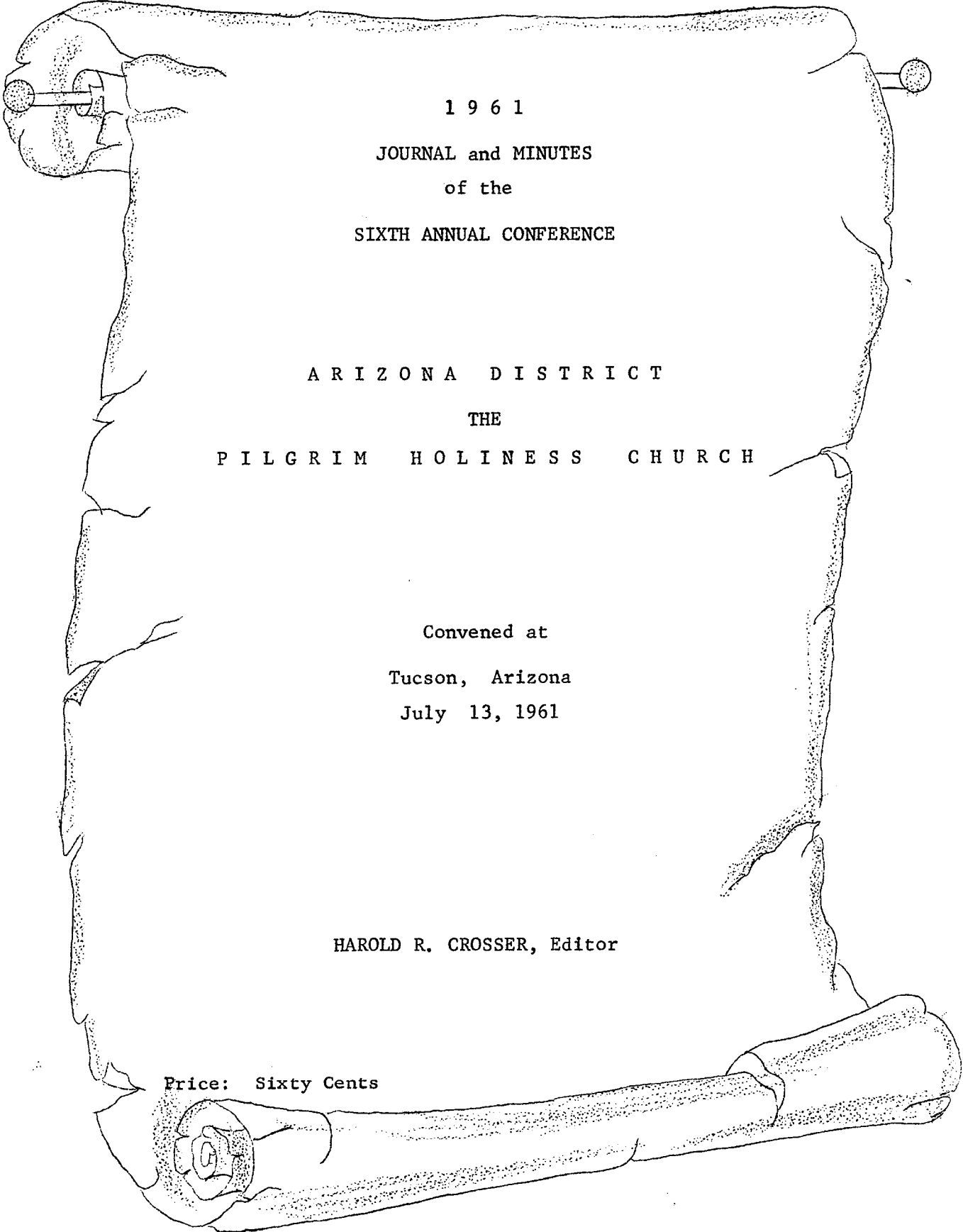

CONFERENCE and LOCAL CHURCH GOALS

1. A 10% membership gain in the District, to include 10% gains in each local church. In the smaller churches a minimum numerical gain of 2 members would apply.
2. A 10% District Sunday School gain, to include 10% gains in each local Sunday School with a minimum attendance goal of 25.
3. A united effort to foster the work of our auxiliary organizations, viz; Young People's Society, Missionary Society, and Men for Missions.
4. Evangelism in each local church community through lay visitation programs by our people.
5. Evangelism through new Sunday Schools in our rapidly expanding cities of Phoenix and Tucson.
6. Probationary and Junior Membership use for the conservation of our converts and our youth.
7. Payment of all budgets by the month and in full.

CONFERENCE PROCEEDINGS

First Sitting

The Sixth Annual Conference of the Arizona District of the Pilgrim Holiness Church convened in the Tucson, First Church at 9:00 a.m. July 13, 1961.

District Superintendent Emery led in singing, "He Leadeth Me" and then called on District Trustee H. C. Fridenmaker to lead the assembled group in prayer.

Presiding Officer, Dr. R. C. Hawkins, Secretary of Church Extension, was introduced and spoke on the subject of "Victory" using I John 5:4 as a basis for his remarks. He emphasized the truths that: Victory is the purpose of God, the prayer of the church, the privilege of the people, the psalm of eternity. The Conference spontaneously sang, "Victory in Jesus".

The Roll was called. Intervening motions called for the seating of Miss Merle Renshaw as a delegate for Phoenix, First; Kenneth Artz for Tempe; and Mrs. Herschel Stewart for Tucson, Parkview.

A motion carried to establish the first six rows of seats in the center section and the platform as the Conference Bar. A motion also carried to set up a schedule of sessions as follows:

Morning	9:00 - 11:30
Afternoon	1:00 - 5:00
Evening	7:00 -

District Superintendent Emery presented his report. It was received by a rising vote.

The Tucson, Rita Manor Church was received into the Conference with a hearty "Amen". Pastor Charles Cooper and Delegate Isabel Davis were presented to the Conference after which the Doxology was sung.

The District Treasurer's report was given by Reverend M. E. Turner pending the report of the Auditor. A motion to accept the report was carried. A motion expressing appreciation to Brother Turner for two years of excellent service, also carried with a "God bless you, Bro. Turner".

Statistician Denzel Clouse read the totals of his report. A motion to accept the report, with gratitude to Brother Clouse for his fine work, carried. The Statistician also read the Arizona District Corporation Financial Statement and it was adopted by motion.

Reverend M. E. Waddell read his Sunday School Promotional Secretary's report and made award presentations to Phoenix, Mountainview for the highest percentage gain; Phoenix, First for the highest numerical gain and the highest standing in the Decade of Progress effort;

and 25% gain ribbons to Prescott, Phoenix, Mountainview, Tempe and Tucson, Trinity.

A motion to accept the Sunday School report with gratitude to God carried by a hearty "Amen".

The Missionary Society report was read by District President Lenore Clouse. It was accepted by motion carried.

It was moved, seconded, and carried that the reports of the District Youth President and Youth Treasurer be incorporated in the Conference Journal.

The Conference Action Committee read its full report through its Secretary, Reverend Charles L. Cooper.

Resolution Number 1 of this report was reread and adopted by motion carried.

Resolution Number 2a was passed by motion as were 2b, 2c, 2d and 2e.

It was moved, seconded, and carried that all items under Resolution Numbers 3a, b, c, d, e, and f be forwarded automatically to next year's Conference Journal.

It was also decided by motion carried that the classified legislation under Resolution Number 3 be automatically forwarded to the Conference Journal with the exception of the mimeographed resolutions mentioned.

The session was adjourned by expiration of time.

After announcements Reverend Willard Metz dismissed with prayer.

Second Sitting

The Second Session of the Sixth Conference convened at 1:05 with Reverend O. D. Emery leading in singing "Sweetly Resting". Prayer was offered by Reverend M. E. Turner.

The minutes were read and approved as read.

Pastoral reports were given by Herman E. Underwood, Apache Jct.; John Dunn, Phoenix, Calvary; Mark E. Waddell, Phoenix, First; Paul Sawdy, Phoenix, Mountainview; M. E. Turner, Prescott; Duane Watkins, Tempe; Harold R. Crosser, Tucson, First; Charles L. Cooper, Tucson, Rita Manor; Willard Metz, Tucson, Trinity; Robert Seelig, Yuma.

The Pastor's reports were received by motion carried.

The new Bethel Church at Phoenix was represented by the Pastor, Wesley Reiff. His report was received by motion.

Charles L. Cooper, Secretary of the Conference Action Committee, continued the report of that committee.

The District Superintendent's salary as dealt with by amendment under Conference Action Resolution Number 3 was adopted by motion carried.

It was moved, seconded, and carried to adopt Resolution Number 5.

Resolution Number 5 was referred back to the Committee for redrafting.

No action was taken on Resolution Number 6.

Resolutions Number 7 through 11 were all passed by motion carried.

A motion carried to consider Resolution Number 12 section by section. Sections I, II, III were passed by motion carried.

A motion to recess and reconvene at 3:15 carried.

The Conference reconvened and immediately passed section IV of Resolution Number 12 with the understanding there would be editorial revisions in both Sections II and IV.

Sections V, VI, and VII of Resolution Number 12 were all adopted by successive motions carried.

It was moved, seconded, and carried to pass Resolution Number 13.

Resolution Number 14 was ruled out of order on the basis of a ruling of the General Superintendents.

It was moved, seconded, and carried that action be deferred on Resolution Number 15 until the Conference Action Committee brings back Resolution Number 5 in redrafted form.

The Committee on Memorials to the General Conference reported through its Secretary Charles L. Cooper. The seven proposed memorials were read in toto.

By motions carried Resolutions Number 1, 2, and 3 were adopted by motion carried.

Proposed Memorial Number 4 was lost.

Proposed Memorial Number 5 was moved, seconded, and carried.

It was moved and seconded to adopt proposed Memorial Number 6. A motion carried to defer action on Number 6 until Number 7 is considered.

Proposed Memorial Number 7 was adopted by motion carried and as a result proposed Memorial Number 6 could not be considered because the Manual established quota of five Memorials had been reached.

A motion to recess until seven o'clock carried. Prayer was offered by Reverend Wesley Reiff.

Third Sitting

The sitting opened with a special number in song, "Until Then" by Reverend and Mrs. William Tromble. District Superintendent Emery led in prayer.

Minutes of the Second Sitting were approved as read.

The Auditor's report was accepted by motion carried. The Statistician, Denzel Clouse, also gave the final figures on evaluation.

Reverend Herman E. Underwood, Secretary of the Education and Examining Board read that report as approved by the District Council. This was adopted by motion.

The Conference Action Committee again reported through its Secretary, Charles L. Cooper.

It was moved and seconded to adopt Resolution Number 5. A motion to amend was lost. A motion to table Resolution Number 5 if favor of a consideration of last year's budget system lost. A motion to amend re-drafted Resolution Number 5 by cutting the Central Pilgrim College budget to \$828.00 carried. The main resolution as amended also carried.

A short recess was called. When the sitting reconvened prayer was offered by the Presiding Officer.

The following resolutions were offered by District Superintendent Emery and adopted by motions carried:

1. "BE IT RESOLVED that no church may borrow from its pastor, nor may any pastor underwrite loans for a church so as to make himself legally responsible as an individual, without the prior consent of the District Council";
2. "WHEREAS the 1960 Conference called for the appointment of a Building Appraisal Committee,
"BE IT RESOLVED" that the appointment of this committee be made bi-annually, for the purpose of making a general appraisal of all local church and district property bi-annually,
"AND BE IT FURTHER RESOLVED that all properties acquired between these appraisals shall be carried as tentatively appraised by the District Council, until the next general appraisal",
3. "WHEREAS the mid-winter camp plan has been adopted,
THEREFORE BE IT RESOLVED that this year be a 10-month year to close March 31, 1962, with Conference to be held on May 1 at a place chosen by the District Council".

The appointment of Executive Officers by the General Board were

read by the Secretary of Church Extension--

District Superintendent - O. D. Emery
District Secretary - Harold R. Crosser
District Treasurer - M. E. Waddell

Denzel Clouse, Duane Watkins, and Wesley Reiff were appointed tellers by the District Superintendent.

A ballot was cast for Advisory Members to the District Council. The motion to vote on two of the four highest carried. Mr. Elwood Hunter was elected on the second ballot and Charles L. Cooper on the third ballot.

The ballot for a three year term on the Educational and Examining Board produced the election of Herman E. Underwood.

After a motion to vote on one of the three highest, Denzel Clouse was elected to a three year term as a District Trustee on the third ballot.

A motion to elect ministerial delegates to the General Conference by a majority vote and alternates by a plurality vote carried. Charles L. Cooper was elected on the second ballot. A motion to vote on one of the next three highest produced the election of John Dunn as a delegate as well as M. E. Turner and Herman E. Underwood as first and second alternates respectively.

It was moved, seconded, and carried to elect the lay delegate by a majority vote and the alternate by plurality. After the first ballot a motion carried to vote on one of the four highest. The third ballot produced the election of Denzel Clouse as delegate and Marvin Fridenmaker as alternate.

A motion carried to accept the transfer of Reverend John Mosier from Northern Indiana.

The committee appointments were read by the District Superintendent.

Reference was made concerning the absence of Reverend and Mrs. H. G. Baker due to a death in the family.

Conference Action Committee Resolution Number 16 was carried unanimously.

Mrs. Charles L. Cooper, Secretary of the Memoirs Committee, read her report. The Conference stood in tribute to the memory of departed Arizona Pilgrims.

The Sixth Annual Conference was concluded with prayer by the District Secretary and the singing of the chorus "In the Sweet By and By".

CONFERENCE REPORTS

Annual Report
of the District Superintendent
to the District Conference
in session July 13, 1961

To our esteemed Chairman, General Church Extension Secretary, Dr. R. C. Hawkins, fellow ministers, lay delegates to this Conference, and friends, Greetings:

Time has hastened us through another year. Perhaps only now and then did we realize the swiftness with which this year was passing. We have clutched some of life's opportunities but many escaped and are

forever gone. However, to stand gazing down the long road to yesterday is to let privilege of the ponderous present slip by unnoticed and unclaimed.

Thus we have met today not to hear reports only, but to plan, to arrange for the work we intend to do, under God. The year we plan for, we may not spend. Our day is growing short, as only the evening hours remain before the night. Carl F. H. Henry writes, "We are either at the end of the Western Civilization or at the Second Coming of Christ". Let us act here today with the urgency that this hour demands. Whatever the arduous task we have willingly spared ourselves from until now, we MUST NOT spare ourselves from longer. Whatever the sacrifices we have forestalled, we MUST now make. As I look at my life record, I am appalled. There is too little done, too little spent, too little ventured. I don't want the record of my service to Christ to close at this point. But I must write with a quick pen. I seek no gallery before which to play with garish glibness, when I declare to you, I am ready to go on, to war, to carry the battle into the very teeth of Satan, and if needs be die for this cause to which I am now committed to live.

Many things combine to make this a good year for our District. Some good salvation victories have occurred. An unusual Youth Convention here in Tucson, followed this summer by an outstanding Youth Camp have together made this a significantly spiritual year for our fine young people. Good Sunday School Conventions and a fine Ministerial Retreat have added to our inspiration. A number of good revivals were reported this year.

This has been a good year financially for us. Our total giving to General Church interests was \$4,255.34. Our United Stewardship Fund giving was up \$400 over a year ago. The District budgets were paid in good measure bringing us \$4,588.00 for operational expense. This is an all-time high, it appears. Six churches paid their budgets in full. It is indeed encouraging to see four of our new churches join the two older churches in paying their budgets entirely. Local church finances seem to be improving. Seven pastors received salary increases this year. This is a good trend for us.

I observed progress in local church organization at the annual meetings this spring. Our lay leaders are some of the finest I have seen in any area of the church. There is a basic strength and spiritual depth in our laity which has been evidenced more than once when the storm broke over us.

Two new churches have been opened this year. The Tucson, Rita Manor Church has been a bright spot all year. The church was organized with 16 charter members. They have formed into one of the finest young churches in the District. My visits to this church have been real delights for me. They have reached up into the 50's in Sunday School and are ready to start construction of a church building soon. The man behind all of this is Reverend Charles Cooper, who brings this church to us today to be received into the Conference.

The Phoenix Bethel Church has made so few birth cries that many folks have not realized her arrival. We have a promising beginning in

this new work. A group of about 20 has been formed. Reverend Wesley Reiff has been appointed pastor. We request your prayers for this new work. God will use Brother and Sister Reiff we believe. Rev. John Dunn and the Phoenix, Calvary Church Church deserve thanks for assisting in getting this new work under way. They have given the use of their Sunday School bus for the first three-month period of operation at Bethel.

The District Council has effected the contract of sale for the Cottonwood Church property and the Flagstaff Church property. Efforts to sell the improvements at the Camp ground have not met with success yet. We do have some contacts with whom we are negotiating. Perhaps through much prayer this problem could soon be solved for us and ease our financial strain. I still believe God answers prayers for us when we really pray.

When I look at the goals for the year past, and consider how far short we feel, I feel like a man, who though dressed in an astronaut's uniform had to satisfy himself by merely climbing up on a stepladder. He might have said, "I really expected more than this", and so did I! We are capable of better things. The membership figures will show that we are at the same point we were one year ago. The loss of members at Cottonwood and Flagstaff offset some good gains made elsewhere. In our District Sunday School attendance we had a substantial gain of about 5%, or 34. The Sunday School Board led by Reverend Mark Waddell promoted one of the most successful District Crusades I have ever witnessed.

I will not report the local church accomplishments since in the plans for Conference it was arranged for each pastor to give you a report.

The Conference Action Committee has done a superb job of preparing the legislation for this Conference. Their report will bring new proposals for budgets, district program, etc. I think their proposals will improve our work. I hope you will give serious thought to these matters.

In looking ahead I would suggest the following goals for next year.

1. A 10% membership gain in the District, to include 10% gains in each local church. In the smaller churches a minimum numerical gain of 2 members would apply.
2. A 10% District Sunday School gain, to include 10% gains in each local Sunday School with a minimum attendance goal of 25.
3. A united effort to foster the work of our auxiliary organizations, viz; Young People's Society, Missionary Society, and Men for Missions.
4. Evangelism in each local church community through lay visitation programs by our people.
5. Evangelism through new Sunday Schools in our rapidly expanding cities of Phoenix and Tucson.

6. Probationary and Junior Membership use for the conservation of our converts and our youth.

7. Payment of all budgets by the month and in full.

I feel these things will do much to help us net greater results in the coming year.

I have had the joy of working with some of the finest people in this church, again this year. I express my appreciation for every kindness you have shown me. Let's stand shoulder to shoulder, strengthening one another. The day cannot be much longer, may the Lord grant us wisdom to spend it well.

My personal report is:

Sermons and addresses-87; Communion Services conducted-14; Revival Meetings held-7; Church Board Meetings held-30; Annual Meetings conducted-12; Organizational Meetings held-1; Youth Council Meetings attended-2; Sunday School Board Meetings attended-1; Central Pilgrim College Committee Meetings-2; Central College Board Meetings attended-1. I have travelled over 30,000 miles, part of which was under appointment for the General Church. I have received my salary in full and \$341.00 in gifts and offerings.

REPORT OF THE
SUNDAY SCHOOL PROMOTIONAL SECRETARY
1960-1961

To our Chairman, Dr. R. C. Hawkins, Secretary of Church Extension; to all Ministers, Delegates, and friends of this Sixth Annual Conference of the Arizona District of the Pilgrim Holiness Church:

"GREETINGS IN THE PRECIOUS NAME OF JESUS"

It is with a sense of deep gratitude to our God for his guidance and help this past year that I bring this report. I feel that God has wonderfully helped us over the District in Sunday School work. I might say that it has been a real joy to work with Rev. Willard Metz and Rev. Arville Parker, who are the Advisory Members of the District Sunday School Board. Their wise counsel and advice have been greatly appreciated.

In spite of many hindrances, our Sunday Schools did register a numerical gain of 34 this past year. This figures to be a percentage gain of 4.7%. I realize that this gain is not as substantial as the 12% gain of last year. While it is easy to offer excuses when greater gains are not realized, I feel that this is a time to surge forward, and not a time for excuses. Frankly, I am glad and thankful that we are still on the gain side of the ledger instead of the loss side.

Several of our Sunday Schools reported excellent gains both numerically and percentage-wise. Phoenix First registered the highest numerical gain of any Sunday School in the District, which was a gain of 22. For the first time in the history of Phoenix First, the Sunday School has averaged over 150 per Sunday, with an average of 158. Phoenix, Mountain View, which has only been in operation since September of 1959, registered the highest percentage gain, with a 44.7% gain. Their numerical gain was 17. These two Sunday Schools will receive the Conference Awards for the highest numerical and percentage gains.

Other Sunday Schools which did exceptionally well, all showing at least a 25% gain are:

Prescott	- Numerical Gain 16; Percentage Gain 40.0%
Tempe	- Numerical Gain 13; Percentage Gain 35.1%
Tucson, Trinity	- Numerical Gain 10; Percentage Gain 25.0%

These three Sunday Schools, along with Mountain View will receive the 25% GAIN Conference Honor Award Ribbons. As Sunday School Promotional Secretary, I feel these Sunday Schools are to be commended.

The new church in South Tucson, the Rita Manor Pilgrim Church, registered an excellent average of 32 for the ten months of its operation.

In thinking back over the past, I feel that the highlights of the year in Sunday School promotion were the Sunday School Conventions, conducted last October, and the Spring Sunday School Crusade Contest.

Two conventions were conducted last fall; one in the Tucson Trinity Church, and one in the Tempe Church. There have been several favorable comments relative to the fine type of convention conducted. Every phase of the convention, from the panel discussions to the Standard of Excellence exams was designed to get right to the root of Sunday School problems, and as much as possible, offer solutions. I trust that much good was accomplished.

For the seven Sundays between Easter Sunday and Mother's Day, the District Sunday School Board planned a District-wide Sunday School Contest. Rather than basing the winning Sunday School on the largest Sunday School attendance for the seven Sundays, the points were figured on a handicap basis. This made the contest fair and equitable for both the large Sunday School and the small one as well. There was much enthusiasm during the contest. Weekly reports were sent out. Also, a lovely banner was presented each week to the weekly Champion, who was entitled to keep the banner until it was taken by another Sunday School. The Sunday School with the most total points at the end of the contest had the privilege of permanently keeping the banner. Phoenix First took the banner five out of seven Sundays, and Tucson First won the banner the other two Sundays. Presently, the banner is gracing the sanctuary of Phoenix First Church.

Inasmuch as the general Sunday School Department of our Church has launched the Decade of Progress promotion, which is designed to help bring about a constant growth in our Sunday Schools for the next ten years, all of our Sunday Schools were urged to cooperate in this church-wide endeavor. I regret that more Sunday Schools did not fill out the Decade of Progress report blank. However, from the reports received, Phoenix First had the most Decade of Progress points, with a total of a little over 18,000. The beautiful trophy, THE PILGRIM SHIP, will be awarded to Phoenix First.

On Easter Sunday, the Sunday Schools of this District registered the highest attendance on any given Sunday, with a total attendance of 1,069. This shatters the old record of 1,020, which was established on Easter Sunday, 1960. We all praise God for this.

Inasmuch as I will not be serving as Sunday School Promotional Secretary for the coming year, I would like to state that it has been a real joy to work in this capacity for the past two years. I appreciate the fine cooperation of every pastor and Sunday School Superintendent. I firmly believe that this next year can be a year of great gains for the GLORY OF GOD. If each Sunday School would merely gain an average of six per Sunday, we would register a fine gain of over 10%. IT CAN BE DONE! GOD HELPING US, WE WILL DO IT!

4. INASMUCH AS there are great difficulties involved in having summer camp meetings in the populous areas of Phoenix and Tucson, and

INASMUCH AS the majority of the members of our churches live in these areas,

THEREFORE BE IT RESOLVED that we plan a mid-winter indoor camp in the early months of each calendar year, to be alternated between the cities of Phoenix and Tucson, and that this indoor camp replace the summer adult camp meeting.

BE IT FURTHER RESOLVED that our summer camp meeting activity be reserved for enlarged district youth camp development, and that no additional camp programs be planned by our churches without approval of the District Council. (Carried)

5. WHEREAS the district operations will require \$6,200.00, the United Stewardship Fund assessment will be \$1,860.00, and Central Pilgrim College budget will be \$828.00.

THEREFORE BE IT RESOLVED that each church pay monthly to the District Treasurer 15% of all regular church offerings and regular Sunday School offerings, and that the 15% will not apply to monies raised for the Building Fund, Land Fund or any special offerings raised for a department supported by these budgets. No other exceptions are to be made. The

15% will constitute the total budgetary assessment to the church.

BE IT FURTHER RESOLVED that this budget be known as the District United Stewardship Fund. (Carried as amended)

6. No action taken.

7. BE IT RESOLVED that the following words be added to Resolution Number 3, page 22, of the 1960 Conference Journal: "...and that the driver be paid an additional one cent per mile for each council member brought in his car". (Carried).

8. BE IT RESOLVED that all ordained or licensed ministers released for Gospel work outside of the denomination be required to pay 50% of their tithe on income for both ministerial and secular labors directly to the District Treasurer. These payments cannot be applied to local church budgets where membership is held. (Carried as amended).

1. INASMUCH AS the Polity Committee of the General Conference of the Pilgrim Holiness Church represents an overlapping of thought with the General Board, and both bodies exercise strong control over actions of the General Conference, and;

INASMUCH AS most major denominations operating under a polity similar to ours have a more democratic approach to the initial handling of general conference legislation;

BE IT THEREFORE RESOLVED, that the Polity Committee be reconstituted and a more democratic process be established.

BE IT FURTHER RESOLVED, that this General Conference establish a system of committees as follows:

1. Government
2. Finance
3. Social Action
4. Doctrine-Ritual
5. Ministerial
6. Education
7. Publishing-Archives

The General Secretary shall receive copies of all memorials presented by the Annual Conferences for General Conference Legislation, and shall classify such memorials for distribution to said committees.

BE IT FURTHER RESOLVED, that the composition of these committees be as follows:

1. Committees 1, 2, 4, 5 and 6, shall be composed as follows:
 - a. One member for each 1,000 members or major fraction thereof for each district, with no district having less than one representative.
2. These committees shall be elected from the General Conference delegates by the Annual Conference preceeding General Conference.
3. No person shall serve on more than one committee.
4. These committees shall meet during mornings of General Conference from 9:00 to 11:30 with business accomplished being brought to the floor during afternoon and evening sessions, their reporting to be in the order of precedence in initial listing.
5. The committees shall organize within themselves, electing a Chairman, Vice-Chairman, and Secretary, with the Secretary serving as reporter to the Conference sessions.
6. Committees 3 and 7 shall be made up of one member from each district with 1,000 members or more, having been elected from the district delegation to the General Conference by the Annual Conference preceeding General Conference. (Carried)

2. Motion carried to adopt the Ministerial Classification Directory exactly as it appears under Resolution Number 12 of the Report of the Conference Action Committee.

3. INASMUCH AS many areas of our Nation are unreached by the Wesleyan message,

THEREFORE BE IT RESOLVED, that this General Conference renew

negotiations for merger with the Wesleyan Methodist Church of North America, feeling that in this union would be a facilitation of efforts of both denominations in spreading the message of scriptural holiness. (Carried)

5. INASMUCH AS the Protestant word is becoming more and more divided into two camps, and

INASMUCH AS the National Association of Evangelicals encourages leadership necessary for the united voice of millions of Evangelical Bible believing Christians, and

WHEREAS it has for years represented Evangelism through Congress and before foreign Embassies defending the Bible truths,

THEREFORE BE IT RESOLVED, that we as a church shall by majority vote of this General Conference affiliate ourselves with the National Association of Evangelicals. (Carried)

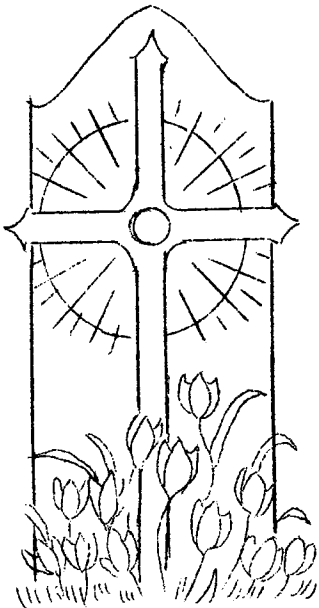

STANDING RESOLUTIONS

of

PREVIOUS CONFERENCES

Local Church

1. The local churches shall provide modern cooling, cooking and heating facilities for the parsonage, the type of facilities to be suitable to the locality where the parsonage is situated, and all churches in the conference shall pay the utilities for the parsonages.
2. Each local church is urged to raise a subscription list to the Pilgrim Holiness Advocate equal to its total membership.
3. The local church is to pay the traveling expense and entertainment of their pastor and delegate for the Conference business sessions. This does not include camp meeting.
4. Each local church shall have a Public Relations Chairman, who will submit copy of local news events to district publications and local newspapers.
5. BE IT RESOLVED that all local indebtedness involving an expenditure of more than \$500, where financing is involved, be approved by the district council. (1960)
6. BE IT RESOLVED that all non-Pilgrim Evangelists must first have the approval of the District Superintendent or the District Council before being called for evangelistic activity in our churches. (1960)

Conference

1. The conference year of the Arizona District shall begin June 1 and end May 31 the following year, and that all reports be sent to the District Statistician by June 15.

2. The district council and the following committees and boards shall meet one day prior to the Annual Conference to take care of such work as they have at hand. Conference Action Committee and the Educational and Examining Board.
3. In order that the relatives and friends may know the set time for the ordaining of ministers, BE IT RESOLVED, that the Ordination Service take place at 4:00 p.m. the first day of Conference. (1957)
4. The Educational and Examining Boards shall be combined and this Board shall consist of three members, one being elected for a period of three years, one for a period of two years and one for one year.
5. There shall be a memoirs committee which shall annually list departed members by name, date of decease, and church, for inclusion in the Conference Journal. In the case of ministers there shall be a picture and a brief resume of ministerial labors.
6. BE IT RESOLVED that the district furnish credential forms to each local church conference delegate and alternate to be filled out and signed by the pastor and the church secretary, and sent to the district secretary at least 30 days prior to Conference. (1959)
7. BE IT RESOLVED that the District Trustees and the Statistician be made permanent members of the District Conference.
8. INASMUCH as there is such close correlation between the work of the Resolutions Committee and the Ways and Means Committee: THEREFORE BE IT RESOLVED that there be the appointment of a Conference Action Committee of 5 members, which would combine the functions and capacities of the Resolutions and the Ways and Means Committees. (1960)
9. BE IT RESOLVED that there be the appointment of a Building Appraisal Committee: (competent in the field of appraisal) the function of which shall be to set the value of all church property. (1960)

District Superintendent

1. BE IT RESOLVED that the District pay \$150.00 per month on salary of the District Superintendent; BE IT FURTHER RESOLVED, that the District Superintendent be remunerated for meals and lodging incidental to travel. (Revised 1961)

Ministerial

1. Before licensed or ordained ministers coming from other churches shall be received into the local church, the pastor shall consult with the District Superintendent and Council regarding said minister.
2. Each pastor is to be granted a two weeks vacation with full salary.
3. INASMUCH as several of our districts have a group hospitalization, surgical, and medical insurance plan, and since a number of the district pastors have expressed a desire for such a plan, BE IT THEREFORE

RESOLVED that we accept the Blue Cross, Blue Shield group hospitalization, surgical, and medical plan. AND BE IT FURTHER RESOLVED that the churches pay \$5.00 per month to be applied to the pastor's premium, and the district pay \$5.00 per month to be applied to the District Superintendent's premium. This resolution is recommended first for discussion by the committee with the added recommendation that the lay delegation be given the privilege of discussion. (1959)

4. BE IT RESOLVED that when ministers come to this district from other denominations, that the Executive Officer of the transferring minister be contacted by the District Superintendent asking for a recommendation, to be in the hands of the District Council at least 30 days prior to moving date. AND BE IT FURTHER RESOLVED that the transferring minister be interviewed by the District Council prior to reception of his credentials. (1959)

District Council

1. BE IT RESOLVED that laymen may serve on the District Council. (1959)

Budget

1. BE IT RESOLVED that all monies raised in local churches for district, general or Bible College purposes be disbursed through the District Treasurer, and only such monies as are processed accordingly may be credited to the local churches on the District Treasurer's report. (1960)

Missionary Organizations

1. INASMUCH AS there is a need for greater missionary activity among our people, THEREFORE BE IT RESOLVED that there be an organization within our district for the promotion of Missions among the men.

ARIZONA MEN FOR MISSIONS CONSTITUTION

ARTICLE I. NAME - There shall be an organization within the District known as the Arizona Men for Missions.

ARTICLE II. PURPOSE - The purpose of the organization shall be:
(1) to promote missionary enterprises within the District;
(2) to encourage Christian service among our men;
(3) to develop district-wide fellowship for the men.

ARTICLE III. OFFICERS - The officers of the organization shall be: Governor, Lieut. Governor, Secretary-Treasurer, and two State Representatives. These officers shall constitute the District Cabinet.

ARTICLE IV. MEMBERSHIP - Membership shall be classified as follows:
Honorary - those men who hold ministerial credentials within the District;
Regular - men who are full members of a local Pilgrim Church in Arizona, not ministers;

Affiliate - men who by reason of interest, desire to participate, but are not members of the church.

ARTICLE V. ELECTIONS - ANNUALLY A MEETING SHALL BE HELD TO ELECT THE OFFICERS. The electing body shall be constituted of the officers of the previous year, and one delegate from each local chapter for each 10 members or major fraction thereof. Each local chapter shall be allowed at least one delegate. The Governor shall be elected from two or more nominees named by the District Council. All officers shall be from the regular members. Only Honorary and Regular members shall vote in elections. No more than one man from any one local church may serve on the District Cabinet. Elections shall be by majority vote. Elections are for one year or until successors are elected and qualified. The District Superintendent or his representative shall preside at elections.

ARTICLE VI. OFFICER'S DUTIES - Governor- to direct the affairs of the organization. Lieut. Governor- to assist the Governor and to succeed the Governor should he fail to serve his term of office. Secretary-Treasurer- to keep records of meetings and finances. State Representatives- to serve as members of the District Cabinet.

ARTICLE VII. MEETINGS - District Meetings may be held when the officers deem it advisable, but such plans are subject to district council approval. Meetings shall be announced at least two weeks in advance to all churches through the pastors.

ARTICLE VIII. SUPERVISION - All activities shall be subject to the approval of the District Council. Likewise all projects shall have such council approval.

ARTICLE IX. AMENDMENTS - These Articles may be amended only by the District Conference in session, and by majority vote.

ARTICLE X. BY-LAWS - By-Laws may be provided to guide the organization. These shall be adopted or amended by a two-thirds vote of the members present at a regularly called meeting. All such By-Laws shall be in harmony with these Articles and the Church Manual.

ARTICLE XI. LOCAL CHAPTERS - There shall be local chapters organized, as contingencies of the district organization. The local chapter shall be subject to the local Church Board.

ARTICLE XII. LOCAL OFFICERS - Wherever local chapters are organized, a chapter committee shall be formed. Three officers shall be elected: a Chairman (from two or more nominees presented by the local Church Board); Vice-chairman, and Secretary-Treasurer. Only men who are full members of the Pilgrim Church and classified as regular members of the organization shall be eligible to hold office within the local chapters. All members- Honorary, Regular and Affiliate shall be given the right to vote in the chapter meetings. (1960)

2. INASMUCH AS we have no Constitution Articles set up for the District Women's Missionary Society, THEREFORE BE IT RESOLVED, that such an organization be initiated and the following Constitution be adopted:

WOMEN'S MISSIONARY SOCIETY OF ARIZONA
CONSTITUTION

- ARTICLE I. NAME - There shall be an organization within the District known as the WOMEN'S MISSIONARY SOCIETY OF ARIZONA.
- ARTICLE II. PURPOSE - The purpose of the organization shall be to foster and coordinate the work of the local church societies within our churches.
- ARTICLE III. OFFICERS -The officers of the organization shall be: The District President, who shall direct the functions; District Vice-president, who shall assist the president and should necessity demand it, succeed to that office through the course of the year; Secretary-Treasurer, who shall keep records and finances for the organization; and two Members at Large. These five persons shall constitute the MISSIONARY SOCIETY BOARD and shall direct executive affairs.
- ARTICLE IV. MEMBERSHIP - Membership in the organization shall be defined in the Constitution for the local church society, Manual, Section 88 Paragraph 7.
- ARTICLE V. MEETINGS -District Meetings may be held at such times as deemed advisable by the Missionary Society Board. However, all meetings shall have the approval of the District Council or the District Superintendent.
- ARTICLE VI. ELECTIONS - Annually the organization shall meet to elect its officers. The District President shall be elected from two or more nominees provided by the District Council. Other officers shall be elected from among the active members. The electing body shall be constituted of the officers of the previous year, and one delegate from each society for each 10 members, or major fraction thereof. Each church shall be allowed at least one delegate. The officers shall be elected for the term of one year, and shall serve until their successors are elected and qualified. The District Superintendent or his representative shall preside at the meeting of election. Election shall be by majority vote.
- ARTICLE VII. SUPERVISION - All activities and projects shall be subject to the approval of the District Council.

ARTICLE VIII. FINANCES - The organization shall not levy assessments upon the local churches or the societies. It may, however, ask for offerings from the local societies.

ARTICLE IX. BY-LAWS - By-Laws may be provided to further guide the work of the organization, and may be adopted or amended by a two-thirds vote of the members present at the Annual Business meeting. These By-Laws must be in keeping with these Articles and the Church Manual.

ARTICLE X. AMENDMENTS - These Articles may be amended only by the District Conference by a majority vote. (1960)

Camp

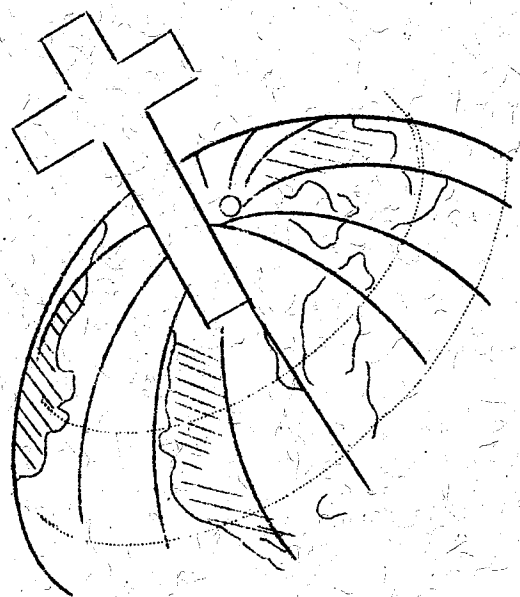
WHEREAS it appears that the cost of owning and maintaining a camp ground is prohibitive;

1. Satisfy the claims of cabin owners;

ANNUAL DISTRICT WOMEN'S MISSIONARY SOCIETY MEETING

Motion carried that each church be notified by the Secretary concerning an offering for traveling expense and that the time for raising this offering be decided by the Executive Board.

Motion carried that the Executive Board choose two other members and that these seven officers form a committee which will formulate the business to be presented to next year's Annual Business Meeting.

YOUTH PRESIDENT'S REPORT

Mr. Chairman, Pastors, Delegates and Friends-- It is with praise and thanksgiving to God that this report is brought to you today. In looking to the many blessings of the past year, we can only say, "Hitherto, hath the Lord helped us."

Honor is due our District Superintendent, the Reverend O. D. Emery for wise counsel. The District Youth Council has given advice and splendid cooperation. A special mention is in order for the ministers who contributed heavily of their talents and energies to the Youth Convention and Camp. We would not overlook the teachers, counselors and staff of the Youth Camp program.

Two major events highlighted the year for the Youth of our District. Namely, the Mid-winter Convention in January at the Tucson, First Church and the Youth Camp in the Catalina Mountains. The manifestations of God were great in both of these efforts. Near 130 young people sought God for spiritual help. Reports have come from many of the churches that both the Convention and Camp have complimented the local church's efforts in Evangelism. We pray this will be a continued by-product of all youth activity. The attendance at

the Youth Convention is conservatively estimated at 100 to 125. There were 79 enrolled for the week of Youth Camp.

We are gathered together today in a history making event. We have been given the opportunity and also responsibility to organize the first District Youth Conference in any Church Extension District. The decisions we make today will determine our course for the to-morrows. May God give us direction.

Among other things, this Conference needs to consider:

1. Ways and Means whereby the District Youth Program will continue to be a compliment to our District and the churches.
2. A system of reporting the activity of the local society to the District Youth officers.
3. A financial program to underwrite the District Youth operational expenses.

The Zone Officers should bear in mind the direction of the District Conference in asking for at least six Zone Rallies throughout the year.

It would be well for the Local societies to:

1. Appraise the development of the local youth work.
2. Strive for organization when possible.
3. Provide a Christ-centered program of activity throughout the year.
4. Aid in the development of a strong local church.
5. Cooperate in all Zone and District Youth endeavors.

Some time ago, Doctor Paul Rees suggested at one of our National Youth Conventions, three views of life-- namely: "The Gutter View, the Gallery View, the Gallilean View". In equating these three views toward life with the various views that can be taken toward the Youth Work, the Gutter View would of necessity be a warped and distorted view. The Gallery View would be those who are satisfied to sit by, contribute nothing, but yet desiring to share in the benefits. The Gallilean View would be the attitude of Christ in preparing youth for an eternity with hope.

The challenge is to us and our generation. Will we be among those who are content to let the youth march toward eternity without the claims of Christ pressed upon them--without providing wholesome activity for them? Five - ten - fifteen years from now will give an indication of how we faced the challenge today. Pray God to help us.

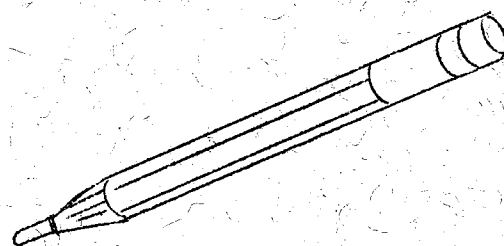
