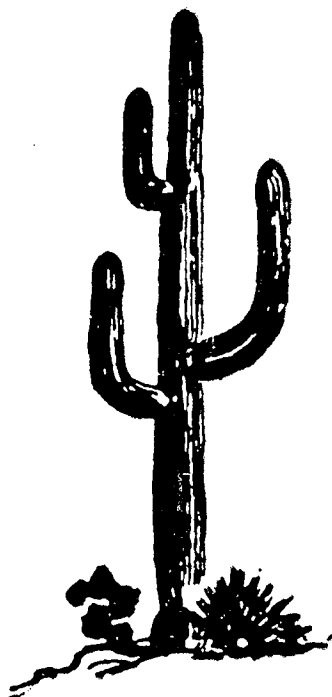

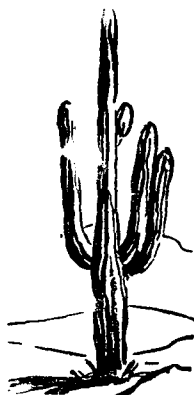

CONFERENCE AND LOCAL CHURCH GOALS

1. Increased fervor for genuine Holy Ghost revival throughout the district.
2. Special revival efforts in new parts of the population centers of Phoenix and Tucson, in an effort to open new Sunday Schools and preaching points.
3. Progress toward full self-government and self-support of the district.
4. Increase in church membership to a total of 450 by next conference. (Represents gain of 101)
5. Increase in Sunday School average attendance to a total of 900 by the last quarter of next year. (Gain of 189)

In the interest of spiritual advances on the local church level, I suggest the following items as a standard for each local church in our district:

1. At least two revival efforts this year.
2. Promotion of a tithing program in each church, to teach our people the Scriptural method of supporting God's work.
3. Use of Preparatory and Junior membership with instruction classes in doctrine.
4. A lay visitation program.
5. A 25% increase in Sunday School attendance.
6. A 20% increase in Church membership.

CONFERENCE PROCEEDINGS

FIRST SITTING

The fifth annual conference of the Arizona District of the Pilgrim Holiness Church was convened July 14, 1960, 9:00 a.m. at the Phoenix, First Church.

The session was called to order by District Superintendent O. D. Emery. He asked Rev. M. E. Waddell to lead the congregation in an opening song. The assembled group feelingly sang, "My Jesus I Love Thee." Rev. H. Grier Baker, new pastor of the Tucson, Parkview Church led in prayer.

District Superintendent Emery introduced Dr. R. C. Hawkins, Secretary of Church Extension, who spoke words of greeting and introduced the presiding officer and General Superintendent of the Western Area, Dr. R. G. Flexon.

General Superintendent Flexon read a scripture lesson from I Corinthians Chapter 9. He used as his text verse 26, "I therefore so run, not as uncertainly; so fight I, not as one that beateth the air." His subject, "A Planned Ministry," highlighted the idea of a compulsion to preach the Gospel. To have an affect on this generation the minister of the Gospel must work with fervency and disciplined action. A planned ministry will never go to seed or fail to emphasize essentials. This type of ministry will have a subject as well as an object.

The roll of ministerial and lay delegates was called. By common consent Mrs. Marvin Fridenmaker was seated as the Phoenix, First delegate.

It was moved, seconded and carried that the platform and the first six rows of seats serve as the conference bar.

The time of the conference sessions were set by motion as follows: the present session is to close at 11:45; afternoon session 2:00 p.m. to 5:00 p.m. and the evening session at 7:00 p.m.

At the call of the chairman, District Superintendent Emery presented the new church at Phoenix, Mountain View with Walter Cook, its pastor and Mrs. Edward Johnson, delegate and the church at Tempe, with Mrs. Eva Massie the delegate. A motion carried to accept these churches.

Ministerial transfers were called forward and presented to the Presiding Officer and the Secretary of Church Extension (with the exception of H. W. Johnston) as follows: Ordained, H. Grier Baker, John Dunn, and C. J. Meyers; Licensed, Willard Metz, Nellie Linder, H. W. Johnston; Ordained Deaconess, Mrs. C. J. Meyers. These people were received into the conference by motion. A few moments later Mrs. H. Grier Baker, an ordained deaconess, was also introduced and received by motion.

The Educational and Examining Board indicated it was still interviewing licentiates. At the call of the Chair for the list of inactive ministers the District Council requested a ruling on certain applications of this part of the Manual.

Manual requiring the payment of the United Stewardship Fund as a qualification for pastor and delegate to participate in the conference was cited. A motion carried to seat all delegates this year with the advice that the list of churches will be carefully screened next year. Attention of the conference was called to the fact that exceptions are granted only on the basis of proven extenuating circumstances.

Reverend O. D. Emery read his report as District Superintendent. After words of commendation from the General Superintendent the report was accepted with deep appreciation for our district leader and his outstanding work.

Denzel Clouse read the Auditor's report and it was received by motion carried.

Reverend M. E. Turner's District Treasurer's Report was received by motion with appreciation for his abundant labors. A financial statement of the Arizona District was also received by motion carried as was a report of District Budget and 50% of the Pastor's Tithe.

Reverend M. E. Waddell gave his report as Promotional Secretary of Sunday Schools showing a district gain of 12%. Awards were presented

for outstanding numerical and percentage gains to the appropriate pastors and delegates of the churches as listed in the report. This report was also received by a standing vote.

The report of the President of the District Youth Society was deferred. Mrs. Denzel Clouse, president of the District Missionary Organization gave her annual resume of society efforts which was received by motion.

A motion carried to set aside the order of the day calling for an ordination service at 4:00 p.m. and set the time for this service for 7:00 p.m.

The General Superintendent spoke on the effort to improve the quality of ministerial orders.

A motion to recess carried.

Rev. M. E. Waddell dismissed with prayer.

SECOND SITTING

The second sitting of the 1960 conference was opened with Rev. M. E. Waddell leading in the song, "Amazing Grace," and Mrs. Willard Metz presiding at the piano. Prayer was offered by Reverend W. E. Cook.

The Reception Committee presented Rev. and Mrs. Neal Bonner to the presiding officer who introduced them to the conference. The Bonners testified and by motion carried were extended the courtesy of the bar. Rev. Bonner is the newly elected President of Central Pilgrim College, Bartlesville, Oklahoma.

A motion to dispense with the roll call prevailed.

The minutes of the first sitting were approved as read.

Rev. John Dunn, President of the Youth Society gave his report. It was accepted by motion carried.

Oral reports were presented by the following pastors: Flagstaff, Rev. Robert Seelig; Phoenix, Calvary, Rev. John Dunn; Phoenix, First, Rev. M. E. Waddell; Apache Junction, Rev. H. E. Underwood; Phoenix, Mountainview, Rev. W. E. Cook; Prescott, Rev. M. E. Turner; Tucson, First, Rev. Harold R. Crosser; Tucson, Parkview, Rev. H. Grier Baker; Yuma, Rev. C. L. Cooper; Cottonwood, Rev. Paul Eversole, by correspondence and read by the secretary. A motion carried to receive these reports.

The Memoirs Committee reported through Mrs. M. E. Turner and the report was accepted by motion.

Reverend M. E. Waddell read the report of the Resolutions Committee in toto.

Resolution Number 1 was adopted by motion.

Resolution Number 2 was carried as amended.

Resolution Number 3 was moved, seconded, and carried after slight editing.

Resolution Number 4 setting up an Arizona Men for Missions Organization carried. A motion also carried to accept the constitution with amendments as offered by the District Council. It was moved, seconded, and carried to change the word "laymen" to "men" in Article II in the aforesaid constitution.

Resolution Number 5 as amended setting up a district women's missionary group and providing a constitution was adopted.

Resolution Number 6 carried as amended.

It was moved, seconded, and carried to table Resolution Number 7.

Resolution Number 8 to initiate an inactive list of ministers carried.

By motion carried Resolution Number 9 was adopted.

Resolution Number 10 accepting the goals as presented by Superintendent Emery in his report as the official goals of the conference carried.

The Ways and Means Committee reported through its secretary, Rev. C. L. Cooper.

It was moved, seconded and carried to adopt the proposed expenditures on the district level.

It was decided by motion to postpone action on Ways and Means Number 1 until after the ordination service and that the Ways and Means Committee yield to the Educational and Examining Board.

A partial report of the Educational and Examining Board was given and the report was accepted by motion.

A motion to adjourn carried. Reverend R. C. Hawkins dismissed with prayer.

THE ORDINATION SERVICE

The ordination service convened with Reverend M. E. Waddell leading the song, "Rock of Ages." Mrs. Waddell served as organist. "A Charge to Keep I have" was also sung. Prayer was offered by Rev. O. D. Emery.

Appropriate scriptures were read by Dr. R. C. Hawkins, Reverend O. D. Emery and Reverend Harold R. Crosser.

General Superintendent, R. G. Flexon then delivered a pointed and practical charge to Williard W. Metz to be ordained a minister, Nellie Linder to be ordained a deaconess and Arville Parker, first ordination. After the laying on of hands by the ordination council and congratulatory greetings, the Waddells sang, "I Gave My Life for Thee". A season of prayer and testimony around the altar closed with a benediction by Dr. R. C. Hawkins.

THIRD SITTING

The third sitting was called to order by Dr. R. G. Flexon. The Minutes were approved as read.

Reverend C. L. Cooper read Ways and Means Number 1. After considerable discussion it was lost.

Ways and Means Number 2 carried.

Ways and Means Number 3 was moved, seconded, and carried.

Ways and Means Number 4 was referred to committee for redrafting.

Ways and Means Number 5 was adopted by motion carried.

Ways and Means Number 6 providing a budget for Central Pilgrim College was adopted.

Ways and Means Number 7 was ruled out of order by the Chairman.

Ways and Means Numbers 8 and 9 were adopted by motion carried.

District Superintendent Emery appointed the following tellers: John Dunn, M. E. Turner, Arville Parker, H. Grier Baker.

The reappointment of the Executive officers was announced.

Ballots were prepared for two advisory members to the District Council. The second ballot produced the election of Elwood Hunter and Reverend C. L. Cooper.

Ballots were cast for three members of the Educational and Examining Board. Reverend John Dunn was elected for a 3 year term, Reverend H. Grier Baker two year term and Reverend H. E. Underwood for a one-year term from nominees provided by the District Council.

The third ballot cast for District Trustee produced the election of Charles Long.

After words of admonition and guidance from Dr. R. C. Hawkins, Secretary of Church Extension, the meeting was adjourned by motion. Reverend O. D. Emery pronounced the benediction.

FOURTH SITTING

The fourth sitting convened with the song, "Leaning on the Everlasting Arms." Prayer was offered by Reverend Neal Bonner, president of Central Pilgrim College, after which General Superintendent Flexon spoke on Psalm 4 emphasizing the verse "But know that the Lord hath set apart him that is godly for himself." There were admonitions to have a Junior Church, convert's class, and probationary membership.

The Ways and Means Committee reported through its secretary, Reverend C. L. Cooper. The Committee indicated that Ways and Means No. 1, Page 16, 1959 Conference Journal would apply to the new conference year.

Ways and Means Number 4 which had been returned to the Committee for revision was read as revised.

By motion carried Ways and Means Number 4 was tabled until other matters could be cared for.

The special camp meeting report was called for and was read by the District Superintendent. After considerable discussion regarding the camp meeting a motion carried to refer the matter to the District Council and ask them to bring a recommendation to the Conference at the afternoon session.

A motion carried to bring Ways and Means Number 4 back to the con-

ference for consideration.

It was moved, seconded, and carried to refer Number 4 back to the committee for reconsideration.

A motion carried to recess until the call of the chair.

The sitting reconvened by singing, "Near the Cross."

The recommendation of the District Council concerning the camp ground (as follows) was read and approved by motion carried.

Whereas it appears that the cost of owning and maintaining a camp ground is prohibitive;

And Whereas other facilities are available;

Be it Resolved that the conference instruct the Council to take steps to dispose of the real property on the camp ground and that the proceeds be applied as follows:

1. Satisfy the claims of cabin owners.
2. Camp ground indebtedness.
3. Balance if any to be put in a camp fund.

And be it Further Resolved that we rent a camp ground next summer.

Ways and Means Number 4 was again presented to the conference and adopted by motion.

The Resolutions Committee presented Number 11 which carried.

Resolutions Number 12 and Number 13 were carried by a motion, with the conference standing to show appreciation for Dr. R. G. Flexon and Dr. R. C. Hawkins.

Resolution Number 14 was passed in appreciation of the Superintendent with a "God Bless you."

A motion carried that the minutes of this and the previous session be cared for by the District Council.

By motion carried the conference expressed its appreciation of the District Council.

A motion to adjourn carried. Doctor R. C. Hawkins dismissed with prayer.

CONFERENCE REPORTS

District Superintendent's Report

To our General Superintendent, R. G. Flexon, Church Extension Secretary, R. C. Hawkins, and delegates of the Fifth Annual Conference of the Arizona District of the Pilgrim Holiness Church, greetings;

Grace be unto you, and peace from Him which is, and which was, and which is to come.

Four years ago next Sunday, here in this auditorium of the Phoenix First Church, the Arizona District had it's beginning. Many wonderful and many exasperating developments have come since that day, yet notwithstanding these things, evidences abound that God has His hand upon this new thing. Frail, blundering mortals we be who might well destroy the very work we attempt to build, were it not for the overruling mercy of God who preserves His Church.

I have served for nine months in my capacity here, and have no illusions as to the difficulties of the task, the demands of the field, the delights of the service, or the dependability of my Lord Jesus. I am happy in the service of the King. Church Extension work has the unique quality of being one of those parts of the Kingdom where the attack is on. Our strategy is always the offensive. We must never allow our efforts to become merely those of self-containment. This will deprive us of our purpose in the church. I frequently relate to candidates for service in Church Extension, General Booth's admonition to applicants for Salvation Army service, as he said, "We have little to offer you but war. If you want war for Jesus' sake, we have all anyone could ask." I seek to speak to our hearts and say, this is war! We must face the demands of war. We must expect the casualties of war and not allow our heads to be turned or our hearts to faint when some go not on to the battle.

This work calls for a special breed of men. Their difference from others is not spiritual necessarily, but rather a difference in the philosophy of their work. This work involves constant emergency, and offers little platitude. Such words as security or complacency are not in our orders. Our orders are charge, advance and lift high the banners of Christ on the ruins of Hell's strongholds. Men who engage in this work remind me of those who follow war with it's danger of fire and blood over this earth. Just so these have battle instincts and yens for the advance of Christ's Kingdom into Satan's territory. Not every man is cut out for this work, but some find their success in another part of the Kingdom. Yes, Church Extension is war, and if you enjoy war you have found your place. As I speak to you today Satan's forces are designing our intended defeat, but I declare in the face of all Satanic forces, we have not begun to fight

as we shall fight!! And I call to you men of valor to rise up and match the enemy's stroke with equal strokes for God. We must not go one mile while Satan goes two. We must not sow less wheat than he sows tares. We must not dare less than he dares, but we must match his might in the Name of Jesus! This is war whether your church is large or small; whether your salary is large or small; this is war for this is Church Extension, and it won't be compared to other kinds of labor for the Lord Jesus. As best I understand it after several years of association, this is the philosophy of Church Extension work. I'm glad to have a part in it!

Our work this year has been largely that of making adjustments on both the district and the local church level. So far as I can know, the figures you will hear in the reports given in this conference, in either statistics or finances are real, unembellished facts. Whatever has been accomplished must be attributed to Christ who said, "Without me ye can do nothing". We rejoice to report a numerical gain of 77 in average Sunday School attendance and a numerical gain of 37 in membership. Both these gains represent 12 percent increases in those departments. Since each pastor will report personally to the conference I think it unnecessary for me to refer to the attainments of the local churches. Something is in order to say about the lovely church which the Phoenix Mt. View congregation has completed this year. Much of the labor was done by the pastor, Walter Cook and his good laymen. We organized this church with 15 charter members early in the spring. Another organizational meeting was held at Tempe in May and the church was organized with 20 members. The pastor, Duane Watkins has done a very fine work of gathering together these people.

We regret the disappointment our people have felt over the campground loss of use for this year. The conference will be given a report on the camp-ground matter later. Also we regret that we have had to close the Flagstaff work lately. Our problem there stemmed from the heavy indebtedness, for so few people. If any other course of action had been opened, certainly we would have gone another way.

The treasurer's report shows the district budget paid at the rate of 58%. This is too low and must be handled differently next year. The pastor's tithe payments have come in at the rate of 80%. On our United Stewardship Fund payments we have given 68% of the total due. Giving in other denominational interests increased proportionately. We must not forget that payment of budgets and giving of denominational offerings is one means of building and expressing loyalty to the total church program. We must build this loyalty into our churches in a new district like this.

I humbly offer the following program for next year to this conference and ask you to accept the challenge it represents.

1. Increased fervor for genuine Holy Ghost revival throughout the district.
2. Special revival efforts in new parts of the population centers of Phoenix and Tucson, in an effort to open new Sunday Schools and preaching points.
3. Progress toward full self-government and self-support of the district.
4. Increase in church membership to a total of 450 by next conference. (Represents gain of 101)
5. Increase in Sunday School average attendance to a total of 900 by the last quarter of next year. (Gain of 189)

In the interest of spiritual advances on the local church level, I suggest the following items as a standard for each local church in our district;

1. At least two revival efforts this year.
2. Promotion of a tithing program in each church, to teach our people the Scriptural method of supporting God's work.
3. Use of Preparatory and Junior membership with instruction classes in doctrine.
4. A lay visitation program.
5. A 25% increase in Sunday School attendance.

But trusting His grace let us strive to do a work for God this year which is so outstanding that it cannot be explained in terms of mere human endeavor, but will of necessity be attributed to the power of God!

My personal report is; Sermons and addresses—91, Church Board Meetings—21, Annual Meetings—12, Organizational Meetings—2, Revival Meetings—3, District Council Meetings—6, Youth Council Meetings—2, Pastoral Installations—3, Western Pilgrim College Board Meetings—2, Central Pilgrim College Board Meetings—1, Central Pilgrim College Executive Committee Meetings—2, The District Superintendent's Meeting—1. I have travelled 28,763 miles. I have received my salary in full. Total Gifts and Offerings—\$750.

We leave all in His hands and pray that these labors be fruitful.

Sunday School Promotional Secretary's Report

To our Chairman, Dr. R. G. Flexon, General Superintendent; to Dr. R. C. Hawkins, Secretary of Church Extension; to the Ministers, Delegates, and Friends of this 5th annual Conference of the Arizona District of the Pilgrim Holiness Church: GREETINGS IN THE PRECIOUS NAME OF JESUS.

It is indeed a pleasure and a privilege to be able to present this report of the accomplishments of our Sunday Schools for the past year. I sense that this has been a very good year. Of course there have been many circumstances which could have discouraged, detoured, or even defeated us. However, God has helped our fine pastors and laymen to look beyond conditions and circumstances, and catch a glimpse of the POWER OF OUR GOD: and then in turn to look at the tremendous POTENTIAL before us.

Words of appreciation are certainly in order to my fine predecessor, Rev. Charles L. Cooper, for the fine leadership he gave the District Sunday School work the past several years. God gave the District wonderful Sunday School gains last year, and it is not always the easiest thing to produce substantial again the next year, but God did help us to do it.

We did have a net numerical gain of 77 per Sunday this year over last. This figures to be a 12.1% gain. This year we did reach a mile post which can be termed a **"FIRST TIME ACCOMPLISHMENT."** Never before did the Sunday Schools of the Arizona District total more than 1000 on any one Sunday. THIS WAS ACCOMPLISHED THIS LAST EASTER SUNDAY, with 1020 people in our Sunday Schools. I know that all of us thank God for this achievement.

It is only fitting that mention should be made concerning those Sunday Schools which had the highest numerical and percentage gains. (This is figured on those Sunday Schools which were in operation last year.)

NUMERICAL GAIN:

1. Apache Junction (26 gain)
2. Phoenix First (24 gain)

PERCENTAGE GAIN:

1. Tempe (146.6%)
2. Apache Junction (89.6%)

Each of these Sunday Schools will receive the Conference Award for the highest numerical gain; the second highest numerical gain; for the highest percentage gain, and the second highest percentage gain.

Also, the following Sunday Schools will receive certificates of achievement for registering at least a 20% increase in Sunday School Attendance.

I am sorry that more promotion in the way of Sunday School Conventions did not materialize this past year. Efforts were made to secure the services of Dr. P. F. Elliott, but he could not make it. Rev. Joe Brown could have come the latter part of March, but many of our pastors were away doing deputational work for the Department of Church Extension about that time, so it was inadvisable to have the conventions.

RECOMMENDATIONS FOR THE FUTURE.

1. I would urge either this conference or the District Council to appoint a Sunday School Board to work in the interest of the Sunday School Promotion.

2. I would suggest that some procedure of financing the promotion of our Sunday School work would be set up. The only money available this past year was the offering taken during the Sunday School session at last year's Camp Meeting. This amounted to \$40.22; \$31.49 of which was used for postage and supplies. This leaves a balance of \$8.73.

Finally, let me say that it has been a pleasure to work in what ever way we could to help promote the Sunday School work of the District. Many thanks to every pastor, Sunday School Superintendent, officer, teacher, and scholar that helped make this year what it has been. Shall we work our best to reach the goal set up by our District Superintendent to increase 189 by end of this next year.

Report of the Ways and Means Committee

1. Did not carry.
2. The Ways and Means Committee moves that number five under Ways and Means of the 1959 Conference Journal, page 16, be deleted from the minutes. (Carried)
3. INASMUCH as the general church requests the Arizona District to pay 75% of the United Stewardship Fund this conference year, and to pay it in full the next conference year, BE IT THEREFORE RESOLVED that each pastor strongly urge his members to pay their share, and FURTHERMORE, that each church set up a systematic method of receiving the budget. (Carried)
4. INASMUCH as it appears necessary to supplement district income, BE IT RESOLVED that 100% of the ministerial tithe be sent monthly through the local treasurer to the district treasurer who will disburse 75% of it to the district operational fund and 25% of it to retire the liabilities as listed in the financial statement of the Arizona District Corporation May 31, 1960, and BE IT FURTHER RESOLVED that a yearly offering also be received at the conference or camp meeting to be applied to the retirement of this indebtedness with a goal of \$1500 per year, and BE IT FURTHER RESOLVED THAT an appeal be made to the general church for a loan to cover this indebtedness and that this loan be retired over a ten year period with funds raised by the methods previously proposed. (Carried)
5. The Ways and Means Committee moves that ways and means resolutions numbers 4, 6 and 7 of the 1959 conference journal pages 11 and 12 be deleted from the minutes. (Carried)
6. WHEREAS we are now in the Central Pilgrim College zone, and INASMUCH as the college board has recommended a budget of \$5.00 per member per year, BE IT THEREFORE RESOLVED that we accept this amount as our college budget. (Carried)
7. Ruled out of order.

Report of the Resolutions Committee

1. INASMUCH as there is such close correlation between the work of the Resolutions Committee and the Ways and Means Committee: THEREFORE BE IT RESOLVED that there be the appointment of a Conference Action Committee of 5 members, which would combine the functions and capacities of the resolutions and the Ways and Means Committees.
2. BE IT RESOLVED that there be the appointment of a Building Appraisal Committee; (competent in the field of appraisal) the function of which shall be to set the value of all church property.

3. BE IT RESOLVED that all non-Pilgrim evangelists must first have the approval of the District Superintendent or the District Council before being called for evangelistic activity in our churches.

4. INASMUCH as there is a need for greater missionary activity among our people,

THEREFORE BE IT RESOLVED that there be an organization within our district for the promotion of Missions among the men.

ARIZONA MEN FOR MISSIONS CONSTITUTION

ARTICLE I. NAME—There shall be an organization within the district known as the Arizona Men for Missions.

ARTICLE 11. PURPOSE—The purpose of the organization shall be: (1) To promote missionary enterprises within the district. (2) to encourage Christian service among our men. (3) To develop district-wide fellowship for the men.

ARTICLE III. OFFICERS—The officers of the organization shall be; the Governor, Leut. Governor, Secretary-treasurer, and two State Representatives. These officers shall constitute the district cabinet.

ARTICLE IV. Membership—Membership shall be classified as follows: Honorary—those men who hold ministerial credentials within the district Regular—Men who are full members of a local Pilgrim Church in Arizona, not ministers; Affiliate—Men who by reason of interest, desire to participate, but are not members of the church.

ARTICLE V. Elections—ANNUALLY A MEETING SHALL BE HELD TO ELECT THE OFFICERS. The electing body shall be constituted of the officers of the previous year, and one delegate from each local chapter for each 10 members or major fraction thereof. Each local chapter shall be allowed at least one delegate. The Governor shall be elected from two or more nominees named by the district council. All officers shall be from the regular members. Only honorary and regular members shall vote in elections. No more than one man from any one local church may serve on the district cabinet. Elections shall be by majority vote. Elections are for one year or until successors are elected and qualified. The District Superintendent or his representative shall preside at elections.

ARTICLE VI. OFFICERS DUTIES—Governor—to direct the affairs of the organization. Leut. Governor—to assist the governor and to succeed the governor should he fail to serve his term of office. Secretary-treasurer—to keep records of meetings and finances. State Representatives—to serve as members of the District Cabinet.

ARTICLES VII—MEETINGS—District Meetings may be held when the officers deem it advisable, but such plans are subject to district council approval. Meetings shall be announced at least two weeks in advance to all churches through the pastors.

ARTICLE VIII. SUPERVISION—All activities shall be subject to the approval of the District Council. Likewise all projects shall have such council approval.

ARTICLE IX. AMMENDMENTS—These articles may be ammended only by the district conference in session, and by majority vote.

ARTICLE X. BY-LAWS—By-laws may be provided to guide the organization. These shall be adopted or ammended by a two-thirds vote of the members present at a regularly called meeting. All such by-laws shall be in harmony with these articles and the Church Manual.

ARTICLE XI. LOCAL CHAPTERS—There shall be local chapters organized, as contingencies of the district organization. The local chapter shall be subject to the local church board.

ARTICLE XII. LOCAL OFFICERS—Wherever local chapters are organized, a chapter committee shall be formed. Three officers shall be elected: a chairman (from two or more nominees presented by the local church board); vice-chairman, and secretary-treasurer. Only men who are full members of the Pilgrim Church, and classified as regular members of the organization shall be eligible to hold office within the local chapters. All members; honorary, regular, and affiliate shall be given the right to vote in the chapter meetings.

5. INASMUCH as we have no Constitution Articles set up for the District Women's Missionary Society,

THEREFORE BE IT RESOLVED that such an organization be initiated and the following constitution be adopted.

WOMEN'S MISSIONARY SOCIETY OF ARIZONA THE CONSTITUTION ARTICLES

ARTICLE I. NAME—There shall be an organization within the district known as the WOMAN'S MISSIONARY SOCIETY OF ARIZONA.

ARTICLE II.—PURPOSE—The purpose of the organization shall be to foster and coordinate the work of the local church societies within our churches.

ARTICLE III. OFFICERS—The officers of the organization shall be: The District President, who shall direct the functions; District Vice-President, who shall assist the president and should necessarily demand it, succeeded to that office through the course of the year; Secretary-Treasurer who shall keep records and finances for the organization; and two members at large. These five persons shall constitute the MISSIONARY SOCIETY BOARD and shall direct executive affairs.

ARTICLE IV. MEMBERSHIP—Membership in the organization shall be defined in the constitution for the local church society, Manual, Section 88, Paragraph 7.

ARTICLE V. MEETINGS—District Meetings may be held at such times as deemed advisable by the Missionary Society Board. However all meetings shall have the approval of the District Council or the District Superintendent.

ARTICLE VI. ELECTIONS—Annually the organization shall meet to elect its officers. The District President shall be elected from two or more nominees provided by the District Council. Other officers shall be elected from among the active members. The electing body shall be constituted of the officers of the previous year, and one delegate from each society for each 10 members, or major fraction thereof. Each church shall be allowed at least one delegate. The officers shall be elected for the term of one year, and shall serve until their successors are elected and qualified. The district Superintendent or his representative shall preside at the meeting of election. Election shall be by majority vote.

ARTICLE VII. SUPERVISION—All activities and projects shall be subject to the approval of the District Council.

ARTICLE VIII. FINANCES—The organization shall not levy assessments upon the local churches or the societies. It may, however, ask for offerings from the local societies.

ARTICLE IX. BY-LAWS—By-Laws may be provided to further guide the work of the organization, and may be adopted or amended by a two-thirds vote of the members present at the annual business meeting. These by-laws must be in keeping with these articles and the church Manual.

ARTICLE X. AMMENDMENTS—These articles may be amended only by the District Conference by a majority vote.

6. BE IT RESOLVED THAT all resolutions and ways and means actions be classified both in presentation and in publication: as Conference, Superintendent, etc.

7. TABLED

8. INASMUCH as the Manual provides for a roll of inactive ministers (Manual, Section 178)

THEREFORE BE IT RESOLVED that the District Council, whose duty it is to establish such a roll, initiate the process with this conference.

9. BE IT RESOLVED that the following words be added to Standing Rule #1 . . . " and that all reports be sent to the District Statistician by June 15th.

10. BE IT RESOLVED that the goals set by the District Superintendent in his report be made the official goals of the District for the coming year.

CONFERENCE GOALS:

1. Increased fervor for genuine Holy Ghost revival throughout the district.

2. Special revival efforts in new parts of the population centers of Phoenix and Tucson, in an effort to open new Sunday Schools and preaching points.

3. Progress toward self-government and self-support of the district.
4. Increase in church membership to a total of 450 by next conference. (Represents gain of 101)
5. Increase in Sunday School average attendance to a total of 900 by the last quarter of next year. (Gain of 189)

LOCAL CHURCH GOALS

1. At least two revival efforts this year.
2. Promotion of a tithing program in each church, to teach our people the Scriptural method of supporting God's work.
3. Use of Preparatory and Junior membership with instruction classes in doctrine.
4. A lay visitation program.
5. A 25% increase in Sunday School attendance.
6. A 20% increase in Church Membership.

11. BE IT RESOLVED that resolution #7, page 11, in the 1959 Conference Journal be made a standing rule.

12. BE IT RESOLVED that by a rising vote of thanks, we express our appreciation to our chairman, Dr. R. G. Flexon, for the efficient way in which he has conducted the conference.

Ways and Means

1. BE IT RESOLVED, that the district budget be computed on the basis of \$1.35 per member per month for all members of voting age. (1957)

2. BE IT RESOLVED, that the District pay \$75.00 per month on salary of the District Superintendent; BE IT FURTHER RESOLVED, that the District Superintendent be remunerated for meals and lodging incidental to travel. (Revised 1958)

3. BE IT RESOLVED, that each council member be paid 5 cents per mile for traveling expense to and from council meetings. (Revised 1958)

5. WHEREAS, there have been no monies available at the beginning of the district camp to make initial purchases of supplies, THEREFORE, BE IT RESOLVED that we ask the churches of the district to raise the following amounts and to forward them to the District Treasurer 30 days preceeding the opening of district camp:

6. INASMUCH as the general church is requesting the Arizona District to pay 75% of the general budget this conference year and 25% each succeeding year until the district is paying its budget in full.

BE IT THEREFORE RESOLVED that each pastor strongly urge his members to pay their share, and furthermore, that each church set up a systematic method of raising the budget. (Revised 1960)

7. INASMUCH as each church is expected to raise its share of the district budget, and as a systematic method of raising the budget, BE IT RESOLVED that a district budget offering be taken during one of the main services of the last Sunday of each month, and FURTHERMORE, that said offering be announced during the preceeding Sunday services. We recommend that this resolution become a standing rule. (1959)

8. INASMUCH as several of our districts have a group hospitalization, surgical, and medical insurance plan, and since a number of the district pastors have expressed a desire for such a plan, BE IT THEREFORE RESOLVED that we accept the Blue Cross, Blue Shield group hospitalization, surgical, and medical plan. AND BE IT FURTHER RESOLVED that the churches pay \$5.00 per month to be applied to the pastor's premium, and the

district pay \$5.00 per month to be applied to the District Superintendent's premium. This resolution is recommended first for discussion by the committee with the added recommendation that the lay delegation be given the privilege of discussion. (1959)

General Resolutions

1. In order that the relatives and friends may know the set time for the ordaining of ministers, BE IT RESOLVED, that the Ordination Service take place at 4:00 p.m., the first day of Conference. (1957)

2. BE IT RESOLVED that the District Conference organize a Camp Meeting Committee to facilitate the handling of responsibilities preparatory to the Annual Camp Meeting. Said committee shall consist of the following members:

1. CHAIRMAN—whose responsibility will be to direct the operations of said Committee.
 - A. PURCHASING AGENT—whose responsibility will be to purchase supplies necessary for operation of the dining hall and the lunch stand.
 - B. ADVERTIZING AGENT—whose responsibility will be to publicize the Camp.
 - C. CAMP GROUND SUPERVISOR—whose responsibility will be to have oversight of the dining room, kitchen help and tabernacle.
 - D. CAMP CLERK—whose responsibility will be to prepare rooms and receive room reservations. (1958)

3. INASMUCH as there is no designated time for working on the District Camp grounds—be it resolved that there be two work weeks per year, one in the fall and one in the spring. Each work week shall begin on Tuesday morning and end on Friday afternoon. Each church may send one man to work, or the equivalent of one week's wages which amounts to \$40.00. (1958)

4. BE IT RESOLVED that when ministers come to this district from other denominations, that the Executive Officer of the transferring minister be contacted by the District Superintendent asking for a recommendation, to be in the hands of the District Council at least 30 days prior to moving date. And BE IT FURTHER RESOLVED that the transferring minister be interviewed by the District Council prior to reception of his credentials. (1959)

5. BE IT RESOLVED that the district furnish credential forms to each local church conference delegate and alternate to be filled out and signed by the pastor and the church secretary, and sent to the district secretary at least 30 days prior to Conference. (1959)

6. BE IT RESOLVED that laymen may serve on the District Council. (1959)

7. BE IT RESOLVED that the District Trustees and the Statistician be made permanent members of the District Conference. (1959)

CONFERENCE

1. The conference year of the Arizona District shall begin June 1 and end May 31 the following year, and that all reports be sent to the District Statistician by June 15.

2. The district council and the following committees and boards shall meet one day prior to the Annual Conference to take care of such work as they have at hand. Conference Action Committee and the Educational and Examining Board.

3. The conference bar shall consist of the tabernacle platform and the first six rows of seats.

CONFERENCE COMMITTEES

4. The Educational and Examining Boards shall be combined and this Board shall consist of three members, one being elected for a period of three years, one for a period of two years and one for one year.

5. There shall be a memoirs committee which shall annually list departed members by name, date of decease and church for inclusion in the conference journal. In the case of ministers there shall be a picture and a brief resume of ministerial labors.

MINISTERS

6. Before licensed or ordained ministers coming from other churches shall be received into the local church, the pastor shall consult with the District Superintendent and Council regarding said minister.

7. Each pastor is to be granted a two weeks vacation with full salary.

LOCAL CHURCH

8. The local churches shall provide modern cooling, cooking and heating facilities for the parsonage, the type of facilities to be suitable to the locality where the parsonage is situated, and all churches in the conference shall pay the utilities for the parsonages.

9. Each local church is urged to raise a subscription list to the Pilgrim Holiness Advocate equal to its total membership.

10. The local church is to pay the traveling expense and entertainment of their pastor and delegate for the Conference business sessions. This does not include camp meeting.

11. Each local church shall have a Public Relations Chairman, who will submit copy of local news events to district publications and local newspapers.
