### SUMMARY PROCEEDINGS

The 15th Annual Conference of the Capital District of the Pilgrim Holiness Church was held at the Alexandria First Pilgrim Church in Alexandria, Virginia on May 20, 1967 with Rev. W. N. Miller, General Secretary of Church Extension as the Presiding Chairman.

# FIRST SITTING - 9:00 A. M.

Rev. Robert N. Campbell, host pastor, opened the conference with greetings and a cordial welcome to all pastors, delegates, District Superintendent Rev. Charles Felsburg, and General Secretary of Church Extension Rev. W. N. Miller.

Rev. Don Pence led the conference in singing "JESUS WILL WALK WITH ME" and "HIGHER GROUND." Mrs. Robert Campbell accompanied the congregation at the organ with Mrs. Charles Felsburg at the piano. The conference then sang the chorus "SPIRIT OF THE LIVING GOD," before prayer.

The Presiding Chairman, Rev. W. N. Miller, introduced Rev. R. A. Beltz, the Director of Pilgrim Pension Plan, who then led the conference in prayer.

Rev. Pence favored the conference in singing, "MY FAITH LOOKS UP TO THEE."

Rev. Miller gave a brief message. His scripture was Titus 1:1-5. In his message he pointed out the positive existence of God and that people are won to God through preaching and also the preaching of Christ is what we need today.

The formal business of the conference began at 10:00 A.M. with the roll call by the Conference Secretary, Rev. Robert Campbell. The roll call showed fifteen ordained ministers, five licensed ministers and seventeen lay delegates present.

Rev. Miller then formally introduced and presented Rev. Charles Felsburg as District Superintendent of the Capital District.

Rev. Felsburg then read and presented his Annual Report as the newly appointed District Superintendent. The report was received by a unanimous standing vote. At this time Rev. Felsburg publicly gave thanks to Rev. R. L. Adams, Mr. Raymond Campbell, and Rev. Robert Campbell for their help in the early days of his work in the Capital District.

The District Secretary then read the Standing Rules of the Conference, the designated times for the business sessions.

The secretary then presented a motion which was seconded that the first six pews be used as the conference bar. The motion was unanimously approved.

The District Superintendent at this time presented a new church to the conference. Rev. Harold Huff and delegate, Mr. Bishop from and representing the Waldorf Pilgrim Church were introduced to the conference and to the General Secretary of Church Extension. Rev. Felsburg presented a motion which was seconded, that the Waldorf Pilgrim Church be accepted into the Capital District. The motion was unanimously approved by a standing vote.

Rev. Charles Beach introduced four ordained ministers, one licensed minister and one licensed deaconess as new members to the conference. They are as follows: "ORDAINED MINISTERS", Rev. T. M. Weir, Rev. Harold Huff, Rev. Gilbert Baker, and Rev. Elmer Drury. "LICENSED MINISTER", Rev. Raymond Jodon. "LICENSED DEACONESS", Mrs. Mable Weir. A motion was made and seconded to accept these new members into the conference. The motion was unamiously approved.

Rev. Drury presented the honored guest, Rev. Beltz, to the conference. Rev. Beltz gave a word of testimony and was given an honorary seat in the conference bar.

Reports of the Auditors, Statisticians and Treasurer were accepted. The District Treasurer, Mr. Raymond Campbell read the projected District Budget for the coming year.

Rev. Campbell then read a letter from Rev. M. C. Johnson, former pastor of Cresaptown, Md. who could not be present due to illness. He expressed his appreciation to Rev. Felsburg, Rev. Thomas Weir and Rev. J. E. Kraus for their invaluable help during his illness.

Rev. Felsburg then made a motion which was seconded that the secretary send a letter of greeting to Rev. and Mrs. Johnson. An amendent to the motion was made, that a telegram be sent in place of a letter. The amended motion was unamiously approved.

Several announcements were made and the meeting adjourned at 11:35 with prayer by Rev. Robert Campbell.

### SECOND SITTING - 1:40 P. M.

The second sitting opened with the congregation singing, "SHOWERS OF BLESSING," after which Mr. Howard Frankenberry, a layman from Cresaptown led in prayer.

Special songs were rendered by Rachel Felsburg and Mrs. Robert Campbell.

Rev. R. A. Beltz spoke to ministers concerning the FILGRIM PEN-SION PLAN and urged each to participate in this program of the church.

The District Youth President, Rev. Bruce Lecates gave his report and it was accepted with deep appreciation.

A motion was made and seconded to have the Youth Treasurer's report included in the minutes.

The recommendations of the Education and Examining Board were approved were approved as follows: For Ordination - Jack St. Clair

District Licensed - Burt Cutshaw, M. C. Johnson

L. L. Pickett, Raymond Jodon

Wayne Moore, Stanley Garrison

The next order of business was the election of three advisory members to the District Council. The results were as follows: Rev. J. W. Kraus, Rev. Charles Beach, and Rev. E. L. Adams.

Rev. T. M. Weir was elected for a three term to the Education and Examining Board.

The results of the election for delegates to the International and Merging Conference were as follows:
MINISTERIAL DELEGATES - Rev. J. W. Kraus and Rev. R. N. Campbell
ALTERNATE DELEGATES - Rev. Beach, Rev. Drury and Rev. Weir

A motion was made and seconded to accept the names presented by the council for lay delegates to the International and Merging Conference.

A motion was made and seconded that alternate lay delegates to the conference be the remaining four people in the order of votes received on the last electing ballot.

A motion was made and approved that the corporation papers of the church be made available to all pastors.

Resolution No. 5 was read and adopted.

Resolution No. 8 was referred to the District Council.

The District Superintendent then read the appointment of committees for the coming year.

The Final Resolution was read and approved by a standing vote.

The 15th Annual Conference of the Capital District was then adjourned. Rev. Louis Adams dismissed with prayer.

# REPORT OF RESOLUTIONS COMMITTEE

### Resolution No. 1

Whereas, we have need to extend our youth administration,
Whereas, we are growing and find the need to expedite some
of our youth activities be it therefore

Resolved, Paragraph #2 in resolution #5 as stated on page 11 in the current minutes be changed to read as follows:

The District Youth Executive Council shall be made up of the District Youth President, the District Youth Secretary, the District Youth Treasurer and two Zone leaders.

### Resolution No. 2

Whereas, our present method of reporting to the District office is inadequate and

Whereas, at present our Minutes make provisions for quarterly conferences (Page 37 - paragraph 3) Therefore be it

Resolved, that this previous action be deleted and that a monthly report be submitted to the District Superintendent. The date of submission will be established by the District Superintendent. The forms as approved by the District Council shall be supplied to each pastor by the District.

### Resolution No. 3

Whereas, Paragraph #4 on page 37 of the current conference minutes is provided for in paragraph 2, page 9 of the same minutes, be it therefore

Resolved, the action on Page 37 be deleted.

# Resolution No. 4

Whereas, present provisions for Ordination Service do not permit ample time for the notification of relatives and friends, and since this is to be considered as a highlight in the life of any minister, be it therefore

Resolved, the District Superintendent and Council shall arrange with the General Superintendent or appointee, and candidate for ordination, for an ordination

service and a time of their choosing.

### Resolution No. 5

Whereas, Referring to Paragraph #6 on page 37, we would recommend that this resolution be changed to read as follows:

Whenever possible, each pastor is requested to furnish active cooperation in the interest of youth camp. The date of Youth Camp shall be set as soon as possible and that all churches shall be notified of this date immediately once it is set. Furthermore, each pastor is asked to arrange his schedule to comply.

### Resolution No. 6

Whereas, Many of our ministers are not covered by an active hospitalization insurance program provided for groups, and that group insurance is available if as many as six will form a participating group, and that group rates are considerably lower in costs, be it therefore

Resclved, that a committee be appointed the District
Superintendent to proceed with negotiations with
several companies to find the best offer for us and
that this offer he presented to us at a minister's
conference in the near future.

# Resolution No. 7

Whereas, there is strength in numbers and we have organized our district for this strength, and

Whereas, there is a great need for collective advertising both in the newspapers and telephone as well as other means, be it therefore

Resolved, we recommend to the District Superintendent and Council that a Publicity Committee be appointed and that their function shall be to coordinate the advertising of our district and that all of our church be included. They shall also be in charge of any other advertising that shall be pertinent to our district.

# Resolution No. 8

Whereas, we have a majority of churches and membership in this area as compared to the Wesleyan Methodist Church and we have a district with a spirit that is second to none, and we definitely feel that this spirit would be curtailed if we were made to merge with an existing district elsewhere, be it therfore

Resolved, that we express our desires and wishes to the Secretary of Church Extension and that he convey these wishes to the proper authorities in the merging committees and pray for their granting our

wish to remain in the present confines of our district as presently set forth in the Manuel. Also that the Wesleyan Churches that are in this area be invited to be full members of this district. This is done to continue a program that we feel is vital to our church and that is the evangelization our large cities.

# Final Resolution

Whereas, this has been a year of transition and re-adjustment, we first want to thank God for his help in keeping us as a district with our men and brethren settling down to do the job before us. Second, we are thankful for the direction of our District Superintendent, how he has not been content to be caught up in the attitude of complete retreating, but has forged ahead into new fields and we are retrenching not retreating. Third, we are thankful for you, Rev. Miller, who has encouraged our District Superintendent as well as we ministers in your leadership in this conference, therefore be it Resolved, that we stand as a conference body and thank you personally for coming here and will pray God's best blessing upon you in the days ahead.

### THE DISTRICT SUPERINTENDENT'S REPORT

# 1966 - '67 Conference Year

General Secretary of Church Extension, Rev. W. N. Miller, Delegates to the 15th Annual Conference of the Capital District of the Pilgrim Holiness Church, Friends:

Late last summer, General Secretary Miller approached me about considering this office. Knowing little about Capital District I gave very little consideration. However, the Lord began to talk to me about the matter and I finally agreed to come to Washington and meet the Pastors and see the Churches.

I was profoundly impressed with the dedication and statue of the pastors and the unlimited opportunities presented in Capital District.

After seeking diligently for God's will, I felt this to be God's choice for my life at this time.

The past few months I have been priviledged to serve as your Superintendent have been pleasant ones. Each Pastor and our many fine laymen have given my entire family a warn welcome. Words cannot express our gratitude to each of you for your sincere kindness.

This conference year has opened new doors of service for Capital District and has proven to be a year of progress for nearly all of our churches.. Thank God for every dedicated Pastor and Laymen who has helped to make this success a reality.

We cannot enumerate every area of achievement but will highlight a few.

# A NEW CHURCH BORN

Over a year ago, a prayer meeting was established in the Waldorf, Maryland area. Rev. Robert Campbell, pastor of Alexandra, First Church, has conducted many of these Thursday night meetings, personally. Last Fall, the local elementary school was rented for Sunday School and Morning Worship Service. No. Sunday evening services were conducted due to lack of facilities.

It was my happy priviledge to organize the Waldorf Church, Sunday, April 2, with Ten (10) Adult and One (1) Junior Member. The newly organized church immediately took steps to produce a permanent place of worship and housing for their pastor. We have a signed purchase contract on a home which serves as a Chapel and Parsonage. The first service was held in these new quarters, Sunday, May7. A sound budget has been worked out which includes, full property payments, utilities, an allotment for pastors salary and other incidental costs. This work is fully self supporting.

Much credit is due Mr. Edward Nugent for his vision and tireless efforts over the last year, which has led to the organization of this new church.

### GROWING PAINS

There is always a price for progress, but this is one cost we face with energy and courage. Where there is a genuine Christian committment, there is persistent determination to reach the lost for Jesus Christ. Such determination demands that we keep pace with our opportunities.

Cresaptown Pilgrims have experienced continual Growing Pains since their organization, less than two and one-half years ago. Pastor Johnson tendered his resignation to me expressing his feeling that the church needed a full time pastor. Since that time, I have been working toward this goal. The District Council in conjunction with the Pastors have worked on an accelerated Missionary Program to make this possible. The District has committed itself to partial salary and the local church is underwriting the balance of the salary and has pledged to provide parsonage and utilities. Plans are well under way to build an adequate parsonage in Cresaptown.

This church has grown rapidly but I believe their finest hours are ahead.

While this conference is in session, Pastor Johnson is convalesing from serious surgery. At his request, I bring you greetings from he and Mrs. Johnson. They send their love and thanks for your prayers.

I take this opportunity to express the deep appreciation of the Conference for the sacrifice and service given so generously to the Church by Rev. and Mrs. Johnson. May the God of all Grace reward accordingly.

Oxon Hill, another of our infant churches, is showing remarkable gains in all departments. Steps need to be taken to increase our educational facilities. We are searching diligently for God's guidance as we endeavor to keep pace with our opportunities in Oxon Hill.

Pastor Davis opened this church without an interested nucleous of people. It is not easy task but a very challenging one when we feel God has led us. Brother Davis is a real Pioneer Missionary and God has blessed his labors.

### OUR FUTURE

Our future is as boundless and limitless as God himself. If there are handicaps and limitations, we create and nurture them.

One human weakness is to think our strength is determined by the number of local churches we have. I believe this is only a partial truth. The greatest growth potential in Capital District lies in the structure of our present congregations. We have adequate facilities to accommodate larger Sunday Schools, Worship services, Evangelistic meetings, etc. There is no area in the Nation more needy for a Positive Salvation Message, than the Nation's Capital.

The secret to success is defining your mission, then with singleness of heart, mind and strength, pursuing that mission. Achievement begins with a fervent vision but is only realized by hard work. Success is created by initiative, promptness, well-organized work schedules, thoroughly organized plans and speedy execution of those plans. The road to success is not an easy road but it is a satisfying and delightful one. Hard work will harm no one but lack of will defined purpose will fade a man or a church into ablivion.

I wish to challenge every Pastor and Congregation to return from the Conference and initiate planning for growth in every department of your local church.

Our Sunday Schools are growing but we must accelerate this growth. Morning Worship attendance has shown marked increase, but we must continue to build this very important phase of our Ministry.

Mid-week Prayer Service is the life line of Spiritual Strength to we Christians, and it needs to have stronger emphasis in the total church program.

We need to strengthen our Youth Program. Social life plays its part and is important but we need to provide opportunities for Christian Service to all our Teenagers. Contrary to our thinking, Youth are looking for a challenge to service and will not be satisfied to exist in a social vacumn. Let's open doors of service for Pilerin Youth.

The Christian Youth Crusaders (C.Y.C.) program of the Denomination is a thoroughly planned and tested program. If your church has not initiated it, plan to do so in the immediate future. Training our youth is building the Kingdom of God. C.Y.C., is a very effective training program.

The door of our Future will be unlocked with the Key of co-operation.

In the work of the Church we do not succeed by traveling alone as individuals or congregations. The degree of Team work greatly effects the degree of our success. We are not capable of proper development as individuals or groups when we build with selfish motives, intentional or unintentional.

One way for a church to completely wither up, is for you to invest colely in your operation. When we do this it is evident we have lost our Missionary Compassion and with this we lose our sense of Mission.

I have every confidence that I can count on every Pastor and you good Laymen to see that your church meets the challenge and keeps all the budgets paid each month.

# CONCLUSION

In conclusion, I express my deep appreciation to all our pastors for the splendid work they have done this past year. It requires genuine dedication to serve without salary or with very limited salary as most of our nen do. Without this sacrificial service Capital District would not exist. Let us Pray and strive together, toward a Goal of full Pastoral support for each Church.

I Thank God for the host of Christian Laymen who make up our Conference.

It has been a pleasure to work with the District Council. Each man has spent many hours, over the past months, giving of his time to the interest of the Conference.

We are honored to have the General Secretary of Church Extension Rev. W. N. Miller, with us. I count it an honor to serve under Brother Miller. He is working tirelessly to advance the work of our Great Department.

Now, May God guide and give wisdom as we begin the work at hand.

### STANDING RULES

# TIME AND PLACE OF ANNUAL CONFERENCE:

The Annual District Conference shall convene each year on the third Saturday in May at 8:00 A.M. at the location designated by the District Council.

The time of the sitting shall be from 9:00 to 11:30 A.M. and from 1:30 P.M. to adjournment.

# EDUCATION AND EXAMINING BOARD:

The Education and Examining Board shall consist of three ordained ministers elected for staggered three year terms so that one member is due for election each year. The chairmanship of the Board shall rotate to the member who has served the longest part of his term.

### RESOLUTIONS COMMITTEE:

The Resolutions Committee shall consist of at least five members.

#### DISTRICT BUILDING COMMITTEE:

The District Council shall appoint a building committee to provide pastors and congregations the information and guidance required for all their building planning.

### LOANS FROM PILGRIM PENSION PLAN:

Whereas the General Board of the Pilgrim Holiness Church has authorized the Pilgrim Pension Plan Inc. to make loans of Pension Funds to local Pilgrin Holiness Churches under such conditions as require active participation on the part of P. H. District, therefore, be it resolved by the Annual Conference of this District that The District Council, District Trustees and all District Officials be, and they are hereby, authorized to do and perform any and all acts required of them in the consumation of authorized loans to local P. H. Churches of this District, subject, however, to the limitation and conditions set out in said Resolutions of the General Board of the Pilgrim Holiness Church.

### DISTRICT JOURNAL PRESS TIME:

The Editing Committee shall have its work completed by June 30th each year.

# CHURCH INVENTORY:

A complete inventory of equipment shall be submitted by each church each year and filed in the individual church packets for safe deposit keeping.

#### EASTERN PILGRIM COLLEGE ASSESSMENT:

Each Church of the Capital District Conference shall pay 25¢ per member per month to the District Treasurer, concurrently with payment of the District Budget, for support of Eastern Pilgrim College. Funds received for this purpose shall be

transmitted to E. P. C. by the District Treasurer within thirty (30) days after receipt.

#### PASTORS VACATION:

Each Church is encouraged to give its pastor two weeks of vacation each year.

### DISTRICT YOUTH EXECUTIVE COUNCIL:

The District Youth Executive Council shall be made up of the District Youth President, the District Youth Secretary, the District Youth Treasurer, and two Zone Leaders.

### MONTHLY CHURCH REPORTS:

Each Church will submit a monthly report to the District Superintendent. The date of submission will be established by the District Superintendent. The forms as approved by the District Council shall be supplied to each pastor by the District.

# ORDINATION SERVICE:

The District Superintendent and Council shall arrange with the available General Superintendent or appointee and candidate for ordination, for ordination service at a time of their choosing.

### PASTORS AT YOUTH CAMP:

Whenever possible, each pastor is requested to furnish active cooperation in the interest of youth camp. The date of youth camp shall be set as soon as possible and that all churches shall be notified of this date immediately once it is set. Furthermore, each pastor is asked to arrange his schedule to comply.

### DISTRICT BUDGET:

The District Budget for District Administration shall be raised as follows:

- 1. Each Church in the District shall pay to the District Treasurer 7% of all offerings received by the church except those offerings designated for a specific purpose or activity outside the local church, such as World Missions, Church Extension, S. S. and Youth (Rally), Colleges, and District Projects.
- 2. All offerings received at District Rallies, Conferences and other meetings shall be credited to the District Administration Fund unless otherwise specifically designated or directed by the District Council.
- 3. Each Minister, ordained or licensed, shall pay 50% of his tithe, directly or through his church treasurer, to the District Treasurer each month.
- 4. Each new church organized within the Capital District,

in lieu full assessments, shall be required to pay Dis-Budget assessments on its offerings as follows: 2% during the first conference year after organized; 4% during the second year; 6% during the third year; and full budget thereafter.

5. The United Stewardship Fund and the District Budget are due on a monthly basis. These funds are received each month and all other funds designated for District or General Church use, shall be sent to the District Treasurer by the 10th of the month following.
