FIRST SITTING

The Seventeenth Annual Assembly of The California District of The Pilgrim Holiness Church convened in First Pilgrim Holiness Church at Pasadena, California, June 26, 1939, with our General Superintendent, Rev. Walter L. Surbrook, presiding.

Devotional service led by our District Superintendent, Rev. C. J. Meyers. Rev. Elmer Hall led the congregation in singing the song, "Under the Atoning Blood," after which Rev. W. H. Neff led the Assembly to the Throne in prayer.

Scripture lesson read by our Secretary of Foreign Missions, Rev. Paul W. Thomas. The fifth chapter of I Thessalonians being the portion.

District roll call given by the Secretary, with thirty responding from the Ministerial delegation and seventeen from the Lay delegation.

Moved and seconded that the Assembly bar include the platform and the first six rows of seats in the auditorium. Carried.

Moved and seconded that this assembly convene as follows: 9:00 to 12 noon; 1:30 to 4:30 p.m.; 7:00 to 9:00 p.m. Carried.

The report of the auditing committee read.

Moved and seconded that the report of the Auditing Committee be accepted. Carried.

The report of our District Treasurer, Rev. E. R. Hall, given.

Moved and seconded that this report be accepted. Carried.

The Assembly was granted a five-minute recess at this time.

After convening the Secretary read the recommendation that the following be accepted into the District:

At this time, W. H. Neff called attention to the fact that a very substantial increase was made in our membership the past year, and suggested that we sing "Praise God from Whom all Blessings Flow."

SECOND SITTING

Moved and seconded that his report be accepted. Carried. Sitting adjourned with prayer.

Moved and seconded that the election of officers be postponed until the Assembly passes on those eligible for license so that the voting number be increased. Carried.

Moved and seconded that these candidates be accepted. Carried.

These were given a seat within the bar.

The Assembly knelt for a season of quiet prayer before balloting began.

Ballot cast for election of District Superintendent. Rev. W. H. Neff elected. Rev. Neff asked the privilege of waiting until morning to make his decision known to the Assembly.

Ballot cast for election of the Assistant Superintendent. Rev. James M. Dooley was elected.

Ballot cast for District Secretary. Rev. G. L. Palmer elected.

Ballot cast for District Treasurer. Rev. E. R. Hall elected.

Ballots were cast for the election of the three additional members of the council.

Moved and seconded that three names be put on one ballot to save time. Carried.

Rev. C. J. Meyers and Rev. Roy L. Morgan elected on first ballot.

Moved and seconded to vote for three highest, and amended to include Rev. J. C. Brillhart's name (since he is a member of the district by virtue of his acceptance of the pastorate of First Church). Carried.

Rev. Brillhart elected.

Ballots cast for election of Trustees. Jens Jensen, W. L. Troyer, H. L. Blake elected.

Ballot cast for the election of the third member of the Educational Board. Rev. O. G. Hahn elected.

Ballot cast for the election of the third member of the examining committee. Rev. W. R. Miner elected.

Sister Robinson, of the New York District, was introduced to the Assembly and gave testimony.

Moved and seconded to adjourn until 9:30 a.m. Carried.

The Assembly arose and sang the Doxology.

Rev. G. L. Palmer dismissed with prayer.

FOURTH SITTING

The Fourth Sitting of the Seventeenth Annual Assembly of the California District convened at 9:45 a.m., June 27, with Rev. W. L. Surbrook presiding.

Song service led by Rev. R. V. Steelhead.

Assembly led in prayer by Rev. C. Edwin Cox, pastor of the Medford, Oregon, Church.

Rev. Surbrook read the 6th chapter of II Corinthians for a Scripture lesson, and gave a very stirring message to Christian workers on the "Need of Keeping our First Love."

Moved and seconded that the matter of examining two candidates be referred to the District Council since there is no quorum for immediate action. Carried.

The Secretary read an invitation of the Pomona Church for Camp and Assembly next year.

REPORT OF THE DISTRICT SUPERINTENDENT

To the Seventeenth Annual Assembly of The California District of The Pilgrim Holiness Church, Greetings:

First of all, I want to testify to the saving and sanctifying and keeping power of God, which has kept me throughout the year. I find within my soul one desire, that is to do the whole will of God always.

We are now up to the close of another year which has been filled with many hard-fought battles, but thank God he has given victory in the midst of battles.

Our District pastors have worked hard, and we have appreciated the sacrificing spirit which they have shown. The type of which we believe cannot be excelled anywhere.

We have investigated several new fields, with the thought of starting new works, and made some contracts which we trust will enable us to enter new doors.

Several good revivals have been held over the District during the past year, and souls have been saved and sanctified.

Numerically, there has been a gain of almost 10 per cent in membership. The records also definitely show a substantial increase in our Sunday School attendance.

I have visited every church at least two times, and many of them three or four times. Held Annual meetings at all of the Church but two and in these the membership was too small to warrant holding Annual meetings. Have preached 60 times, and have seen a number of seekers bowing at an altar of prayer.
