CONFERENCE PROCEEDINGS

FIRST SITTING

The fourth annual conference of the Arizona District of the Pilgrim Holiness Church convened August 6, 1959, at 9:00 p.m. in the District Tabernacle at the new camp ground, Prescott, Arizona.

The session was called to order by Reverend L. W. Quinn the district

superintendent.

Reverend David Bailey led in singing, "Amazing Grace," and "When the Battle's Over We shall Wear a Crown." Reverend Duane Watkins, new

pastor at Tempe, led in prayer.

District Suprintendent Quinn then introduced Dr. R. C. Hawkins, Secretary of Church Extension and presiding officer, to the conference. He spoke convincingly concerning the first chapter of Colossians, showing the distinction between citizenship in heaven and citizenship on earth. There are clear distinctions drawn between the saint and sinner, righteousness and ungodliness, insomuch that a godly man is a living rebuke to the world. The test of godliness is giving life and meaning today to my altar vows. The message was climaxed with an admonition to ministers to submit to the refinement of God with afflictions counted an honor.

The roll of ministerial and lay delegates was called.

A motion carried that Brother Holloway be placed as the delegate from Cottonwood.

It was moved, seconded, and carried that the first six rows of seats

and the platform be designated as the conference bar.

The District Superintendent called for transfers to the conference to come forward. Rev. and Mrs. David Bailey, Idaho-Washington, Reverend and Mrs. Duane Watkins, Southern Indiana, Reverend and Mrs. Mark E. Waddell of East Michigan, Reverend Mrs. Wilma Reiff of Rocky Mountain, Reverend and Mrs. W. E. Cook of the Wesleyan Methodist Church, all ordained ministers and Mrs. Flora Johnson, an ordained deaconess from the Texas District, were introduced to the presiding officer and in turn to the conference by Dr. R. C. Hawkins. Those with ministerial credentials were seated in the conference bar by motion.

A motion carried to seat the district trustees and the statistician as

members of the conference.

By motion the times for conference sittings were established with the present sitting to end at 11:45 and the afternoon sitting to convene at 2:00.

Mrs. Meredith E. Turner and Mrs. Mark E. Waddell were appointed by

the Superintendent to serve on the Memoirs Committee.

The District Superintendent's report was the next order of business. A strong and comprehensive report was given on advances throughout the district. Gains of 176 in the Sunday School average attendance and 86 in church membership were reported, indicating the conference was well ahead in the pattern of progress as established by General Conference legislation. Proposed goals for next year were presented and graphically illustrated by metropolitan maps of Phoenix and Tucson.

Church Extension Secretary Hawkins rose to comment on the Superintendent's report stating that Brother Quinn had given himself unstinting. ly to the work and had shown a fine spark of leadership in guiding the district to these exceptional gains. He explained the chain of responsibility in matters of church promotion from the General to the local level.

affirming that we cannot afford the luxury of failure.

The report of District Superintendent L. W. Quinn was received with a rising vote of appreciation and thanks.

The conference was adjourned until 2:00 p.m.

SECOND SITTING

The afternoon siting convened with Reverend David Bailey leading the

delegates and ministers in singing, "Victory Ahead," Reverend Charles L. Cooper, pastor at Yuma, led in prayer.

Dr. R. C. Hawkins, the presiding officer, made several announcements relative to the conduct of conference business.

The two new churches at Prescott and Tucson, Trinity were presented by the District Superintendent to the Presiding Officer. The Prescott pastor, Reverend Meredith E. Turner and delegate Arville Parker, along with Harvey Irwin delegate from the Tucson, Trinity Church came forward and were introduced to the gathering. The two churches were received with a rising vote.

Denzel Clouse gave the statistical report. It was received by motion carried with gratitude to God and thanks to the statistician for his hard

The Treasurer's Report was read by Reverend M. E. Turner in behalf of Reverend B. Ivan Williams. A motion carried that the report be

A report of the Sunday School and Youth work was given by Reverend Charles Cooper. Achievement awards were presented to representatives of the Phoenix, Calvary Church for the highest numerical gain and the Apache Junction Church for the highest percentage gain. Yuma, Cotonwood, and Phoenix, Westside also received certificates for gains of 20% or more. A motion carried to accept the report with gratitude to God and appreciation for a task well done.

Mrs. Denzel Clouse, president of the District Missionary Society, read

her report. This good report was received by motion.

It was decided by motion to adjourn at 4:00 p.m. and reconvene at

9:00 a.m. in the morning.

M. E. Turner, Secretary of the Education and Examining Board presented the work of that group. It was moved, seconded, and carried to receive this report.

Resolutions 1 through 8 were read by Reverend Garth Shav, secretary of the resolutions committee. Resolution 1 was reread and adopted by

motion. Resolution 2 was moved, seconded, and carried.

By motion resolution 3 was referred back to the committee for redrafting. It was moved, seconded and carried to adopt Resolution 4.

Resolution 5 was ruled out of order.

District Superintendent Quinn informed the conference that the wife of Reverend Bruce Echols had passed away. By motion the secretary was instructed to send a night letter expressing our sympathy.

The sitting was adjourned by expiration of time.

Brother Harvey Irwin dismissed with prayer.

THIRD SITTING

The third sitting of the conference convened August 7, at 9:00 a.m., with Brother Bailey leading in the singing of "What A Friend We Have After several special requests prayer was offered by Brothers Crosser and Waddell.

Dr. R. C. Hawkins read a portion of scripture from Acts 28 concerning Paul the prisoner of the Lord and the courage that came to him through the fellowship of the saints who met him on the Appian Way. speaker urged all to be abandoned to the will of God and let the future in His hands.

The minutes of the first session were read and approved. The minutes

of the second session were read and approved as corrected.

The Resolutions Committee reported through its Chairman, Mark E. Waddell. Resolution Number 3, which had been referred to the committee for revision, was brought back to the floor. This resolution as amended carried.

Resolution Number 6 was adopted by motion carried.

Resolution Number 7 concerning a public relations chairman for each local church was moved, seconded, and carried.

By motion resolution Number 8 was passed.

A new resolution, not presented in the complete reding of the committee

report yesterday, was read. Resolution number 9 was carried.

Charles L. Cooper, secretary of the Ways and Means Committee read five items from that committee. Ways and Means item 1 was adopted by motion. Items 2, 3, and 4 having to do with a health insurance plan, the gathering of the General Stewardship Fund, and the Laymen's dormitory, respectively, were adopted by motion.

Item 5 concerning a dormitory for ministers was amended and carried

as amended.

The Secretary of General Church Extension announced the appointment of the executive officers as follows: District Superintendent L. W. Quinn, District Secretary, Harold R. Crosser, District Treasurer, M. E. Turner. After Brother Quinn spoke words of appreciation and admonition, the conference sang, "Blest Be the Tie that Binds."

By motion it was decided to adjourn at noon.

Sister M. E. Turner and Brother E. A. Johnson were appointed as tellers. There was no election on the first ballot for advisory council members. The second ballot produced the election of Brother Elwood Hunter. motion carried to use the next three highest names for the third ballot. There was no election on the third and fourth ballots.

The session was adjourned by expiration of time.

FOURTH SITTING

The last sitting of the conference convened at 1:30 p.m. with Brother David Bailey leading in the song "Draw me Nearer." Mrs. Duane Watkins led in a season of prayer.

Minutes of the morning sitting were approved as read.

The fifth ballot for election of the second advisory member to the Council produced no election.

A motion carried to ballot on the two highest names, these being, Charles L. Cooper and Mark E. Waddell.

The sixth ballot resulted in the election of Brother Cooper.

A motion carried to elect Brother H. C. Fridenmaker to a three year term as District Trustee.

It was moved, seconded, and carried to reelect Harold R. Crosser to the

Board of Trustees of Western Pilgrim College by acclamation.

Nominations from the District Council for a three year term for the Educational and Examining Board were: M. E. Turner and David D. Bailey. Brother Bailey was elected.

Committee appointments by the Superintendent and the District Council were read by Superintendent Quinn.
Ways and Means Item number 6 was read and adopted by motion.

The Resolutions Committee presented three more items.

Resolution Number 10, making the District Trustees and the Statistician permanent members of the conference, carried.

Resolution Number 11 expressing appreciation to Dr. Hawkins for his kindness and presiding skill carried with a spontaneous rising vote of thanks.

Resolution Number 12 carried.

A motion from the District Superintendent concerning cabin locations and deposit for the same was adopted by motion—(listed as Ways and

The Conference was adjourned by motion. Prayer was offered by Reverend Paul Eversole. Signed by the Secretary, Harold R. Crosser

CONFERENCE REPORTS

District Superintendent's Report

To our Chairman, Dr. R. C. Hawkins, Secretary of Church Extension, pastors, ministers, delegates, and our wonderful laymen and friends of the Fourth Annual Conference of the Pilgrim Holiness Church of the Arizona District, Greetings in the name of our Master.

New Churches Organized

Two new churches were organized this past year and are ready to be formally received by this conference.

Tucson Trinity:

In the north west section of the fast growing city of Tucson we have a commercial acre of land, six room parsonage and a lovely new 34 X 60 brick tile church building. Our 14 members deserve much of the credit for a job of building this new church building for less than \$8,000.00. **Prescott:**

Eleven months ago we started a new Pilgrim Church here in Prescott. We did not have any Pilgrim families to begin with. We do praise God for 15 members, a lovely parsonage and a very adequate church building. Rev. and Mrs. M. E. Turner have done a very splendid piece of work.

Flagstaff:

We are a fellowship in Flagstaff. Our Sunday School and church has been limited because of the lack of space to grow. However, the walls of our new 30 X 56 church are going up. Rev. and Mrs. Jordan have worked hard and it has been appreciated.

Tempe:

Our work here has suffered a setback. However, the future is brighter today than ever. 300 homes are being built across the street of our location. We are believing that Rev. and Mrs. Watkins will be able to present to this conference next year an organized church.

Church and Sunday School Growth

We praise God for the 39% gain or 175 numerical gain in our Sunday Schools and a 38% or 86 numerical gain in church membership.

Youth Work

Rev. Charles L. Cooper has done another splendid job with our youth. Youth camps really do pay.

Camp Ground

The work has been so hard and the load has been much too heavy but God has been so real to me in all of this undertaking. Our good laymen wanted to get on our own grounds so badly I could not let them down. I have asked 3 men to appraise our facilities and this is the replaceable cost, \$55,000.00. We owe approximately \$8,000.00. The hours of labor have been too many to report.

Church Improvements

Tucson First:

Buying new location, \$900.00 in that fund.

Tucson Parkview:

New three bedroom parsonage.

Tempe:

New steeple and chime system.

Apache Junction:

They have built and furnished the finest building in our church here in Arizona. Their 40 X 84 building has steel trusses. The workmenship throughout is superb. Thanks to Rev. and Mrs. Underwood and their aggressive laymen.

Cottonwood:

Building a new three bedroom parsonage.

Yuma:

They have put a steeple on their church.

New Works

Phoenix Mountain View:

Rev. Walter Cook is our pastor. This new church will be organized the first of September. We have purchased 3 nice lots located right for a church. Plans are to build a 33 X 72 red brick tile. This has the promise of a very strong church.

Tucson Southside:

We need a church in the south part of Tucson. There are a few Pilgrims families in that area. We want to open here some time this year.

Sunday School and Youth Report

To those assembled for the 4th annual Conference of the Arizona District of the Pilgrim Holiness Church, Sunday school and Youth greetings!

This conference is a high water mark in the history of our district in that we are privileged to meet for the first time on our own 20 acre camp grounds for which I personally say, "Praise God!" It is my sincere prayer that God shall dedicate these grounds and buildings with many souls finding Jesus Christ as their personal Saviour and others being led into a

finding Jesus Christ as their personal Saviour and others being led into a deeper life of entire sanctification. I know the forces of evil offer much opposition to my prayer, however, as Seth Cook Rees, a General Superintendent of our Zion once said, "If the devil should empty hell to overthrow us, God would, if need be, empty heaven to sustain us."

When I compiled the district Sunday school averages for the so called "summer slump season" of June, July and August of 1958, I was pleasantly surprised to discover the district showed a 50% gain over the same months of the previous year. It was then that I stated in the Reporter if we could show that size of a gain during the summer months then we could make the 1958-59 conference year an outstanding year of Sunday could make the 1958-59 conference year an outstanding year of Sunday school growth which we did by the help of God and hard work. I am pleased to report to this Conference the Sunday school department shows a 38% gain for the conference year and that we exceeded last year's con-

ference goal of 125 new Sunday school members by 50.

At this time it is only proper to honor the schools which helped to make the district growth possible. But first let me express my sincere appreciation to the new schools which have organized since last conference. These tion to the new schools which have organized since last conference. These schools have done an excellent job in helping the district to have a net numerical gain of 175 new Sunday School members for the conference year—undoubtedly next year several of them will be receiving the conference awards! First I wish to present the conference award for the highest numerical gain of 23 new members to Calvary Church; also, I am pleased to present the conference award for the highest percentage gain of 61% to the Apache Junction Church. The following schools will receive certificates of recognition for making a 20% or more gain in Sunday school attendance: Yuma (53%) Calvary (31%), Cottonwood (21%) and Wasteida (20%) Westside (20%).

Dr. P. F. Elliott strongly urged all schools in the denomination to give liberally in the annual Raly Day offering to defray the cost of operating General Headquarters Department of Sunday Schools and Youth. The district gave a total of \$85.00 which was a nice increase over last year. To promote the offering in the district, I offered a personal gift to the Sunday School superintendent of the school which gave the largest offering. Mr. Marvin Wainscott, of Tucson 1st, received the new study Bible.

Dr. Wm. H. Neff, General Superintendent of the Western Area of the

Pilgrim Holiness Church, was the speaker for the district Sunday School and Youth Rally held on December 5th at Phoenix 1st Church. It was during that rally that the district Sunday school and Youth projects for the year were presented. The Sunday schools were presented the "Race for Space" contest which was simply a way of enrolling new scholars by letting them know there was parking space for the family auto, space for the family in one of the churchpews, but most important of all, space to serve God and the community within the friendly circle of our church and its wonderful people. The district youth project was presented which was to build a youth fellowship hall on the new camp ground site. Both projects were very graciously accepted by the pastors.

The idea and materials for the "Race For Space" contest came from the Minister's Idea Kit, Golden, Colorado. The material and instructions to properly launch the contest were presented in 3 different zone rallies on January 13, 14 and 15. The district schools were divided into 2 teams, Atlas and Titans, "count down" began February 1, "blast off" Sunday was February 15th, and the contest continued through Easter Sunday. Each school was given an individual contest goal for enrollment; when it was reached, the school was in "orbit." For each school to get into orbit, the classes were given individual goals, thereby the entire Sunday School department had a part in the contest and growth. The Sunday School with the largest number of new enrollees from the contest was Phoenix, Westside. During the 7 weeks, Westside enrolled 33 new scholars I wish to give conference recognition to pastor Garth Shay and his Sunday School superintendent for not only a job well done but also to present this rocket which will be placed in the new youth fellowship hall with proper information printed on it.

The prices of the items necessary for the construction of a youth fellowship hall were assigned to each church in the district. If the monies were received then the work on the hall was to begin as soon as possible.

According to the district youth treasurer, Rev. Robert Seelig, a total of \$117.00 was received. So I recommend to the conference that we definitely accept the responsibility of finishing the construction of the hall and also make plans for attending the National Youth Convention in the summer, 1960.

A total of 94 enrolled for the 2nd annual district youth camp which convened from July 28—August 3 with a special invitation to young married couples to camp with us during the week end. A schedule of the day which included classes, recreation, entertainment and religious services was enjoyed by everyone. My sincere thanks to the several adults who accepted the entire responsibility of camp operations.

Plans were then begun and later presented to the council for a better organization and distribution of adult help. So, during the 6 zone youth rallies during the year, ideas, suggestions and assignments of responsibility were given. However, I wish more adults in the district will accept their part of the operation of the district youth camp by offering their services and planning to attend the camp for the choice blessings it renders to our

youth.

I realize this has been a rather lengthy report but then this has been an active year with nice results. May the goals presented by the District Superintendent, who is merely carrying out the wish of the General Conference, be accepted wholeheartedly so that when the Arizona District becomes a self-supporting fully organized district it will be the best in the entire denomination.

secretary at least 30 days prior to Conference.

VII. INASMUCH as public relations is a vital link in church and community life, BE IT THEREFORE RESOLVED that each church maintain a Public Relations Chairman, who will submit copy of local news events to district publications and local newspapers.

VIII. BE IT RESOLVED that the first 6 rows of seats, plus the platform be designated as the conference bar, and that this shall become a

standing rule.

IX. BE IT RESOLVED that laymen may serve on the District Council. X. BE IT RESOLVED that the District Trustees and the Statistician be

Report of Ways and Means Committee

I. INASMUCH as each church is expected to raise its share of the district budget, and as a systematic method of raising the budget, BE IT RESOLVED that a district budget offering be taken during one of the main services of the last Sunday of each month, and FURTHERMORE, that said offering be announced during the preceeding Sunday services. We recom-

mend that this resolution become a standing rule.

II. INASMUCH as several of our districts have a group hospitalization, surgical, and medical insurance plan, and since a number of the district pastors have expressed a desire for such a plan, BE IT THEREFORE RESOLVED that we accept the Blue Cross, Blue Shield group hospitalization, surgical, and medical plan. AND BE IT FURTHER RESOLVED that the churches pay \$5.00 per month to be applied to the pastor's premium, and the district pay \$5.00 per month to be applied to the District Superintendent's premium. This resolution is recommended first for discussion by the committee with the added recommendation that the lay delegation be given the privilege of discussion.

BE IT RESOLVED that resolution No. 6, under Ways and Means report of last year's conference, page 13 of Conference Journal be revised to read: "... the Arizona District pay 50% of the General Stewardship Fund this conference year, and 25% increase each succeeding year until the

district is paying its budget in full. . . ."

IV. BE IT RESOLVED that we build a fourteen room laymen's dormitory to be sold for \$150.00 per room, with \$25.00 deposit required on date of pur-

chase, with the balance to be paid within six months; with construction to begin upon subscription of all rooms.

V. INASMUCH as General Resolution No. 4, page 21, of last year's conference journal, has not been carried out, BE IT THEREFORE RESOLVED that a pastor's dormitory be constructed within the Conference year of 1960-61, with the following provisions:

(1) Rooms shall be approximately 10' X 12'.

The room prices shall be \$175.00 per room, except corner

rooms which shall be priced at \$200.00 each.

If additions to the building are made, those who make earliest purchases of corner rooms may have the privilege of either moving to the new corner of the addition or remain in the same room with a \$25.00 refund being credited on the district budget of the local church involved.

(3)The down payment shall be \$25.00 per room, with balance payable within 18 months of the 1959 conference.

These rooms shall be purchased and owned by the local church.

VI. INASMUCH as we need to finance the \$6,000.00 camp building program for the next five years to be retired at \$1250.00 per year at 6% per annum, all pastors are urged to go to their churches and begin immediately to encourage subscribers. The method of which will be \$1.00

per subscriber per month.

VII INASMUCH as the building of cabins will presently begin on the district camp ground, BE IT RESOLVED that all locations be assigned and approved by the District Council and that a five dollar deposit be placed with the District Treasurer with the necessity of paying this amount anually if cottage construction has not begun.

- 1. In order that the relatives and friends may know the set time for the ordaining of ministers, BE IT RESOLVED, that the Ordination Service take place at 4:00 p.m., the first day of Conference. (1957)
- 2. BE IT RESOLVED that the District Conference organize a Camp Meeting Committee to facilitate the handling of responsibilities preparatory to the Annual Camp Meeting. Said committee shall consist of the following members:
 - CHAIRMAN—whose responsibility will be to direct the operations of said Committee.
 - A. PURCHASING AGENT—whose responsibility will be to purchase supplies necessary for operation of the dining hall and the lunch stand.
 - B. ADVERTIZING AGENT—whose responsibility will be to publicize the Camp.
 - C. CAMP GROUND SUPERVISOR—whose responsibility will be to have oversight of the dining room, kitchen help and tabernacle.

- 5. The Educational and Examining Boards shall be combined and this Board shall consist of three members, one being elected for a period of three years, one for a period of two years and one for one year.
- 6. The local churches shall provide modern cooling, cooking and heating facilities for the parsonage, the type of facilities to be suitable to the locality where the parsonage is situated, and all churches in the conference shall pay the utilities for the parsonages.
- 7. Each local church is urged to raise a subscription list to the Pilgrim Heliness Advocate equal to its total membership.
- $8.\,$ The local church is to pay the traveling expense and entertainment of their pastor and delegate for the Conference business sessions. This does not include camp meeting.
- 9. There shall be a memoirs committee which shall annually list departed members by name, date of decease and church for inclusion in the conference journal. In the case of ministers there shall be a picture and a brief resume of ministerial labors.
- 10. The conference bar shall consist of the tabernacle platform and the first six rows of seats.
