#### DISTRICT SUPERINTENDENT'S REPORT

To the 42nd Annual Conference of the California District, Pilgrim Holiness Church, convened at East Pasadena church, June 22, 1964, greetings in Christ!
With deep Christian joy we report the following work in our churches for
this Conference year. We give thanks to God for His most gracious presence
and for the outpoured Holy Spirit's blessings upon our work.

#### On the Spiritual Horizon

In almost every respect this has been a gracious year. Most of our churches have had some type of revival or evangelistic emphasis, and I have also conducted several Spiritual Life Conventions during the year.

It is very encouraging to note the progress made this year. The Statistician's figures show that we have made a 7.2% gain in church membership; an 8.8% gain in average S. S. attendance, and in youth society membership this year, an overwhelming gain of 57%! This certainly rejoices our hearts and causes us to render projects to Cod for these gainst a resident with the second resident res

us to render praises to God for these gracious gains.

These gains have been made largely because our people have had a mind

to work, and the Lord has prospered their labors.

#### Temporal Progress

We mention here only those churches where building or improvement has amounted to \$300 or over in value. Other churches have made excellent progress in various ways. Some have paid more USF this year than last, and this is also deeply appreciated.

Adams Memorial is just ready to start their new church building program.

Beaumont has completed the interior of a new unit for their church.

Bell Gardens is planning to build an considerable addition onto their church for more church and S. S. room.

Buena Park is in the process of adding a S. S. unit and making needed improvements in their sanctuary. The Fentons are doing excellent work there, too.

Corona church has also made considerable improvements this year.

Dixon has seen its parsonage completed this year, thanks to Rev. Clayton Schletewitz and his father-in-law who did the work. The new building is valued at about \$15,000.

E. Pasadena has completed considerable work on their S. S. department this year.

El Monte has made considerable interior improvements in their sanctuary.

They have had a fine school year, too, in their elementary school.

Long Beach has placed new pews in their sanctuary this year. Although the pastor has not been well, the people have worked and it is remarkable what progress has been made there.

Los Angeles First church has made considerable improvements in their parsonage, and have completely redecorated it. Plans are under way to build a new church as soon as arrangements can be made for this.

North Redondo Beach has made all plans for a new building.

Pomona church has placed a nice parking lot out in front of the church, and made certain other helpful improvements.

Rees Memorial has made remarkable improvements in landscaping and has

made other improvements.

Riverside church has borrowed several thousand dollars. has added two much needed rooms onto their parsonage, and has done some helpful improving on the church grounds.

Rosemead has made improvements in the primary S. S. department.

Sacramento has connected city water to their church, with the gracious help of the community about the church.

San Dimas has been making progress in their building plans and should

soon be ready to break ground for their new church.

South San Gabriel has not built anything except a neat little nursery room this year, at a nominal cost, but the miracle here is in what has happened to the church itself. At Conference last year it was up for sale. Under the capable and God-blessed ministry of the Palmers, we were able to re-organize there the last of May. They reported about 33 members. Praise God for this remarkable work.

#### District Home Missions

This has been a very successful year in District Home Missions. We had planned to try to fortify what work we have, rather than open up more; however, as the year unfolded, God gave us some new works, for which we are grateful.

Beaumont has suffered the loss of the pastor, Rev. Haskell Robinson, who had to give up the work because of illness this spring. Rev. Seelig has been placed there as pastor and is getting hold of things nicely.

Los Gatos was fully organized last August. They have received several new members and are being brought into Conference as a fully organized church this year. Rev. Charles T. Elkins and wife have done a fine work as the new pastors, following the Parmenters who were there for about three years as the originators of the work.

Rialto was opened up last fall in the Hogle home, where weekly meetings were held for several months. This spring we were able to secure a building and start regular services. Rev. Fred Wells was placed as pastor by the District Council. In April, we organized there with eight charter members. They now have 10 members, with others to follow. Attendance has been encouraging. They are to be commended for their splendid financial strength. They have already begun to pay USF, even though they will not be admitted into Conference until at least a year later. They are also paying the pastor's traveling expenses and will likely begin paying partial salary for him soon. Besides, they are now setting aside 20% of all their regular offerings for their building fund.

This church has cost the District Home Missions fund less than \$300.00 so far. We deeply appreciate the several pastors who held services there in the early days, and the work of Brother Wells. We also appreciate the contribution made by the Riverside and Corona churches, from whose congregations some of the people came to help start this work.

Arcata, California, is far to the north, just beyond Eureka. This spring we received word from Rev. Gilman Welch there, through the good services of Brother Victor Klein, that he had a group interested in opening a new Pilgrim

church.

Early in April the District Superintendent visited there and found a blessed group of people, ready to unite with our church. Seven members were received

into the original membership, with others to be received later.

This is our newest church. So far there has been no cost to getting this work started, except the expense of my trip up there. We have here a fine group of deeply spiritual people and we look forward to a successful work there.

#### 500 Club

During a share of this year Rev. Haskell Robinson has represented the 500 Club in special services in our churches. Most of the churches were visited and the response has been appreciated. Brother Robinson did all this work gratis. We paid only his travel mileage.

A word of due appreciation also goes to Rev. L. B. Smalley who has collected the funds for the 500 Club during the year. Assisting him was Mr. Bud Lester,

who did much of the clerical work.

#### District Property

We were able finally to get the District property sold last fall and winter. The Treasurer's report will show financial figures, but it cannot show the long, hard hours of work and headaches and the time it took to get this finished to the present.

The money received from this sale has been duly placed in Crown Savings as directed by last Conference. Two loans have been made from it. The Board of Directors found, however, after more careful study, that if we continue to use the program set up at last Conference for loans, we will soon exhaust the funds and have only a few churches helped. After careful study and advice from various persons and financial institutions, we are offering a completely new plan of operation for the Loan Fund, whereby it will be available only on short term loans. Upon the completion of a project for which it is borrowed by a church, that church will secure a real estate loan, and the District Loan will be repaid to the Fund. In this way, many more churches can be helped by the Fund. This new plan will be presented, as outlined by the Board and written up by our attorney.

#### Personal Remarks

This has been a gracious year for us as we have traveled from church to church. Mrs. Deal has been able to accompany me and add a blessing to the services from time to time, as she ministered in Sunday School or youth services.

Despite the fact of years of service in this work, it has taken a share of this year to get really adjusted to this District and the work here. Pastors realize that when going to a new charge, almost a year is required to get one's feet down and really get adjusted to the new work. It is little different with a District Superintendent. The first year is quite largely a year of adjustment and re-adjustment, for both the Superintendent, the pastors, and the churches. The pastors and churches have received us most graciously everywhere. We are deeply grateful for this, as it has made our work much easier.

Much time has been taken up this year with property affairs, which hereafter will not be so. Despite this, I have held numerous meetings in the District. All outside meetings have been cancelled, except a summer camp, and I have given my whole time to this work, not even taking the extra meetings which

I have also appreciated every committeeman on all the District committees and boards, who have worked so faithfully during the year. They have done a very commendable work. Special thanks are due to Mrs. Marianne Troyer, who has edited and put out the California Pilgrim this year. Her unselfish service is deeply appreciated.

Together let us look forward to a most gracious year of victory in Christ as we face the coming year. It will be filled with a thousand opportunities, beset by unnumbered trials, but also freighted with untold blessings. We accept its challenge in the name of our Christ, and in His name set our banner for-

### REPORT OF THE DISTRICT YOUTH PRESIDENT

To the members of the Annual Conference of California District of the

Pilgrim Holiness Church, convened at E. Pasadena June 22, 1964.

Another year of youth activity is history. In many ways this has been the most faithful and productive Youth Council with which I have worked; they have matched a vision of the needs with a proposed program to meet those needs. This conference will do much to determine the eventual effects of this planning.

The Central zone has exhibited a much improved program; the Western zone has had an encouraging increase in participation; the Northern and Eastern zones have maintained an active and well-supported program. A hearty thanks to Marianne Troyer, Rev. James Crowder, Marcia Fain and Sarah Smalley for the fine work they have done as zone chairmen. Rev. Gene Lee accepted the position of treasurer after the year was well under way; I appreciate the excellent job he has done under difficult circumstances. Special recognition is due Evangeline Deal for her effective and efficient service as secretary; her contributions to the Youth Council are deeply appreciated.

Several promising programs have been initiated during this past year. A Christian Education Conferette was conducted in conjunction with the Sunday School Committee; this was of great value to all who attended. Plans for Youth participation in our coming Camp Meeting include concerns for the spiritual, social, physical and intellectual growth of our young people. Youth Camp plans have also been greatly altered; it is anticipated that this new approach will improve participation and strengthen the total youth camp program. Growing concern for our "college and career" young people has led to planning a special youth camp for them to run concurrently with our family Labor Day Camp.

#### Statistical Report

During this past year I have presided at eleven meetings of the District Youth Council; attended fourteen committee meetings relating to youth work; made fifteen visits to churches; conducted two district rallies; made nine visits to zones for rallies or organization; traveled in excess of 2,500 miles; written letters and made telephone calls too numerous to tabulate.

I regret that precedent requires such a statistical accounting be given because such reporting emphasizes activity not accomplishment. Such reports attempt to tell what the church or its representatives have done when our first concern should be what the church is or should be. Indeed, there is often the tacit implication that more miles, more meetings and more committees will guarantee an improved program. Success should be measured in terms of objectives; our basic goals have been, and are, both laudable and Scriptural, namely, making men fit for heaven and better men as they journey toward heaven. Our means of attaining these goals, however, need constant re-examination. We must ask: Are our present plans, programs and organization those best calculated to reach our goals? While we must be constantly alert to the danger of substituting a program for purpose, we must also avoid the opposite problem of having pious ends but no programs for making them realities. Thus, the challenge that faces our youth, our district and our denomination is this: we must develop a program and organization that is geared to meeting present problems and at the same time it must be redemptive in meeting constant and eternal needs. In planning such a program we must combine a passion for the lost with a compassion for the needy; we must distinguish between Biblical requirements and man-made traditions; we must substitute meaningful answers for pious platitudes; we must emphasize the spirit of Christ as we search for Christian solutions to the problems of today. We must stress meaning over meetings, men over miles, commitment over committees. We cannot continue to confuse rigidity with firmness; we must distinguish between principles and the status quo; we must recognize that what is old must receive the same careful scrutiny we give what is new; we cannot assume that what is, is right.

The future will only be bright as we work, under God, to make it so. At the national level we have fine leadership with a real grasp of the magnitude of the problems before us. I trust California will be in the first ranks of those supporting the imaginative reorganization and full orbed youth program now being suggested.

As I leave the office of district Youth president, I trust that my successor will have your prayers and support; I pray that seeds planted during these last ten years may yet bear fruit.

### DISTRICT SUNDAY SCHOOL PROMOTIONAL SECRETARY'S REPORT

To the members of the 42nd annual conference of the California District of the Pilgrim Holiness Church convened at East Pasadena, California June 22, 1964.

Greetings:

We would like to take this opportunity to thank each of you, and the officers and teachers of our local Sunday Schools, for the cooperation over the past year. I deeply appreciate the understanding and patience of everyone who took into consideration the handicap under which we laboured. We sought to accomplish, as promotional secretary, in seven months what should have taken a full year.

Shortly after having been appointed promotional secretary we rushed into the annual Superintendent's banquet. This was a success because of the fine committee with which we were privileged to work. The banquet was well attended and we shall long remember the message given by Dr. Clinton Jones.

The spring victory night banquet at Clifton's Cafeteria was also well attend-

ed. I am certain everyone enjoyed the evening and will long remember the

The major emphasis of the committee over the past few months was that of conducting Sunday School Seminars. #### DISTRICT MISSIONARY SOCIETY PRESIDENT

June 1, 1963 to May 31, 1964

To the Annual District Conference, Greetings:

Our new year began with camp meeting activities. It was a joy to take the responsibility of making the beds for the District guests, with all our new

bedding that the missionary societies had furnished. Also towels and wash cloths. Thanks to our societies.

Then our missionary room demanded our attention throughout camp. We greatly appreciated Mrs. Ruby Tschinkel assisting in the arrangement of the room. A number of the societies brought in posters and a display of things

they made throughout the year.

Our District Committee being responsible for the missionary services each morning from 9 to 10 A.M., and one morning service from 9 to 12 A.M., and presidents' luncheon at 12 noon, kept us busy throughout camp. All missionary presidents reported during the morning, each one telling of their activities during the year. These services were especially good with Rev. and Mrs. Charles Lewis and Rev. and Mrs. Paul Downey from Brazil. Every minute was enjoyed. The minutes were not long enough. #### RESOLUTIONS OF THE 1964 CONFERENCE

#### Ways and Means Committee

No. 1—This resolution to rescind resolution No. 2, page 28, of the 1963 Minutes was lost; therefore, the 1964 conference authorizes full payment of the District parsonage loan from Revolving Loan Funds.

No. 9—Whereas a great portion of the income from the "500 Club" has been expended in promotional work, therefore be it resolved that the District Superintendent shall present the "500 Club" program and enroll members in the club as he visits the churches.

No. 10—Whereas there have not been equal payments made to each delegate to the General Conferences in the past; therefore be it resolved that each delegate to each International General Conference be allowed the same pro-rated amount; to be calculated before any delegates are elected. The amount is to be calculated to cover the average travel cost from the central part of the California District,

No. 11-Tabled.

No. 12-Lost.

No. 13—Be it resolved that promoting, collection, recording, and reporting of the "500 Club," be placed under the direction of the District Missionary Society. And be it further resolved that the District Missionary Society shall work through the local church Missionary Society to implement this program.

No. 14—Be it resolved that the Revolving Loan Fund be governed by the

following By-Laws:

### By-Laws Governing the California District of the Pilgrim Holiness Church Loan Fund

#### Purpose

1. The California District of the Pilgrim Holiness Church shall maintain a fund to be known as the CALIFORNIA DISTRICT LOAN FUND. The purpose and use of this fund shall be to lend money to churches in the California District under the supervision and jurisdiction of the California District Council for the purpose of construction, relocation, improvement, and repair of church buildings and parsonages. No loan shall be made for a period of more than 12 months except upon approval by a 2/3 vote of the Board of Directors.

#### Control

- 2. This fund shall be under the control of the District Council, also known as the Board of Directors.
- 3. The District Treasurer shall maintain this fund in the Crown Savings and Loan Association of El Monte, California, in a separate account from all other funds of the church. The District Superintendent shall be Chairman of the Board of Directors. He shall carry on all correspondence relative to this fund. All monies shall be paid through the office of the District Treasurer, and he shall keep all records and papers of same.
- 4. The District Council shall govern the size of the loan by the funds available and the value of the property on which the loan is to be made.

Composition

- 5. This fund shall be accumulated from monies received from the sale of the District Headquarters property, sale of other district properties not otherwise designated for other purposes, special contributions and low interest loans, or investments by individuals.
- 6. All monies collected as interest shall be added to the capital of said fund. No gifts shall be made from this fund for any purpose, nor shall it be used except for making loans.

#### Processing

- 7. The directors shall prepare an application form to be filled out by the church making application for a loan. The note and mortgage shall be signed for the church by the local trustees, if any; the pastor, district superintendent, and district trustees. It shall be secured by a mortgage on the property and such other security as may be required by the directors. Loans shall be made only when title to such property is written according to the Manual of the Pilgrim Holiness Church or is vested in the California District of the Pilgrim Holiness Church.
- 8. All applications are to be made by the local trustees and pastor on behalf of the local church after they are instructed to do so by the local church board. The application shall then be submitted to the District Council for consideration and disposition. A committee from the District Council shall investigate the property on which the loan is to be made. The investigating committee shall then report their findings to the District Council and a two-thirds vote of the entire council shall be necessary to grant a loan. All checks drawn on this fund must bear the signatures of both the District Superintendent and the District Treasurer.

#### Repayment

- 9. Interest at the rate of 5.5% per annum will be charged on all loans. Full repayment shall be due at the end of the loan period. The District Board of Trustees shall be empowered to negotiate a real estate loan for the local church at the end of the loan period, if necessary.
- 10. These by-laws governing the CALIFORNIA DISTRICT LOAN FUND may be changed by a two-thirds vote of the District Conference. Such changes shall not be retroactive.

No. 15—BE IT RESOLVED that the District Sunday School Committee, the District Missionary Society and the District Youth Society prepare their monthly financial report in triplicate, one copy to be mailed to the District Secretary for the benefit of the District Council, one copy for the chairman of the organization and one copy for the permanent record with the treasurer's books.

This financial report shall include a balance forward. It shall specifically indicate source of income. It shall include a detailed account of expenditures. Also included will be a checkbook balance, the amount of cash on hand, and a list of all outstanding bills with the amount of each.

BE IT FURTHER RESOLVED that one copy of each report of the above named departments shall be sent to the District Superintendent and the Auditing Committee chairman.

The Ways and Means Committee shall prepare report blanks for use by the

various departments.

No. 16—BE IT RESOLVED that the last Sunday afternoon of camp meeting be given to a Home Missionary service and that an offering of cash and pledges shall be taken.

No. 19-BE IT RESOLVED that greetings be sent to all the missionaries now serving under appointment abroad, who hold membership in this district.

#### STANDING RULES AND BY-LAWS

#### Annual Conference

1. The time for conference sittings shall be as follows:

9:00 a.m. to 12:00 noon; 2:00 p.m. to 4:30 p.m., and 7:00 p.m. to 10:00 p.m. 2. A Conference Registrar, appointed by the District Council, shall assume his duties at the place of conference one hour prior to the opening of each session of the Conference and shall register all members of the Conference and all duly certified lay delegates, presenting each member or delegate with a badge admitting him within the conference bar. The Conference Registrar shall receive and record the certificates from the lay delegates and shall present the list of registered delegates to the Conference Secretary prior to the opening of each session of the Conference

The chairman of the Statistical Committee shall present orally the follow-ing highlights from the Statistical Committee report: total number of seekers, membership, Sunday School attendance and the financial summary of totals by departments. This entire report shall be posted before the fourth sitting of the Conference.

4. The ordination service shall be conducted in a special service at the beginning of the evening sitting on the first day of Conference.

5. The District Council, the Resolutions Committee, the Ways and Means Committee, the Educational Board, and the Examining Board shall meet one day prior to the Annual Conference to take care of such work as they have on hand.

6. When recommendation for credentials is presented to the Conference the candidate shall be present or send a written testimony to accompany the

recommendation.

7. Each local church delegate shall be reminded of and shall abide by the following requirement found in Section 92, Paragraph 3, of the Manual: "All delegates shall pledge themselves to their local church that they will stay until the close of the annual conference unless called home by sickness or death." Further, that such delegates pledge to attend all sessions.

8. Since local church lay delegates are required by Manual to stay until the end of conference, all who hold credentials in the California Conference.

shall also feel obligated to conduct themselves in like manner.

#### Conference Committees

1. The financial records of all departments of the Conference shall be submitted to the District Auditing Committee at least three days prior to the District Conference. This includes District Treasurer, District Youth,

Sunday School Committee.

2. The Conference Sunday School Promotional Secretary or his representative shall have the privilege of holding two services annually in each of the churches of the Conference in the interest of the work of the Conference Sunday School Committee and an offering shall be taken in said service and forwarded immediately to the Conference Treasurer being specified as an offering for the Conference Sunday School Committee.

3. All licensed ministers and deaconesses shall be notified in advance of Conference to meet with the Educational and Eventing Boards on the Sature.

ference to meet with the Educational and Examining Boards on the Satur-

day previous to Conference and in the event it is impossible to do so they shall notify these boards in writing. If there is no response it will indicate to the Educational and Examining Boards that the licentiate is not interested in his or her credentials.

4. The Ways and Means and Resolutions Committees shall meet 30 days prior to Conference and mimeographed copies listing all resolutions shall be placed in the hands of all delegates no later than 10 days prior to said District

Conference.

5. A permanent committee known as the District Stewardship Committee, shall be established to investigate and provide material in the area of tithing for the education of our people. This committee shall be comprised of the following officers: District Superintendent, District Sunday School Promotional Secretary, District Youth President, District Missionary Society President. This committee shall make a report of its activities to the annual conference.

6. The Conference Scholarship Committee shall be appointed by the District Council for the purpose of raising finances for a District Scholarship Fund. This committee will serve in the examination and recommendation of worthy students to receive help from such funds. Said committee is to be amenable to the District Council and all final appointments are to be subject to Coun-

cil approval.

7. It is recommended that all plans for construction or remodeling of church buildings and parsonages be presented to the District Building Committee for their suggestions. Said committee shall be appointed by the District Council. (1963)

#### District

1. The following items shall be paid out of the District expense fund: Utilities for the home of the District Superintendent; Publication of the California Pilgrim; District office expense.

2. The cafeteria shall be considered part of the camp meeting operations and all monies pertaining thereto shall be held in the camp meeting fund.

3. This Conference shall list inactive ministers according to the interpretation of the General Board with reference to Section 178 of the Manual. "We understand by the term 'active and regularly engaged in the work of the ministry,' to mean pastors with a regular appointment and full time evangelists and to ministers who are under special appointment. reference to the aged ministers we suggest that only those above 65 years may be so classified."

4. The following sums shall be allowed the District Secretary and the Dis-

trict Treasurer for their services:

District Secretary—\$ 25.00 per quarter; District Treasurer—\$100.00 per quarter.

5. This conference shall accept and adopt a goal of \$5.00 per member per year in support of Central Pilgrim College. The basis for determining membership responsibility for the above-mentioned goal is to deduct 10% from the total voting membership of the church. Each church shall receive an offering for Central Pilgrim College at least once each month as a means of reaching the above goal. (1963)

6. The District Youth President or his representative shall have the privilegement.

6. The District Youth President or his representative shall have the privilege of holding two services annually in each of the churches of the District in the interest of the work of District Youth and an offering shall be taken in said service and forwarded immediately to the District Treasurer

being specified as an offering for District Youth.

7. The full membership of the district shall covenant to daily hold up the hands of District leaders and officers with prayer and supplication.

8. The following dates shall be set for District functions:

Conference—the third Tuesday and Wednesday of June. Camp Meeting-the third through the fourth Sunday of July. Summer Camps—Labor Day weekend and the preceding three weeks.

Pastors' and Leaders' Conference—during camp meeting week. District Home Missions Emphasis—the month of September. District Stewardship Emphasis—the month of November.
District Ministerial Convention—in the last full week of February. Pastors' Retreat-during the week preceding Easter.

Annual Sunday School Banquet-in the month of May. (1964)

9. A system to raise finance for District Home Missions shall be established. This system shall be known as the District Home Missions 500 Club, the purpose of which shall be to secure subscriptions to the 500 Club-individuals who will pledge themselves to give \$1.00 per month for the establishment of new churches in California. The District Superintendent shall

solicit members during his visit to the local churches, and an offering for District Home Missions to be taken at that time.

10. The Office of Public Affairs of the National Association of Evangelicals shall be authorized to speak for the California District of the Pilgrim Holiness Church on all legislative matters that are of vital interest to

Christian citizens.

11. All correspondence with the General Missionary Society Director at head-quarters, including reports, shall be directed to the District President, who will in turn relay the information to headquarters and/or secure an answer in return. The ONE EXCEPTION to the above rule relates to the correspondence concerning MISSIONARY CHRISTMAS BOXES, which should still be carried on directly with headquarters.

12. Proceeds from the sale of the entire District Headquarters property shall be placed in a separate fund to be called a Revolving Loan Fund. (1963)

13. Each standing rule shall be dated, such date to be its origin or last revision. A reporting committee shall be instructed to prepare said dating within one year.(1963)

#### District Council

1. The District Council shall be informed of all matters of major legislative

change prior to presentation to the conference.

2. The District Secretary shall be informed immediately upon the death of any pastor or pastor's wife of the district and he shall notify by telephone all pastors in the district and notify the editor of the district publication.

3. An honor system for recognition of churches who pay their United Stewardship Fund shall be established and a chart be compiled by the District

Treasurer and displayed at the District Camp and Conference.

4. The District Secretary shall give written notification to all appointees to standing conference committees within 30 days after District Conference. The chairman of each standing committee shall be notified by the District Secretary 60 days prior to District Conference to activate his committee.

5. Ministers coming to this District from other denominations shall be interviewed by the District Council before their credentials are presented to

the Conference.

6. The District council shall be empowered to acquire property at a proper location, and to build a district office which shall adequately meet our needs. (1963)

#### District Superintendent

1. The District Superintendent's salary shall be \$4,500.00 per year in addition to his residence, utilities, traveling expenses and automobile mileage at seven cents per mile.

2. The District Superintendent shall be given an annual two-week vacation

with pay.

3. The District Superintendent shall arrange for an annual Pastors' Retreat. 4. The District Superintendent shall call a meeting of all District leaders and pastors for the purpose of introducing the programs of the various departments for the coming year. (1964)

5. The District Superintendent, in cooperation with youth zone leaders and

heads of departments of the District Conference, shall formulate a district calendar and place same in the hands of each pastor and department head of this district; each youth zone leader and district department head shall prepare and send his annual schedules to the District Superintendent prior to the Pastors' and District Leaders' Conference during camp meeting week. (1964)

#### Local Church

All local churches shall pay the traveling expenses and entertainment of their delegates for the Conference business sessions.
 All local churches shall forward to the District Council for filing all legal

papers pertaining to the ownership of the local church property.

3. Each pastor shall be granted the privilege of holding at least one revival in each Conference year.

4. All reports shall be made in full and sent to the Statistical Committee not

later than one week before the Conference date.

5. Each local church shall be urged to raise a subscription list to the Pilgrim Holiness Advocate equal to its total membership.

6. The Conference Minutes shall be sold at \$1.00 per copy and each church

- to the members for the stipulated price. 7. Pastors are urged to secure Pilgrim Holiness evangelists as much as possible. Evangelists from other denominations shall be secured under the
- District Superintendent's approval.

8. Each pastor shall receive an annual two-week vacation with pay.

- 9. Each church shall pay the assessment fees of the pastor and wife who are members of the Ministerial Benefit Association.
- 10. The conference shall use the following method of renewing pastoral relations:
  - a. That each church when renewing pastoral relations, shall vote during the last full week of March.
  - b. That each local church secretary shall forward to the District Superintendent the results of such vote within five days following the time of voting.
  - c. That each pastor shall forward to the District Superintendent his reply within 15 days of the time of voting. (See 1962 Manual, Section 53, Paragraph 3.)
  - d. That each pastor who does not plan to renew pastoral relations shall notify the District Superintendent on or before the 15th day of March.
- 11. We recommend that before licensed or ordained ministers coming from outside the California District, or from other denominations, he received into local church membership, the pastor shall consult with the District Superintendent and the District Council regarding said minister.
- 12. All Sunday Schools shall conform to the General Sunday School Department's "Standard of Excellence" with respect to computing Sunday School attendance.
- 13. Local churches calling pastors from outside the confines of the District shall pay the necessary expenses involved in the changing of automobile license and registration. (1963)

#### United Stewardship Fund

- 1. The Manual of the Pilgrim Holiness Church which reads as follows shall be enforced:
  - "Any church or pastor failing to raise the United Stewardship Fund without good reason shall be denied a voice in the annual conference."
  - 2. Newly organized churches shall assume one-fourth of their United Stew-

ardship Fund the first year after being organized, one-half the second year, three-fourths the third year, and beginning with the fourth year, pay in full.

3. The following system of finance shall be followed, in caring for the United Stewardship Fund obligations of each local church:

Twelve percent (12%) of all offerings received by the local church in all departments (EXCEPT all specified funds raised for the construction or acquisition of the church buildings or property, Sunday School units, and parsonages; the 500 club, and for all specified purposes outside the California District) shall be remitted by the local treasurer(s) each month to the District Treasurer.

The District Treasurer shall distribute within 30 days after receipt the

funds received in the United Stewardship Fund as follows:

BE IT RESOLVED THAT whereas there exists a need on the local level for counsel and help in all areas of Christian Education, such as Sunday Schools, Youth work, Leadership Training, and Vacation Bible Schools; This District Youth Conference recommend to the 1964 Annual District Conference that the position of District Director of Christian Education be es-

tablished.

9. BE IT RESOLVED THAT the District Council be requested to print the Minutes of this 1964 District Youth Conference in the District Journal and Minutes of the District Conference. In addition, it is requested that the District Youth bear the cost of such printing on a per page basis this year and each year hereafter.

#### STANDING RULES AND BY-LAWS

#### Annual Youth Conference

No. 1-All reports to the District Youth Conference shall be submitted to the District Youth Secretary one week prior to the Conference.

No. 2-All reports to the District Youth Conference are to be prepared in triplicate: one copy to go to the District Youth President; one copy to the District Youth Secretary; one to be retained by the local society. In reference to the local society, the society president's report shall be given to the society secretary and the Zone Chairman's report to the zone secretary.

No. 3—The date of the Annual Youth Conference shall be set by the District Youth Council and the Annual Youth Banquet shall be held the evening before the Conference, thus combining these two vital items relating to the youth of the California District.

#### District Youth Council

No. 1—Where at all possible, no one person should hold two offices on the District Youth Council.

No. 2—The District Young People's President shall send a written quarterly report to the District Council covering his activities, those of the zone leaders, District Youth Treasurer, and Pilgrim Youth Camp Chairman or Activities of Youth Camp Committee.

No. 3—The District Youth shall hold a quarterly workshop for the purpose of: (a)—exchanging programs and ideas for youth services; (b)—discussing methods of working unsaved youth into young people's services; (c)—discussing problems relating to local youth societies.

No. 4—The Picayo editor from California District Youth shall be instructed to send news items each month to the Pilgrim Youth News.

No. 5—The official name "Pilgrim Youth Society" shall be used on all materials and in all oral communication.

No. 6—The District Youth Council shall be urged to approach the District Sunday School Committee to cooperate in District Christian Education planning. Such group would present to the District Council their suggestions for the implementation of a total Christian Education Program to the local churches.

  - C. Procedure to be followed in filing accident reports and insurance claims.
  - D. Cleanliness requirements for kitchen, dining hall, dishwashing facilities rest rooms and shower rooms.

  - F. Holding fire drills.
  - G. Distribution of mail.
  - H. Holding basic course for counselors (prior to camping season).

No. 3-In case the zone chairman is incapacitated in any way, the Executive members of the District Youth Council along with the District Super-intendent, shall appoint his successor. No. 4—Each zone treasurer shall pay to the District Youth Treasurer 10%

of all offerings taken at zone rallies.

No. 5—Within 60 days prior to the Annual Youth Conference, the District Youth President shall meet with the regular delegates of each zon to elect officers for that zone. These elections shall be considered preliminary and upon presentation by the Youth President, shall be ratified by the Youth

Conference. Such officers shall take office immediately following the Youth Conference.

No. 6—The Dixon, Sacramento and Fresno area societies shall be called the Capital Zone. As result of the 1962 Youth Conference, Los Gatos is added to this zone.
