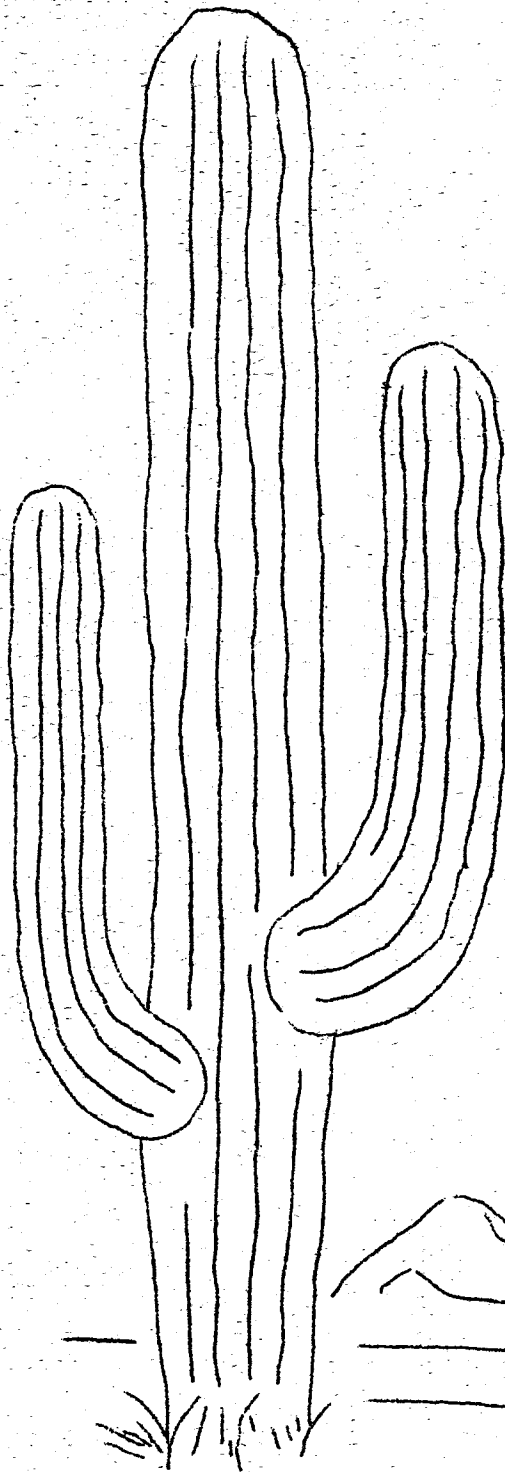

CONFERENCE PROCEEDINGS

First Sitting

The twelfth annual conference of the Arizona-New Mexico District convened at Phoenix First Pilgrim Church at 9:00 A. M., May 23, 1967.

The host pastor, Rev. M. E. Turner, welcomed the conference.

Rev. Neil Bailey led the congregation in singing, "Lead on, Oh King Eternal" and "Oh, to be Like Thee".

Rev. Melvin Lockard read a scripture from Psalms 1 and 2. Prayer was offered by Rev. R. W. Brown.

The Church Extension Secretary, Rev. W. N. Miller, brought greetings to the Conference and words of appreciation.

District Superintendent, John Dunn, presented the General Superintendent of the Western Area of our Church, Rev. J. D. Abbott, who brought greetings from the General Church and then addressed the conference.

General Superintendent Abbott read from II Thessalonians 3:1 which expresses Paul's attitude toward the spread of the Gospel and also presents the awesomeness of our responsibility. His message emphasized two important facets of the Church:

It is the FINEST OF FRATERNITIES
It is a wonderful fellowship.

It is the FRONTIER OF FAITH
Paul, in asking for prayer for himself is praying for
the Church too, that our faith will provide:
Free course for the Word
Fetters broken by it's power
Fruitful carrier for the Word

This inspiring message was appended with a prayer to God to fulfill this challenge in us.

The roll call was heard and 41 ministers and delegates answered present. A motion carried to seat Emma Summers as a second delegate from Apache Junction.

A motion carried to establish the conference bar and all voting members of the conference were seated in it's confines.

District Superintendent, Dunn, introduced two new ministerial members to the conference: Rev. Arthur Hunter and Rev. Walter Cook. Rev. Hunter comes from the Church of Christ in Christian Union and Rev. Cook comes from the Wesleyan Methodist Church. The motion to seat these brethren was affirmed.

It was moved and carried to have the first sitting close at 12:00 and the afternoon session to begin at 1:30 P. M. and continue until business is concluded.

Ushers appointed were: Vernon Brown, Neil Bailey, and Bob Langenfield.

District Superintendent Dunn's address and personal report was given, punctuated with admonition that was pertinent and pointed. It was received enthusiastically by a rising vote.

Rev. Melvin Lockard, Assistant Superintendent, gave a very unique report and expressed his appreciation for being able to work with Rev. Dunn.

The Auditor's Report was read and attested to the correctness of the District Treasurer's Books.

Denzel Clouse gave the yearly Treasurers Report including the Financial Statement of our District Corporation, which was received by motion. The total report was received by motion and with praise for it's clarity and comprehensiveness.

Rev. Abbott expressed appreciation for the 250% increase in our giving to the United Stewardship Fund. He presented the Board of General Superintendent's Certificate of Recognition to the Apache Junction Church for paying 88.9% of it's U. S. F. budget and to the Tucson First Church for paying 87.7% of it's U. S. F. budget.

The District Sunday School Promotional Secretary gave her report using a graph of District Sunday School activity to high light the year. New materials for the use of the local Sunday Schools in reporting were presented. Rev. Barefoot gave a resume of the District Sunday School special occasions. A motion carried to accept both this report and the challenge presented.

The Missionary Society President, Faith Turner, gave a brief report supplementary to the written report given in the Missionary Conference. Her report was accepted by motion.

Rev. David Miller presented the Statisticians Report. He read only the summary report to the Conference. The full report will appear in the statistical portion of the minutes. The report was received by motion.

A motion was made to reconcile the difference between the Promotional Secretary's Report and the reports sent to the Statistician by declaring the Promotional Secretary's Report the official report of the Conference for Sunday School Statistics. The motion carried.

The conference heard the report of the Educational and Examining Board which was accepted and approved by motion.

Rev. W. N. Miller presented, in behalf of Rev. R. A. Beltz, the Pension Plan of our denomination. The annual financial report was read. A packet of information was given to each minister.

A motion carried to make the first order of business at the second sitting, the election of officers.

The morning session concluded with announcements and prayer.

Second Sitting

After opening the session, Rev. Dunn announced the churches that qualified for the dollar per scholar award for pastor and superintendent, which is the price of a steak dinner.

Denzel Clouse presented forms for delegates travel expense.

Rev. W. D. Shelor was introduced to the Conference and by motion was given the privilege of sitting within the bar.

The election of officers, being the "order of the day", was expedited as nominations from the Council were voted on with the following results:

Melvin Lockard was elected Assistant Superintendent on the first ballot.

M. E. Turner was re-elected Secretary on the first ballot.

Denzel Clouse was re-elected District Treasurer on the first ballot.

Neil Bailey was re-elected as Advisory Member of the Council on the second ballot.

Elwood Hunter was elected for a three year term to the Board of Trustees on the first ballot.

For a three year term on the Educational and Examining Board, Arthur Hunter was elected on the first ballot.

Rev. Abbott presented the plan for electing delegates to the International Conferences to be held in Anderson, Indiana, June, 1968. We will elect one minister and one layman to the Pilgrim International Conference and one minister and two laymen to the merging International Conference.

On the second ballot, Melvin Lockard was elected as Ministerial Delegate with M. E. Turner to serve as alternate.

On the first ballot, Denzel Clouse was elected to serve as lay delegate. He will represent our district at both the Pilgrim and the Merging Conferences.

On the second ballot, Charles Long was elected as lay delegate to the Pilgrim and the Merging Conferences. The alternate lay delegates are Kenneth Artz and Elwood Hunter.

A motion was made to express our thanks for the fine way that General Superintendent Abbott conducted our Conference and represented the General Church. (Carried).

The Memoirs Committee made its report concerning those who departed from our midst during this past conference year, who were members or friends of our churches. The report was accepted with a standing tribute and prayer by W. N. Miller.

Second Sitting (continued)

The Conference Action Committee brought it's report and all eleven resolutions were passed except #5. A substitute motion for #5 was made as follows:

"BE IT RESOLVED, that all licensed and ordained Ministers and Deaconesses shall pay \$2.00 at the time each receives his or her annual pocket credential." A motion to table this matter (both the amendment and the initial resolution) was carried after a period of discussion.

It was moved and carried to have any unfinished business and the minutes of the sessions to be cared for and approved by the District Council.

Rev. Lockard distributed some Youth Camp materials and information to each pastor and urged their use in the months before Camp.

A final resolution from the Conference Action Committee was approved as follows:

"BE IT RESOLVED, that the Conference extend our thanks and appreciation to Church Extension Secretary, Rev. W. N. Miller, not only for his chairing, in part, this conference, but for his able supervision of the Church Extension work throughout the year." This resolution was accepted by a rising vote of thanks.

The conference adjourned with the feeling that the business of our district had been dealt with carefully and courageously, and that God is to be praised for every gain and good.

CONFERENCE REPORTS

ADDRESS OF THE DISTRICT SUPERINTENDENT TO THE DISTRICT CONFERENCE SESSION--May 23, 1967

To the twelfth annual conference of the Arizona-New Mexico District of the Pilgrim Holiness Church, to our General Superintendent, Reverend J. D. Abbott, to our General Secretary of Church Extension, Reverend W. N. Miller, ministers, delegates and friends; Greetings in the name of Christ.

Permit me to begin my report by giving thanks first of all to God for giving strength for duties assigned by the conference. I have endeavored to "wait on the Lord" and He has surely "renewed my strength". We would also be ungrateful if we did not thank the General Church for their assistance, patience and understanding of our Mission Conference. The Department of Church Extension has given counsel and direction through its leader, Reverend W. N. Miller. The District Council has worked very cooperatively together for another year. They have served, asking nothing for themselves, but only to serve the Lord through the district. Various district committees have served faithfully and we are thankful. Certainly our lay people have shouldered the necessary responsibilities of the local churches and we thank God for everyone of them.

Permit a brief word about some achievements. We have consolidated in-so-far as we know, all of our property holdings. The Camp Ground debt is history. The Treasurer's report will show another significant increase in income while we have held expenditures to a minimum. Our giving to the United Stewardship Fund is $2\frac{1}{2}$ times greater than last year. It is interesting to note, while the Department of Church Extension gave our conference a total of \$7,200.00 last year, we gave to General Church Interests a total of \$6,032.42. Added to this is \$564.19 given to Central Pilgrim College.

Let us move on to areas that need improvement and special attention in the churches. We need an INCREASE IN FAITH that will believe God for an enlargement of our churches. Let us, as a district, set aside the first Saturday night of each month to pray for such an increase of faith. We sorely need an INCREASE IN WORKS that will not only bring about a loyalty to God but also the Pilgrim Holiness Church. Of course, our first responsibility is to work for God in the local vineyard. As the local church prospers, the district will become stronger. As our district gains strength, we will enhance the stature of the General Church. In keeping with this, we need to be wider awake in securing new members in our churches. Also, I think the least we can do is to give our people opportunity to participate in every denominational offering. We need to promote our Zone College in a greater way. We need to solicit wills, annuities and special gifts from our people for the local church. Several churches need to think about expanding their facilities for future growth. Special gifts will help greatly in this endeavor. May I add, if we don't, other worthy interests will.

In order to accomplish the desired results in the local church unit, let each church conduct a community survey, door to door witnessing or a similar approach that will let people know that Christ and our Church is interested in them. Let each church plan one or two special evangelistic campaigns during the year. Certainly God's promise is true that if we sow, in due season, we shall reap.

District Superintendent's Report (continued)

It has been a privilege to serve you this year. As we have met together to examine the record, ponder new legislation and look forward to the mighty power of God in our midst this year, let us seek to have the mind and spirit of Him who hath redeemed us with His Blood.

SUPERINTENDENT'S PERSONAL REPORT

To the best of my ability, I have cared for the responsibilities of the office of District Superintendent. To my knowledge, all matters of church business were cared for with the aid of my good Assistant, Reverend M. D. Lockard.

BE IT RESOLVED that the following be added under Ministerial #2, page 24: And BE IT FURTHER RESOLVED that a pastor with 10 years of pastoral service, including two consecutive years on the Arizona-New Mexico District, shall be granted three weeks annual vacation with pay. (Carried)

BE IT RESOLVED that all licensed and ordained Ministers and Deaconesses shall pay \$2.00 to the District for the annual pocket credential. Credentials will be issued upon receipt of this fee by the District Secretary. STANDING RESOLUTIONS OF PREVIOUS
CONFERENCES

LOCAL CHURCH

1. The local churches shall provide modern cooling, cooking and heating facilities for the parsonage, the type of facilities to be suitable to the locality where the parsonage is situated, and all churches in the conference shall pay the utilities for the parsonages.
2. Each local church is urged to raise a subscription list to the Pilgrim Holiness Advocate equal to its total family membership. (Revised 1965)
3. BE IT RESOLVED that all local indebtedness involving an expenditure of more than \$500, where financing is involved, be approved by the District Council. (1960)
4. BE IT RESOLVED that all non-Pilgrim Evangelists must first have the approval of the District Superintendent or the District Council before being called for evangelistic activity in our churches. (1960)
5. BE IT RESOLVED that no church may borrow from its pastor, nor may any pastor underwrite loans for a church so as to make himself legally responsible as an individual, without the prior consent of the District Council. (1961)
6. BE IT RESOLVED that a call pastor meeting be conducted between the first two Sundays of March. BE IT FURTHER RESOLVED that in the absence of the District Superintendent, the Church Secretary conduct said meeting. BE IT FURTHER RESOLVED that the pastor present a letter of answer to the District Superintendent within 15 days of acceptance or rejection of call. It is understood that each pastor enters into a moral contract when accepting a call to a church and should do everything possible to honor the term of his call. BE IT FURTHER RESOLVED that retiring pastors terminate their services on the 2nd Sunday in June. BE IT FURTHER RESOLVED that the Church Secretary count the ballots and notify the pastor and District Superintendent at the close of the election. (1965)
7. In the interest of good business practice BE IT RESOLVED that the offerings received in the local churches be counted cooperatively by both the Secretary and the Treasurer of the Congregation or designated parties appointed by the local church board and that the pastor consistently be informed of offering receipts each Sunday. (1965)
8. BE IT RESOLVED that budget monies be forwarded to the District Treasurer by the local church treasurers no later than the 10th of each month. (1965)
9. In order to present the privileges and responsibilities of Church Membership, THEREFORE BE IT RESOLVED that each church conduct Church Membership Classes, with a minimum of four sessions for adult membership. The instruction is to be in the following areas: 1. Articles of Faith. 2. Church History. 3. Church Organization and Finance. 4. The Church Covenant. (1966)

CONFERENCE

1. The District Council and the following committees and boards shall meet at least 30 days prior to the Annual Conference to take care of such work as they have at hand: Conference Action Committee and the Educational and Examining Board.
2. In order that the relatives and friends may know the set time for the ordaining of ministers, BE IT RESOLVED that the Ordination Service take place at 4:00 P.M. the first day of Conference. (1957)
3. The Education and Examining Boards shall be combined and this Board shall consist of three members, one being elected for a period of three years, one for two years and one for one year.

Standing Resolutions Conference (continued)

4. There shall be a Memoirs Committee which shall annually list departed members by name, date of decease, and church, for inclusion in the Conference Journal. In case of ministers, there shall be a picture and a brief resume of ministerial labors.
5. BE IT RESOLVED that the district furnish credential forms to each local church conference delegate and alternate to be filled out and signed by the pastor and the church secretary, and sent to the district secretary at least 30 days prior to Conference. (1959)
6. BE IT RESOLVED that the District Trustees and the Statistician be made permanent members of the District Conference. (1959)
7. INASMUCH AS there is such close correlation between the work of the Resolutions Committee and the Ways and Means Committee, THEREFORE BE IT RESOLVED that there be an appointment of a Conference Action Committee of 5 members, which would combine the functions and capacities of the Resolutions and Ways and Means Committees. (1960)
8. BE IT RESOLVED that there be an appointment of a Building Appraisal Committee (competent in the field of Appraisal) the function of which shall be to set the value of all church property. BE IT FURTHER RESOLVED that the appointment of this committee be made bi-annually. BE IT FURTHER RESOLVED that all properties acquired between these appraisals shall be carried as tentatively appraised by the District Council until the next general appraisal. (Revised 1961)
9. WHEREAS the District Council has recommended the moving of the Arizona-New Mexico District into the "ADVANCED LEVEL", THEREFORE BE IT RESOLVED that this conference approve the promotion of the Arizona-New Mexico District into the "ADVANCED LEVEL STATUS". (1962)
10. BE IT RESOLVED that the conference year of the Arizona-New Mexico District shall begin April 1 and end March 31 the following year, and that all reports be sent to the District Superintendent and District Statistician by April 15. (Revised 1965)
11. WHEREAS the District Conference expenses for pastors and delegates is to be paid by the local churches, and WHEREAS this creates a disadvantage for the churches at greater distances from the place of conference, THEREFORE BE IT RESOLVED that the total expense for District Officers, pastors and delegates be pro-rated and paid on a basis similar to the General Conference system, for automobile travel. (1962)
12. BE IT RESOLVED that the District Conference of the Arizona-New Mexico District be held annually on the Tuesday following the third Sunday in May with the following schedule of sessions: 9:00 A.M. - 11:30 A.M.; 1:30 P.M. - 5:00 P.M.; 7:00 P.M. - 9:00 P.M. or until business is completed. (1965)
13. BE IT RESOLVED that the Ministerial Convention be held annually on Tuesday and Wednesday following the second Sunday in October. (1965 as amended)
14. WHEREAS the Department of Church Extension has presented the program WAGING THE WAR, BE IT RESOLVED that we accept the challenge and with God's help - 1. We will wage war on our knees in meaningful prayer meetings and the deepening of the devotional life of our ministers and our members. 2. Wage the warfare locally to enlarge our churches by every possible means, enlarging our buildings and drafting new recruits through lay visitation, ladies and mens organizations, CYC and an increased emphasis on Sunday night evangelism. 3. Wage the war for prosperity through a planned annual budget and a systematic monthly check on income with faithfulness to care for District and General Church obligations. 4. Wage the war with planned aggression by meaningful District and Ministerial gatherings where spiritual life will be cultivated. (1966)

Standing Resolutions (continued)

DISTRICT SUPERINTENDENT

1. BE IT RESOLVED that the District pay \$85.00 per month on the salary of the District Superintendent. BE IT FURTHER RESOLVED that the District Superintendent be remunerated for meals and lodging incidental to travel. (Revised 1963) See current legislation.

MINISTERIAL

1. BE IT RESOLVED that we accept the Blue Cross, Blue Shield group hospitalization, surgical and medical plan. And BE IT FURTHER RESOLVED that the churches pay \$5.00 per month to be applied to the pastor's premium, and the district pay \$5.00 per month to be applied to the District Superintendent's premium. (1959 - Revised 1962 & 1966)
2. BE IT RESOLVED that each pastor be granted a two weeks vacation with full salary. (See current legislation)
3. BE IT RESOLVED that when ministers come to this district from another denomination, that the Executive Officer of the transferring minister be contacted by the District Superintendent asking for a recommendation, to be in the hands of the District Council at least 30 days prior to moving date. And BE IT FURTHER RESOLVED that the transferring minister be interviewed by the District Council prior to reception of his credentials. (1959)

DISTRICT COUNCIL

1. BE IT RESOLVED that each council member be paid 6 cents per mile for travel expense to and from council meetings and that when several members travel in one car, the driver be paid an additional one cent per mile for each council member travelling with him. (Amended 1961 & 1966) (See current legislation)
2. WHEREAS those who serve as District Secretary and District Treasurer must devote considerable time to their duties, and INASMUCH AS other districts comparable in size to our district pay their Secretary and Treasurer token remunerations, THEREFORE BE IT RESOLVED that the yearly honorarium for the District Secretary be \$60.00 and the District Treasurer \$75.00. (1962 - Revised 1964) (See current rules)

BUDGET

1. BE IT RESOLVED that all monies raised in local churches for district, general or Bible College purposes be disbursed through the District Treasurer, and only such monies as are processed accordingly may be credited to the local churches on the District Treasurer's Report. (1961-Revised 1967).
