The following is a condensation of Bro. Chamberlain's

letter to the Board of Elders:

"Many names must soon be taken from our list of subscribers to the paper, as we cannot carry them any longer. To offset this there should be a steady increase of names coming month by month. We feel it should be handled through the local churches the way they see fit, and suggest each church be responsible for as many subscriptions as they have members enrolled. Most members could well afford to give at least one new subscription a year, and some could give a number of subscriptions. If such were done we would be printing about 450 more copies in a year, bringing in \$450 more for the paper. Surely God would have us to have a plan and then work the plan."

3. We recommend the General Assembly to authorize the Board of Elders to appoint a General Superintendent

of Sunday Bible School work,

4. We recommend the General Assembly to authorize the Church Treasurer to take sufficient funds from the Treasury to liquidate the note held by the General Assembly against the Downey membership, not to exceed \$150.

5. We recommend the General Assembly that the Joint Boards be authorized to culminate the matter of August 10 regarding the local church property, with power to act.


