

The business session of the Semi-annual General Assembly of the Holiness Church convened at Ojai, Cal., April 13, 1920, at 10 a. m.; President Clark in the chair.

Opening remarks by the President on the importance of the work we have been called to, and chosen for; we should be consecrated to, and concentrated in, this work, so we can perpetuate the principles we stand for.

Partial report of the Board of Elders was read, received, and ordered spread on the minutes, and recommendations were carried out.

PARTIAL REPORT OF THE BOARD OF ELDERS

To the General Assembly now convened at Oiai Cal., Greeting in Jesus' name. We, the Board of Elders, beg to submit to you

In looking over the work we find many encouraging things have transpired since last report.

God has graciously helped us to a new church at San Dimas. A tent meeting held by Bro. Jas. R. Adams and workers resulted in the salvation of many souls. At the close a church was organized, and soon a lot was purchased and they have now a church and parsonage on it. And the revival still continues.

The work in Mexicali among the Chinese, in the hands of Sister Gladys Clark, and Bro. and Sister R. B. Clark, is prospering; and at the present time about thirty students are in attendance at the school. Some of the students have been turning to the Lord. Also a house and lot in Calexico has been paid for and deeded to the Honness Church, as home for the Mission workers.

The contemplated Mission property in Los Angeles has been purchased for \$9486.70 and deeded to the Holiness Church, and plans drawn for building thereon. The blue print here on exhibition.

We have an encouraging report from Bro. and Sister Moyle in Arizona. They have opened up a new work in another school house. Other information will lbe obtained from their communication

to the Assembly.

The work in the South, under the supervision of Bros. J. H. Creswell and Roy Whiting has been gaining some. They have bought a new lot in Tell City and have part of the material on the ground for a church. Also the work in the West Main St. church has taken on new life; and at the present time is very encouraging. A number of new members have recently united with the church. The Hickman-Ebbert church is in good shape, and have paid quite a sum on the church.

Owing to ill health Bro. and Sister Whiting were forced to leave Kentucky and are now settled near De Ridder, La. They are beginning to work there, and there are signs of a work opening for holiness in that locality. Bro. Roy Whiting is also with them at present. Let us pray that the Lord will

open a great work there.
