The following action of the General Assembly Board was ratified: Bro. E. C. AGREEMENT

Ray W. Chamberlain agrees:

One-To publish forty-nine issues of the Standard Bearer (eight page periodical, same quality paper as now used, up to 750 copies each week), beginning with the issue of August 26, 1942, through August 6, 1943.

Two-To pay all costs of publishing and mailing the above described periodical.

Three-To pay The Holiness Church \$50.00 per month rental for the sole use of the Standard Bearer Publishing House and its equipment for one year dating from August 10, 1942, to August 10, 1943.

Four-To maintain the equipment while in his possession and to return it to the General Assembly (with reasonable depreciation) at the expiration of the agreement.

The Holiness Church agrees:

We advise those who wish to prepare for more efficient Christian work, and who cannot attend our school at present, to start taking the Theological Correspondence Course offered by God's Bible School, and our own course in Theology as soon as it is ready, with the end in view of spending at least one year as a resident student in the Holiness Evangelistic Institute, and graduating therefrom. wear their dresses not less than one-half the distance between the ankle and the knee. Full length stockings shall be worn and no bobby socks shall be permitted at any age.

6. The use of lip stick, rouge, and like cosmetics, as well as the wearing of jewelry and kindred items, is not consistent with holiness or with the doctrine of this church; therefore we ask that all residents refrain from their use, that this church may be an example in deed and precept.

We recommend to the General Assembly that they ratify the following rules concerning the properties of The Holiness Church located at the grounds situated along Hoyt and Klingerman Avenues, Los Angeles County. These rules and regulations are to apply to all persons permanently residing on the above mentioned properties. We define permanent as meaning thirty days or more.

Camp-ground Rules

1. There shall be no immoral conduct, obscene or profane language allowed on these premises at any time.

2. The use of liquors and all forms of tobacco is strictly prohibited.

3. The limit of speed of motor vehicles shall not exceed fifteen miles per hour at any time upon the streets of this property. This limit must be observed by all. Please do not park-your cars on lawn except in front of tabernacle in space provided for parking.

4. All property destruction shall be paid for by the guilty party, and willful destruction shall be dealt with by all means at our disposal. No alterations shall be made without first securing the written consent of the Board or its representatives. Cooking in cabins is not permitted (State Law).

5. The Holiness Church believes in modesty of dress and shall expect all ladies to be clothed in simple and modest dress: modest in cut of neck, length of skirt, weight of material and length of sleeves (at least below the elbow). All ladies, and girls over the age of fourteen years, shall

The following recommendations of Board of Elders were read, received and acted upon separately. Each was on motion adopted by the Assembly.

1. We recommend to the General Assembly that no one be eligible for election on any general board until such person has been a member of our church for two years.

2. We recommend to the General Assembly that no minister be eligible to pastor our churches unless he or she has been a member of our church for at least one year. 3. We recommend to the General Assembly that the

following action of the General Assembly at Chino, Calif.,

on April 11, 1940 be rescinded:

"Each church decide approximately what they can give to their pastor monthly. This amount shall be governed by the financial ability of the church. When the tithe percentage fails to reach this amount, the local church should appoint someone to take the necessary stens to bring up the shortage. When the amount is \$50.00 or more, above utilities and parsonage, the pastor shall be required to devote full time to church work."

4. We recommend to the General Assembly that the Home Missionary credentials of Bro. William Robinson be cancelled, he having united with another denomination.

5. We recommend to the General Assembly that the 10 per cent fund received from the local churches, and commonly known to be used in New and Restoral Work, be recognized solely as the New Work Fund.

6. We recommend to the General Assembly that they ratify the action of the Board of Elders in calling in the charter of the Murrieta Holiness Church, and recommend same for cancellation upon their request.—Thomas E. Lee, Secretary
