#### MORAL REFORM.

We, your Committee on Moral Reform, beg leave to submit the following report:

The Wesleyan Methodist church had its birth in the midst of a great controversy; and we should not be unmindful of the fact that we are again living in perilous times, a time when home, church and state is fraught with danger on every hand. The thing most to be feared, we believe, in the home today is the assault upon the marriage relation; companionate marriage, lax divorce laws and birth control are subtle forces undermining the divine institution of matrimony, which God made the foundation stone in proper home life. Another menace to the home life today is the assault upon the purity of the body. Unscrupulous peddlers of commercialized vice are making a strong bid for the constitutional forces of our youth. The dope, or soft drink craze, the tobacco scourge, "a cigarette in the mouth of every boy and girl in America" is the slogan of the tobacco companies today. The destruction of the moral tone of youth by the movie sex appeal, the godless, and immoral display of womanhood, along with the unequaled sale of salacious books and literature present a moral and physical menace that is stupendous.

We believe the voice of our church should be raised in emphatic protest and opposition to these evils. There should be no compromise. Perhaps our church never faced conditions in which the warning of the inspired writer "Be not deceived" is more timely and fitting than at the present. Our attitude toward such unchristian movements as: Romanism, Mormanism, Russell ism, Moderninsm and Christian Science should not be one of indifference, but one of pronounced and aggressive opposition. No favorable consideration should be given any part of their program; and we should protect ourselves against the unscriptural and unwholesome literature placed in the hands of our youth by these harmful movements. We reaffirm our position as opposed to all secret or oath-bound societies; since our great teacher and Saviour said, "In secret have I said nothing." We also speak with abhorence of the of the various Atheistic and Infidelic societies which would destroy faith in the word of God, or make void the precepts of His Law.

Realizing we are not alone in this battle for moral and religious reform, we commend the work of other agencies in this field; the American Bible Society in its distribution of the word in almost every land and tongue, the Lord's Day Alliance which is meeting a definite need in protecting the laws

for Sabbath observance, the National Christian Association which is seeking to break the power of secrecy in our land, the Anti-Tobacco Societies are endeavoring to save our youth from the curse of nicotine.

The present trend of the world and religion makes it necessary for the Wesleyan Methodist church to register its emphatic protest against, and pledge itself to fight these subtle forces of evil which seek to afflict the young

life committed to our keeping.

Ralance from last year

Our attitude toward the Eighteenth Amendment is that of unqualified approval and united support. The movement that led up to the Eighteenth Amendment began in 1851, when the first state adopted prohibition, 80 years ago. No other amendment to the constitution was discussed so widely, or through so long a stretch of years; nor was any amendment ever opposed by such organized, and well financed forces. And yet it was adopted by an overwhelming vote. Therefore, since court statistics reveal the conviction of 86% of those arrested for violation of the prohibition laws, we believe the attitude of the Wesleyan Methodist church toward the wet propaganda, and the vicious liquor traffic should be that of pronounced opposition. We call upon all constituted authority to enforce the laws supporting the Eighteenth Amendment more rigidly than in the past.

- 4. Whereas, we are living in an age of educational facilities and advantages that are unique, and since the standard of ministerial qualification must measure up to the demands of the present educational age, as far as it is expedient, we urge that the requirements of the Discipline relating to the qualifications of licensed preachers be strictly carried out, and that emphasis be placed on the study and practice of "good English".

We recommend that where there are licentiates on charges, the pastors of said charge shall hold such meetings as they deem best, for the mutual improvement of the local preachers pertaining to their spoken English, pronunciation, pulpit mannerisms, gestures, etc., advising and correcting them where such correction is deemed necessary.

5. That programs of both physical, mental and spiritual recreation be encouraged in our Sunday School and church life, and where such programs are arranged for they shall be placed under the supervision of the pastors.

6. That this conference express its appreciation of the services of its

president, and pledges to him their prayers and support in the coming year.
