First Day, A. M. Session Wednesday, April 24, 1861

The Ministers and Delegates constituting the Rochester Yearly Conference of the Wesleyan Methodist Connection met for their Seventeenth Session, with the Yates Church, on the Eagle Harbor and Yates charge, Orleans Co. N.Y. on Wednesday the 24th day of April, 1861, and were called by the President, John Johnston, who invited H. B. Knight to conduct the opening religious exercises.

The Secretary then called the Roll of Ministerial members, after which the Certificates of Delegates were called for and presented as follows: Richard Britton, from the Williamson and New Salem charge; Peter Dean, North Bradford, Levi Rogers, Elkland; Harry B. Odell, Lyndon; John Cain, Eagle Harbor; A. W. Bishop, Alleghany; H. W. Rathbun, Haskinville; [sic] Ira R. Weaver, Phillipsville; Wm Depue, Hopewell; Wesley Doughty, Canadice; John Powley, Ransomville.

On motion of Bro Slauson, the name of Willard Chase was transferred from the Unstationed to the Superannuated list, and Danforth Booth was enrolled as his Delegate

Voted to proceed to the election of

Officers, Bros Inman and Depue being appointed Tellers.

John W. Labar, delegate from Chesnut [sic] Ridge and Royalton Ct, presented his certificate and his name enrolled; Also, Elisha Fay, a delegate from Forrestville [sic] and Ellington.

Tellers reported the ballot for President, as follows: Whole No of Votes cast 32; necessary to a choice 17; John Johnston had 14, M. Q. McFarland 13, Scattering 5; no election.

Second Ballott [sic] taken. Whole No of Votes cast 32; necessary to a choice 17; John Johnston had 18, M. Q. M°Farland 11, Scattering 4; Bro Johnston was declared elected.

Proceeded to the election of Secretary: On first ballot, 34 Votes were cast; necessary to a choice 18; H. B. Knight had 30 of this No and was declared elected.

The appointment of Committees was then called for, when on motion the President of the Conf. was requested to constitute them.

Bro M^cFarland moved that a Special Committee of Seven, on dividing the Conf. as provided for by last Gen. Conf. Carried

Wesleyan Annual Conference:

Gentlemen: Elder Orson Medbury, (Wesleyan Minister), left a <u>Will</u> a few years Since, which will some day need the attention of our Society, and I suggest that Some Memorandum of the following <u>clauses</u>, be made on your Records, or otherwise, as found best, so that the gift may not finally be forgotten:

"After giving a third to his Widow, it reads thus: "Further, I will and bequeath as aforesaid, the use of the remaining two-thirds to her use, and [insert: enjoy] peaceably enjoy without let or hindrance during her natural life.

"Thirdly: I will and bequeath to the Wesleyan Conference that may embrace this territory, at that time, one fourth of the two-thirds last mentioned real estate, for the <u>liberation</u> or educating African Slaves, as they may lawfully do; considering themselves my agents under God, for this last mentioned benevolent purpose."

"This real estate is (total) 140 acres, in Tyrone. An equally good farm adjoining it Sold at \$45 per acre. (Donation, <u>now</u>, if due, worth \$1.000,) Mrs. Medbury now lives in Clinton Co. N.Y. – is over 50 years old. <u>Eliphalet Price</u>, has bought <u>all</u> her rights and lives on the farm. Said <u>Will</u> is on record in Schuyler Co
