The Committee on Ministerial Character Respectfully report to the Conference That they have had the Matters refered [sic] to them in charge and find that in the Case of H. M. Boothe – Charges were presented to your Committee as follows viz –

1st Specification – In neglecting the appointment on the Circuit

2nd Charge – For Slandering & abusing his family –

1 Spec. In saying that he had no natural affection for his wife & family 2nd Spec. For laying violent hands on his wife & abusing her.

3^{<u>d</u>} Charge. For seeking an improper intimacy with two certain Ladies which in their nature were improper and wholly inconsistent with and unbecoming in any christian [sic] & especially a christian [sic] minister.

Your Committee regret that from the evidence given before them, they feel [insert: themselves] compelled to find & report that the Charges & Specifications were each * every one sustained by the evidence.

Your Committee would therefore respectfully suggest that the Said H. M. Boothe be brought to trial on Said Charges,

Resolved 1st The Christian Ministry is an institution of God recognized & regulated in the revelations of his will as the Great agent of this Worlds Salvation & the mean who claim to be called to this office & Work are under the most sacred obligations to preach the gospel whether men will hear or forbear. at any Sacrifice at the loss of all things, even life itself.

Resolved 2nd The christian [sic] church is an organized System of Stewardship, appointed of God for the purpose of sustaining the Institutions of religion with all the ability of body, mind, heart & purse that God has given them & the laws of religious obligation binding on <u>laymen</u> are precicely [sic] the same in length & breadth - & height & depth as those that rest upon the ministry, & the measure of obligation is to be determined by the amount of ability possessed - & opportunity for usefulness afforded, so that it is the duty of the lay members to sustain the Institutions of religion at any sacrifice to the extent of their means.

Resolved 3d The support of the Ministry ought therefore to be provided for by the Churches on some fixed rule so that the Ministry may be unembarrassed by anxious fears & afflicting disappointments in reference to the means of Livelihood, In this way alone can the word of God have free course & be glorified

Church by neglecting his appointments – and further – The accused said that he had no natural affection for his wife & family because he considered them unworthy, he further acknowledged that he got vexed & handled his wife roughly

The accused acknowledged that the affidavit of L. Ticknor hereunto annexed was true, the accused acknowledged to the witness that he had the conversation with L Ticknor in which he enquired of said Ticknor about his daughter & said that he loved her more than all other females he ever saw & wished to know whether she had any regard for him That it had been revealed to him that his wife was to die & he was to have Hannah Ticknor for his wife.

After hearing the evidence the Committee or a majority of the Committee voted that each & every one of said charges were sustained by the Evidence

They therefore recommend that the said Henry M. Booth be expelled
