Snipes received a majority of all votes cast for trustee, and was declared elected. Upon second ballot H. F. Pair received a majority of all votes cast for second member of the Board of Trustees and was declared elected. Upon second ballot H. A. Johnson received a majority of all votes cast for the third member of the board of trustees and was declared elected. Upon third ballot D. L. Jones received a majority of all votes cast for the fourth member of the board of trustees and was declared elected. Upon second ballot F. J. Kewish received a majority of all votes cast for the fifth member of the board of trustees and was declared elected.

Upon nomination by the president H. A. Johnson and D. L. Jones were elected as the president's advisory board.

On nomination H. F. Pair, H. R. French, E. L. Shigley, H. A. Jones were elected as Judiciary Committee.
