### JOURNAL OF DAILY PROCEEDINGS.

The Allegheny Annual Conference of the Wesleyan Methodist Connection (or Church) of America, convened for its sixty-fifth session with the church at Titusville, Pa., in their mission room over 27 Diamond Street, at 9 o'clock A. M., March 18, 1908.

President P. B. Campbell called the conference to order.

Conference opened by devotional services conducted by Elders T. K. Doty and J. H. Ellett reading Phil. 3.

The roll was called, eleven elders, six licentiates and three from the quarterly conference roll responded to their names.

The President appointed Elder S. E. Graves and W. H. Williams a Committee on Credentials. They reported eleven delegates from the various charges.

Roll was arranged and names called. (See roll.)

On motion the bar of conference was fixed to include the first four tiers of seats.



On motion the time of opening and closing the meetings of this conference session was fixed as follows: The morning meeting to open at 8:30 and close at 11:30. Afternoon meeting to open at 1:30 and close by vote.

By vote of conference the following committees were elected.

The Committee on Itinerancy and Orders rendered partial report and items 1 to 8 inclusive were on motion adopted (See Report No. 7).

At this point the Rev. H. N. Lance of the Evangelical church of Somerville, Mass., was introduced to the conference.

On motion adjourned to call of the chair.

Conference called to order at 11 o'clock.

Examination of character taken up. Names of J. H. Ellett, T. K. Doty and G. W. Richardson were called, reported and characters passed.

#### First Day. Afternoon Meeting.

Conference met at 1:30. Called to order by the President. Devotional services conducted by Elder F. L. Presley of the Syracuse Conference.

Roll called twenty-four members responding.

Minutes read, corrected and approved.

Committee on Credentials reported names of Rufus Copeland, Emma E. Muman and Mrs. Maud Head. Names called and added to the list.

Examination of character taken up: Name of P. B. Campbell called. Elder J. R. Babcock was called to the chair and Brother Campbell reported as President of conference. (See Report No. 1.)

On motion the report was considered item by item.

Item 1 was read and on motion Elders T. K. Doty, F. W. Cox and Sister Lydia Cole were elected a Committee on Memorials and on motion item 1 was referred to Committee on Memorials.

Items 2, 3, and 4 were adopted.

Rev. E. Teter, Missionary Secretary, was introduced to the conference.

On motion the order of the day immediately following the election of conference officers to-morrow morning be the time for hearing the Connectional Agent.

Elder A. D. Fero was excused from further attendance upon conference after three o'clock.

Committee on Credentials reported and the name was added to list of delegates.

The time for the order of the day having arrived Elder P. B. Campbell preached the conference sermon reading from the Twentieth Century Version II. Cor. 6:1-10. Text I. Tim. 4:6: subject, a good minister of Christ Jesus.

On motion adjourned.

### **Third Day. Morning Meeting.**

The sunrise prayer-meeting conducted by Elder J. H. Ellett continued until 8:30 A. M. Conference called to order by the President.

Roll called thirty-eight members answering.

Minutes read, corrected, and approved.

A correspondence from N. F. Robb was read.

Committee on Credentials reported and name was added to list of delegates.

The chairman of the districts reported, the paper was on motion adopted (See Report No. 10).

The Committee on Itinerancy and Orders reported item 11 which was accepted.

On motion it was resolved that the devotional services in open-of conference to-morrow morning be given to the tithing secretary to make his report.

On motion it was decided to proceed to choose place for holding next conference session. Invitations were received from Stewart Run, Barberton and Bethesda churches.

The roll was called and votes taken, Stewart Run receiving four, Barberton twenty-two and Bethesda eight votes. Barberton was chosen. Conference to meet March 17th, 1909.

On motion it was resolved to elect a committee for revising the standing resolutions of the conference. On motion committee was formed (See committees elected).

A resolution on tobacco was presented.

The Rev. A. Meeker of the United Brethren conference, was introduced to the conference.

The time for the order of the day having arrived conference proceeded to election of conference officers.

Ballots were cast for President; Elder P. B. Campbell having received the majority of votes cast was declared elected.

Ballots were cast for Vice-President and Elder D. B. Hampe having received the majority of votes was declared elected.

Ballots were cast for Secretary; L. H. McLeister having received the majority of votes cast was declared elected.

Ballots were cast for Assistant Secretary; D. B. Hampe having received the majority of votes cast was declared elected.

On motion Elder J. R. Babcock and J. H. Hogg were elected Advisory Board.

On motion G. W. Richardson, J. R. Babcock, P. D. Cutshall and Fleming Perrine and C. W. Pelton were elected Committee on Presidency.

Ballots were cast for Trustee and Philip D. Cutshall was elected Trustee for the term of five years.

On motion S. E. Graves and Mary C. Cordner were elected to the Missionary Board.

On motion J. R. Babcock, S. E. Graves, C. L. Smith and J. H. Ellett were elected a Judiciary Committee.

On motion reconsidered the question of hearing our Connectional Agent and Secretary.

And on motion it was resolved that the order of the day tomorrow at 10 A. M. be the hearing of our Connectional Agent.

W. H. Williams the Tithing Secretary having been called home on account of sickness, on motion Elder F. J. Davis was elected Tithing Secretary pro tem.



On motion the resolution on tobacco was referred back for revision.

Charges were taken up and Rochester called; H. L. Grimes reported and character passed.

Name of D. B. Hampe called, reported and character passed.

On motion adjourned, benediction by Rev. F. N. Fox of the Free Methodist church.

### **Third Day. Afternoon Meeting.**

Conference called to order by the President at 1:30 P. M. Devotional services conducted by Elder W. Ingersoll.

Roll called thirty-three members responding.

Minutes read and approved.

An offering was taken for the Secretary amounting to \$9.05.

C. L. Smith, Conference Treasurer reported (See Report No. 12).

On motion referred to Auditing and Finance Committee.

The resolution on tobacco was reported and on motion adopted (See Resolution).

The time for the order of the day having arrived the missionary meeting was held; returned missionary Sister Hattie B. Crosby presented the foreign work and E. Teter, Missionary Secretary, the home work. An offering was taken amounting to \$137.50. Cash, \$36.50; pledges, \$101.

On motion adjourned.

### **Fourth Day. Morning Meeting.**

Conference called to order by the President 8:30 A. M., the Tithing Secretary making report and presenting the question of tithing (See Report No. 11).

Roll called twenty-five responding. Minutes read and approved.

Auditing and Finance Committee reported (See Report No. 13).

On motion item 1 was adopted. Item 2 referred back for revision. Item 3 was on motion adopted. Item 4 referred back. Item 5 was adopted. Item 6 was referred back for revision. Item 7 was on motion adopted.

On motion P. D. Cutshall was elected Treasurer of Superannuated Fund with instructions to receive funds from former treasurer as soon as possible.

Elder J. T. Broadhead, returned missionary of the Free Methodist church was introduced to the conference.



On motion it was resolved that the Conference Treasurer be elected by ballot.

Ballots were cast and C. Leslie Smith was elected Conference Treasurer.

The order of the day was called and Elder J. H. Bowen, Connectional Agent presented the Connectional interests to the conference and \$220 was pledged to the Publishing Association.

On motion time for adjournment was extended.

On motion W. H. Williams was elected Tithing Secretary.

Committee on Statistics reported (See Report No. 9) and with correction was adopted.

S. E. Graves was excused from further attendance.

On motion adjourned.

#### Fourth Day. Afternoon meeting.

Conference called to order by the President 1:30 P. M.

Devotional services conducted by Elder J. T. Broadhead of the Free Methodist church.

Roll called twenty-two responding.

Minutes read, corrected and approved.

Auditing and Finance Committee reported. Item 2 on motion adopted. Item 4 on motion adopted. Item 6 was adopted. Item 8 was adopted.

On motion the report of Auditing and Finance Committee was adopted as a whole.

The verbal report of D. B. Hampe concerning the use of the Tabernacle was on motion adopted.

On motion D. B. Hampe was given the oversight of the tabernacle for this year.

Committee on Standing Resolutions reported and report on motion adopted (See Resolutions).

Committee on Itinerancy and Orders reported item 12; on motion adopted.

The order of the day was called and memorial services of Sister Sarah Kennedy were conducted, and Elder T. K. Doty preached to the conference.

On motion it was resolved that we consider Sarah E. Shultz a suitable person to be ordained. On motion Sarah E. Shultz was elected to elder's orders.



Committee on thanks reported (See Report No. 8) which was on motion adopted with recommend that it be read in the churches to-morrow morning and given to the daily paper.

The motion to make it the sense of this conference that the Wesleyan Methodist be advanced to \$1.50 per annum was lost.

On motion it was resolved that we print the standing resolutions in the minutes.

On motion it was resolved that an order be drawn on the treasurer for \$25 in favor of the Publishing House in payment for the books in Course of Study purchased by the conference.

On motion it was decided that the secretaries be instructed to have the Conference Minutes published and an order be drawn on the Treasurer for amount sufficient to pay for same, and that they receive money for sale of minutes and turn proceeds into the treasury.

Names of J. Case and Fannie M. Wike called and characters passed.

On motion adjourned to call of the chair.

Conference called to order by the chair.

Committee on Pastoral Relations reported (See Report No. 14). Items 1 to 7 inclusive were on motion adopted and on motion the report as a whole was adopted.

Committee on Itinerancy and Orders reported item 13 which was adopted. On motion conference adjourned to call of chair.

Conference called to order by chair.

The District chairman reported as follows:

Titusville District reported election of P. D. Cutshall Chairman, F. E. Kline Secretary, W. H. Armstrong Treasurer, and a convention to be held in Pittsfield in May. On motion adopted.

New Castle District reported election of L. H. McLeister Chairman, Mrs. J. R. Babcock Secretary, J. B. Hawkins Treasurer, a convention to be held in New Castle May 20 to 24. On motion adopted,

Akron District reported election of I. F. McLeister Chairman, Clara McLeister Secretary and Treasurer. Convention April 14 to 19. On motion adopted.

Indiana District reported election of C. L. Smith Chairman, Ettie Hayward Secretary. On motion adopted.

Minutes were read, corrected and approved.

### REPORT No. 1.—PRESIDENT'S REPORT.

"The Lord of the harvest" who has so graciously kept the Allegheny conference under his watchful eye and careful hand for sixty-four years still abides with us.

1. It has seemed good to Him to call our beloved Sister, Elder Sarah Kennedy, from labor to her joyous reward on the 22nd of February, 1908. We bow our heads in humble submission and amidst our keen sense of loss say, "Thy will be done."

2. We have received during the year, Elder W. A. Backus, by letter of transfer from the Lockport conference; and Elder J. M. Humphrey, on the presentation of parchments from the Old Time Methodist Church. He having given satisfactory evidence of being in harmony with us in doctrine, experience and practice.

Both of these brethren have been received subject to the acceptance of this report.

3. The charges "In care of President" have been provided for as follows:

**Ashville.** Brother Floyd E. Kline appointed. He has served the work faithfully and has been asked to remain another year.

**Pine Grove.** To the south part of this charge we appointed Elder W. Ingersoll on the next day after the rise of conference. He has continued upon the charge through the year and in that time held ten weeks' special meetings. We did not succeed in getting a supply for the north part of this charge until Dec. 1, 1907, at which time Brother T. C. Shane was appointed. He has given good service and has been called to remain next year.

**Rochester.** The request of the charge to have Brother H. L. Grimes continue serving them was approved, resulting in an almost continuous revival throughout the year. He has been called to remain next year.

**Templeton.** Brother George Enty was appointed to this charge, and has served acceptably through the year.

4. Four houses of worship have come into our possession during the year by deed. Two of them also by dedication. One of the others was dedicated last year, and the other will soon be



ready for dedication. Of the two churches dedicated the one located on Brown Hill, Warren Co., Pa., is a small but neat building sufficient for the ordinary congregations, and with its excellent horse sheds is valued at \$1100. The other in Massillon, O., is small, neat, well located, and suitable for the present congregation, and with the large corner lot on which it is located is valued at \$2,000. Both of these houses have been paid for through the energies of our consecrated pastors and people of these charges.

5. The President and Missionary Board paid, by order on the treasury during the year, to Mount Pleasant charge the sum of \$10; and to Pleasant Valley charge the sum of \$10. These appropriations were made on account of the meager pittance the pastors receive on these charges.

The \$100 appropriated by our last session of conference for indebtedness on Ashville church property has been paid and receipt for same in hand.

The terms stipulated by last session of conference have been met by Barberton church and \$100 paid from treasury on indebtedness of that church. Receipt in hand.

Rent on Conference Safety Deposit box (No. 21) in bank at Stoneboro, Pa., paid up to May 3rd, 1908, amounting to \$2. Receipt in hand.

**Mrs. Sarah Kennedy.**

Sarah Kennedy was born near West Liberty, Ohio, March, 1837. She was married to W. H. Kennedy of Marion, Ohio, in 1872. She died at her home near Springboro, Pa., February 22, 1908. One daughter was born to them who died a few years ago, she leaving one son. Two sons of Brother Kennedy reside in Indiana each having a family. Sister Kennedy was converted at the age of fourteen and joined the Methodist Episcopal church. She with her husband joined the Wesleyan connection in 1876. She was sanctified in 1872, licensed to preach in 1877 and ordained an elder in 1882. She engaged with her husband in pastoral and evangelistic work in Indiana, Ohio, and Pennsylvania and was a teacher and preacher of signal power. For many years she enjoyed and exemplified a religious experience of unusual grace. Her husband testifies that she was wise and safe in counsel, prudent in all of her affairs and strong in her attachments. August 5th she slipped and sprained her ankle by which she was kept in for about five months; a little over six months from her fall she fell again continuing her confinement to her room. 7. That our pastors and people make it a matter of special prayer and effort to get souls saved, sanctified and brought into church membership with us in our quarterly meetings.



8. That a list of the names of the licentiates recommended to and received by conference, but not having had work assigned them, be kept as a reserve force and that their names be called at least twice during a conference session.

9. We agree with our Discipline that the use of tobacco is a great evil, therefore we strongly object to our churches or pastors receiving any persons in full membership who use, sell or manufacture this filthy weed.

We also urge upon our pastors and churches to use all their moral influence to oppose this great evil by both example and precept in and out of the pulpit.
