The Alabama Annual Conference of the Wesleyan Methodist Connection (or Church) of America convened in its fifteenth session at Birmingham, Ala., Wednesday, October 29, A. D. 1924 at 9:00 A. M., the President in the chair and the Secretary present.

Devotional exercises were conducted by the President. Upon the request of the President Rev. T. P. Baker took the chair to preside over the Conference.

Conference came to order and the Secretary called the roll and credentials for enrolling the following delegates; W. R. Tune, Mrs. H. F. Pair, Mrs. Tinie Segrest, W. F. Bunnell, Mrs. John Gilbert.

The Conference Bar was fixed to include three seats in front of the pulpit.

The President read his annual report, which was adopted. See Report No. 1.

Upon nominations H. R. French, W. F. Bunnell, and R. E. Snipes were elected a Committee on Religious Services.

Upon nominations H. R. French and M. A. Medders were elected a Committee on Courtesies.

Upon nomination H. R. French, D. L. Jones, M. A. Medders, R. E. Snipes, W. F. Bunnell were elected as Finance Committee.

Upon motion the hour of meeting was fixed at 9:00 A. M. and 1:30 P. M., to close at 12:00 Noon and by motion in the afternoon.

Upon first ballot M. A. Medders received a majority of all votes cast for third ministerial trustee and was declared elected.

Upon second ballot W. F. Bunnell received a majority of all votes cast for lay trustee and was declared elected.

Upon first ballot W. E. Hobson, Jr., received a majority of all votes cast for a second lay trustee and was declared elected.

Located a property known as the Carloos Reese place between Bessemer and Birmingham containing 18.038 acres at \$1,500.00 per acre, totaling \$27,057.00. A contract was entered into upon the following terms; \$8,000.00 cash; \$5,000.00 payable in one year, \$5,000.00 in two years and \$9,000.00 in three years with six per cent interest on the deferred payments. \$500.00 was paid upon this option or contract which applies on the initial payment if the contract is fulfilled.
