The Alabama Annual Conference of the Wesleyan Methodist Connection (or Church) of America convened in its eighteenth session at Bessemer, Alabama, Wednesday, November 2, 1927, at 9:30 a. m. The President called the meeting to order, after singing a song, prayer was offered by Rev. E. L. Shigley. Opening remarks were made by the president expressing his appreciation of the cooperation with him of the pastors in the work of the past year, also gave encouraging reports of the year's work urging a progressive forward movement in the work of the coming year. Prayer was then offered by the president. Rev. T. P. Baker was invited by the president to the chair to act as chairman of the conference session.

Roll was called. Quorum present.

The chair appointed E. L. Shigley and G. W. Wall as committee on credentials. Upon recommendation the following delegates were enrolled: D. L. Jones, A. J. Moore, Mrs. John Gilbert, Mrs. Cassie Golden, Miss Frances Compton, W. T. Aultman, E. W. Hill, J. D. Avery, J. W. Hawkins, A. T. Johnson.

On nomination R. E. Snipes, H. A. Johnson, Mrs. D. H. Segrest, D. L. Jones, C. H. Pickel, A. J. Moore and W. E. Hobson, Jr., were elected Missionary Board.

The following names were presented as elected by the Camp Meeting Association as the camp meeting committee: W. H. Tillman, E. L. Shigley, H. A. Johnson, C. H. Pickel, H. R. French. On motion they were elected as the conference camp meeting committee.

The president nominated as his advisory board, H. A. Johnson and D. L. Jones, upon motion they were elected.

A resolution authorizing the transfer of the Orphanage property at Macon, Ga. to the Wesleyan Methodist Missionary Society was presented and adopted as follows: "Resolved that the Alabama Conference do hereby petition the Board of Trustees of the Hephzibah Orphanage of Macon, Ga., to transfer the property of said Orphanage, with appurtenances thereto, to the

Missionary Society of the Wesleyan Methodist Connection (or Church) of America to be administered by them through the Home Missionary Department of said Corporation. This transfer to be made with the understanding that a warranty deed in fee simple be given to the Missionary Society of the Wesleyan Methodist Connection (or Church) of America, and that said Corporation in such transfer assume all standing liabilities against the Hephzibah Orphanage at Macon, Ga."
