# STANDING RULES

1. The Conference year shall begin on June 1 and close on May 31. Only those funds received by the Conference Treasurers, on or before June 10, will receive credit. All Conference Treasurers of Auxiliary Organizations shall immediately close their books, disburse funds and forward a report in full to the Annual Conference Treasurer by June 15.

2. The Conference Secretary shall mail one copy of the Pastor's Statistical Report for each charge with budget assessment from the Senior Conference and Auxiliary Organizations to the pastor and the second copy to the Conference Treasurer. The Conference Treasurer will fill in the total budget receipts paid for each assessed item for each church, sign the copy and mail it to the pastor of each charge by June 25. The pastor shall complete the signed report and mail it to the Chairman of the Statistical Committee by July 1.

3. The Character blank is to be filled out and mailed to the Conference President, Chairman of the Committee on Ministerial Character, not acter than TWO WEEKS before the opening day of Conference.

4. The Pastor's Sunday School report shall be sent to the Sunday School Secretary not later than 15 days prior to Annual Conference.

5. The Secretary of the "Central" Canada Conference shall be the Committee on Credentials. All lay delegate's parchments to the Conference shall be mailed to him one week previous to the opening of Conference.

6. The Annual Conference and Adult Camp shall close on the Sunday immediately preceeding the Civic Holiday in August.

7 The Conference President and his Advisory Board shall annually appoint a Nominating Committee of seven (7), which will present, at the Annual Conference, a slate of nominees for all Conference Officers and Standing Committees.

8. The President, with his Advisory Board, shall be a Committee on Orders of the Day and Religious Services during Conference.

9. The Conference President shall be Record Clerk.

10. The Ministerial Member of the Houghton College Board of Trustees shall also be the Educational Secretary.

11. The Executive Board of Directors and Conference Trustees of the Corporate Body of the Wesleyan Mcthodist Church of America in Canada

shall consist of ten (10) members in good standing with the Corporation, as directed under "Management", Paragraph 6, of the Charter of the Act of Corporation of the Wesleyan Methodist Church of America in Canada. FIVE as ex-officio, namely: The President, the Vice-President; the Conference Treasurer, and TWO elders, designed as, the Conference Secretary, and the Conference Youth President, if an elder, and FIVE men, THREE elders and TWO laymen, who shall be elected to a five year term of service by a ballot vote in rotating order. The expiring date of their term of service shall be July 31st, 11:59 p.m., and beginning date of their term of service shall be August 1st, 12:01 a.m.

12. The only items of the Pastor's Statistical Report to be read on the Conference floor are as follows: Item 1—Appointments; Item 2—Wesleyan Methodist, Wesleyan Missionary, Wesleyan Youth; Item 3—Present Total Membership, loss or gain; number of family altars; Item 4—Average Attendance; Item 5—To be read in full; Item 6—To be read in full; Item 9. To be read in full; Item 10—Total for Benevolances; Item 11—To be read in full.

13. All reports to the Annual Conference are to be made out in triplicate. Two copies to be given to the Conference Secretary and one to be retained by the person reporting.

14. The Conference Treasurer shall be given \$100.00 per year and the Conference Secretary \$50.00 per year for their services.

15. The Pastoral Vote shall be taken throughout the Conference the first full week in April and completed by April 30.

16. Churches calling pastors are to pay their moving expenses.

17. The third Sunday in August shall be the final Sunday for all pastors who are moving from their present charges.

18. The churches shall grant each pastor two week's vacation with pay at a time agreeable to the pastor and congregation.

19. Travel on Conference Assignments, or to Conference gatherings when travelling expenses are remunerated, the following will be observed:

(a) Where possible and convenient, clergy rates will be paid.

(b) The expenses of meals, room and when necessary travel to and from trains.

(c) When it is judged best to travel by train and one has come by car, clergy rates will be paid.

(d) Automobile travel on a basis of 5 cents per mile.

20. Churches having business with the Board of Directors and Conference Trustees requiring a visit of the body to their church, shall be responsible for the expense attached to such calls, unless released by the Board.

21. The Committee on Itineracy and Orders shall decide on those who shall receive the benefits of payment of our Conference Educational Budget.

22. Each church be requested to present annually, in a series of studies, based upon material known as "A Guide to Church Membership", that all prospective new members be requested to attend these classes and any others who are interested may also attend.

23. The presidents of the Woman's Missionary Society and Wesleyan Youth shall be members of the Committee on Church Extension and Evangelism.

24. Each Church is to contribute the minimum of two work days at the Annual Work Bee for camp maintenance. This may be contributed by pastors and laymen, or by hired help.

25. The Conference Camp Preparation Day is to be held annually on the Saturday preceeding the summer camps.

26. The Camp and Conference Entertainment assessment is to be used for entertainment of guests and provide for pastors, their wives and families' meals at half price during camp.

27. The Camp Meeting Committee shall be composed of: Camp Chairman; Conference President; President of Woman's Missionary Society; President of Wesleyan Youth; Camp Treasurer; Advisory Board.

28. Pastors receiving financial assistance from the Conference will be paid directly from the Conference Treasurer. This aid is considered a Conference Grant, thus it is to be reported under Item, "Gifts to Pastor", on Statistical form.

Conference aid for churches will be sent to the local church treasurer.

29. The Report to Conference of the Board of Directors and Conference Trustees shall be mimeographed and copies given to pastors and delegates prior to the reading of the report.

30. The moving expense of a pastor going to a pioneer field is to be paid by the Conference.

# DAILY PROCEEDINGS

# First Meeting—Wednesday, 9 a.m. July 26, 1967

1. Opening—The 70th Annual Session of the Central Canada Conference of the Wesleyan Methodist Church of America in Canada, met on the Silver Lake Campground, Maberley, Ontario, Wednesday, July 26, 1967, 9 a.m.

9 a.m. 'The Rev. M. E. Summers, Conference Vice President, conducted the devotional basing his message upon John 20:19 and Acts 2:1-7.

2. Elder's Roll Call—The roll call of Elders was read and 17 re-

sponded. 3. Committee on Credentials—The report of the Committee on Credentials was read and adopted by vote. (Report No. 4).

4. Delegate's Roll Call—The names of the Lay Delegates were read and 18 responded.

5. Conference Bar—On motion the Conference Bar was set as being the first 7 rows in the centre section of the auditorium including the platform.

6. Agenda—The business agenda of Conference was presented by the President and it was adopted by vote.

7. Committee on Temporary Organization—The report of the Committee on Temporary Organization was read and adopted by vote. (Report No. 2).

8. Hour of Conference—By vote of Conference the following time schedule was approved for Conference sessions: 9 a.m. to 12 noon; and 1:30 p.m. until adjournment by motion.

9. Courtesy—The Committee on Courtesy introduced the following:
 Dr. C. Wesley Lovin, Denominational Representative; the Rev. Percy Baily

of the Middle Atlantic States Conference; the Rev. Norman Nixon of the Pilgrim Holiness Church.

10. Session Chairman-Dr. C. Wesley Lovin was invited by the Conference to act as Chairman of the Conference Session.

11. Audit Committee-The Audit Committee read a partial report which was adopted by vote.

12. Invitation-By vote Conference invited all those introduced to Conference to sit within the Conference Bar and to speak on any question.

13. President's Report-The Rev. J. S. A. Spearman, Conference President, read his report which was considered as follows:

A. Section 1-adopted

B. Section 2-recommendations:

(a) Adopted with the following directive:

By vote it was decided that the above recommendation be referred to the Committee on Church Extension & Evangelism for specific consideration as to the relationship of associate churches with the Conference.

(b) Adopted with the following directive:

By vote this recommendation was also referred to the Committee on Church Extension and Evangelism with the understanding that a report be brought to this Conference Session.

C. Section 3-Official Acts and Meetings-Adopted with a standing vote of thanks.

D. The President's financial report was read and adopted.

(Report No. 6)

14. Record Clerk-The Report of the Record Clerk was read by J.S.A. Spearman. It was adopted by vote. (Report No. 7).

15. Religious Services-The Report of the Committee on Religious Services was read and adopted by vote. (Report No. 1).

16. Committee on Church Records-The Report of the Committee on Church records read their report and it was accepted for consideration. (Report No. 28).

By motion item "P" was amended to read as follows:

"All records of historical and legal value are to remain in custody of the local church: however, when a congregation ceases to exist, such records are to be deposited with the Conference Record Clerk."-Carried.

By vote the Report of the Committee on Records was adopted .----Carried.

17. Audit Committee Appointment-Conference President, J. S. A. Spearman appointed Mr. Herbert Locklin a member of the Committee on Audit.

18. Adjournment—Adjournment by limitation of time. The Rev. Percy Bailcy. Middle Atlantic States Conference, dismissed with prayer.

Wednesday-1:30 p.m.

19. Devotions-Rev. R. L. LeRoy led in the devotional period basing his meditation upon Romans 12 and I Corinthians 13.

20. Minutes-The Minutes of the previous session were read and adopted.

21. C. Y. C. Report-The Report of the Christian Youth Crusaders was read and adopted by vote. (Report No. 20)

22. Wesleyan Men—The Report of Wesleyan Men was read and adopted by vote. (Report No. 24).

# CONFERENCE PRESIDENT'S ANNUAL REPORT

To the representative of our Denomination, Rev. C. Wesley Lovin, brethren in the ministry, lay members of the Conference, and visitors, we greet you in the name of the Lord at this opening of our 70th Annual Conference. It is in the providence of God we have been permitted to meet during Canada's Centennial for another Conference on the grounds of Silver Lake Camp. We join the sincere and devoted members of this body in gratitude to God for His many blessings and unquestioned protection and guidance through another fiscal year. The words of the great Apostle express well our thoughts today, "I thank God for you Christians... My constant prayers for you are a real joy, and they bring back to my mind how we have worked together for the Gospel..."

Nine years ago when we assumed the leadership committed to us by you it was with no small degree of fear and trembling, knowing well our limitations in time, talent, and wisdom. Through the years we have come to realize that it is not the sole responsibility of any one person, but rather a responsibility which rests upon each of us. Words are inadequate to express my feelings of gratitude to you, my brethren, for your patience, your love, your many kind words of appreciation, and your sincere cooperation in all efforts projected and promoted in carrying on the Conference program. In addition I would publicly offer my thanks for the help received from the General Office, and in particular from the Rev. C. Wesley Lovin, Executive Secretary Church Extension and Evangelism; from Rev. M. E. Summers, Conference Vice President; and from all Conference officers and officials.

Reflection upon the last year reveals both advancement and reternch-

ADVANCEMENT is evidenced in our OSHAWA PIONEER PROJ-ECT. Under the efficient leadership of the pastor, Rev. W. W. Jewell, services were started last October in the Community Centre. In January the newly formed congregation moved to the Hillsdale School. A number of setbacks were experienced by the moving away of 3 or 4 leading families. Notwithstanding these setbacks the congregation continues to grow. If the number present for the ground breaking ceremony of the new church is any indication of interest, then we bespeak for the Rev. and Mrs. Jewell, and the present nucleus, a challenging year. We now have erected on our church property a commodious brick parsonage with attached car port and plans are well under way for the completion of the first unit of the church by the end of this year.

In the NORTH BAY AREA two small congregations presently being pastored by Mr. Ronald Shepstone, have expressed a desire for an associate relationship with the Conference. This request has been granted subject to confirmation by this Conference, and an associate church agreement accepted by the congregations mentioned, and the Conference.

While serving full time as manager of the Canada Bread Company in the North Bay area, Pastor Shepstone has found time through the year to conduct Sunday and week night services in the Nipissing Junction and Callander areas with a good measure of success.

A visit in November to HUDSON HEIGHTS, QUEBEC, was a memorable occasion. In company with the Rev. M. E. Summers, the day was spent with Mr. and Mrs. Laurie Summers, who for sometime have conducted Sunday School and Bible Study classes in the recreational room of their home in this Montreal suburb. The service rendered by the Summers family, who have recently moved, will not go unrewarded. It is hoped the work will be carried on by others of our people in the area, and that in time we can reach our ultimate goal of another Wesleyan work.

In POWASSAN there is a real need for a new parsonage. The faithful and loyal people of the church are well aware of this situation and are presently obtaining prices on the cost of building a house, moderate in design and yet adequate to meet the need.

Through the year the value of a number of our church properties has increased as a result of improvements.

At INKERMAN the interior of the parsonage has been painted and papered and a furnace room added to the rear of the church to house a new heating unit. The church building has been redecorated.

Much work has been done on the ARNPRIOR CHURCH PROPERTY which includes a new furnace for the parsonage, new pews for the church and a considerable amount of redecorating.

The WALTHAM PARSONAGE and grounds have also been improved thus enhansing the general appearance.

At WINCHESTER a number of changes and renovations have been made on the church, parsonage and camp grounds. These include a new dormitory for summer use during camp.

A general "paint up" has been given the BELLEVILLE CHURCH PROPERTIES. This, with some new landscaping and a paved driveway greatly improve the general appearance.

Our PIONEER CHURCH IN TRENTON continues its healthy and normal growth. To maintain an increasing average attendance is not an easy task, due to the number of family transfers from this air base town. The church is faced with the challenge of ministering to the many needy families who find, for a time at least, a home church away from home. The assistance of Mrs. Spearman and the help given by Rev. N. White

make it possible for us to assume the work of this pioneer pastorate.

RETRENCHMENT, for the present, is evidenced in our OWEN SOUND PROJECT. An average of one midweek service each month was held during the year in anticipation of beginning Sunday services this fall. In preparation for the opening of this new work an option to purchase a church building from the Christian and Missionary Alliance was unanimously approved by the Board of Directors and Conference Trustees. Due to spiralling costs in new church building, the Christian and Missionary Alliance found it impossible to give vacant possession of their present building this year. This has naturally meant a withdrawing of our option and delaying action for the time being.

Listed AMONG THE HIGHLIGHTS of the year I would name the Leaders' Conference held at Marion, Indiana, which was attended by Brother Summers and myself; the Annual Ministerial at Houghton College attended by a number of the pastors; our own Conference Ministerial and S. S. Convention, which proved to be a real inspiration and encouragement to all; the almost unanimous vote among the churches of the Conference for Merger with our Pilgrim Holiness Brethren; and the Conference-wide Day of Prayer and Fellowship for the pastors and their wives.

While our accomplishments for the year are measurably insignificant in comparison with the immeasurable task before us, yet there have been gains and for these we give praise first to God, and secondly to you, our pastors, and to you our laymen, for your devotion to God and your labours of love. Whether I serve as your Conference President for another year is in the Divine Providence of God. But whether I serve in this capacity, or not, let us join hand and heart to make this Conference year one of marked progress both spiritually and numerically. May God help us our "calling to fulfill", and may God grant to each of us a mighty outpouring of His Holy Spirit.

#### RECOMMENDATIONS

- 1. That we make provision whereby an Independent church or churches may have associate relationship with the Conference.
- 2. That we give consideration of assistance with the Conference and Denominational Budget Assessment of pioneer churches for the first three to five years depending on the amount of indebtedness being carried by the pioneer church.

## Report No. 10. CONFERENCE SUNDAY SCHOOL SECRETARY 1 9 6 7

The Central Canada Conference Sunday Schools register an average attendance of 1,019 in the Main School weekly with a total enrollment of 1,521 in the Main School. While the enrollment has increased, the average attendance was 48 less than 1966 reports. 15 of the 18 schools reported on the Standard of Achievement Score for a total of 700 points. 15 scholars joined the Church; 9 WETT Units were taught and 48 Credit Cards earned.

At the forthcoming Fall Conference Sunday School Convention the recently initiated Annual Award Plaque will be presented to the winning Local Sunday School, along with a permanent Plaque to be kept by the Local Church. The Sunday School Board will be tabulating the score of each Sunday School based upon the Annual Reports to the Secretary.

#### Report No. 13. REPORT OF CAMP CHAIRMAN

As your Camp Chairman I thank you for the privilege of serving in this capacity during the past year and now attempt to report on the responsibilities assigned.

Yet I would first like to offer praise to our magnanimous Lord for the potential entrusted to us in this Camp and then thanksgiving for the enablement and realization of this potential He made possible this past year. Most of that realized was effected through dedicated human instrumentality, particularly our Camp Committee, with our Dining Hall Manager, Rev. W. A. Smith taking the lead, followed by others in key positions, who have shown the same vision, generosity of soul, and practical sacrifice. To these we are especially indebted.

While this past year has seen much planning for the future, yet much has been done toward the actual development of our grounds as well. I am sure you have noticed the new road to the east end of the grounds. While not quite ready for full use, we have the gravel on hand to finish it and hope to complete it this fall. This will not only afford shorter and easier access to that portion of the camp, but open up 30 to 40 additional cottage lots. These are needed, as nearly all, if not all, of those opened up two years at the west end have been sold. It is our intention as soon as we are financially able, to put the water line on the new road. We are not sure just when this will be, as the increased load will in all probability mean another pumping system as well.

It had been our aim to have plans for our latest project, the Camp Centre, completed before Conference, but our building program at Oshawa, plus other duties, prevented this. The rough layouts are ready, and the complete plans, which anticipate a chapel-recreation area with stone fireplace, washrooms, office and storage space, should be completed this fall. While accurate cost estimates have not yet been prepared, the building will probably cost in the neighbourhood of \$8,000. I would like to see this project pushed financially this year that we might be able to get this badly needed building under construction next year.

Several interested individuals have suggested another project; the erection of a motel-type accommodation, the units of which would be sold to individuals for their personal use. If we could get at least five subscribers to this type of a venture, we could get additional facilities without any capital expenditure by your camp committee. Again we have fallen short of our hopes, for we wanted to have drawings ready to present at this gathering. Rough sketches have been made and show a building of concrete block construction with units about 14' by 16' and include a two piece bath. It is anticipated that we could erect these for about \$800 per unit, ready for occupancy.

We have done a great deal of maintenance and improvement on existing facilities this year and this coupled with rising costs in every area, particularly, food, have really imposed some financial pressures. However we have held our prices to that of the past few years, except for our Junior Camps. A deficit of several hundred dollars in these camps last year forced us to make a modest increase, but we are still in line with most camps and below many. Only a continuing, and even increasing generosity on the part of God's people will forestall an increase next year.

In closing may I submit, on behalf of the Committee, a recommendation that we continue the same budget assessment of \$.50 per member for Camp and Conference Entertainment.

Submitted in humble gratitude for the privilege of service to God and His church in this area, and with thanksgiving for all the splendid assistance and cooperation.

# **REPORT OF BOARD OF CHURCH EXTENSION & EVANGELISM**

The Board of Church Extension and Evangelism begs leave to submit the following report:

1 The Board of Church Extension and Evangelism met at Owen Sound, Ontario on Wednesday, August 31, 1966.

It was recommended that provided funds were made available for the \$5,000 down payment by the time the Board of Directors and Trustees of the Conference met on September 15, we proceed to purchase the Christian and Missionary Alliance Church and land in Owen Sound, Ontario for the sum of \$35,000, with the view to opening a new church in our Conference.

2 The Board of Church Extension and Evangelism met in Brockville, Ontario on Wednesday night, April 5, 1967. a. The pioneer project at Oshawa was reviewed by the board. It was recommended that we proceed with construction of Unit 1-J. S. 500 in Oshawa as soon as possible this spring and that we borrow up to \$50,000, for its construction.

b. It was recommended that we investigate the possibility of temporarily renting a home for the pastor in Owen Sound and if this is not economically feasible we obtain prices for construction of a parsonage.

c. It was recommended that the Conference President continue negotiations with the Community Churches at Nipissing Junction and South Shore and that these be organized into Wesleyan Churches at his discretion.

d. It was recommended that we express appreciation to Mr. Laurie Summers for his labours at Hudson Heights and assuring him of our interest in the work there.

3 The Board of Church Extension and Evangelism met at Silver Lake on Saturday, June 10, 1967.

a. It was recommended that the Oshawa congregation be granted permission to borrow funds not to exceed \$55,000, rather than the original \$50,000, due to the increase in building costs.

b. It was recommended that we accept the recommendation of the Oshawa church relative to their building as follows: The tender of Murray L. Bell Construction of Oshawa be accepted for construction of the Oshawa Chapel—Education Unit for a price not to exceed \$47,000, including \$400 hardware allowance; \$2,000 heating allowance, but not including sewer connections; fixtures; furnishings; carpeting, contingent upon satisfactory workmanship and financial status.

4 The Board of Church Extension and Evangelism met at Silver Lake on Wednesday, July 26, 1967.

a. It was recommended that the Conference President continue association with the South Shore Gospel Chapel and the Nipissing Junction Community Church and that we further recommend the supplying of Mr. Ronald Shepstone as pastor and advise the Conference President and his advisory board to encourage them to become more closely affiliated in a pioneer relationship looking forward to organization as Wesleyan Methodist Churches.

b. It was recommended that in view of the possibility of budget change in the merged church recommendation number 2, as made by the Conference President be deferred until next annual Conference for recommendation and report.

5 The Board of Church Extension and Evangelism met at Silver Lake on Thursday, July 27, 1967.

a. We recommend that the Madoc pastor receive \$25.00 per month for this Conference year.

b. We recommend that the Conference President receive \$150.00 per month from the Conference this year to assist in the remuneration of his assistant.

c. We recommend that the Conference pay \$20.00 per week toward support of the Trenton pastor to partially replace that paid previously by auxiliary organizations.

d. We recommend that the Conference Church Extension budget assessment be \$7.00 per member for this Conference year.

e. We recommend that the budget assessment for Silver Lake be \$4.00 per member for this Conference year.

f. We recommend that the Arnprior indebtedness and interest be paid from funds received through Conference Extension Self-denial offerings during the Lenten season on the basis of 10 cents per day per family or a minimum of \$4.00 per family.

g. We recommend that the Conference President continue to explore possibilities in Hudson Heights and Owen Sound, and that he visit interested families with a hope of beginning a new work, in one or both of these areas, when feasible.

h. We recommend that a special Christmas gift offering be taken to help pay taxes on the Oshawa property and that the subject be presented the first Sunday of December.

Moved, seconded and unanimously resolved that we rescind original motion relative to purchase of the Owen Sound property dated September 15, 1966, and approve action of the Signing Officers of the Conference in acceptance of the offer to Purchase dated December 12, 1966, and counter offer dated December 12, 1966 in details as follows:—

To THE OWEN SOUND CHURCH OF THE CHRISTIAN & MIS-SIONARY ALLIANCE I, THE WESLEYAN METHODIST CHURCH OF AMERICA (as purchaser), hereby agree to and with the OWEN SOUND CHURCH OF THE CHRISTIAN AND MISSIONARY ALLIANCE (as vendor) to purchase all and singular the following described property:— Church premises, together with all lands used in connection therewith situate in the City of Owen Sound and being composed of Lots Nos. 1 and 2 on the west side of Mulholland Street, according to Plan No. 207.

For the price of THIRTY-FIVE THOUSAND DOLLARS (\$35,000.00), payable \$5,000.00 as a deposit and the balance of Thirty thousand dollars (\$30,000.00) in cash on closing.

Drapes throughout the Church building, projector screen, 3 attached blackboards, attached office desks, church pews, pews in classrooms in

basement, broadloom on platform and rubber runners on aisles, Sunday School curtain screens for auditorium platform, church signs, speakers for P.A. system on sanctuary ceiling, lighting fixtures, outside storm porches, coat racks and air cooling fans stay with the premises at the above stated price; all other chattels and moveables contained in church premises, including the organ and all electrical attachments therefore are not included in this sale and are reserved by the vendor.

#### Report No. 29.

Report of THE COMMITTEE ON CHURCH RECORDS as appointed by the Central Canada Conference Ministerial Institute, Meeting at the Trenton Wesleyan Methodist Church in February, 1967.

The Committee was asked to review the subject of local church records and to report to the 70th Annual Session of the Central Canada Conference with recommendations for standardized procedures and record forms.

The Committee composed of the Reverend Walter A. Smith, Chairman, and the Reverends Frederick S. Irish and Eldon F. LeRoy, met in the parsonage at Madoc, Ontario, June 12, 1967, and submit the following recommendations:

1. We call to your attention the responsibility of the local church toward the Annual Conference as seen in the Wesleyan Methodist Church Discipline, 1963 Edition, under Paragraph (60) sixty, subsections (1) one and (6) six; and also paragraphs (223) two hundred and twenty-three, and (228) two hundred and twenty-eight. These paragraphs state in part that the "local church is subject to such rules as the Annual Conference shall judge necessary", and also require that the local pastor shall report the work of the local church on the report form called the "Statistical Report."

Further, in reference to the responsibility of keeping accurate records in the local church, we call to your attention the instruction as outlined by the Wesleyan Methodist Church Discipline 1963 Edition, under paragraphs (131) one hundred and thirty-one, the last sentence of paragraph (134) one hundred and thirty-four, paragraph (138) one hundred and thirtyeight; the last two sentences of paragraph (162) one hundred and sixtytwo; paragraph (166) one hundred and sixty-six; and paragraph (168) one hundred and sixty-eight.

Therefore we recommend:

(a) Inasmuch as the records of the Quarterly Conference and the record of all births, baptisms, dedications, marriages, funerals, and membership of the local church have a historical and legal value that necessitates their being correctly kept and carefully preserved: that the local church clerks and secretaries use the utmost diligence to secure the accuracy and the safety of their records. Further, that since church records belong to the church, minister, officials or individuals should not alienate them or in any way assume personal control of them.

(b) Inasmuch as there is a need for standardized methods of keeping records in the local churches of the Conference; that all organized and pioneer churches of the Central Canada Conference be required to adopt such record books and procedures as shall be approved by the Conference from time to time; and that in addition to those requirements for organizing a local church as stated in Paragraph (111) one hundred and eleven of the Wesleyan Methodist Church Discipline, 1963 Edition, such local church be required to show proof of having provided for such record books and procedures as the Conference shall from time to time approve.

(c) In order that the Conference may enforce the keeping of approved record books and procedures; that the local church membership,

birth baptismal, marriage and funeral records, together with the Quarterly Conference Minutes, at the time of the Annual Conference, be made available to the Pastoral Relations Committee for inspection; and if necessary, in the case of inadequate or poorly kept records that the local church be brought under discipline by the Committee on Pastoral Relations.

2. Inasmuch as procedures for keeping records on the local level are left up to the varied expressions of individuals, we believe that the following procedures will be helpful to all and so recommend that they be adopted for use by the clerks, secretaries, and pastors, of the local churches of the Central Canada Conference; and that copies of these procedures be available from, and circulated as required, by the Conference Secretary.

(a) The clerks or secretaries shall keep full and accurate minutes of the proceedings of all meetings.

(b) The minutes shall be written in ink in a legible hand, or typewritten, or printed.

(c) The pages shall be numbered, and the number of each page written or printed at the top of the page.

(d) Every page shall be signed or initialed by the secretary.

(e) The record of each local organization, committee, board, or quarterly conference be signed by the presiding officer and the secretary.

(f) The time and place of each meeting shall be fully stated in words and the date of the meeting shall be indicated on the margin at the top of each page.

(g) The minutes shall state by whose or what authority the meeting was held, as for example "at the call of the chairman," "the first quarterly Conference," or as the case may be.

(h) The opening of the meeting with prayer and the closing of the meeting with prayer, or/and the benediction, shall be recorded in the Minutes.

(i) The name of the presiding officer shall be recorded, and in the case of Quarterly Conference meetings, official boards, committees, and auxiliary organizations, the names of members present.

(j) The items of business shall be briefly indicated by paragraph headings or marginal notes, for ready reference as seen for example in the 1966 Conference Annual Journal.

(k) Care shall be taken that all numbers are distinctly written.

(1) All written reports shall be numbered chronologically by the secretary.

(m) All erasures, cancellings, interlineations, or other changes shall be initialed in the margin by the secretary.

(n) No unnecessary vacant space shall be left between the minutes of successive meetings. If any such vacant space be left, it shall be ruled in plain lines from the writing to the bottom of the page.

(o) The use of initials for organizations and other abbreviations should be carefully avoided.

(p) The record books of the local church, when no longer regularly needed, along with any documents of historical value, should be deposited for safe keeping with the Conference Record Clerk.

3. In order to provide a Standard size and quality Minute binder for use in the local churches of the Central Canada Conference, we recommend the following:

"a) That Lucketts Sterling Line No. 7718 (seven thousand seven hundred and eighteen) Post binder book, size  $9\frac{1}{4} \times 117/8$  (size nine and one quarter inches by eleven and seven-eighths inches) with post size 5/16" (five-sixteenths inch) be the Standard Minute binder for each local church. These can presently be purchased at \$8.80 (Eight dollars and eighty cents) each, on a dozen lot purchase, in Belleville. They list at \$11.00 each (eleven dollars).

(b) That 20 (twenty) pound Bond sheets be purchased for use in these binders and prepared as the Conference shall order. These may presently be purchased at the rate of \$8.00 per thousand in Belleville.

(c) That such as Number 2206 (Two thousand two hundred and six) Accopress Binders may be purchased for 87 cents (Eighty-seven) at O'Neil's in Belleville, for use in storing quarterly reports not to be incorporated into permanent minutes.

4. Inasmuch as the financial reports of church treasurers are summarized in the yearly report, we recommend that the quarterly reports of church treasurers be kept on file, only, during the year, and disposed of as the local church or Conference may direct after that time when they are summarized in a yearly or annual report of that treasurer.

5. In order to expedite the purchase of binders and paper by the local churches, we recommend that the Conference Secretary be empowered to purchase and distribute the binders and papers as may be required, and that funds be made available as the Conference may direct so that he may be able to do so.

6. In order to provide for systemized reporting and record keeping, we recommend that the Conference Secretary provide Binder Sheets as in the following manner:

(a) a plain white unruled Binder sheet for use to record by typewriter or written by hand, the minutes of the meeting, or the pastor's report, the minutes of a committee, etc.,...

(b) a printed Binder sheet for general treasurer's reporting such as shall hereafter be called Form CCC 1000.

(c) a more detailed Binder sheet to systemize treasurer's reporting and shall be hereafter called Form No. CCC 2000.

#### Report No. 31. JUNIOR YOUTH CAMP, JULY 1 - 8, 1967

Seventy-five Junior Campers representing seven different denominations and twenty-one staff members attended the seven day Junior Youth Camp, July 1-8, 1967, at the Silver Lake Wesleyan Methodist Camp Grounds. Approximately two-thirds of the registered campers were girls. Twenty-five of the campers, who were locally registered Christian Youth Crusaders, were awarded Camp Cadet Pins.

Registration receipts were \$1,238.00; refunds of \$24.95 were granted leaving a balance of \$1,213.05 in receipts for registration only.

#### DAILY PROCEEDINGS

#### JULY 26, 1967:

1. **Opening**—The Woman's Missionary Society of the Central Canada Conference convened for its forty-seventh session at the Silver Lake Campground on July 26, 1967.

The session met in the Tabernacle for morning devotions led by Rev. Summers. He read the Scripture from St. John and the Acts and gave a devotional talk on our duty as a church in this Centennial year to spread

6. Committee on Courtesy—Committee on Courtesy introduced Miss Florence Glass R.N., missionary from Haiti, Mrs. Baily from the Middle Atlantic States Conference and Mrs. Nixon from the Pilgrim Holiness Church and these ladies all brought greetings to our Conference.

7. Highlights from Haiti—Miss Glass gave us a short talk on "Highlights from Haiti" and based her remarks on Romans 10: 13-15. She took us on an imaginary visit to Haiti, telling us a little of the size of the country, the population, the language, the religion, and the habits of the people of Haiti. Her talk was very interesting and enlightening.

8. W. M. S. President's Report—The President's Report was read and adopted. (See Report No. 2).

9. Poster Judges—The posters are to be displayed in the Tabernacle and Miss Glass and Mrs. Bailey were asked to be the judges.

10. Camp Centre Fund—A report from the Conference Treasurer told us our Camp Centre Fund project fell short of the \$500 goal and it was voted to continue the project and our goal to again be set at \$500 with each Society setting their own goal.

11. Statistical Reports-Several Statistical Reports were read.

12. Adjournment-We adjourned with prayer by Mrs. Phyllis Smith.

13. Devotions—Our afternoon session was opened with the singing of our theme chorus "Give Me a Passion for Souls" and prayer by Mrs. Nora Elliott. Miss Florence Glass led us in devotions using as her topic "Despondency and Its Cause and Cure". She dealt with three Old Testament men, Moses, Elijah and Jonah as examples and closed with the Scripture verse from Eph. 6:16.

Highlights from Haiti—Miss Glass again gave us some Highlights from Haiti, first of all reading portions of a letter written by Rev. & Mrs. Barnett telling of the loss by drowning of their daughter Marilyn. She then went on to tell us that there are 32 established churches in Haiti with 1918 members and 531 associate members. She also gave us an interesting and informative talk on the work of the Dispensaries.

23. Elections-Mrs. Beiley, W. M. S. President of the M. A. S. Conference was asked to preside over the election of officers.

24. Nominating Committee Report—The report of the Nominating Committee was read and adopted.

**25. Tellers**—The tellers appointed were Mrs. Nora Elliott and Mrs. Margery Cooney.

Mrs. Ruth Irish led in prayer followed by the reading of Psalm 2 by Mrs. Eleanor Spearman. The congregation were led in the singing of the hymn, "Ready". Announcements were given and the offering was received for Miss Glass. Mrs. Bailey, W.M.S. president of the Middle Atlantic States Conference played the organ for the service. Mrs. Laura Smith and Mrs. Phyllis Smith sang a duet "Shall I Find Any Star". The Rev. Wesley Lovin brought the message encouraging us to pray to use our energies to the greatest advantage before our missionaries have to

leave. We were challenged to expand at home so we can expand abroad. His text was Acts 1:8. We have three needs in expanding the kingdom: man power; money power; Holy Spirit power. Following the service Miss Glass showed pictures of Haiti. Offering received: \$53.87.

The Sunday afternoon service of the Annual Conference was opened with the singing of "I Love To Tell The Story" led by Mr. and Mrs. Larry Neff.
