DAILY PROCEEDINGS

Pell City, Ala., November 6, 1919.

The Tenth Session of the Alabama Annual Conference assembled in the First Church at Pell City, Alabama, Wednesday evening, November 5, 1919, at 7:00 P. M. and listened to a soul-inspiring sermon delivered by Rev. I. F. McLeister, our very efficient Associate Sunday School Editor of Akron, Ohio.

The first business meeting was called to order November 6, 1919, at 9 A. M., by Rev. R. A. French, President.

The devotions were conducted by Rev. J. L. Averett.

By request of the President, Rev. T. P. Baker, Missionary Secretary, took the chair as Chairman to preside over the Conference.

The Roll of Elders and Licentiates was called, and 7 Elders and 2 Licentiates answered to their names.

The following named persons then presented proper credentials and were enrolled as Delegates: Miss Frances French, Miss Ella Avery, L. W. Moore, C. A. Weaver, H. A. Johnson, H. F. Shigley, Mrs. T. J. Gleaton, Mrs. Boss Hager, J. L. Hartley.

The Chairman then declared the Conference ready for business, and the President made his annual report which was adopted. (See Report No. 1.)

The Committee on Nominations made its report, which was adopted. (See Report No. 2.)

Recessed for Committee work.

After the recess of the morning, Conference convened for business at 1:30 P. M.

The roll was called and the minutes read and approved.

By motion and vote, order of business was adopted as follows:

- 2. Reading of minutes of previous meeting.
- 3. Presenting credentials of Delegates.
- 4. Unfinished business.
- 5. Recommendations, communications, Resolutions, Reports of Committees, etc.

Committee on Nominations made an additional report, appointing a Committee on Memorials.

Rev. I. F. McLeister, Miss Cleo Young, and Mrs. Anna K. Folger were introduced to the Conference and given honorary privileges and seats within its bar.

Committee on Conference Bar reported, which by motion was adopted fixing the bar to include two seats on each side and front of the pulpit. (See Report No. 3.)

Mrs. Harris, of Birmingham, Ala., was introduced to the Conference, and after listening to an instructive and interesting talk on missionary work, she was accorded honorary privileges within the Conference bar.

Upon motion the following special orders were adopted:

- 2. Sunday, November 9th, 10 A. M., address of the Connectional Sunday School Secretary.

- 4. Friday, November 7th, 10 A. M., election of Conference officials.
- 5. Saturday, November 8th, 3 P. M., Educational address by S. W. Wright, President of Central College.
 - 6. Saturday, November 8th, 11 A. M., Memorial Services.
- 7. Friday, November 7th, 3 P. M., Missionary Secretary's Connectional address.

Upon motion W. R. French was elected Conference Reporter. Upon motion J. A. S. Anderson and J. L. Hartley were elected to assist the President in the examination of character and pastoral reports.

Upon motion the Conference adjourned. Benediction by W. E. Hobson, Jr.

Second Meeting-Friday, 9:00 A. M.

Devotional exercises were conducted by H. A. Johnson. The roll was called and the minutes were read and approved.

The names of Boss Phillips, H. F. Paire, H. C. Paire and H. A. Johnson were recommended to the Conference as suitable persons to take the Course of Study preparatory to travel under the direction of the Conference. Upon motion of the Conference they were referred to the Committee on Itineracy and Orders.

. The Committee on Pastoral Relations gave the first reading on a partial report. (See Report No. 7.)

M. A. Medders made his pastoral report.

The order of the day was called for, and Conference then proceeded to the election of Conference officials.

Upon ballot R. A. French received a majority of all votes cast for President and was declared elected.

The Conference then proceeded to ballot for Vice-President, and upon second ballot J. A. S. Anderson received a majority of all votes cast and was declared elected.

Upon motion the Tellers were instructed to cast the ballot of Conference for W. E. Hobson, Jr., for Secretary and Treasurer, which was done and he was declared elected.

Upon motion the President was empowered with the authority to nominate his Advisory Board.

Upon ballot J. D. Muse received a majority of all votes cast for Sunday School Secretary and was declared elected, with J. L. Averett and W. E. Hobson, Jr., as the other two members of the Conference Sunday School Board.

The President nominated and upon motion the Conference elected H. F. Paire and W. E. Hobson, Jr., as his Advisory Committee.

The Conference then adjourned by limitation.

The roll was called and the minutes were read and approved.

Rev. Ridley, of Tallapoosa, Ga., was introduced to the Conference and given honorary privileges within its bar.

Upon motion and vote, R. G. Ramsey, J. A. S. Anderson, M. A. Medders, J. L. Hartley and Mrs. T. J. Gleaton were elected a Committee on Vacancies.

Upon motion and vote, N. G. Pulliam, R. G. Ramsey, J. A. S. Anderson, and M. A. Medders were elected as a Judicial Committee.

Upon motion and vote, R. A. French was elected for 4 years, and R. G. Ramsey for 1 year on the Committee on Itineracy and Orders.

Upon nomination and by ballot, J. A. S. Anderson and J. L. Hartley were elected a Committee on Ministerial Character.

Upon motion and vote, H. A. Johnson, L. A. Bamburg, M. A. Medders were elected Fifth Sunday Convention Committee.

The order of the day was called for and the Connectional address of T. P. Baker was postponed, and Conference proceeded with its business.
