DAILY PROCEEDINGS

FIRST DAY-TUESDAY-FORENOON

The Iowa Annual Conference of the Wesleyan Methodist Connection convened for its fifty-second annual session at Fairview church, near Marengo, Iowa, Tuesday, Sept. 19, 1905, at half past ten o'clock a. m.

Devotional services were conducted by the Rev. Thomas Hartley, who read scripture lesson and offered prayer. So few members of conference having arrived, on motion conference adjourned to meet at two o'clock p. m.

Benediction by Bro. Andrews of South Dakota.

FIRST DAY-TUESDAY-AFTERNOON

- Devotional services led by the Rev. J. W. Leedy.

On motion the Rev. Thos. Hartley was elected chairmen of the committee on credentials.

The credentials committee made partial report, naming J. D. Williams and J. D. Frick as delegates from Marengo and Sister Libbie Bailey from Greenwood Charge (Minn.).

On motion the bar of the conference was fixed so as to include all seats in front of the stoves.

Rev. J. W. Leedy, lately received as a licentiate, and Rev. A. B. Gould, received from the Minnesota conference, were introduced to the conference.

The president recommended the following persons to the committees named: Rev. A. B. Gould, Education; Rev. J. W. Leedy, Resolutions; Rev. Thos. Hartley, Books and Periodi-

cals; J. D. Williams, Itinerancy and Orders; Rev. Mrs. L. A. Bishop and J. D. Williams, Religious Services.

The above named persons were elected to the offices recommended.

On motion the conference president was added to the committee on religious services.

A motion prevailed to fix the time of opening and closing the meetings of this session. On suggestion of the president the time was fixed as follows: Forenoon meetings to open at 9:00 and to close at 11:30 afternoon meetings to open at 1:30 and to close at the discretion of the body.

The following resolution was presented: First, that the president of conference be constituted permanent chairman of the committee on religious services; second, that the pastor and first delegate from the charge at which the next conference is to be held be constituted the remaining members of the committee for the session; third, that this arrangement be a standing rule of conference until rescinded. On motion the matter was laid on the table for future consideration.

Communications were read from the Rev. J. H. Meek, pastor of Dundee charge, and the Rev. L. W. Easton of Wellsford, Kansas, and their characters passed.

A communication from the Revs. J. C. and Anna McGovern was also read, in which they request letters from this conference.

On motion the names of J. C. and Anna McGovern were ordered restored to the roll (their letters of standing from this conference having been returned to the president during this conference year).

Their names were called for passage of character and their characters passed.

On motion their requests were granted and they were grantted letters of transfer from this conference to the Dakota conference. A communication from the Rev. H. E. Buck was read and his character passed.

On motion all papers when read before this body were ordered passed to the committees to which they properly belong.

In the passage of character the Rev. Thos. Hartley was called, made report, answered disciplinary questions, and his character was passed.

On motion conference adjourned at 4 p. m. for the organization of committees.

Benediction by the Rev. A. B. Gould.

SECOND DAY—WEDNESDAY—FORENOON

Conference opened with devotional services led by the Rev. F. A. Butterfield.

The Rev. W. D. Merryman was elected a member of the committee on credentials.

The committee on credentials reported the following named persons as duly elected delegates to this body: Maurice Brink, Dayton; Miss Maud Nickolaus, Wayne; Mrs. Ella Reed, Elm Ridge.

Roll called, minutes read, corrected and approved.

The president made recommendations regarding the filling of standing committees as follows: Sunday Schools, Miss Bertha Betzer; Itinerancy and Orders, Maurice Brink; Postoffice Addresses, Edythe Merryman; Auditing, Revs. George S. Fry and Albert Johnson; Disbursement of Superannuated Ministers' Fund, Revs. Thos. Hartley, T. F. Blair and G. C. Houck; Memorials, Revs. George S. Fry and A. W. Hall; Pastoral Relations, Rev. George S. Fry, Rev. R. Wesley Mack, Rev. E. R. Dodd, J. D. Frick, W. N. Walton and Sister Ella Reed.

Motion prevailed to adopt the above recommendations of the president.

A communication from the Rev. B. F. Logsden was read, his name called for passage of character and his character passed.

A letter of greeting from Mother M. C. Grinnell was read, after which conference joined in singing "My Latest Sun Is

Sinking Fast."

On motion the conference secretary was instructed to write a letter of greeting to Mother Grinnell and to any others that in his judgment required such.

Sister Bertha Betzer, a licentiate received during the year, was introduced to the conference.

In the passage of character the Rev. Geo. S. Fry was called, answered disciplinary questions, and his character passed.

The name of the Rev. R. D. Robertson was called; he being absent and no communication from him having been received, the following motion regarding his case prevailed: Moved that the secretary of the conference be instructed to communicate with the Rev. R. D. Robertson of Doan, Iowa, for the purpose of ascertaining his present relations to this conference, and that the action of this conference shall be final when an answer from him shall have been received.

The name of the Rev. W. H. Riley was called, reported by the Rev. Dodd, and his character passed.

The name of the Rev. James Lytle was called, reported as having passed to his final reward during the past conference year; his name was ordered placed upon the roll of honored dead.

The committee on credentials reported the following delegates: Miss Edythe Merryman, Guthrie Center; D. O. Bliss, St. Charles; W. N. Walton, Hoover.

A letter of standing of Elder W. Van Driessen of the former Minnesota conference was read and referred to the committee on itinerancy and orders.

The name of the Rev. B. Bender was called and report was

made that he had passed during the conference year to his Heavenly Home. His name was ordered passed to the roll of honored dead. Conference joined in singing one of Father Bender's favorite songs, "I Shall Be Like Him," and Rev. Dodd led the conference in prayer.

The Revs. F. A. Butterfield, C. M. Howe, R. E. Willis and Albert Johnson were called, made report and characters passed.

The Rev. A. B. Gould was called and was offering his report when at 11:30 a. m. conference was adjourned by limitation.

The conference president offered prayer and the Rev. A. Johnson pronounced the benediction.

SECOND DAY-WEDNESDAY-AFTERNOON

Devotional services led by Sister Bertha Betzer, who led the conference in prayer, then reading the word from the tenth chapter of John. Rev. Fry then offered prayer.

Minutes read and approved.

The committee on credentials reported Mrs. Mattie Jones as delegate from Bennezette.

The item of unfinished business, viz. the examination of the character of the Rev. A. B. Gould, was resumed and after answering disciplinary questions his character passed.

The Rev. W. D. Merryman was called and was offering his report when the question of reporting Union Sunday Schools was raised and after being discussed at some length the following resolution was offered and previled: "Resolved, first, that all Sunday Schools under the pastoral oversight of Wesleyan Methodist pastors may be included in the statistical report of the pastor having said school in charge; second, that the above be spread upon the conference minutes as a standing rule." On completion of this report the character of Rev. Merryman passed.

The committee on credentials reported S. Rymil as delegate from Homer (Neb.) charge.

The Rev. E. R. Dodd was called, made report as conference evangelist and his character passed. On motion the conference evangelist's report was adopted. See report.

The resolution relative to the committee on religious services, which was laid upon the table in yesterday's afternoon meeting, was by motion taken from the table. A motion to adopt the resolutions prevailed.

On motion it was made the order of the day at 2:30 p. m. tomorrow to elect conference officers.

On motion Rev. A. Johnson was added to the committee on statistics.

On motion conference adjourned at 4:00 p. m.

THIRD DAY-THURSDAY-FORENOON

Devotional services led by the Rev. A. B. Gould.

The committee on credentials reported W. M. Gipe as delegate from Emmanuel charge.

Roll called and minutes read and approved.

Recommendations of W. D. Merryman, Edythe Merryman and Bertha Betzer were read and by previous action referred to the committee of itinerancy and orders.

On motion it was made the order of the day to hear Rev. Hall's report Saturday afternoon at 2:30 o'clock.

On motion all visiting brethren and sisters in harmony with our doctrines and principles were invited to honorary seats.

The Rev. F. J. Wilson was called for passage of character and offered his official report, which was by motion ordered adopted item by item.

Items 1, 2, 3, 4, 5, 6 and 7 were read and adopted.

Item 8 read and was being discussed when conference was adjourned by vote at 11:30 a. m.

Benediction by the Rev. Hall.

THIRD DAY-THURSDAY-AFTERNOON

Devotional services were conducted by Rev. Dodd.

Minutes read and approved.

Rev. Fry was again called to the chair and the conference president proceeded to make his report.

On motion this item of business was waived and the committee on credentials reported Mrs. Anna Rogers as delegate from Pilot Rock.

The president again read item 8 of his report which was by motion referred to a special committee of three to be appointed by the chair. The chair appointed Revs. A. W. Hall, E. R. Dodd and Thomas Hartley as such committee.

On motion the order of the day, viz. the election of officers, was postponed until 10 a. m. tomorrow.

The president proceeded with his report.

Items 9 to 27, inclusive, were by motion adopted.

Items 28 to end of the report were by motion referred to the auditing committee.

The president resumed the chair and Houghton Student Committee reported by Rev. R. E. Willis. Report adopted. See report.

A subscription was taken for Sister May Lord, our present student in Houghton College and fifty-eight dollars was pledged for her support in completing her school.

The conference president offered the following: "Following resolutions are offered as a substitute for 'First' in instructions to president in published minutes of 1904, page 21: First, that the conference president be required, authorized and appointed to travel the conference as president and hold at least one

service at each of the churches during the year, under such dates as he may publish in advance, having general supervision of the spiritual interests thereof; second, that he shall also have charge of the benevolences of the conference, and shall receive contributions therefor, which shall be divided as follows: 60 per cent shall be placed to the conference fund, 15 per cent to foreign missions, 15 per cent to home missions, 10 per cent to the superannuated ministers' fund; third, that he shall have general supervision of the church property within the bounds of the conference, and shall inquire into the titles of the same to see that no property is loosely held. and shall look after the rental of conference property and see that the rent is placed in the conference treasury, and shall investigate the feasibility and possibility of the sale of conference property not in use, and report his findings to the next session of the conference; fourth, that he shall also devote as much time as possible and as occasion may afford in quarterly and other meetings."

The above resoultions were by vote referred to a committee of three appointed by the chair. The chair appointed as such committee the Revs. Mack, Butterfield and Hall.

Conference adjourned by motion.

Benediction by the Rev. Thos. Hartley.

FOURTH DAY-FRIDAY-FORENOON

Devotional services were led by the Rev. D. W. Scott.

Roll called, minutes read and approved.

Recommendation of W. R. Emerson was read and referred to the committee of itinerancy and orders.

Communications from the Revs. G. J. Cameron and J. J. Fell were read.

The auditing committee made a report regarding the financial portion of the president's report. Report adopted. See report.

The special commmittee to which was referred the resolutions presented yesterday by the conference president made report. Report ordered adopted item by item.

Item 1 read and adopted.

Item 2 was read, discussed and adopted by a vote of twenty for and one against, the negative vote being east by the president.

Items 3 and 4 read and adopted.

The remaining portion of the report, which was explanatory in its character, was read and adopted by a vote of eighteen for and two against. The report as a whole was adopted.

The special committee to which was referred item 8 of the president's report, made report. Report unanimously adopted. See report.

Recommendation of Adelia Houck was read and referred to the committee of itinerancy and orders.

Rev. W. D. Merryman was elected to the committee on statistics.

The president's report as a whole was adopted. Conference adjourned by limitation at 11:30 a. m. Benediction by the Rev. J. W. Leedy.

FOURTH DAY-FRIDAY-AFTERNOON

Devotional exercises led by the Rev. Merryman.

Minutes read, corrected and approved.

The belated order of the day, viz. the election of conference officers, was taken up and resulted as follows:

For president, on first ballot, Rev. F. J. Wilson received twelve of the twenty votes cast and was declared elected.

For vice-president, on first ballot, Rev. F. A. Butterfield received eleven of the twenty-one votes and was declared elected.

For secretary, on first ballot, Rev. R. Wesley Mack receiv-

ed nineteen of the twenty-two votes cast and was declared elected.

The committee on credentials reported George W. Belt as delegate from Bethel charge.

For treasurer, on first ballot, Rev. R. E. Willis received twenty-five of the twenty-six votes cast and was thus elected.

For conference trustee, on first ballot, Rev. John T. Platt received thirteen of the twenty-five votes cast and was thus elected to succeed himself.

For trustee for one year to fill vacancy occasioned by the resignation of the Rev. F. E. Calhoon, Rev. A. B. Gould received fifteen of the twenty-five votes cast and was thus elected.

On motion the Rev. F. A. Butterfield was elected to succeed himself on the committee of itinerancy and orders.

On motion the present committee on presidency was re-elected.

On motion the present advisory board was re-elected.

On motion the present judicial committee, with Rev. Thos. Hartley to take the place of Rev. Calhoon, resigned, was reelected.

On motion the present camp meeting committee, with Rev. A. B. Gould to take the place of Rev. Meek, who expects to reside outside the bounds of the conference, was re-elected.

The order of the day was called and the officers of the W. H., F. & Conf. Missionary Society were invited to the president's and secretary's chairs to take charge of the annual conference missionary meeting, report of which follows:

The eighth annual report of the St. Charles Home and Foreign Missionary Society:

The St. Charles society meets every two weeks. The devotional exercises and business meetings are led by the president or vice-president. Each meeting is opened by singing, reading a chapter from God's word and prayer. The business meetings consist of roll call, reading minutes of last meeting, hearing report of solicitors and committees, paying of dues, etc.

Number of members belonging to the society at the commencement of the year, 18. One member removed by death during the year, one withdrew, and three were received, making 19 members in society now.

Standing Rules and Resolutions

By an act of conference the conference secretary was instructed to include in the conference minutes all standing rules and resolutions of this conference.

On page 3 of Vol. III of the Conference Records we find the following: On motion of Rev. S. A. Gilley, "All resolutions of this conference in annual sessions, so far as adopted at previous sittings, are hereby repealed."

See Conference Journal Vol. III, page 117: 1, "That the enrollment and not the average attendance shall be the basis of the statistical report of number in Sunday Schools;" 2, "That pastors report all salary and donations separately and that the committee on statistics shall so record them;" 3, "That the rent of parsonages be not reported as part of the salary."

On same page of Journal we find the following: "Resolved that it is the sense of this conference that the discipline requires that the license of every quarterly conference licentiate, whether or not recommended to the annual conference to travel under its direction, or to be ordained as elders at its hands, shall be renewed once a year and so reported to to the annual conference, provided it is the mind and purpose of the quarterly conference to continue the licentiate in such relations."

From page 158, Vol. III: "Ordered that, until further notice, annual conference shall convene on Tuesday instead of Wednesday as heretofore."

Page 185, same book: "Resolved that it be the rule of this conference that no elder or licentiate thereof has the right to hold or conduct religious services within the bounds of any church or charge within the conference without the consent and approval of the pastor of such church or charge, unless so authorized or appointed by the conference president thereof."

"Resolved: First, That the conference president be required, authorized and appointed to travel the conference as president, having general supervision of the spiritual interests and benevolences thereof, holding at least one service at each of the churches during the year, under such dates as he may publish in advance. Second, At such services he shall present the subject of our benevolences and direct, assist and encourage the pastors and churches in raising the same, as provided by our book of discipline, under the dollar plan and offering for superannuated ministers. Third, He shall have general supervision of the church property within the bounds of the conference, and shall inquire into the titles of

the same to see that no property is loosely held, and shall look after the rental of conference property and see that the rent is placed in the conference treasury, and shall investigate the feasibility and possibility of of the sale of conference property not in use and report his findings to the next session of the conference. Fourth, He shall also devote as much time as possible, and as occasion may afford, in quarterly and other meetings. Fifth, He shall be paid from the conference fund the sum of \$500.00 and traveling expenses per year for his services, the s me to be paid quarterly."

!'Resolved: First, That the president of conference be constituted permanent chairman of the committee on religious services. Second, that the pastor and first delegate from the charge at which the next conference is to be held, be constituted the remaining members of the committee for the session."

"Resolved: That all Sunday Schools under the pastoral oversight of Wesleyan Methodist pastors may be included in the statistical report of the pastor having said school in charge."

REPORTS

PRESIDENT'S OFFICIAL REPORT

With gratitude to our blessed Lord for his kind and tender care and gracious benediction, and to the brothers and sisters who have borne so patiently our many mistakes and infirmities and co-operated so earnestly and generously to make the year a spiritual and financial success, we submit the following report:

- 1. Sept. 21, 1904. Arranged for Rev. M. R. Baldridge of the Dakota conference to serve the church at Bulah, Neb.
- 2. Oct. 31. Rev. G. J. Cameron resigned his work at Homer, Neb., and Guthrie Circuit, and engaged to serve the Hoover charge, which was approved.
- 3. Nov. 8. Rev. J. J. Fell resigned from the statistical committee and Rev. Waldo R. Emerson was appointed to fill the vacancy.
- 4. Nov. 8. The action of the last conference inviting the Minnesota conference to unite with us and the following resolution passed by the Minnesota conference Oct. 1, 1904, and approved Nov. 1 by the president

of the general conference, formed a basis for our operations in that state during the conference year: "Resolved, That, in accordance with the action taken by the late session of the Iowa conference and insofar as this body has power to act, we do hereby discontinue our separate existence and unite ourselves with the Iowa conference, subject to the forms and rules provided by the discipline and otherwise for making this action valid. It is understood and provided in this action that the preachers and churches of this conference who shall so elect shall be received by the Iowa conference to its full privileges and rights and shall receive the same consideration and care accorded those now belonging thereto, and if, in the good providence of God, our borders shall be enlarged and our numbers increased so that it shall seem best to assume again our separate station, the right to do so is reserved without prejudice by this action."

- 5. Oct. 19. As Rev. A. B. Culbertson did not take the Hoover and West Union churches as conditionally appointed by the last conference, he was appointed missionary evangelist and went to Washington state.
- 6. Nov. 16. Received \$15, interest on the Beasonsfield parsonage note, and forwarded same to the conference treasurer.
- 7. Jan. 1, 1905. Endorsed the arrangement for Rev. C. G. Chandler to serve the West Union work as pastor for an indefinate time.
- 8. Jan. 21. Received official notice that the Greenwood and Buttermore churches in Minnesota had voted to unite with the Iowa conference, and, having secured the concurrence of one of the advisory board, received them.
- 9. Jan. 27. Received letters of standing from Rev. J. C. McGovern (elder) and Rev. Anna McGovern (licentiate) as returned to the Iowa conference, and ordered the secretary to issue conference license to Anna McGovern.
- 10. Feb 6. Received Rev. A. B. Gould into the conference as an elder on his credentials from the Minnesota conference.
- 11. Received and accepted the resignation of Rev. F. E. Calhoon from the committee on itinerancy and orders and appointed Rev. A. B. Gould to fill vacancy.
- 12. Rev. G. J. Cameron desiring to go to Nebraska, resigned his work at the Hoover charge, and was appointed missionary evangelist Mar. 23.
- 13. April 5. The purchaser of the Beaconsfield property released the same to the Iowa conference, being unable to pay out, which was accepted, and the property was rented to the same party for one year at \$4.00 per month, payable monthly in advance. \$12.00 was paid in advance and forwarded to the conference treasurer.

14. For lack of funds and other reasons deemed justifiable, I did not travel the conference according to directions from April 10 to July 9.

15. Accepted the resignation of Rev. F. E. Calhoon as pastor of the College Springs church, he having accepted a charge in the Congregational church.

 April 13. Issued letter of standing to Rev. James Hughes and on April 25 issued letter of withdrawal.

17. April 30. The arrangement for Rev. A. R. Higgs of the U. B. church to serve the Tuttle's Grove church half his time was approved.

18. May 20. Granted letter of standing to Rev. F. E. Calhoon.

19. June 12. Accepted the recommendation of J. W. Leedy, licentiate of Marengo charge, to travel, and appointed him missionary evangelist.

20. June 25. Issued transfer to E. S. Goodin, licentiate, to the Kan-

sas conference.

21. July 7. Received \$12.00, less 25¢ commission, for rent on the Beaconsfield parsonage, and forwarded the same to conference treasurer.

22. Aug. 9. Purchased tent of Des Moines Tent and Awning Co., 33x50, three years old, for \$100.00. \$75.00 has been paid on the same, \$50.00 of which was sent from the Hoover church and \$25.00 I borrowed on my own account. \$13.10 of this has been secured in the meeting in Guthrie Co. \$15.00 is yet back on the subscription for the same at Hoover. The balance is yet unprovided for.

24. Arranged for the conference evangelist to hold meetings at Emmanual, Dayton Valley, Guthrie Center, West Union, Marengo, Dale, Homer, Neb., and Hoover. The last three named were tent meetings. These meetings were productive of good and from which there were some

accessions to the church.

25. Arranged for Rev. Harry Furgeson to hold meetings at Dundee, Bethel and Tuttle's Grove. Some fruit resulted from these meetings.

26. Arranged for Rev. J. W. Leedy to hold meetings at Guthrie Center, Greenwood, Minn., and Wichita, which were not without results and ingathering.

27. Upon repeated and earnest requests from the president of the Alleghany conference for the Rev. E. R. Dodd, conference evangelist, to assist in their conference camp meetings, Aug. 23, I consented.

REPORT OF COMMITTEE ON EDUCATION

The Iowa Conference believes in education. While we deplore the tendency of the times to dethrone the Holy Spirit and set up in its stead a godless head-worship, we recognize that the plan of God to use human instruments in the salvation of the world implies intellectual equipment as one of the weapons by which his servants are to wage a good warfare. "Study to show thyself approved." The first requisite is the enduenient with the spirit of God. "Without me ye can do nothing." Second to this alone is a mine trained and shaped as an instrument to our hands for the work to which we are called. From Moses down the men whom God has used to guide and establish his cause have been men endowed with both these requisites—they were spirit filled men and they were educated men.

Now, an educated man does not of necessity imply a course in school. Many a man who deserves that title has carned it as Abraham Lincoln earned it, with little help from the schools. And let no man to whom early advantages have been denied despair of remedying the defect by his own efforts. But the fact remains that ordinarily the school is the only practical means of securing an education and we urge upon our young, especially those who feel called of God to the work of the ministry, to fit themselves for that work by a course in school.

And in these days of apostary and disloyalty to God and his bible, when many so-called Christian colleges and even theological seminaries have become hot-beds of infidelity, we exhort our people to great carefullness in the choice of the schools they shall patronize. We recommend to them our own school at Houghton as one where a full gospel and a whole bible are taught and revered, and where the spiritual is not forgotten or subordinated to the development of the intellectual.

COMMITTEE ON RESOLUTIONS

Believing it to be for the glory of God that we publicly declare our open disapproval and relentless hostility to certain public evils, which we recognize with sadness have such a hold upon our nation and in too many cases upon the church itself, we, the Iowa Conference of the Wesleyan Methodist Connection at Marengo assembled, do declare our purpose in the following resolutions:

PROHIBITION

Whereas we believe the use of alcoholic liquors by the individual, and the manufacture and sale of the same by individuals, companies or

states, is evil in its practice and results, a sin against God and humanity; and whereas the word "temperance" cannot be applied to any form or sin, the least compromise or indulgence being excess, therefore be it resolved,

First, That we demand of our ministers and members that they totally abstain from the use of all forms of alcoholic liquors as a beverage, and urge them to endeavor to persuade others to total abstinence.

Second, That we believe the sale of and indulgence in the so-called "lighter drinks," as pop, giuger ale, etc., is a great source of temptation to the young and therefore a great evil, and we pledge ourselves to at all times shun the very appearance of evil in this matter and to use our influence against the same.

Third, That, in our opinion, the only solution of the saloon problem is no saloon, and that the only right course of action for the state and nation is to refuse to license this evil, and by state and national amendment to prohibit the manufacture, sale, importation and exportation of alcholic liquors for beverage purposes. And we deem no political party worthy of the support of Christian men which consents to the license system, or does not put itself on record as openly hostile to this accursed traffic. To this end we affirm that no member of the Wesleyan Methodist church can consistently lend aid by voice, vote or influence to such organizations.

SECRET SOCIETIES

Whereas, we see only evil, and that continually, from the unholy fellowship with secret orders, therefore be it resolved,

That we re-affirm the declarations of our discipline, that we will on no account tolerate our ministers or members joining or holding fellowship with secret societies, as in the judgment of this conference it is inconsistent with our duty to God to hold such relations.

DIVORCE

Whereas, the foundation of our civil and religious life is that sacred institution, the home; and whereas, its security and purity is being wantonly destroyed by the looseness which prevails in the laws of the state and in the practices of the church, many of which recognize at least a score of different causes as a basis for annulling the marriage contract; and whereas, the word of God admits of but one cause, therefore be it resolved,

First, That, following the teaching of our blessed Lord, we will recognize but one ground for divorce—that leff us in His precious word.

Second, That our ministers keep themselves unspotted from this thing

by refusing to unite in marriage persons divorced for any other than the one cause, believing John II-11 "that he that biddeth him godspeed is partaker of his evil deeds."

Third, That we heartily join in the just indignation and righteous efforts against the seating of polygomous congressmen but from the statement of Jesus that "whosoever putteth away his wife and marrieth another committeh adultery," we give as our judgment that there is no difference between the man who contracts plural marriages and chooses to retain all as wives and the man who contracts plural marriages and who on unscriptual grounds chooses to put away all but one, and that this last state of sin should be exposed and given its proper place by the side of the other.
