# RESOLUTION NO. 1.

Whereas, it is apparent to the considerate that much of the conflict in pastoral work and the obstructions to best success, arise from confusion in the churches growing out of conflicting administration of church discipline, and consequent antagonism to the most faithful pastors among us. And

Whereas, on the line of disregard of disciplinary law touching methods of raising funds for church purposes, too tolerate a spirit has been manifest and grievous violations have been overlooked and excused, until the violaters have taken courage and become defiant, which brings our holy cause into reproach, sapping the spirituality and threatening the very life of some of our churches and charges. And

Whereas, it is the sense of this Conference that to further tolerate these abuses is to sacrifice principle, surrender the church to her enemies and betray our trust as watchmen on the walls of Zion. Therefore

Resolved I. That we judge the times are ominous of danger when members of an annual Conference practice and advocate the over-riding of Disciplinary law which renders them guilty of misdemeanor and that strenuous measures are required to abate this intolerable offence.

Resolved II. That in the examination of ministerial characters it shall be the privilege of any member of Conference to question parties being examined touching their practice in raising of funds or sanctioning the raising of funds in their respective fields.

Resolved III. That in case any member shall fail to give satisfactory evidence that his practice has been scriptural and disciplinary his case shall be referred to the Judiciary committee for immediate action.

## REPORTS.

Report of official action of President from May 1st, 1904, to April 25th, 1905.

1. May 2nd, 1904, entered into correspondence with S. H. Stokes as per order of Conference relative to funds in his hands from Long Lake charge. Received the same week, May 6th, money in his hands as follows:

II. May 9th, 1904. Visited Glens Falls, accompanied from Brandon, Vt., by C. E. Hill, to look over Glens Falls church property An extension of time on option given was secured, time of extension twenty days. Because of being unable to secure the needful funds as ordered by Conference, the church property has not been acquired by the Conference.

Total expense of trip \$13.60.

III. May 13th, 1904. Received Rev. D. C. Haven by transfer from Syracuse conference.

Consented that A. J. Allen should take the field at Long Lake.

Consented to the extension of work of H. C. Shares so as to embrace any part of the conference where his labors might be desired.

IV. May 27th, 1904. Visited Mooers to confer with several of the brethren who were invited to meet me there. Subject of conference relative to Camp meeting and purchase of conference tent and seats. Expense of trip \$4.13.

V. About June 1st, 1904, entered into correspondence with different firms relative to purchase of conference tent and settees, After carefully considering the offers of different firms, in the month of July purchased of the DesMoines Tent & Awning Co., of DesMoines, Iowa, a tent, 40x61 with 7 foot side walls with side poles and center poles, at a cost of \$194.00, on board cars at DesMoines.

Purchased of W. H. Lattimer & Son, of Orwell, N. Y. 126 settees at a cost on board of cars at Richland, N. Y., of

\$66.00

Making a total cost of

\$260.00

Of this amount \$142.00 has been secured in cash in harmony with your action at the last session of Conference. A Conference note was given for \$112.00. This has been reduced by payment until at this date the balance which is now due is \$43.24.

VI. July 5th. Approved of the engagement of Earl E. Curtis as pastor at Chittenden, Vt.

VII July 16th, 1904. Requested Rev. C. E. Hill to look after our interests at East Warren, Vt.

VIII September 5th, 1904. Appointed Rev. J. F. Wright to look after the legal matters in securing Camp Meeting grounds at West Chazy, N. Y.

IX. Jan. 24th, 1905. Appointed the first delegates to be elected from Forestdale and Chittenden charges respectively, as lay members of the committee on Itinerancy and Orders.

X. Feb. 8th, 1905. Received petition from three churches in Ulster Co., N. Y., (namely Woodstock, Acorn Hill, Chiches ter,) asking to become a part of the Champlain Conference. Subject to ratification by the General Conference. So received subject to Conference approval.

XI. March 30th. Peekskill church asked to come under care of Champlain Conference. Received, subject to Conference approval.

XII. April 18th. Rev. A. F. Lent received to membership, formerly member of New York Conference.

Dear Brethren:—Under the providence of God, we are permitted to gather for our Sixty-fourth annual gathering. Surely when we look over our list and realize that the ranks of our ministry have not been broken by the hand of death during the conference year; we can say God hath dealt gently with us and to Him will we give praise, adoration and continued devotion and loyal service.

May we not profitably for a moment consider some of the encouragements of the past and some of the needs of the future.

So far as your servant has been informed there comes much encouragement from the fields of the Conference in the main; from many fields comes reports of souls saved, and some sanctified, with some additions to the church. Some good substantial improvements have been made to church property.

It has been said that the day of holding Camp meetings profitably is gone by. Such by the experiences of the past is not true however of the Champlain conference, as those who have attended the Camp-meetings of the last two years can testify. And we do not find it necessary to resort to the popular methods of conducting them with a lecture on some popular theme each day. But in the presentation of the good old gospel plan of salvation, and the blessed unity and harmony existing among the workers in honoring the Holy Ghost and humbly and willingly obeying God, with three altar services a day, scarcely an altar service at which there were not souls seeking and finding pardon and purity. And from these meetings much good has gone out to the charges represented by individual and tent companies on the grounds. This is a source of encouragement; and there is need that under the leadership of the pastors there should be if possible a representation of one or more tent companies from every charge in the conference. It may take much work and some sacrifice, but the time of our sacrificing, for the cause will be short for it will all be in this life if at all. The time of our opportunities are hastening. The importance of the work, the value of the souls, the multitudes going the downward way, the number hungering and

thirsting for heart purity, demand a mighty concentration of effort all along the line for carrying on the work till the grandest measures of successful gathering of sheaves for the Master is realized.

There has never been grander possibilities before us as a conference, and if the report of official action following this be adopted we have never had as great responsibilities resting upon us as to developing the territory covered by our conference. One great need felt in the past in evangelistic work in the summer is overcome viz, the need of a tent. We now have an excellent tent with good seating facilities and lights for the same. What is needed? Fields to occupy? No, we have them. need is workers both for our charges and for evangelistic work. and then another need is means to pay the workers; and we speak of the means last for it occupies a secondary place though of great importance. And the greatest measures of success will come along the line of securing funds for broadening our work; only as we who are pastors are much broader than our own particular field of labor; and the people of our charges see beyond the boundary of the circuit on which they live and worship. If one half of the tithe coming from the salaries of preachers in the conference could be devoted in that direction, one evangelist could be thus supported, and if God's people all through the conference were fully up on the tithing line every pastor would be comfortably cared for and money enough in the Lord's treasury to sustain a good corps of workers in the field. But we need the men. In writing the President of the Allegany Conference for suitable men, he replied; "Have none I could clearly recommend." We surely need to use Luke 10: 2, when we go to prayer: "Therefore said he unto them, the harvest truly is great, but the laborers are few: Pray ve therefore the Lord of the harvest, that he would send forth laborers into his harvest." And truly the fields are white for the Harvest; the veterans of the past have loyally labored and gone on to reward. Some of long years of service respond to roll call to-day and press the battle yet. Some of middle age; and a few but just entering on life's work, are with us on the battle line. And yet our great need is for more laborers.

Many there are sailing with us on life's sea, and yet not safe on the old ship Zion.

We look back over the year; let us take warning from any failures of the past; and take courage from the success God has given and the souls saved; and press forward to the work of the year to come with increasing zeal and earnestness, a continued sense of the abiding presence of the Holy Ghost, as laborers togather with him, keeping the unity of the spirit; glorifying God in service. Saved, sanctified, with the glory in our souls and should he come for any laborers before the year closes ready for the mansions of Glory beyond.

# REPORT OF CAMP MEETING.

Report of Camp Meeting Committee, your committee beg leave to submit the following report:

- 1. After careful consideration of the interests of the camp meeting, your committee changed date of meeting from June 16 to August 23.
- 2. We are glad to report success in obtaining the services of Rev. E. W. Bruce and Miss A. Rubardt.
  - 3. It is with great pleasure that we report success in the

purchase of the grounds used the last two years to hold our camp meeting on. As many of you know these grounds are located at West Chazy, containing nearly ten acres of land. Price is \$1,500, \$964.00 of which has been paid. Leaving a debt of \$536,00. \$500,00 of this stands against the grounds in the form of a mortgage held by Mrs. Anna Olnev of West Chazy. \$36.00 is due Rev. L. C. Partridge, \$800.00 of the amount raised was realized from the sale of lots, of which there are at least 100 more, which we shall be glad to sell at ten dollars each. were two special meetings of the committee, one July 14 to select a permanent place for tabernacle and fix on size of lot and location of streets and avenues. September 2, one to appoint a committee to collect funds, secure deed, stake out grounds, etc. The deed has been secured, abundance of contracts provided and part of the lots staked. There was raised at the time of the camp meeting to defray expenses of meeting and preparing for same. There were more tents, more pastors and more tenters than the year before. There were three services held daily. Bro. Bruce's work was highly satisfactory. The committee extend an invitation to him to come another year.

# No. 4. REPORT ON GLENS FALLS.

We, your committee on Glens Falls church, beg leave to submit the following report:

- 1. After examination of the papers of incorporation we find that they are unsatisfactory, not connecting said church properly with the Wesleyan Methodist Connection.
- 2. We have secured the promise of the pastor of said church, Bro. C. E. Fox, that the church will amend the incorporation of said church as The First Wesleyan Methodist Church of Glens Falls, of the Wesleyan Methodist Connection (or Church) of America, and deed the property direct to the Champlain Conference of the Wesleyan Methodist Connection of

America, if the following assistance is realized.

- 3. That we as a conference still assure the Glens Falls Wesleyan Methodist church of our interest in them, and urge them to hold on in present relation to the property until the desired consummation can be realized, and that we will again make effort to negotiate a loan, secured by mortgage upon the property, at the most reasonable rate, as soon as it can be secured.
- 4. We recommend that Edward D. Carpenter be by vote elected attorney in fact to look after and if possible consummate the purchase.
