DAILY PROCEEDINGS

The Alabama Annual Conference of the Wesleyan Methodist Church convened for its thirty-eighth annual session at Camp Eden, Ala., August 13, 1947, at 10:00 A.M. with song services conducted by Oscar Bynum, Jr., followed by Devotions conducted by Chaplain Frank W. Warren.

The session was called to order for business by the President and the roll was called, with a quorum present. The Nominating Committee made a partial report. The Committee on Credentials gave a partial report and fourteen lay delegates were enrolled.

The Conference Bar was fixed to include all seats in front of the second row of posts in the auditorium.

The Committee on Nominations read its final report. The name of Mrs. Vera Cash was substituted for that of Mrs. J. H. Lawson on the Committee on Thanks.

Rev. H. K. Sheets, Connectional Representative, was introduced to the body, and was asked by the President to preside as chairman of the Conference business meetings.

The time of meetings was fixed to meet at 8:45 A.M. and 1:30 P.M. and adjourn by motion.

The President read his annual report, which was approved and adopted as read.

A report was read from the President and Advisory Board fixing Orders of the Day as follows: Conference Sermon, Wednesday, 7:00 P.M.; Election of Officials, Thursday, 9:00 A.M.; Connectional Address, Thursday, 11:15 A.M.; Educational Address, Thursday, 3:30 P.M.; Memorial Services, Friday, 1:30 P.M.

A resolution was adopted reducing the reading of Pastor's reports to total items only.

Tegen and Wardner Medders, acting as tellers, resulting as follows: President, E. L. Shigley; Vice-President, J. A. Treese; Secretary, W. E. Hobson, Jr.; Trustee for a term of three years, Preston S. Spruiell; Member of the Local Board of Managers of Central College, E. L. Shigley, Sr., with S. D. Herron, Alternate.

Mrs. Hallie Watson was introduced to the body by the Committee on Courtesies.

The Finance Committee recommended the election of a committee to study and present to the body definite recommendations regarding the Superannuated Ministers Pension plan. The committee was elected as follows: Fred T. Brazier, J. A. Treese, H. F. Pair and A. L. Deason.

The following pastors read their annual reports: G. C. Frederick, H. R. French, J. L. Davis, D. M. Downey, F. E. Crowe, W. B. Hill. All were approved.

Adjourned by motion until 3:30 P.M. for Committee work.

The Order of the Day was called at 3:30 P.M. and Prof. J. B. Hilson presented the work and needs of the Wesleyan Methodist College, Central, S. C.

FRIDAY—MORNING MEETING

Devotions were conducted by J. L. Averett.

Roll called, minutes read and approved.

Pastoral reports were read by M. A. Medders, O. C. Wood and N. C. Hogg. Reports were approved.

George B. Vernon, Tithing Secretary, read his annual report.

Committee on Pastoral Relations gave its first reading.

J. A. Treease read his pastoral report of the Active church.

The Committee on Pension Plan and Superannuated Ministers Funds gave the following report:

We, your Committee on Superannuated Ministers Fund, submit the following report: Since this Committee was created at such a late date with the task of weighing all matters concerned, the need of looking into the General Conference Plan, adopted, the successful working of other Conference Plans to be considered, we recommend this committee be made a standing committee authorized to bring in a plan for adoption next year or reason why we should accept the General Conference Plan, and that all assignments to the Superannuated Ministers list be referred to this committee with the authority to handle the Superannuated Ministers Fund. The above recommendation was by motion and vote approved.

Committee on Moral Reform reported. Adopted as read.

Camp-Meeting Treasurer reported. Report adopted.

Adjourned by motion for committee work.

FRIDAY—AFTERNOON MEETING

Devotional services were conducted by R. E. Snipes in connection with the Memorial services in which the names of Mrs. Bessie Medders, Mrs. Sarah Barnett, Mrs. W. F. Bunnell and J. D. Avery were read as having passed to their eternal reward during the past year. Remarks were made by several persons relative to the lives and activities of the deceased.

The body was called to order for business.

Roll was called and minutes read and approved.

By vote, one additional lay delegate was seated.

The Committee on Resolutions reported. It was moved that the part of the report containing the resolutions be adopted item by item.

A motion was offered by Wardner Medders to make the item referring to the termination of pastors appointments become effective with the 1948 Conference session. This motion prevailed. A motion was offered by Fred T. Brazier to strike out the termination item entirely. The motion lost. An amendment offered by S. D. Herron prevailed. The Standing Rules were adopted as amended. The Resolutions were read and adopted item by item.

A motion was offered by Fred T. Brazier and carried that all pastors' labors terminate with the last Sunday of camp-meeting this year.

By motion and vote the name of C. R. Tegen was added to the Committee on Thanks.

It was moved and carried that only the items of statistical report as read by pastors be read by the Committee on Statistics.

S. D. Herron was elected as Secretary of Evangelism.

Committee on Finance reported. Report adopted as read.

Committee on Statistics read the Statistical Report.

A motion was presented by J. A. Treease asking that complete address and telephone of pastors be included in the list in the minutes. The motion was adopted.

Auditing Committee reported. Adopted.
Treasurer's report was read and adopted.
Conference Reporter Treasurer reported. Report was adopted.
Committee on Pastoral Relations gave its second reading.
Adjourned by limitation for Orders of the Day.

SATURDAY—MORNING MEETING

Devotions were conducted by E. T. Meacham.

Roll called, minutes read and approved.

The Conference President gave his annual Financial Report, which was adopted as read.

A motion was offered to reconsider the resolution adopted relative to the termination of pastors' appointments or labors. The motion lost by vote.

A motion was offered by Fred T. Brazier asking that the termination of pastors' labors close this year with the rise of this Conference session. This motion prevailed.

The Committee on Pastoral Relations gave its third and last reading which was adopted as read.

Committee on Thanks reported. Report adopted by vote.

Report of the Sunday School Secretary was adopted.

A letter of communication was read from the Missionary Society requesting the publication of the Conference Reporter be continued.

A motion was offered by E. T. Meacham asking the continuation of the publication of the Conference Reporter. The motion was adopted by a vote.

By motion and vote the publication of the Conference Reporter was delegated to the Committee on Conventions with power to act.

Missionary Board reported. Report adopted.

Committee on Itinerancy and Orders reported. Report adopted as read with a proviso to include any name omitted.

A recommendation was presented from the Pell City church recommending Douglas Eugene Smith as a suitable person to study and travel under the direction of the Conference. The recommendation was referred to the Committee on Itinerancy and Orders, with recommendations for Claud W. Hodge and Dozier Gibbs.

On motion adjourned to 2:30 P.M.

SATURDAY—AFTERNOON MEETING

Devotions were conducted by E. L. Shigley.

A recommendation from the Jasper church was offered recommending Erlene Lindsey as a suitable person to study and travel under the direction of the Conference. Referred by vote to the Committee on Itinerancy and Orders.

An expense allowance of \$25.00 was voted to the Secretary.

A transfer was granted Charles W. Crowe to the North Georgia Conference.

It was moved and carried that the Conference pay the telephone, light and water bill of the Conference President each month.

The repairs necessary to the President's home was referred to the Board of Conference Trustees for their attention.

The W.Y.P.S. officers elected for the next year were by vote approved by the Conference body.

Time and place of next annual session of Conference, August 11, 1948, at Camp Eden, with camp meeting to begin August 13 and close August 20, 1948.

Rev. Fred T. Brazier was elected to preach the Conference Sermon next year at 11:00 A.M., August 11, 1948.

The Sunday School Secretary nominated A. L. Deason and Frank W. Warren as members of the Sunday School Board. By motion and vote they were elected.

A motion prevailed requesting the Conference President to ask for a ruling relative to placing members on the associate membership list when dropped from the regular membership roll.

Secretary was instructed to respond to letters from absent members of the body.

A motion prevailed requesting the Conference calendar be printed in the minutes.

It was moved that all matters overlooked or any unfinished business by referred to the President and his advisory board.

A rising vote of thanks was given H. K. Sheets for his service as chairman.

Minutes were read and adopted as read from time to time during the session.

On motion adjourned.

PRESIDENT'S REPORT

As I come to you with this my tenth official report, in this the thirty-eighth session of our Annual Conference, it is with a deep sense of gratitude to God for His manifold blessings and mercies and to the brethren of the Conference for their loyal co-operation and kind indulgence.

To have succeeded in office one whose love and sacrificial service had meant so much to the Alabama Conference as that of Rev. R. E. Snipes has been an honor and privilege of which we have felt very unworthy. We have often been conscious of the splendid foundation work which he did, and have felt more keenly the responsibility enjoined upon us.

The past year has been one of definite progress materially as well as spiritually.

God has blessed a number of the churches with the greatest revivals witnessed in many years. Let us thank God and take courage.

The Mt. Zion Church which showed an indebtedness of \$728.00 on their parsonage last year, paid that off in full in December. The cement block parsonage at Nixon Chapel which was begun last summer has been finished up free of debt and the Church is going forward. The new Church at Prattmont has been finished and is one of the best buildings in the Conference. The East Lake Church has taken a definite step forward by purchasing a much more desirable location where they plan to build in the near future. The Sylacauga Church has voted unanimously authorizing the Conference trustees to sell the church property there and purchase a more desirable location in town. The Anniston Church has definite plans for building a new parsonage in the near future. The Tuscaloosa Church is pushing a program for remodeling and enlarging their place of worship. The Mentone parsonage has been remodeled and the appearance of the property greatly improved. Others have made commendable progress, mention of which time and space forbids.

The improvements on the camp grounds have required much of the President's time and labor for the past five months and we wish to express our deep appreciation to all those who have helped with this work.

There are many open fields in Alabama where there should be Wesleyan Churches and I hope plans can be made for entering some of these

at once. One of the greatest problems at present is that of securing pastors for the established churches as well as for new work.

We, your Committee on Moral Reform, wish to submit the following report:

Standing amid the perils of these days let us as a Church upholding the principles of righteousness and moral decency, give the more earnest heed to the Bible standards of Christian living lest at any time we let them slip.

In order that we as a Wesleyan Methodist Conference may measure up to the name of a reform church, we recommend the following:

1—Not only should our pastors faithfully denounce from our pulpits the modern popular evils of indecent and immodest dress, movies, popular amusements, Sabbath desecration, use of tobacco and alcoholic beverages, and the use of the Church as a mere humanitarian institution, but we should also disseminate good holiness papers, books, tracts, and literature on these evils, and also furnish literature encouraging tithing and faithful church attendance among our people.

2—We further recommend that our pastors set the example for deep spiritual living, and that they diligently give attention to the matter of forming family altars among our people. The importance of spiritual living in family life cannot be over-emphasized.

3—We also recommend that insofar as it is practicable, we have district conventions under the direction of capable, qualified leaders for our young people for the purpose of Bible study and indoctrination and instruction against the popular teachings of evolution and other false theories of so-called science, that tend to undermine faith in the Bible as the inspired Word of God.

That we renew our attack on the movie, the cheap radio program, parties and certain types of music and literature which are detrimental to deep spirituality.

That where there is a rapid destruction of the Lord's Day, we stress the need of keeping the Sabbath in harmony with the Word of God.

That this Conference raise its voice of protest regarding the "isms" of our day in religion and State.

Whereas the full time supervision of the Church by the Conference President which has proven very beneficial, greatly limits his time for Church Extension.

We recommend that the Conference elect a Secretary of Evangelism whose duty it shall be to plan, supervise and where possible promote church extension in the Conference, subject to the approval and directions of the Missionary Board. He shall sit in and have the privilege of speaking in the meetings of the Missionary Board, and shall have the privilege of suggesting a meeting of the Missionary Board to consider Conference extension plans. He shall be paid for his expenses incurred in supervising extension work and when investing full time he shall be paid a salary as stipulated by the Missionary Board.
