STANDING RULES

1. The Conference year shall begin on July 1, and close on June 30. Local Church and Auxiliary Treasurers shall close their books on May 31, and only funds received by the Conference Treasurers, on or before June

10, will receive credit. All Conference Treasurers of Auxiliary Organizations shall immediately close their books; disburse funds and forward a report in full to the Annual Conference Treasurer by June 15.

- 2. The Conference Secretary shall mail one copy of the Pastor's Statistical Report for each charge with budget assessment from the Senior Conference and Auxiliary Organizations to the pastor and the second copy to the Conference Treasurer. The Conference Treasurer will fill in the total budget receipts paid for each assessed item for each church, sign the copy and mail it to the pastor of each charge by June 25. The pastor shall complete the signed report and mail it to the Chairman of the Statistical Committee by July 1.
- 3. The pastor's Conference Sunday School report shall be sent to the Sunday School Secretary not later than 15 days prior to Annual Conference.
- 4. The Secretary of the Canada Conference shall be the Committee on Credentials, and all Lay Delegate's parchments to the Conference shall be mailed to him one week previous to the opening session of Conference.
- 5. The Annual Conference and Adult Camp shall close on the Sunday immediately preceeding the Civic Holiday in August.
- 6. The Conference President and his Advisory Board shall annually appoint a Nominating Committee of seven (7), who will present at the Annual Conference a slate of nominees for all Conference officers and standing committees.
- 7. The President, with his Advisory Board, shall be a Committee on Orders of the Day and Religious Services during Conference.
 - 8. The Conference President shall be Record Clerk.
- The Ministerial Member of the Houghton College Board shall also be Conference Educational Secretary.
- 10. The Executive Board of Directors and Conference Trustees of the Corporate Body of the Wesleyan Methodist Church of America in Canada shall consist of ten (10) members in good standing with the Corporation, as directed under "Management", Paragraph 6, of the Charter of the Act of Corporation of the Wesleyan Methodist Church of America in Canada. FIVE as ex-officio, namely: the President, the Vice-President; the Conference Treasurer, and TWO elders, designed as, the Conference Secretary, and the Conference Youth President, if an elder, and FIVE men, THREE elders and TWO laymen, who shall be elected to a five year term of service by a ballot vote in rotating order. The expiring date of their term of service shall be July 31st, 11:59 p.m., and the beginning date of their term of service shall be August 1st, 12:01 a.m.
- 11. The only items of the Pastor's Statistical Report to be read on the Conference floor are as follows: Item 1—Appointments; Item 2—Wesleyan Methodist, Wesleyan Missionaries, Wesleyan Youth; Item 3—Present Total Membership, loss or gain; number of family alters; Item 4—Potential Regular Attendance; average attendance; Item 5—To be read in full; Item 6—To be read in full; Item 7—To be read in full; Item 8—Total for Church; Item 9—

To be read in full; Item 10-Total for Benevolences; Item 11-To be read in full.

- 12. All reports to the Annual Conference are to be made out in triplicate. Two copies to be given to the Conference Secretary and one to be retained by the individual reporting.
- 13. The Conference Treasurer shall be given \$100.00 per year and the Conference Secretary \$50.00 per year for their services.
 - 14. The Pastoral vote shall be completed by April 30.
 - 15. Churches calling pastors are to pay their moving expenses.
- 16. The third Sunday in August shall be the final Sunday for all pastors who are moving from their present charge.
- 17. The churches shall grant each pastor two week's vacation with pay at a time agreeable to the pastor and congregation.
- 18. Those who travel on Conference Assignments, or to Conference gatherings where travelling expenses are remunerated, the following will be observed:
 - (a) Where possible and convenient clergy rates will be paid.
 - (b) The expenses of meals, room and when necessary travel to and from trains.
 - (c) When it is judged best to travel by train where one has come by car, clergy rates will be paid.
 - (d) When travelling by car, a basis of five per mile will be paid.
- 19. Churches having business with the Board of Directors and Conference Trustees requiring a visit of that body to their church, shall be responsible for the expense attached to such calls, unless released by the Board.
- The Committee on Itineracy and Orders shall decide on those who shall receive the benefits of payment of our Conference Educational Budget.
- 21. That each church be requested to present annually, in a series of studies, the material known as "A Guide to Church Membership", that all prospective new members be requested to attend these classes and any others who are interested may also attend.
- 22. That the Presidents of the Woman's Missionary Society and Wesleyan Youth be members of the Committee on Church Extension and Evangelism.
- 23. That a Conference Camp preparation period be held during the week previous to Annual Conference and that all pastors and as many laymen as possible co-operate in getting the grounds and buildings in readiness for use.
- 24. That the Camp and Conference Entertainment assessment be continued to entertain guests and provide for pastors, their wives and families, meals at half price during camp.
- 25. The Camp Meeting Committee shall be composed of: The Camp Meeting Chairman; The Conference President; and his Advisory Board;

President of Wesleyan Youth; President of Woman's Missionary Society and the Camp Treasurer.

26. Pastors receiving financial assistance from the Conference be paid direct from the Conference Treasurer, and to be shown as a Conference grant under gifts to pastor on the statistical report. Churches receiving aid are to be paid directly to the Church Treasurer.

DAILY PROCEEDINGS

The Corporate Body of the Wesleyan Methodist Church of America in Canada, convened for its Sixty-seventh Annual Conference at the Silvet Lake Campground Maberley, Ontario, July 22, 1964, at 9.00 o'clock a.m.

The Rev. J. S. A. Spearman, Conference President, called the Conference to order.

A devotional period was conducted by the Rev. W. E. Moutoux.

Report of Committee on Credentials was read and adopted on motion.

On motion the action of the President and his Advisory Board concerning the hours of Conference was adopted. The hours being: 9 a.m. to 12 noon, and 1:30 p.m. to adjournment.

On motion, Dr. B. H. Phaup was invited to take the "Chair" and conduct the remaining business of Conference.

On motion, that only the summary totals of the report of the Committee on Statistics be read.

The Report of the Board of Church Extension and Evangelism was read and adopted, Report No. 31.

The Rev. J. H. Walker expressed his desire to relinquish the Conference subsidy for the Conference year 1964-1965. Mr. Spearman expressed the willingness of the Conference to maintain this support.

The Report of the Committee on Itineracy and Orders was read and adopted on motion. Report No. 3.

At this point the Educational Secretary was directed to investigate the possibility to Miss Helen Spearman and Mr. Wayne Wager receiving the tuition reduction at Houghton College.

CONFERENCE PRESIDENT'S ANNUAL REPORT REPORT NO. 1

July 22, 1964

To the representative of our Denomination, Dr. B. H. Phaup, brethren in the ministry, lay members of the Conference, and visitors, we greet you in the name of the Lord at this the opening of our 67th Annual Conference of the Wesleyan Methodist Church of America in Canada.

We are grateful for the privilege of meeting again to consider together our stewardship for the Conference year 1963-64.

We gather at a time of great tension and great concern over the troubled conditions in our world. We meet at a time when nations are struggling in the travail and throws of being born or of becoming independent; at a time when two great conflicting ideologies and two opposing forms of government are in a life and death struggle for supremacy in our world, and at a time when godless atheism is spreading rapidly and is being carried into every area of discontent and trouble.

In the midst of these world conditions, we can take either of two attitudes, an attitude of anxiety, fear and frustration, or one of courage, faith and fortitude; an attitude of conservation and regression or one of aggression and extension. As we face a new Conference year, it is our prayer that we would always be reminded of the fact that "God has not given us a spirit of fear, but of power, and of love and of a sound mind."

This is a time of repentance for the church—repentance for its selfishness, its ease, and its lethargy in extending the Kingdom. It is also a time for revival, redemption, revitalization, and recommitment under the Holy Spirit to a greater, wider and more effective witness, and to an "all out"

giving of self in sacrificial service. Opportunities to extend the Kingdom of our Christ are to be found on every side. In his vision Isaiah said that the church would break forth on the right and on the left. He meant nothing else than that opportunity would be afforded to enlarge the place of our tent and spread forth the curtains of our habitation.

With all that has been accomplished, the opportunities of doing something more are tremendous. If we do not enlarge our borders and double our numerical strength and the number of the churches, it is not going to be because of a lack of opportunities.

Listed among the developments in Conference outreach during the year is the purchase of one and a half acres of land located on the corner of Rossland and Ritson Roads, in the city of Oshawa.

Since our last Annual Conference, our Offer to Purchase property in the town of Trenton has been accepted. Presently a parsonage is under construction by a contractor, Mr. Elmer Woods, from our Belleville Church. It should be ready for occupancy by the middle of August. Renovation and construction has also been started on the place of worship.

We have nothing of major importance to report concerning the two acres of land purchased in Kingston. To retain this property, we must be underway with our church building program by the spring of 1965.

These are but three of many opportunities before us for Church Extension within the bounds of our Conference. To man the work that is before us, we need not only pioneer workers, but we need your co-operation and financial support. We need your prayers and encouragement, and above all else we need God's daily guidance and direction.

On February 18th of this year the Rev. Lloyd McCorriston was called to join the Church Triumphant. The past few years health reasons made it impossible for him to assume the responsibility of a pastorate. Nevertheless he was keenly interested in his home church at Belleville and his Conference. A suitable memorial service will be held during this Conference for our departed brother, and for those of the laity who have passed away during the year. Our sympathies are extended to all who have suffered loss and bereavement.

I must recognize and pay tribute to the churches and people of our Conference who have made certain gains possible. To the Toronto Church for the donation of \$5,000 and another \$2,000 forthcoming for the Kingston for the donation of \$5,000 and another 02,000 forthcoming for the Kingston project, to the Ottawa Church for their willingness to endeavour to raise over the next three years \$10,000 for Church Extension, part of which will go to Trenton and Arnprior, to our Brockville Church for their willingness to assist in Church Extension, to Wesleyan Men for a Memorial Cottage erected on the camp ground, and to the many private individuals who have helped financially in so many different ways.

I would also express gratitude for the co-operation and assistance given to us by the Advisory Board, all officers and officials, and in fact, all my fellow ministers. To these I would add the names of Mrs. Spearman and the Rev. Nancy White who have given sacrificially of their time to the work of the Lord.

As we move forward into the second year of the quadrennium, we would challenge each pastor and church of our Conference to glorious venturing as they strive in faith to reach the goals and objectives which lie before us.

REPORT NO. 6

REPORT OF THE BOARD OF CHURCH EXTENSION & EVANGELISM

The Board of Church Extension and Evangelism begs leave to submit the following report:

1. The Board of Church Extension and Evangelism met Thursday evening, January 30, 1964 in the Brockville Wesleyan Methodist Church.

- a. The matter of the Retirement Savings Plan was presented. It was recommended that the Canada Conference of the Wesleyan Methodist Church borrow such funds as become available through the Retirement Savings Plan of Guarantee Trust Company of Canada and that such funds be used for designated church extension projects only, and as these local projects repay this borrowed money it would be used only to retire these loans unless with the permission otherwise of the individuals involved. We recommend that there be extensive promotion of this plan throughout the Conference.
- b. We recommend that Rev. Walter W. Jewell, Edward E. Wilson and the Conference President be a committee to study and prepare a bond for use in Conference Church Extension.
- c. We recommend that Plan 1, as drawn and presented by Rev. Walter Jewell be accepted as a basic plan for Kingston if approved and for any other location where feasible.
- d. We recommend that we endeavour to locate property in Oshawa and to take steps to establish a work there as soon as possible.
- The Board of Church Extension and Evangelism met Monday evening, May 11, 1964 in the Brockville Wesleyan Methodist Church.
 - a. It was recommended that the mortgage on the Oshawa property with Mrs. Emma Hall amounting to \$6,388.47 be retired as funds become available.
 - b. We recommend that an account be set up in Oshawa bank in the name of the Conference for the deposit of rental for the Oshawa property and that a notice of deposit go to Mr. Bert Young or whoever may be otherwise appointed to act as our agent in care of the property and that we give the mortgagee postdated cheques against the above account.
 - c. We recommend that appreciation be expressed to the Trenton people commending them for their vision and sacrificial labour in establishing a new work.
 - d. We recommend that the Trenton people contribute as much as possible per week toward support of a pioneer pastor and either erect or rent a suitable parsonage and proceed with the church as finances permit.
 - e. We recommend that the Conference pay \$10 a week toward support of the Trenton pastor and that the Auxiliary organizations contribute additional support.
 - f. We recommend that we endeavour to locate a resident pastor for Cornwall if possible.
 - g We recommend that the Conference pay a resident pastor in Cornwall at least \$15 per week and that the local congregation continue to pay at least what they are presently paying for pastoral support and that the church assume the principal and interest payment on the mortgage.

- h. We recommend that the Conference Treasurer be a member exofficio of the Board of Church Extension and Evangelism.
- 3. The Board of Church Extension and Evangelism met on Silver Lake Wesleyan Methodist Campgrounds, Thursday, July 23, 1964.
 - We recommend that the Madoc pastor receive \$25 per month for the Conference year.
 - b. We recommend that the Conference President receive \$140 per month from the Conference this year as previously to assist in the remuneration of his assistant.
 - c. We recommend that the Campbell's Bay pastor receive \$18 per month from the Conference for this year.
 - d. We recommend that the Cornwall Church receive \$200 this year and that it be applied on the principal of their parsonage.
 - e. We recommend that the budget assessment for Silver Lake be \$5.00 per member for this Conference year.
 - f. We recommend that the Conference Church Extension budget assessment be \$6.00 per member for this Conference year.
 - g. We recommend that pastors receiving financial assistance from the Conference be paid direct from the Conference Treasurer and to be shown as a Conference grant under gifts to pastor on the statistical report. Churches receiving aid are to be paid directly to the Church Treasurer, and that this become a standing rule.
 - h. We recommend that the Amprior indebtedness and interest be paid from funds received through Conference Extension Self-Denial Offerings.

REPORT NO. 7

CONFERENCE SUNDAY SCHOOL SECRETARY'S REPORT

This has been a good year in the Sunday Schools of the Canada Conference. With the exception of three schools, all have made substantial gains. The Toronto school had an average gain of 23, Brockville and Ottawa of 12, Shawville of 8, Belleville and Cornwall of 6, North Bay of 5, Powassan of 4, Arnprior, Campbell's Bay and Newington of 3, and Winchester with a gain of 2. The total average attendance for this past year was 1,017. Comparing this figure with the average, one year ago of 934, an average gain of 83 has been achieved. This is equal to the establishment of an average size school.

Several from the conference attended the Wesleyan Day, and NSSA Conventions held in Buffalo, N.Y. last October. This indicates a healthy interest in Sunday School work. Three schools took advantage of the assistance the conference offered in expenses to the convention.

October 3, 1964 at 8.31 a.m. the greatest one day convention you have ever attended will get underway at the Ottawa, Wesleyan Methodist Church. Dr. Paul Kindschi, Executive Secretary of Wesleyan Methodist Sunday Schools, and the Sunday School Staff from World Headquarters will bring this special Share Convention our way. This is part of the Share Project of the Thanksgiving offering of 1963.

It was my privilege to present the need of extension Sunday Schools at the Ministerial Convention last February. The work in its general, conference and local interests was discussed.

Let us plan for more, pray for more and work for more in '64.

Moved by Henry Kielty, seconded by Mervyn Earl Summers and unanimously resolved that the Workers Memorial Cottage be 20' x 24', and Brother F. Pinch have the plans approved by the Camp Meeting Committee.

It was moved by Henry Kielty, seconded by Murray Jackson McKnight, and unanimously resolved that Mr. Barclay Smith be appointed treasurer of the Worker's Memorial Cottage Fund. That all monies received by the Conference Treasurer, the Rev. Jacob Hamilton Weaver, for this fund be forwarded to Mr. Barclay Smith, and Mr. Barclay Smith give a complete statement of money and costs of materials bought, to the Conference Treasurer.

REPORT NO. 20B REPORT OF CAMP CHAIRMAN

To the 67th Annual Conference of the Canada Conference, greetings. It is the privilege of your Camp Committee Chairman to submit this report, not as a personal one, but rather as a supplement to the Camp Committee Report, in an effort to reveal not only the progress made during the past year, but something of our hopes and aspirations, for the future.

While we have not achieved fully the improvements desired this year, yet I feel we are justified in saying a good measure of progress has been made toward this end.

The rewiring of the Dining Hall, installation of water heater, and grease traps while a costly project is one that has already proven it's worth, not only from the viewpoint of convenience, but to a degree economically and certainly in expediting our dishwashing. This with the electric clothes dryer donated by Dr. Dow, for which the wiring is now complete, add considerably to Dining Hall facilities.

By way of grounds improvements I am sure all have noted with pride the new Memorial Worker's cottage now ready for occupancy as sponsored by Wesleyan Men, under Frank Pinch. Our sincere thanks to them. We hope the second cottage will be ready for next year. The addition of the concrete shuffleboard court; donated and equipped by one of our committee members, Dr. E. W. Dow; will not only provide much needed recreational facilities for all ages, but do much to enhance the beauty of the grounds when landscaping is finished.

A good deal has been done on maintenance of existing buildings, including exterior painting of all the cabins, which although costly does not provide additional facilities. It is anticipated most, if not all of the rest of the buildings, including the Tabernacle and Dining Hall will be painted next year. Much expense was saved through donated labor in this area in the two Work Bees, totalling five days. It is our hope that a greater saving can be made here as more of the laity join hands with the ministers.

As you can see a good deal of work has been done toward opening new roads within the grounds as well as maintaining existing ones. All existing roads have been graded and gravelled, in an effort to cut down on the dust as well improve their travellability. This has been an expensive but necessary procedure. The new entrance road has been opened on the grounds now in negotiation of purchase, with funds provided by Wesleyan Men; as well as an access road to the new area opened for cottage sites. All of this would have been well nigh impossible had Ken Smith not donated the bull-dozer work. Further work on these roads will have to be postponed until the thousand or so dollars necessary to gravel these roads is forthcoming.

We have endeavoured to improve our public beach area somewhat, in that we not only widened to access to the water, by removing some stumps and boulders and making the approach more gradual, but drew several loads of white sand so as to make the bathing area cleaner and more pleasant in general.

You will note from the Treasurer's report that our indebtedness is somewhat higher than when we reported a year ago. We had hoped to see this reduced; but we have found that as well as an ever widening area of financial responsibility, we have to contend with an ever shrinking income. Our only source of income for maintenance and expansion, besides offerings, is room and board; and the ever rising cost of food has almost eliminated any area of profit, so that little is left for maintenance and development. The rates have not been changed since they were originally set in 1958 and we all know how costs have spiralled since then. Your committee will have to look hard and long at our rates before finally establishing them this coming year.

We have many projects in mind for the future, but here again finances are the determining factor. As well as completing the new roads now underway, we would like to develop an access road to the north-east end of the property similar to the new one at the south-east end, so as to reroute even more traffic, going to cottages, away from the dining hall area. There are several more areas that offer wonderful potential for cottage sites, which will have to be developed as the need arises. We also have in mind for the future the development of a sports area, as those now being used are merely improvised and no work has really been put into these to make them suitable. Probably the most pressing need is for further sleeping accommodation. Our youth facilities are taxed to capacity this year, and the demand for cabins is far beyond our ability to supply. In all probability, since sleeping cabins are so in demand, this will be our next step; but when finances will determine.

We thank God for all the progress He has brought about, and for the spirit of cooperation and sacrifice he has put in the heart of so many. Especially for the vision and labours of the Camp Committee and our Dining Hall Manager, Walter Smith, are we grateful; without this progress would have been impossible.

- (iii) That we encourage fellowship with all who accept the basic authority of the Bible as the Word of God.
- (iv) That wherever possible we co-operate with those who are sincerely striving for union with all denominations, regardless of belief, but that with firmness and Christian love and always with common courtesy, we strive to uphold the faith for which we stand, and the basic unity of believers.
- (5) Whereas our nation has for years been a part of the British Empire and has shared its glories and fought for its liberty and unity and, Whereas many of our nation have during the past two world wars given of their lives and their loved ones for the freedom and the unity of our nation under the symbol of the Red Ensign.

Whereas the Red Ensign represents the various cultural and national heritages of our Dominion

Be it Therefore Resolved that the Wesleyan Methodist Church of America in Canada now convened at Silver Lake, Maberly, Ontario go on record as being opposed to the proposed new tri-Maple leaf flag to replace the Red Ensign.

REPORT NO. 26

Canada Conference of the Wesleyan Methodist Church of America. Greetings!

Your Conference Direction of "Wesleyan Men" submits the following Annual Report.

It has been my privilege to be the duly appointed Representative of "Wesleyan Men" for two Conference years.

No official organizing was done on the local Church level.

Lorne Elliott, in conversation on New Year's Day, 1964, made a suggestion which resulted in the writer seeking authority to visit the local Churches to raise money for a "Wesleyan Men's Project". Authority was granted to the Conference Director of "Wesleyan Men" to so visit local Churches to raise \$600.00 to purchase a right of way to Silver Lake Camp so as not to go through other property where two gates have to be opened and closed each time to get access to the Camp, and also to establish a Memorial Cottage Fund in memory of six Laymen of the Conference who died in 1963. These are as follows:

Ward Summers Oliver Trotter Alex McLean Wes. Presley Lloyd Spearman Glen Spearman

The writer has always been of the firm opinion that if there is a job to be done, "Get on with the job" and accordingly our first visit was to the Ottawa Church where the response in pledges was like a "shot in the arm", so impetus was obtained to endeavour to have a Memorial Cottage erected and ready for use prior to the Conference and Camp of 1964. Everything was made to bend to that end, even though there were more difficulties to be encountered and hurdled than a small project should justify, but thanks be to God, who caused us to triumph.

Permission was sought from the Pastor in each case to visit his Church and the response in pledges for this dual project was beyond expectation. In all, \$2,884.00 was pledged and only \$192.00 has yet to come in.

After turning over \$600.00 for the land project, it left \$2,184.00 towards a Memorial Cottage for the use of visiting Evangelists and Singers.

The Board of Directors and Conference Trustees did not approve the plan for the double Cottage with four bedrooms originally submitted and in fact, several drawings were submitted before approval was gained to build two units — each with two bedrooms, living room, kitchen area and bath.

Instructions were given to build one cottage at present, and hold the balance of the money until additional funds necessary could be raised to proceed with the second cottage. The Director was to be in charge of the building operations under the supervision of the Camp Committee Chairman, Rev. W. W. Jewell.

Every effort was made to buy economically so as to build the best possible for the least money and Memorial Cottage No. 1, as erected, cost \$1,159.49 (subject to correction) and the furnishings for Memorial Cottage No. 1 includes the following:

- 2 Mattresses
- 2 Mattress covers
- 2 Box Springs
- 2 prs. sheets
- 1 Bed Chesterfield

Table and four chairs

- 4 prs. drapes
- 2 Bedspreads
- 4 mats
- 7 Drapery tracks
- 16 Gliders
- 4 Wall hangers
- 2 Folding Aluminium Chairs

at a delivered cost of \$450.03 (subject to correction).

There has also been spent for the Memorial Cottage No. 2, \$173.02 for the following:

- 2 Box Springs
- 2 prs. sheets

After travelling in excess of 6,800 miles for which reimbursement for only 4,760 miles was claimed at $2\frac{1}{2}c$ per mile which is included in the cost of Memorial Cottage No. 1.

REPORT NO. 29

REPORT OF PROPOSED CONSTITUTIONAL CHANGES PROPOSAL A

The following statement, if approved, will become a new Article of Religion and will be placed in the Discipline as Article XIX, preceding the present XIX entitled "Rites and Ceremonies of the Church."

THE CHURCH

"The Christian Church is the entire body of believers in Jesus Christ.

The Founder and only Head of the Church is Christ.

"A local church is a body of believers formally organized on gospel principles, meeting regularly for purposes of worship, edification, and evangelism.

"The Wesleyan Methodist Church of America is a denomination consisting of those members within annual conferences and local churches who hold the faith set forth in these Articles and acknowledge the ecclesiastical authority of its governing bodies."

NOTE: The purpose of this proposal is to give a clearer definition of the church and specifically to denote that the term "church" refers to more than a local organization, as seems to be indicated in Par. 41 of the Discipline.

NOTE: It should be pointed out, also, that this does not provide for the deletion of Par. 41, 42, and 43, from the Discipline.

This was approved by the General Conference by a standing vote of $102\ to\ 0$.

PROPOSAL B

This proposal is to add followng "bounds" in Par. 60 (1) on Line 2, the parenthetical cross-reference:(as modified by VIII 5 below). The reference is to Article VIII, Par. 69 (5).

This portion of the Discipline now reads:

Par. 60. "The constitutional rights of each annual conference shall include the following:

"(1) The right to take charge of all the ministers and churches within its bounds except such of the general officers of the church as the General Conference shall define (who shall be amenable to the Board of Administration for their official conduct and to their annual conferences for their moral character), and subject to the right of the ministers and churches to enter into pastoral engagements for one year from the next session of the annual conference, or to contract the pastoral relationship at any time during the interval of the sessions of the annual conference when this does not interrupt any arrangement which was sanctioned by the annual conference at its previous session." The proposed change would cause this paragraph to read as follows:

- Par. 60. The constitutional rights of each annual conference shall include the following:
- (1) The right to take charge of all the ministers and churches within its bounds (as modified by VIII 5 below) except such of the general officers . . . (The remainder is unchanged.)
- NOTE: Observe that this is not a new provision, but is a cross-reference to Par. 69 (5) which already makes a distinction between the regular and mission annual conferences.
- NOTE: This could well have been an editorial insertion, but it was felt that possibly it should be voted upon by due constitutional processes.

 This was approved by the General Conference by a standing vote of 100 to 1.

PROPOSAL C

It is proposed that the second paragraph in Par. 30 of the Discipline be deleted. This is Article of Religion XIX, and entitled "The Rites and Ceremonies of Churches." (If all these proposals are approved, this would likely become Article XX, inasmuch as an Article entitled "The Church" would become XIX. This would necessitate the renumbering of the Articles of Religion from this point forward.)

This Article now reads:

Par. 30. "It is not necessary that rites and ceremonies should in all places be the same or exactly alike, for they have always been different and may be changed according to the diversities of countries, times, and men's manners, so that nothing be ordained against God's Word

"Every particular church may ordain, change, or abolish rites and ceremonies, so that all things may be done to edification."

The proposal is to delete the last short paragraph, making this Article to read as follows:

It is not necessary that rites and ceremonies should in all places be the same or exactly alike, for they have always been different and may be changed according to the diversities of countries, times, and men's manners, so that nothing be ordained against God's Word.

NOTE: The following explanation was given the Board to support recommending this change.

"... some of our missionary leaders have felt that the second paragraph under this paragraph number should be clarified or preferably deleted. If the words 'every particular church' is interpreted to mean every local church, the sense of the paragraph is highly undesirable in areas where a church has newly come out of paganism, whose members still have no appreciable store of Christian content in their history or background. In practice we are not able to permit each particular church to change or abolish rites and ceremonies or to ordain new or different ceremonies until their social life has more Christian

July 22nd, 1964.

Offering taken \$5.55, Minutes read and approved. Motion to adjourn, Prayer by Mrs. Cora Mack.

RELIGIOUS SERVICES

The Friday evening service of the Annual conference was opened with the singing of the hymn "Jesus Saves" led by Mr. Paul Mullen. Rev. Huff our visiting Missionary read the scripture from Ephesians, second chapter. He read it in the Limba language and then translated it to English. After the scripture reading Rev. Huff led in prayer. The three Mullen children sang to us a chorus in Spanish, "Jesus I love Thee". Miss Joan Anglin, outgoing missionary to teach in the School for the Deaf in Peurto Rico, spoke to us, telling of her call to this needy mission work. The hymn "Send the Light" was sung and announcements and offering followed. We were then favored with a quartette composed of the Mullen family, "Jesus is Calling" after which Mrs. Huff spoke to us. She and Rev. Huff have spent four terms in Sierre Leon and are at present in Michigan as Rev. Huff is the President of the Michigan conference. They have just completed along with Mrs. Mary Lane Clarke the translation of the New Testament into the Limba language. Mrs. Clarke translated the four gospels and they completed the New Testament. Speaking a little about their work Mrs. Huff mentioned the fact of ministering to a people that have no Bible and though they may be taught to read and write, they need something to read after they learn and what more precious than the Word of God. A people without this Word is a lost people.

We were shown a number of interesting pictures on Africa taken recently during a three months trip to Sierre Leon while doing the translation work on the New Testament. Mrs. Huff showed us how simple the Limba language is, mentioning the fact that the Africans can learn to read in two weeks. She taught us to read John 3:16 in the Limba language after which she closed the service with prayer. Offered amounted to \$40.35.

The Sunday afternoon service of the Annual Conference was opened

with Mr. Mullen singing "Let Me Burn Out For Thee" after which Rev. Huff took charge of the service opening his remarks with a story of a journey to see a tribe of people called the Cliff Dwellers who lived in caves near the Sahara desert. Meeting an old school chum from New York who was a missionary to these people, he told the story of how a Watchman guarded the opening of the valley near these cliff dwellers and one night he failed his job as watchman and the result was that nearly a city was destroyed by the enemy. Rev. Huff went on to say, we are living in the last days and it behooves every Christian to be a watchman. It is a sacred trust that God has given to us to hand down the torch from generation to generation. We are being consumed more and more with the pleasures of the world while the world languishes for the gospel. At one time nine hundred churches failed in their duty and millions of souls were dying without Christ. This began the great move to Mohamedism. It is a supreme task to send out the gospel and it demands the very best there is in us. After relating many interesting stories of Africa, Rev. Huff called on the young people to dedicate their lives to God, and a prayer of dedication was given by Rev. Spearman. The Mullen family sang "Reapers are Needed".

The new Executive was introduced and Mrs. Huff led in prayer asking God's blessing on the W.M.S. Executive for the coming year.

Rev. Spearman pronounced the Benediction.
