JOURNAL OF DAILY PROCEEDINGS.

Fairmount, Indiana, August 15, 1911.

Under the good providence and blessing of our heavenly Father, the Indiana conference assembled in its sixty-third annual session in the Campground Auditorium, at 8:30 A. M. The congregation sang "My faith looks up to Thee."

The devotional services were opened by Elder Aaron Worth in the reading of the second chapter of the Epistle to the Ephesians. The reading of the Word was followed by the offering of prayer by Elders A. Worth, George Reber, W. J. Seekins. The presence of the Spirit marked these intercessions unto God. The congregation then engaged in singing No. 7 in "Old Story in Song," "Jesus brought me out."

The Word of God was read by Rev. J. L. Snyder, from the 17th chapter of St. John. Brother Snyder then offered prayer, which was followed by singing "Never Give Up."

She extended to us the greetings of the organization she represents. On motion Sister Ayers was accorded an honorary seat within the conference bar, and was granted the privileges of the same.

A motion was made, that we memorialize the General Conference to make appropriate changes in the delegates certificate blanks. The motion prevailed.

In view of the fact that our Educational Interests, in order to succeed, must be kept before the people, and in view of the fact that Rev. E. D. Carpenter has done so well in the place he now occupies, the Indiana Conference hereby petitions the General Conference to create the office of educational secretary, and we also recommend the delegates to the General Conference to vote for said E. D. Carpenter for educational secretary, in case the General Conference creates said office.

The item of the resolution referring to Rev. Eber Teter, as missionary secretary, was offered as an amendment to the resolution by Rev. E. H. Kennedy. The amendment carried. The resolution, as amended, was voted upon, and carried.

The Committee on Itineracy and Elders Orders made a partial report. The partial report was adopted. (See report No. 2.)

A motion was made to memorialize the General Conference to place in the Discipline a blank form for the recommendation of licentiate to be received to study preparatory to travel under the direction of conference. The motion was referred to the Committee on Resolutions and Memorials.

The special orders of the day were called, and the Connectional Agent and Treasurer, Rev. W. J. Seekins, made his official report of the interests placed in his care. He reported carefully in a written statement the conditions of each of the incorporate societies, giv-

ing the needs, and the hopeful signs each, full notice; appealing for a continuance of the faithful work and help of all our people. His report shows a possibility of putting all our work upon a prosperous basis.

It was moved and supported to adjourn. The motion carried. Benediction.

Wednesday Afternoon, 1:30, August 16, 1911

The afternoon meeting opened with congregational singing from "Old Story In Song"—No. 2. Rev. Eber Teter read the Scriptures, and led in prayer.

The roll was called. The minutes of the morning meeting were read and approved.

The Committee on Evangelists Plan reported. On motion the report was adopted. (See report No. 3.)

The Sabbath School Committee made a partial report. (See report No. 4.) A motion prevailed to refer back the partial report; also suggesting to the committee that the clause relating to the S. S. Secretary's salary and traveling be made optional.

The special orders of the day were called, and Rev. Eber Teter, Connectional Missionary Secretary, was given the time to present the missionary interests of the Connection. Elder F. M. Roberts then spoke of his work in the Southland, where he has been laboring for some time. His remarks were thrilling in describing the conditions of need, and the gracious way in which the Lord has delivered, and given the victory. The roll was called. The minutes of the previous meeting were read and approved.

James Wood, Dennison Dooley, were recommended to the conference as suitable persons to be received to study, preparatory to travel under its direction. They were referred to the Committee on Itinerary and Elders Orders.

Elder L. G. Bears presented a resolution concerning the seating, and repairing of the floor of the Tabernacle, for the use of the

The Committee on Sabbath Schools made a further partial report. A motion was made to adopt the report. An amendment was made to adopt the report item by item. The amendment prevailed. Item No. 1 was read and adopted. (See report No. 4.)

On motion the remainder of the report was laid upon the table until after the election of conference officers and evangelists.

The orders of the day were called, and the conference proceeded to the election of officers and evangelists.

On motion the secretary was instructed to cast the conference ballot for Elder Thomas P. Baker as president. The secretary did as ordered, and T. P. Baker was declared elected.

On motion the secretary was instructed to cast the conference ballot for Rev. Josiah E. Smiley as treasurer. It was done as ordered, and J. E. Smiley was declared elected.

On motion the secretary was instructed to cast the conference ballot for James Oliver Baker as (ministerial) conference trustee for a term of three years. It was done as ordered, and James Oliver Baker was declared elected.

On motion the secretary was instructed to cast the conference ballot for John J. Coleman as (ministerial) conference trustee for a term of three years. It was done as ordered, and John J. Coleman was declared elected.

On motion the secretary was instructed to cast the conference ballot for David W. Wood as (lay) conference trustee for a term of three years. It was so done, and David W. Wood was declared elected.

The conference then proceeded to the election of conference evangelists by LONG BALLOT. H. T. Arnold, S. C. Kinnison, W. H. Hopkins, and T. M. Bodenhorn were appointed as tellers.

In view of the standing rule of conference demanding that the conference president travel the conference and hold quarterly meetings, Elder T. P. Baker was declared to be the first evangelist. The roll was called. The minutes of the morning meeting were read and approved.

Delegates' certificates were presented, and the following persons were enrolled: Nancy Sylvester, Strawtown; Millard McDonald, Sylvania; and J. A. Fancher, Sheridan.

On motion the Sunday school report was taken from the table, and was again read in full. Item No. 2 was read, amended, and passed. Item No. 3 was read and passed. Item No. 4 was read, amended and passed. Item No. 5 was read and passed. Item No. 6 was read and passed. The report as amended was adopted as a whole, by the vote of conference. (See report No. 4.)

A motion prevailed that a Committee on Statistical Blanks both for Pastors and Sabbath Schools, be elected. H. T. Hawkins, J. E. Smiley and E. H. Kennedy were elected as said committee.

Rev. J. J. Coleman tendered his resignation from the Committee on Finance. By vote, his resignation was accepted. On motion Rev. H. T. Arnold was elected in Brother Coleman's stead.

On motion a Conference Sunday School Examining Board was elected in the following named persons: Edward H. Kennedy, and

Sewell E. Baker; the conference Sunday school secretary to be the chairman.

The orders of the day were called, and Rev. J. O. Baker, president of Indiana Theological Institute and Bible Training High School, was given the hour to present the interests of the school. A large group photograph of the class of 1911 was presented to the institution by the photographer, Mr. Hockett, for which the conference tendered the donor a vote of thanks. Sisters Ora J. Turner and Eula Jay favored us with a duet, "There's a new name written down in Glory." Prayer was offered by Rev. C. B. Whitaker. The school male quartette sang a selection. Sisters Turner and Jay brought us another joyous message in song. Brother Baker then presented the interests of the work entrusted to his care. Matt. 9:37 was chosen as the basis of his remarks. The words of our Brother were burning loaded expressions of devotion to the cause of God, and the school; and were full of exhortation worthy a prayerful hearing and obedience. Sister Grace B. The following persons were named by the Nominating Committee and were elected by the ballot of the conference as lay delegates to the General Conference: J. L. Rigsbee, H. M. Crilley, G. W. Felton, J. E. Smiley, J. H. Pickett, O. H. Mann, Brother G. W. Teter, P. H. Rindfusz, and Walter Northam.

The names of D. L. Shideler, C. F. Roberts, Absalom Miller, and George Rager were placed in nomination by the committee, and by ballot of conference were elected as alternate lay delegates to the General Conference.

A motion prevailed that in the absence of any of the regular ministerial, or lay delegates from the General Conference, that one alternate shall be chosen in their order of succession to fill each vacancy of their kind thus occurring.

Saturday Morning, 8:30, August 19, 1911

Meeting opened with singing No. 33, "Heavenly Sunlight," and No. 82, "It Is Mine."

The Word of the Lord was read by Rev. James Jester from the thirty-seventh Psalm, after which he offered prayer, which was followed with singing, "My Jesus I Love Thee." No. 167.

The roll was called. The minutes of the previous meeting were read and approved.

The Committee on Itineracy and Elders Orders made a full report, and on motion the report was adopted. (See report No. 2).

On motion C. B. Whitaker was elected to supply the vacancy made by the absence of L. G. Bears on the Auditing Committee.

The Committee on Resolutions and Memorials made its report. The report was adopted. (See report No. 7).

The Woman's Home and Foreign Missionary Society made its

annual report through the state treasurer, Mrs. Bessie Baker. On motion the report was endorsed by the conference, and ordered spread upon the conference minutes. (See report No. 8.)

The Committee on Book for Teachers Training Course made its report. The report was adopted. (See report No. 9.) The committee was continued.

A Committee to Examine the Book on Teacher's Training Course was elected in the persons of J. J. Coleman, T. M. Bodenhorn, and H. T. Hawkins. Rev. A. T. Jennings was made an honorary member of the committee.

A motion was made to elect Rev. W. J. Seekins to memorialize the General Conference relative to the placing of the Teacher's Training Book in the disciplinary course of study, and the curriculums of our denominational schools. The motion prevailed.

Rev. A. T. Jennings, Editor of the Wesleyan Methodist, was introduced to the conference, and was accorded an honorary seat in the body.

The special orders of the day were called, and A. T. Jennings was given the hour to represent the interests of our paper, and defining to us the issues that divide us from the world, and that face us as a Church. He exhorted us against seeking popularity and ease; declaring that the world is still the wicked deadly enemy of God, and that the victory will not be easily won. A plea was made for personal, practicable intelligence, and a consecration that meant sacrifice—a sacrifice and an intelligence that equal each other. The words of Brother Jennings were full of inspiration, and helpful counsel throughout.

The president nominated J. J. Coleman and George W. Felton as his Advisory Board. On motion they were elected by the conference.

An amendment was made by inserting the statement that \$50 should be added to the evangelists' salaries, and that the same is to be paid from the Conference Budget Fund before it is divided. The amendment carried. The report as amended was adopted. (See report No. 10.)

Moved and carried to adjourn. Benediction by Elder J. Hester.

Saturday Afternoon, 1:30, August 19, 1911

Devotional services opened in the use of Nos. 196 and 110 from "Old Story In Song." No. 2. Reading of the Word of God from the thirty-fifth chapter of Isaiah, and offering of prayer by Rev. H. T. Arnold. Singing again from No. 24.

The conference roll was called. The minutes of the morning meeting were read and approved.

The Committee on Sabbath Schools made its report. On motion the report was adopted. (See report No. 4.)

A motion was made that disbursements be made to Sisters Emma Fall, and Elvira Gordon to the amount of \$40 each, and that said sum be taken from the Superannuated Ministers' Fund. The motion carried.

A motion was made that the conference president and the con-

ference secretary each be paid \$25 and that the assistant secretary be paid \$20 for their services rendered, and incidental expenses, and that this money be taken from the Conference Missions Fund. The motion prevailed.

A motion prevailed that the circuits be requested to apportion their quota of evangelist's salary to their respective classes; and that they elect some one as steward for the same.

Rev. G. H. Clarke, our returned missionary from Africa, was given the time to present the interests of Foreign Missions. We were all glad to meet and greet Brother Clarke in the flesh again, and to hear the interesting and helpful things which he had to say. After his address an offering was taken to defray the traveling expenses of Sister Nancy Barts to Africa. The amount received in cash and pledges was \$266.90.

The Stationing Committee made its report. The report was adopted. (See report No. II.)

A motion was made that when we adjourn we adjourn to meet at 8:30 o'clock Monday morning, August 21. The motion was carried.

The Conference Board of Trustees made their report through the secretary, J. J. Coleman. On motion the report was adopted.

A meeting of the Library Association was called, for the reorganization of that society. S. C. Kinnison was elected Secretary pro tem.

On motion W. D. Baker was elected president of the association. On motion Sewell E. Baker was elected vice president. On motion T. M. Bodenhorn was elected secretary. On motion J. E. Smiley was elected treasurer.

On motion conference adjourned. Benediction by T. J. Pierce.

Monday Morning 8:30, August 21, 1911

The meeting opened with singing No. 197 from "Old Story In Song No. 2." The Scriptures were read from the second chapter of 1 Peter followed with prayer by Brother Milton Peters. Singing again, "Jesus Is Mine."

The roll was called. The minutes of the previous meeting were read and approved.

On motion Mrs. Irene Peters was elected reporter for the conference and campmeeting.

The conference treasurer made his report. The report was adopted. (See report No. 12.)

A motion was made granting the secretary the privilege of making any precaution necessary to the safety of the conference records. The motion was carried.

The motion prevailed that the next Theological Institute shall be held at Sylvania, Green County, Ind., provided that satisfactory arrangements can be made, and in case this shall fail, the Committee on Itineracy and Elders Orders may decide and arrange the matter.

A motion prevailed that each charge be instructed to solicit funds for to pay the expenses of licentiates to the Institute.

A motion was made that the Conference Trustees be empowered to take any necessary or legal steps that may be required in order to properly turn over the Indiana Wesleyan Bible Training High School assets to the Connection. The motion was carried.

A motion was made that the conference treasurer be instructed to send statements to persons indebted to the various arms of the work, and that the expense of the same to the treasurer be paid from the funds of the interests represented. This motion was carried.

No. 4. Report of the Sabbath School Committee

We, your Committee on Sabbath schools, beg leave to submit the following report:

Because of the importance of this work to us, we, as a conference and Church at large, now ask that you give the recommendations herein contained your careful and prayerful consideration.

I. Literature

As is the Sunday school so will be the Church. As is the Sunday school literature so will be the Sunday school. These two statements coupled with the fact that the Wesleyan Methodist Church stands for and should seek to maintain the highest type of Christian perfection, it is imperative that we guard and discriminate against any literature that is in any sense antagonistic to the doctrines of the Bible as believed and taught by us as a Church, and as set forth in our book of discipline. Knowing the literature published and sold by our Publishing Association to be the safest, soundest and most loyal to the trust God has committed to our care, we recommend that this conference earnestly request that no Wesleyan Methodist Sunday school within the jurisdiction of the Indiana Conference of the Wesleyan Methodist Church use any literature other than secured through the Wesleyan Methodist Publishing Association. In accord with the aforesaid recommendation we express our utmost sympathy for the graded literature in its adaptiveness to the nature of our beings and recommend that wherever this class of literature is demanded that it be endorsed by this conference provided such literature can be obtained through our Publishing Association.

II. Pastor and the Sabbath School

Whereas, the pastor of the church is the pastor of the Sunday school and by virtue of this relationship, he being general superintendent of the Sunday school work on the charge, we recommend that no Sunday school shall make any change either in literature or

methods without the consent of the pastor and his co-operation in the introduction of such literature and methods having been accepted.

III. School Grading

Whereas, in a majority of cases in the conference it would not be advisable to introduce the graded literature, we recommend that all of the schools of the conference be organized according to the graded system, believing this to be in accord with the creation of our beings and the inherent demands of our nature.

IV. Reaffirmation

We recommend that this conference reaffirm the resolutions passed by it at its session of 1909 and in some points strengthen them, as herein contained.

1. The personal appearance and manifestation of interest of the pastor in the Sabbath school is of so great importance that we recommend that at least ten minutes be devoted each Sabbath to interesting the children and young people in the work of the Sabbath school and church and that in order to fulfill this demand the pastor be accorded the opportunity to review the Sabbath school lesson in connection with which he can offer appropriate remarks which will be of great benefit to the school.

2. That each Sunday school hold a teacher's meeting each week in which the perplexing questions of the school may be discussed, its methods considered and the lessons reviewed, thus giving the school a uniformity of instructions and methods that are so necessary to its success.

3. That there be a conference Sunday school secretary whose duty shall be to have the general oversight of the Sunday school work.

4. That each circuit or station in the Indiana Conference be required as far as possible to hold an annual Sunday School Convention at which the conference Sunday school secretary be present to address the representatives of the Sabbath schools of the charge

and the church to co-operate with the pastor and to create on the work an intense interest for this great department of the church work.

5. We furthermore recommend that the Stationing Committee designate one of the quarterly meetings evangelists as the conference Sunday school secretary.

6. That a complete quarterly report of the Sunday school work be made to the pastor by the superintendent, upon blanks furnished by the conference.

Furthermore we recommend that these reports be given to the pastor of the charge and that his annual statistical report, as far as necessary, be made from these reports.

We also recommend that the pastor be required to send said reports to the conference Sunday school secretary and that he report to the annual conference complete statistics obtained from these reports and that these statistics be recorded in our minutes.

8. That this conference elect a Sunday School Board, the chairman of which shall be the conference Sunday school secretary.

That the duties of this Board be to prepare examination questions upon the Teacher's Training Course and to send them to the teachers of the classes and arrange for the issuing of diplomas to graduates of these courses.

7. We endorse the Teacher's Training Plan of the State Sunday School Association and we recommend that the Conference Sunday School Secretary be expected to organize classes in this work upon our charges and that the following texts be used in these courses.

Primary—"Hurlbut's Teacher's Training Lessons."

Advanced—Book edited by El. J. O. Baker and El. E. H. Kennedy.

We your Committee on Memorials and Resolutions beg leave to submit the following report.

1. We are glad to recognize any progress which may have been made in the world, of science, of invention, and of educational and religious culture, and he who is looking for that may find a great deal to encourage him. But on the other hand, we are confronted with some conditions, which are calculated to bring very great concern to the minds of those who love God and humanity.

In reference to the educational systems it is a deplorable fact that the enemy of all good has succeeded in injecting into many of the educators and the managers of many of the leading educational

institutions as well as some of the high schools, that pernicious doctrine known as higher criticism, or modern theology, or advanced thought, in which the authenticity and inspiration of the Holy Scriptures are denied, and such fundamental doctrines as the incarnation and the resurrection are laughed to scorn. We as a people should be so clear on these points, that men, devils and angels know that we stand for the Book from lid to lid with all that it teaches, and our people should by all means support our schools with their money and children.

There is no doubt, but that the printing press has done and is doing untold good in the world, yet we cannot overlook the fact, that the entire country including almost every move, is being flooded with a poisonous literature, evidently inspired by the devil himself; we hereby declare a relentless warfare against all of this, and give our undivided support to our own incomparable publications.

We should also bestir ourselves to the importance of the Sabbath, and press forward and hold firmly, for the holy Sabbath day, a day of rest for all the people of the country.

If there ever was a time when we needed to stand true to ourselves, to humanity and to our God, that time is now. We rejoice that we as a people are free from the domination of the lodge system and are clean from the pollutions of worldly amusements, yet we have a great battle to be fought, and our adorable Lord is expecting a good fight at our hands in which, by the grace of God, we will not disappoint Him. We need to move ourselves to the conflict. Anarchy is moving along very stealthily, crime is vaunting itself, stalking abroad in the land leaving wreck and ruin in its path. The statisticians tell us that criminals have increased from one in every sixteen hundred of our population in 1854 to one in every three hundred in 1904.

Just fifty years and still the fearful increase goes on and who is to blame?

While we are pleased with the indications pointing to arbitration and world wide peace, yet we are grieved with the fact that our own

government (the best the sun ever shone upon) is involved in the crime of ages, the legalized liquor traffic. This with its twin evils, gambling and the social vice, which it fosters and protects, is largely responsible for the increase of crime. While this blasting, blighting, accursed, powerfully organized force, is protected and legalized by the government, it is very difficult to accomplish much with these other agencies for evil which are connected with it.

Here we stand, we can do no less, so help us God.

No. 14. Church Extension

The conference has experienced the most aggressive year in this phase of its work of any time for a great many years. The church at Wabash has been saved to the conference by our assuming an obligation of paying off an indebtedness of \$500, which the church was unable to pay. We now have deeded to us a property worth over seven thousand dollars and a congregation worshipping underneath the banner of the Wesleyan Methodist Church. At Frankfort our people secured a good church property at a cost of \$300 and the greater part of this has been paid.

A fine new brick church has been built at Marion, Indiana, under the pastorate of Elders A. P. Fooshee and S. E. Baker. Donations and subscriptions covering the entire cost of about \$2,500, has been secured, the church deeded to the conference and insured for \$1,800 and dedicated to God.

Our church at Cicero, Indiana, was located outside the city limits, which location, seriously hindered the building up of our work. The Board of Conference Trustees ordered the sale of our church there and the purchase of a much better one near the heart

of the city formerly owned by the Presbyterian church. At a small cost above the sale price of our old church this other church has been secured and a subscription nearly sufficient to cover the cost is now on hand. It is believed that the amount yet necessary will be fully provided at the dedicatory services, which will probably be held early in the new conference year. A new parsonage has been built at Sheridan, Indiana, which will not only greatly add to the conveniences of our work there but will increase the assets of the conference property to the extent of about \$2,000.

A new parsonage now adorns the Payne circuit which will add about \$1,000 to the material value of the circuit and conference. This makes two new parsonages this year.

Our plan for increasing the Church Extension fund has met with general favor, and nearly three hundred names have been secured to the list of regular Church Extension subscribers. The aggregate of these subscriptions added to the per cent due the fund from our Church benevolences will greatly aid our conference in developing our new and weaker charges. This need and the necessity of meeting obligations assumed in the past as a result of the growth of our work, should prompt us to encourage and deepen interest in the Church Extension fund.

The aggregate of contributions to Church Extension this year amounts to \$649.14. The amount paid out for building and repair over the conference totals the sum of \$7,351.92. The secretary has sought to create interest and build up this important phase of our conference work, and solicits the co-operation of all our pastors for its further development.

We the members of the Indiana Conference assembled in our sixty-third session, hereby memorialize the General Conference of the Wesleyan Methodist Connection, which meets at Fairmount, Indiana, October 18, 1911, to amend Section X by adding to said section the following, beginning with the word "Minister" "Ministers of other Evangelical Churches who may desire to unite with us" to read as it now does to the word "Church" on page 108 4th line from the top—here insert, "But for the first year said ministers shall be known only as a supply and shall labor under the direction of the president and his Advisory Board, and the president and his Advisory Board shall have the power to terminate any and all relationships, said minister may have been placed in as a supply, when in the judgment of the president and his Advisory Board, said minister is not a suitable person to be continued as a supply, and this dismissal shall terminate all relations to this body. In case said persons shall prove themselves worthy to be received in the judgment of the president and his Advisory Board, the President shall recommend that they be received" the rest of the section beginning with the word "whenever" 4th line, top of the page 108, to remain as it now is. Then add at the end of the section, these words "The above as it pertains to elders, shall also apply to those coming to us in deacon's orders and as licentiates.

DISCIPLINARY COURSE OF STUDY

All persons, not students of the Bible School, studying for ordination at the hands of the Church, are required to take the following course of study and pass examination upon the same under direction of the Committee on Itineracy and Elders Orders. Any licentiate having taken examinations on any certain studies of the Course, under the Committee on Itineracy and Elders Orders, upon presenting them, their grades shall be recorded and credited when they have taken at least six terms of work in the Bible School.

Any person who expects to be recommended by the Committee on Itineracy and Elders Orders for ordination, not having taken the Course under its direction, must present their credits, from the proper authority, of a sufficient grade upon each and every study as specified in the Disciplinary Course, or an equivalent, covering the same subject, in some accredited Theological Course, equal in its standard to that of the Wesleyan Methodist Church.

On page 232 of the Discipline it is required that no licentiate be received to travel until his or her recommendation be accompanied with the examination papers of their quarterly conference, including the questions and answers of such examination, which shall have been conducted in writing. This preliminary course shall include English, Grammar, Arithmetic, Geography, English Composition, and (United States History). The Discipline also states on page 83, "No licentiate who is delinquent in his efforts to prepare himself to pass the Course of Study, of which fact the Committee on Itineracy and Orders shall be the judge, shall be considered worthy of employment at the hands of the annual conference."

The action of the last session of conference in adopting the report of the Committee on Itineracy and Orders, makes it obligatory upon all candidates for license to appear before the proper authorities and assert whether or no they will take work at the hands of the conference when they shall have come to that point in their course.

It is the mind of the committee that the rule of the Discipline, found on pages 65 and 66, paragraph 6, requiring a licentiate to

travel under the direction of conference for two years before ordination, means that he or she shall be a pastor, or shall possibly be engaged in such work as belongs specifically to the ministry of the Gospel, and that it does not cover the scope generally accorded it.

Course of Reading: Life of St. Paul, Stalker; The Revival and the Pastor, Peck; History of Wesleyan Methodism, Jennings; Wesley's Sermons, Vol. I., first twenty-five sermons.

Second Year: Lee's Theology; Fisher's Church History (first half); Kidder's Homiletics; Natural Theology, Lee; McIlvane's Christian Evidences; Philosophy of Christian Experience, Foster; D'Aubigne's History of the Reformation (first half).

Course of Reading: Life of Christ, Stalker; Nelson on Infidelity; Wesley's Sermons, Vol. II., twenty-five sermons.

Third Year: Lee's Theology; Elements of Intellectual Science, Porter; D'Aubigne's History of the Reformation, continued; Fisher's Church History (second half); Wayland's Moral Science; Philosophy of the Plan of Salvation, Walker.

Course of Reading: Life of Hester Ann Rogers; Love Enthroned, Steele.

Any of these books can be bought of Rev. W. J. Seekins, Nos. 315, 318 E. Onondaga St., Syracuse, N. Y.

Seventy-five per cent is the standing required in order to pass the Course of Study. It is the purpose of the committee to adhere kindly, carefully, impartially, and closely to the spirit of the disciplinary requirements in the discharge of their sacred and important duty.
