The forty-fourth session of the Kansas Annual Conference of the Wesleyan Methodist Church met at Miltonvale, Cloud County, Kansas, August 25, 1914, at 1:30 p. m.

Opened by singing "Jesus is my all in all," and "Crown Him Lord of all" after which the President, Brother P. A. Miller led in prayer. Scripture lesson was read from Phil. 2:1-18.

Calling of the Roll by the secretary-was answered by 16 elders and 5 licentiates.

On motion adjourned for the Orders of the Day. Preaching by Evangelist Shea.

WEDNESDAY MORNING.

Devotions led by Brother Grant Mann who read for a lesson Gen. 28:11-22 and led in prayer.

Roll call. Reading and approval of minutes.

Committee on Credentials make partial report, reporting the name of Sister Leota Burroughs of the New Hope charge as delegate. On motion report adopted.

Rev. F. A. Butterfield, Connectional Editor, and Rev. Platt of the Iowa Conference introduced to Conference. Visiting brethren invited to an honorary seat in the Conference.

Committee on Credentials report the names of John T. Baker of the Deering charge, Frank Duncan of LeRoy and James Woodhams of Chapman Creek as delegates. On motion report adopted and delegates seated.

Brother Evan Howard asks permission for one hour during the Conference to present the interests of the Kansas City Mission work. On approved motion the request was referred to the Committee on Orders of the Day.

Recess of thirty minutes taken for Committee work and gathering reports.

Conference again called to order by the President at 10:30 a.m. Committee on Orders of the Day report as follows:

We recommend the hour of 10 to 11 a.m. Thursday to the Kansas City Mission work. 2 o'clock p. m. Thursday to the election of permanent officers. Friday morning at 10 o'clock to Brother Butterfield, Connectional Editor. Memorial Services Friday afternoon at 3 o'clock. Woman's Home and Foreign Missionary Society the hour of 8 p. m. Saturday evening. Sunday School work 10 to 11 Saturday morning. On approved motion report adopted.

Examination of character taken up. Sister Lizzie Feltar called and states her experience. Character passed.

Committee on Credentials make partial report giving the name of Brother Davidson of Bethel Chapel as delegate. On motion report adopted.

Examination of character again taken up. The following names were called: Brother George Girtler of the Excelsior charge, F. E. Shivers of the Hollis charge, Wm. A. Smith of Wide Range, L. S. Currie of Keene, E. H. Cook of Topeka, also Brother O. W. Cooper and Silas W. Bond. After being told by the President that their characters were passed, the different pastors were asked to read their statistical report. The pastors spoke of the condition of their work and all who were examined testified to the blessing of God upon their souls.

On approved motion adjourned.

WEDNESDAY AFTERNOON.

Devotions led by Rev. G. B. Howard who read for a lesson the 34 Psalm and led in prayer.

Roll call and reading and approval of the minutes.

Motion made and supported that Brother Bond be given one hour during the Conference to present educational interests.

Motion made that the hour for education work be referred to Committee on Orders of the Day. Carried.

Committee on Credentials make partial report. George F. Hudson of the Kansas City charge recommended to travel under the direction of the Conference.

Committee also reads papers authorizing T. F. Child and Alice Child as recognized ministers of the Church of God. On motion referred to Committee on Itineracy and Orders.

Committee on Credentials report E. H. Dunbar of Concordia charge as delegate. On motion report adopted and delegate seated.

The matter of Holiness Conventions was thoroughly discussed by the Conference. They were most earnestly encouraged whether the attendance be large or small. It was recommended that so far as possible, we arrange for the conventions at the time of the quarterly meeting, also that some time be given for the discussion of Sunday School work. The President, Brother P. A. Miller spoke upon the subject and asked that we consider the length of time that each convention should be held, believing that a good three days Convention is better in some cases than a ten days convention.

The President makes statement regarding the Institute at Hollis. Several of the pastors spoke of the good received from the Institute.

Motion made and approved that we hold a ten days Institute next year.

On motion adjourned to meet at the call of the Chair. Preach-

ing by Brother Porter Willis.

The Lord blessed Brother Willis' message "Lord Help Me," and following the preaching service there was an unusual manifestation of the presence of God in the praise service in which many of the saints praised the Lord with a loud voice.

Conference called to order by the Chair at 5 p. m.

Motion made and approved that the sum of \$30 be set aside from the Conference Fund for the benefit of the Institute.

On motion President of the Conference and Committee on Itineracy and Orders made the Institute Committee.

President makes his annual report. See report.

On motion report adopted.

Motion made and approved that inasmuch as we had promised the President a salary of \$650 per year and he has received only \$530.40, that the difference, \$119.60 be paid him by the Conference from the Conference Fund.

Motion made that amount paid by the President for postage and stationery amounting to \$8 be paid him from the Conference

Fund.

Examination of character again taken up. Rev. T. J. Pomeroy, F. C. Hill and A. B. Hotchkiss called. Each report and give satisfactory religious experiences.

On motion adjourned. Benediction by Brother Hill.

THURSDAY MORNING.

Devotions led by Brother I. L. DeWitt, who read 2 Tim 2:1-9 and led in prayer.

Roll call and reading and approval of the minutes.

Committee on Credentials report the name of J. W. Glover

delegate from North Branch. On motion report adopted.

Committee on Orders of the Day report giving the hour of 2 p. m. Saturday to Brother Bond to present the interests of Educational work.

On motion report adopted.

Examination of character taken up. Brother Grant Mann, of Gaylord, reads report and gives statement regarding his Christian experience. The names of Raymond E. Young, of Eskridge, Rosa Gordon, of the Alton charge, and Walter E. Carrington, of the Ames charge were called and since they were absent their statistical reports were read and their characters passed.

Sister Fannie Dunbar called and makes statement and gives her experience. Brother P. A. Miller called. Gives an account of the blessing of the Lord enjoyed in his soul. Brother J. A. Stansbury of Crawford, Brother J. L. Whitney, of Deering; Brother C. H. Dow, of Miltonvale and Brother I. L. DeWitt of LeRoy charge each read their statistical report and testify of the grace of God still experienced.

Motion made and approved that the matter of properly arranging the statistical report be left with the Statistical Committee.

Orders of the Day called for. Hour given to the Kansas City Mission work. The different workers at the Mission make statements regarding the work done and an offering was taken, amounting to \$41.75.

Devotions 1ed by Brother A. B. Hotchkiss, who led in prayer and read the 46th Psalm.

Roll call. Reading and approval of minutes.

Committee on Credentials report the name of Sister Charlotte Pomeroy alternate delegate from Raymond, P. M. Mack delegate from Chapman Creek, W. S. Ashcraft from Crawford and Glenn Williams from Union Valley. On motion report adopted and delegates seated.

Committee on Credentials report the name of Wesley Reed,

delegate from Wide Range. On motion adopted.

Committee on Itineracy and Orders report, recommending

Brother George L. Girtler and Brother Daniel F. Smith be elected to Elders Orders. On motion report adopted.

Committee on Credentials report Hattie Bond alternate delegate from Miltonvale. On motion report adopted.

Motion made and approved that the President be one of the Quarterly Conference Evangelists.

Orders of the Day called for. Election of permanent officers.

President.

Ballot for President. Brother P. A. Miller having received a majority of all the votes cast on the first ballot, declared elected.

Vice President.

Brother F. C. Hill elected as Vice President on the first ballot.

Secretary.

Motion made and approved that the Assistant Secretary cast the ballot of the Conference for E. H. Cook as Secretary.

Assistant Secretary.

On motion, the Secretary instructed to cast the ballot of the Conference for F. E. Shivers as Assistant Secretary.

Treasurer.

Ballot for Treasurer. Brother I. L. DeWitt elected on the first ballot.

Assistant Treasurer.

Motion made and approved that Secretary be instructed to cast the ballot of the Conference for W. H. Carey as Assistant Treasurer.

Motion objected to and ballot called for. Brother Carey having received a majority of the votes cast in the first ballot was declared elected.

Quarterly Conference Evangelist.

Brother A. B. Hotchkiss having received a majority of all the votes cast on the first ballot was declared elected.

Ballot for alternate Elder for Brother Miller. No election on the first and second ballots. On the third ballot Brother S. F. Wilson was elected.

Ballot for alternate Elder for Brother Dow. Brother S. W. Bond was elected on the first ballot.

On motion, adjourned. Benediction by Brother Hill.

FRIDAY MORNING.

Devotions led by Brother C. A. Hill, who commented upon a portion of the 12th chapter of Hebrews and led in prayer.

Roll call. Reading and approval of the minutes.

President appoints Brother A. B. Hotchkiss and Brother Frank Dietrich as the additional members of the Camp Ground and Camp Meeting Committee.

Motion made that the action of the Chair be approved.

Expense of the delegates to the General Conference considered.

Motion made and approved that the Committee on Apportionment take up the matter of the expense and apportion the same to the different charges of the Conference.

Brother Hotchkiss, Tithing Secretary of the Conference makes report. On motion report adopted.

On motion, Brother Hotchkiss continued as Tithing Secretary of the Conference.

Expense of the Secretary, \$1.30 for postage and stationery reported to the Conference. Motion made and approved that the Secretary be reimbursed for the above expense.

Treasurer reports an expense of \$5.85. Motion made that the above amount be paid the Treasurer.

Motion made and approved that the Kansas City Mission be recognized by the Conference as our City Mission work and that the same be under the care and direction of the Missionary Board.

Examination of Character taken up. Brother W. L. Carkuff of Chapman Creek called. Reads statistical report and gives his Christian experience. Brother S. F. Wilson called. Reads report and makes statement of his work and Christian experience. Both of their characters passed.

Lay Delegates to the General Conference.

No election on the first ballot. Brother C. L. Williams elected on the second ballot as first Lay Delegate. Brother P. M. Martin elected on the first ballot as the second Lay Delegate.

SABBATH SCHOOLS.

Whereas, the Sabbath School is the most important factor in the continuation of the Church, nine tenths of her membership coming through that source; and

Whereas, it affords an avenue for reaching the children and instructing them concerning the truths of the Scripture such as is not found elsewhere; and

Whereas, there is the enormous loss of 60 per cent from the attendance of the Sabbath Schools during the teen age; and

Whereas, there is an increased activity in other denominations and a tendency to proselyte from our schools; and

Whereas, the tendency of the modern Sunday School is to unduly exalt entertainment and worldliness;

We deplore the lack of interest manifested by our own people in Sunday School work, and wish to exhort to greater activity and aggressiveness along these lines.

We recommend that when possible only those having good religious experiences be chosen teachers of our Sabbath School classes:

That special attention be given to the teen ages as this is the critical period in the life of our youth, and also the time when the tendency is to drop out of the Sunday School;

That while denouncing all worldly methods of entertainment, we do not forget that the desire for social life is a God-given instinct, and that it is our duty to mold and cultivate it to the glory of God;

That we should seek to make the Sunday School work so attractive that the children will be anxious to attend. This can be done by varying the order of the Sunday School services, so that it will break the monotony, by giving them some work to do, by appointing choristers who can be present regularly and who are interested in children and will arrange to have them take a special part in the singing.

That we should give special attention to the different departments of the Sunday School work, such as Teacher's Training Class; The Home Department which reaches those shut in from religious services; and the Cradle Roll, which takes an interest in the child early in life.

That above all, over all, in all, and through all we seek to let

the Holy Spirit have His way; remembering that it is "not by might, nor by power, but by my Spirit" that we shall prevail.

MORAL REFORM.

We look back with great pleasure to the fact that the Wesleyan Methodist Church had its origin because men like O. Scott, J. Horton, L. R. Sunderland, Luther Lee, L. C. Matlack and other grand and noble men of God refused to remain associated in Church fellowship with those who trafficked in the bodies and souls of their fellowmen. This reason for their separation no longer exists, but it is just as important that we, their successors, separate ourselves from the evils of our day as it was that they should come out from among them and touch no unclean thing. Therefore we desire to renewedly pledge ourselves to keep absolutely free from every form of worldliness that would entangle our feet and hinder us in the race or eternal life.

The liquor traffic with all its associated evils remains with all its abominations simply because the Church of God does not do its duty. We rejoice at the awakening of the public conscience at the present time upon the question and will with vote and voice do our best to bring about absolute prohibition to the nation at the earliest possible moment. Until that day arrives we especially favor the passing of a law that will take the federal government out of complicity with criminals in breaking down law in prohibition states.

We reaffirm the position taken in our Discipline that we will not extend membership in our Churches to those holding membership in any secret society. We believe that such association is incompatable with our highest service to God, and our best service to men, therefore we admonish our pastors and members to keep absolutely free from every form of secrecy, and to guard the door of the church faithfully, that none of them creep in unawares among us.

We believe that God has a just claim upon one seventh of our time and one tenth of our money, therefore we most earnestly request all our people to "Remember the Sabbath day to keep it holy" by keeping entirely free from Sabbath visiting, reading all literature not calculated to lead into deeper spirituality, idling away the sacred hours in careless ease or in pleasure and sight seeing, as well as to keep absolutely free from the grosser forms of desecration, such as ball playing, Sunday excursions, and all unnecessary work of every kind.

We believe that our Church paper, the Wesleyan Methodist, is worthy of our loyal support as a means of deepening our interest in holy things as well as an avenue of communication between the different departments of our work. We, therefore, urge every pastor

to make a special effort this year to see that every family in the church has a copy of it in the home each week.

Our people everywhere are demanding a better qualified ministry, and are reluctant to grant indulgence to those who learn in the school of experience what could have been gathered in a much shorter time in our church school. If we demand trained men it is absolutely necessary that we provide the very best opportunities possible for our young people to secure their education. Therefore we pledge our prayers and loyal support to our school at Miltonvale and will endeavor by every means possible to encourage our people to send their children to the school, and to give their means to its support.
