JOURNAL OF DAILY PROCEEDINGS

The California Conference of the Wesleyan Methodist Church of America met for its Thirty-Third Annual Session in the auditorium of Azusa College in Azusa, California, at 9:00 a.m. on Tune 24. 1957.

The opening devotional period was conducted by the president, Sherwood Eddy. He read from Luke 17:3-10, and urged us to do the "Beyond Command" in the service of our Lord.

The roll was called.

The bar of Conference was made the first nine rows of seats and the platform.

Lillian Fahy was seated as a delegate in the place of Charles Christie, who is unable to be present.

The report of the Agenda Committee was read. It was amended. The amended report was adopted. See Report No. 1.

The following were elected on the Nominating Committee: Keith McRoberts, Elzie Gordon, John Henley, Orval Butcher, and Luther Emery.

The Nominating Committee retired for Committee work.

Pearl Taylor was appointed secretary pro tem.

The report of the Missionary Board was read by Richard Rossow. The report was adopted. See Report No. 2.

The report of the Camp Meeting Board was read by Archy Mudgett. It was adopted. See Report No. 3.

The Sunday School Secretary, L. J. Reckard gave an oral report of the Sunday School Department. It had urged attendance at the Greater Sunday School Convention in Los Angeles. It had promoted the Thanksgiving offering for the Headquarters building. Banners were purchased for awards. The Whittier Sunday School received both banners, one for the largest Sunday School and one for the greatest increase. A Sunday

School Rally was suggested but was not held because of a conflict with the Youth Rally. The possibility of holding a Teacher Training Class was investigated but was found to be a larger project than was able to be carried out. All were urged to attend the National Sunday School Convention to be held in Los Angeles, Oct. 9 - 11. The report was adopted.

The report of the Committee on Cooperation between the California Conference and Pacific Bible College was read by Archy Mudgett. It was adopted. See Report No. 4.

The Denominational Representative, Dr. R. S. Nicholson, was invited to sit within the bar of Conference. He brought encouraging words of greeting.

The Conference President read his report. It was accepted with a rising vote of thanks. See Report No. 5.

A partial report of the Nominating Committee was read. It was amended. The report as amended was adopted. See Report No. 6.

The Courtesy Committee introduced Rev. J. M. Kavanaugh.

The president nominated Ted Marsh, Dorothy Vogel, and Ruth Henley on the Committee on Itineracy and Elder's Orders. They were elected.

The report of the Board of Trustees was read. A motion was made and carried that it be accepted. See Report No. 7.

SECOND MEETING, MONDAY P. M.

Sherwood Eddy directed the Devotions.

The roll was called.

John McCain, the Conference treasurer, was granted an honorary seat within the bar.

The minutes were read and approved.

A motion carried to adopt the schedule of the Camp Meeting Board and the Agenda Committee as the report of the Religious Services Committee.

A motion carried that the Denominational Representative be given time to speak to us Wednesday afternoon.

The Auditing Committee was excused for committee work.

A motion carried that the reports scheduled for Tuesday afternoon be heard this afternoon.

The Tithing Secretary, James Judy, gave an oral report, asking several ministers to give their reasons for tithing. The report was adopted.

The Transportation Secretary, Eldred Perkins, gave a report on his efforts to get clergy rates on airplanes for elders. The report was adopted.

The Card Call Secretary, DeVere Wilson, gave a report which consisted of statements from some of the pastors who had received Card Call aid, telling of the benefits of the Card Call Plan. The report was adopted.

The Promotional Secretary of Wesleyan Men, Richard Rossow, reported on the activities and benefits of the Men's Fellowship in the Conference. The report was adopted.

The member of the Board of Trustees of Miltonvale College, Charles Butcher, reported on the Board meeting held last January. The report was adopted.

Adjourned for Committee work.

The roll was called.

The minutes were read, corrected and approved.

A partial report of the Ministerial Character Committee was read. A motion carried to adopt this partial report.

The Camp Meeting Treasurer read his report. It was adopted. See Report No. 10.

The treasurer of the Pension Plan read his report. It was adopted. See Report No. 11.

The report of the Conference Treasurer was read. It was adopted by a rising vote of thanks. See Report No. 12.

The Educational Secretary, Archy Mudgett, gave an oral report. It was adopted.

The Burial Association Secretary, Arthur Depew, gave an oral report. It was adopted.

The Courtesy Committee introduced Rev. E. J. Mills and Chaplain John Frisk.

The Denominational Representative, Dr. Nicholson, was invited to take the chair during the election of officers.

The chair was turned back to the president.

FIFTH MEETING, WEDNESDAY A. M.

The devotions were conducted by J. M. Kavanaugh, calling our attention to some of the conditions for answered prayer.

The roll was called.

The minutes were read and approved.

Prayer was offered for Tommy Laymon, a member of the Arrow Highway Church, who had been seriously injured in an auto accident.

The Committee on Memorials read its report. It was accepted. See Report No. 14. A few moments of silent prayer were spent in memory of those who have passed away.

The report of the Committee on Itineracy and Elder's Orders was read. It was adopted. See Report No. 15.

A partial report of the Committee on Nominations was read. It was adopted. See Report No. 16.

The Ministerial Character Committee gave a partial report. A motion carried to adopt the report. Included in Report No. 8.

A motion carried that there being nothing against the character of Charles Denison, Eldred Perkins, Arthur Taylor, or Elvina Perkins, their character be passed and that the secretary send a letter of appreciation of the labors of those not able to be present at Conference.

The Statistical Committee read its report. A motion carried to adopt it. See Report No. 17.

The following resolution was presented and adopted:
WHEREAS the liquor traffic is making such subtle
inroads into our homes by means of radio, television and the
press, in popularizing moderation in drinking;

WHEREAS many ministers in the pulpits throughout the nation are failing to definitely preach and teach Total Abstinence for the individual and prohibition for our nation;

WHEREAS of the stand of our church in the discipline

according to article 3, paragraph 58 under Special Rules:

Be it resolved that this thirty-third Annual Conference of the Wesleyan Methodist Church go on record that we urge our ministers and laymen to actively oppose the liquor traffic in all its evils and faithfully work for the dry cause, by precept and example.

A motion was made and seconded to adopt the following resolution:

"Be it resolved by the California Conference now in session that the next session of the General Conference be, it hereby is, authorized to order the inclusion of the sentence in Paragraph 46: 'The wearing of clothing which does not modestly and properly clothe the person' between the line which reads 'The putting on of gold and costly apparel' and the line which reads 'The taking of such diversions....' The motion carried by a vote of 47 in favor and none against.

A motion was made to write a letter to the Legislature of Arizona opposing a bill which would result in the taxing of our churches in Arizona. The motion was amended that the Conference president, the Conference secretary, Dr. Nicholson, and the two pastors from Arizona prepare a resolution opposing said legislation. The motion carried.

Sherwood Eddy was elected by ballot as a member on the Board of Trustees of Miltonvale College.

Charles Butcher was elected by ballot as Alternate member of the Board of Trustees of Miltonvale College.

The Courtesy Committee introduced Charles Spisak.

Recessed to meet at the call of the chair.

The meeting was called to order.

The Pastoral Relations Committee read its report. It was adopted. See Report No. 18.

Rev. E. J. Mills, former General Secretary of the Burial Association was given time to speak about the Association.

Adjourned.

A rising vote of thanks was given to Miss Marie Lind for her labors in benefit of the Conference.

- WHEREAS, it is often impossible to send young people from the Pacific Southwest to the mid-west to our own denominational schools, and.
- WHEREAS, it is impossible for the California Conference to operate its own college in the West (because of heavy financial burdens), and,
- WHEREAS, Azusa College (formerly Pacific Bible College of Azusa) is a Wesleyan-Arminian school whose doctrines and standards are in keeping with those of our own denomination, and,
- WHEREAS, the Board of Trustees of Azusa College (formerly Pacific Bible College of Azusa) has made provision for cooperation between the college and the California Conference,
- BE IT THEREFORE RESOLVED that the California Conference of

STANDING RULES

- 1. The Conference shall convene at the call of the Chair. The President shall announce the date of its meeting sufficient time before the opening in conformity with the Denominational Board.
- 2. As soon as possible after the last Quarterly Meeting on each charge the pastor shall forward the Delegate's credentials to the Conference secretary. The secretary shall then compile the roll of Conference to be ready for the opening of each session.
- 3. The quorum of this Conference shall be twenty-five per cent of its possible enrollment. Ministerial or lay members of the Conference must not leave the bar of Conference without consent of the chair, nor withdraw from the Conference session permanently without consent of the Conference.
- 4. The Conference shall elect a Nominating Committee which shall bring in nominations for Sessions Committees as early in the first meeting as possible and nominations for Standing Committees at the time of election of Conference officers.
- 5. All recommendations to study, to travel, to receive Elders Orders or to be received on credentials shall be handed to the secretary as early as possible and he shall pass them to the proper committee without vote of the Conference.
- 6. Pastors shall not drop any of their appointments without consent of the president and his Advisory Board.
- 7. All charges shall pay the moving expenses of the incoming pastor within the bounds of the Conference.
- 8. While we believe in and will practice ministerial courtesies yet it is the sense of this Conference that our churches shall not be opened to other denominations to maintain a regular appointment as such is likely to scatter the flock.

- 9. It shall be the duty of the pastors to see that all property is properly insured. Failing to do so the Conference will do it and in event of fire collect the monies.
- 10. No person making application for membership on letters of dismissal shall be received until impediments in the way of granting a letter of good standing shall have been removed by proper adjustment.
- 11. The fiscal year of the Conference shall close May 31 each year and the Conference treasurer shall close the Conference books on that day. The local treasurers shall close their books at the same time and have their statistical reports made out and in the hands of the Statistical Committee at least five days before Conference. Each church shall pay salary to the outgoing pastor for two Sundays following adjournment of the Annual Conference. Any arrangement contrary to this rule shall be cleared with the Conference President and his Advisory Board.
- 12. Examinations on the Course of Study shall be taken before an Elder of the Conference unless permission is obtained from the chairman of the Committee on Itineracy and Elders Orders to do otherwise.
- 13. The president and his Advisory Board and the Board of Trustees are to be the Board on Church and Parsonage Location and Plans.
- 14. The president and his Advisory Board are designated as a Deed Examining Committee for the Conference. When deeds to Conference, Church or Parsonage property are received, before being recorded, they shall be submitted to this committee for examination and the insertion of such disciplinary clauses as necessary to make the property safe for the Conference.
- 15. The Committee on Religious Services for the Conference shall be composed of the president and his Advisory Board, the president of the W.M.S. and the president of the Conference W.Y.P.S.
- 16. All pastors are required to subscribe to THE WESLEYAN METHODIST and the WESLEYAN MISSIONARY.
- 17. The Conference secretary and treasurer shall each be reimbursed to the amount of \$50.00 for each year's labor.

- 18. Each church shall adopt and practice the storehouse tithing plan as set forth in the Bible and Discipline.
- 19. The Camp Meeting Committee shall be composed of four elders, elected in rotation for a term of four years each, and two laymen, elected in rotation for a term of four years each, with the president of the Conference, the president of the Woman's Missionary Society and the president of the Wesleyan Young People's Society members ex-officio.
- 20. The Camp Meeting Committee is empowered to employ evangelistic help up to and including three years in advance.
- 21. Pastor's statistical reports shall be posted rather than read orally.
- 22. The Missionary Board shall be composed of the Conference President, the W.M.S. President, the W. Y. President, the Conference Treasurer, one elected Member and the Conference Board of Trustees. All Church Extension as to location, planning, policy and promotion shall be under the direction of this Board.
- 23. All officers, Boards and Standing Committees shall take office as soon as elected except the Statistical and Auditing Committees, whose term of office shall be from the rise of the Conference in which they are elected until the rise of the following Conference.
- 24. It shall be the duty of each pastor to get his Progress Report in the mail by the 5th of each month. All others under Conference appointment shall report to the Conference President monthly.
