Standing Rules

I. CONFERENCE OFFICERS—Resolved, that the officers be installed during Conference, at a public service announced in advance, office to take effect at the rise of Conference.

II. CONFERENCE PRESIDENT—Resolved: (1) That the Conference President be appointed, authorized and required to travel the Conference as President, having general supervision of the spiritual interests and benevolences thereof, holding at least one service at each church during the year under such date as he may announce in advance.

(2) That he shall raise funds to meet the demands of the Conference work, assisted by the pastors, and he shall receive contributions for Missions, Education, and Superannuated Ministers where there are no pastors.

(3) That he shall have general supervision of the church property, and shall inquire into the titles of the same, to see that no property is loosely held, and shall look after the rental of Conference property and see that the rent is turned into the treasury and he shall investigate the possibility and feasibility of the sale of property not in use.

(4) That he shall be authorized to grant letters to disband classes.

(5) That he shall be required to write non-resident members of the Conference asking them in case they cannot attend, to write the Conference a letter of greeting, stating the condition of their religious experience.

(6) That he shall devote as much time as possible and as occasion may afford in evangelistic and other meetings in the Conference.

(7) That he may engage help from time to time, as may be advisable and who he may consider properly qualified to assist in holding Evangelistic and Quarterly meetings, such help to be remunerated from the Church Extension Fund.

(8) That he shall be paid from the Conference President's Salary Budget the sum of seventy dollars (\$70.) per week for his services, the same to begin the first Sunday following the rise of the next Conference, and to continue through the second Sunday following the rise of the next Conference, the same to be paid monthly in advance; he shall also be paid official expenses, including secretarial help up to ten dollars (\$10) per week, and he shall be paid five dollars (\$5) per week for utilities, and his premium on the Conference approved minister's health insurance policy shall also be paid. He shall also be paid \$20.00 per month for car depreciation.

(9) That he shall act, or appoint to act, as Fraternal Delegate to all denominational or inter-denominational bodies, as he deems advisable.

III. CONFERENCE TRUSTEES—Resolved: (1) That the Board of Trustees shall consist of nine members, three to be elected, each for a term of three years, and each to reside within the bounds of the Conference.

(2) That the duly elected and qualified Trustees of the Annual Conference are hereby authorized and directed to sign for the purchase, sale, mortgaging and conveyance of real estate recommended by the Conference Missionary Board during the interim between the meetings of the Annual Conference, and all such action or actions shall be deemed to be legal and binding upon the Conference, and of as full force and effect as they would have been if such actions on the part of the Trustees had been specially authorized by the Annual Conference.

(3) That the President and Secretary of the Board of Trustees shall be authorized to sign on behalf of the Board of Trustees, such signatures to be valid and binding as if all members of the Board of Trustees had signed said papers.

IV. MISSIONARY BOARD—Resolved: (1) That the Conference Board of Trustees, and the President of the Conference Women's Missionary Society constitute the Missionary Board.

(2) That the Missionary Board is hereby authorized to pay out all monies from the Church Extension Fund.

V. COMMITTEE ON CHURCH AND PARSONAGE BUILDING, LOCATION, ALTERATION AND REMODELING—Resolved: That the Conference Board of Trustees shall constitute the Committee on Church and Parsonage Building, Location, Alteration and Remodeling.

VI. CAMP MEETING BOARD—Resolved: (1) That the Conference President, the Conference Wesleyan Youth President and the Charles City pastor be members ex-officio, except when the Charles City pastor is an elected member of the Board.

(2) That the Board be constituted of a total of ten members, elected by ballot for a term of three years each.

(3) That the Camp Ground Property shall be under the care of the Camp Meeting Board.

(4) That this Board shall have the power to engage workers beyond the present year.

(5) That this Board, together with the Conference Secretary, constitute the Orders Of The Day Committee.

(6) That all pledges and cash received during the sessions of Conference and Camp Meeting be placed in the Camp Meeting Fund unless otherwise designated.

(7) That the incidental expenses of the Annual Conference, while in session, be paid from the Camp Meeting Fund.

VII. COMMITTEE ON STATISTICS—Resolved: That a standing Committee on Statistics be elected, consisting of the Statistical Secretary and three other ministerial members. That three lay members be elected at the opening of Conference.

VIII. FINANCIAL SECRETARY—Resolved: That the Conference shall elect a Financial Secretary for the Conference year, whose duty it shall be to study finances and bring recommendations to the Committee on Finance at the next Annual Conference, of which committee he shall be first member. He shall also require the various treasurers of the conference to secure a competent auditor and submit a "Certificate of Audit" and the qualifications of the auditor to them. He shall give a "Report of the Auditors" to the Conference.

IX. BUDGET ITEMS—Resolved: That all Treasurers shall mark receipts "Budget" or "Not Budget."

X. LOCAL CHURCH FISCAL YEAR—Resolved: That each local church of our Conference close their books June 30.

XI. CONFERENCE FISCAL YEAR—Resolved: That the Conference Fiscal Year close July 15th: that all money shall be in the hands of the proper Treasurers on or before that date; that within seven days thereafter each pastor shall submit to the Conference Treasurer his budget check sheet, with receipts covering the same, and his statistical blank, completed in full, except for the budget raised; that the Conference Treasurer shall fill in budget raised items and hold reports for the Statistical Committee the first day of Conference.

XII. CONFERENCE DATE—Resolved: That Camp Meeting begin the first Sunday of August and continue through the second Sunday. That Conference begin the following Monday and conclude Wednesday.

XIII. SUNDAY SCHOOL—Resolved: That Sunday School shall be held each Sunday of Conference and Camp Meeting.

XIV. LEAVE—Resolved: That no member shall leave the Conference Session without the permission of the President.

XV. COMMITTEE REPORTS—Resolved: That all reports of Committees be made in writing, complete and ready for the printer, and handed to the Secretary at the earliest possible date after such report has been made.

XVI. PASTORAL REPORT—Resolved: (1) That each ministerial member of our Conference report to his Quarterly and Annual Conference the

number of sermons preached, prayer meetings attended, homes visited and pastoral calls made.

(2) That each Sunday School under pastoral oversight of Wesleyan Methodist pastors shall be included in a separate Statistical Report.

XVII. CONFERENCE PREACHER'S REPORT—Resolved: That all Conference Preachers not stationed by the Pastoral Relations Committee, shall report to the chairman of the Committee on Itineracy and Elder's Orders not later than 30 days prior to the first day of the Annual Conference.

XVIII. CREDENTIALS—Resolved: That each Annual Conference Preacher present his Credentials at Conference for renewal and proper signature.

XIX. TEXT BOOKS—Resolved: That all persons shall be requested to bring the text books to Conference in which they are to be examined.

XX. PASTOR'S SUPPORT DURING CONFERENCE—Resolved: That it be our plan that all pastors remain on their charges for one Sunday after Conference and that the churches financial obligation to the pastor, whether he be leaving the field or not, be extended through that Sunday.

XXI. MOVING PASTORS—Resolved: That each charge make provision for the moving expense of the incoming pastor.

XXII. MINISTER'S VACATION—Resolved: That the Conference President and all pastors be given a two weeks vacation with pay.

XXIII. MEMBERSHIP IN SUPERANNUATED PENSION PLAN—Resolved: That all ministers be required to join the Superannuated Pension Plan before receiving Conference appointment, unless they furnish the Superannuated Ministers Committee sufficient evidence of inability to join or participation in Social Security. That this action become a Standing Rule effective as of 1954. Ministers receiving their first appointment shall have one year in which to join either or both.

XXIV. DEATH OR ILLNESS—Resolved: That the Conference Secretary be notified by telephone in case of death or critical illness in a minister's home, and that he shall send cards at once to each pastor.

XXV. MINUTES—Resolved: That the Conference Secretary bill each church for the number of Minutes ordered by that church, and that the Conference Secretary bill the Conference Fund for those Minutes not ordered by individual churches.

XXVI. PUBLISHING OF EVANGEL—Resolved: That the Evangel be published monthly; that the Editor be also Publisher, that he be nominated by a staff composed of President of the Conference, President of the W.M.S., President of the Conference Wesleyan Youth, and the Conference Sunday School Secretary, and after being elected by the Conference, the manner of financing the publishing of the Evangel be left to the Editor and his staff.

XXVII. NOMINATING COMMITTEE—Resolved: That a Nominating Conference to consist of: Conference President, ex-officio as chairman, three elders elected by the Conference and three church Delegates of the three elders elected by the Conference and three church Delegates of the Conference to serve in alphabetical order of the churches. Said Delegates shall notify the Conference President of their availability by July 1st. Successive church Delegates shall serve as alternates. Said Committee to nominate Conference session committees, Trustees to Miltonvale Wesleyan College, Conference Trustees and members of the Camp Meeting Board.

XXVIII. MID-YEAR CONVENTION COMMITTEE Resolved: That the

Committee on Mid-year Convention consist of three members elected for three years; one member to be elected each year. The Host pastor to be member *ex-officio*.

XXIX CITATION COMMITTEE—Resolved: That there be a Committee on Citation, composed of three members. The Secretary Treasurer of the Superannuated Pension Plan shall be chairmen of this Committee. The other members shall be elected annually. It shall be the duty of this Committee to prepare and present appropriately worded citations to those Elders who have served the Conference 25 years or more on a consecutive or cumulated basis. Eligibility shall be determined by the number of years applicable to Superannuated Pension credit. Those eligible for citation shall be notified 30 days prior to the time of presentation.

XXX COMMITTEE ON CREDENTIALS—Resolved: That there be a standing Committee on Credentials whose duties shall be to send each pastor Sunday School report blanks, Character blanks and Delegates blanks. The Delegate Credentials shall be returned to him by July 15th.

JOURNAL OF DAILY PROCEEDINGS

Monday, August 15, 1960 — 8:30 A.M.

The One-hundred-seventh session of the Iowa Annual Conference was called to order on the Camp Grounds at Charles City, Iowa, Monday, August 15, 1960, at 8:30 a.m. Special prayer was the first order of business. Rev. Donald D. Calhoun and the Vice President, Rev. Paul R. Davis led in this special prayer. Rev. Albert R. Fookes led in singing "Bringing In The Sheaves".

CONFERENCE SERMON — Rev Clarence Budensiek introduced Rev. Clayton P. Elsberry who brought the Conference Sermon. His subject was "God's Word For His Work," and he took for his scripture lesson Habakkuk 1:1-6 and 2:18-20. The acts of faith as enumerated in the eleventh chapter of Hebrews were accomplished by faith in the Divine Word of God. There is a place for all. We dare not be too big for our shoes, nor yet too small to serve where God calls. If the church is not willing too oppose evil it is in essence supporting it. We are faced with a necessity of either opposing evil or affiliating with it. We need to face Satan and tell him that we are going to triumph. The church is like a great sleeping giant before a great flood of communism and evil. Are we too large for our shoes, or too small for our armor? Attention was called to the widow of great faith and the disciples of little faith. We need to pray that the Word of God go forth in fullness of power. The Word has come especially for man. The Word of God is alive and it creates life. It is like a hammer to break the stony heart; a sharp two edged sword to cut in the heart of the one to whom it is delivered. God says IT shall accomplish that whereunto it is sent. Since God can give me victory through the Word, so can He the church. The church that is not pulling together will soon pull apart. Since God can give victory to the church He can also evangelize the unsaved world through the church. We were challenged to preach the Word in power, love and conviction for decisions. To draw out the souls of the hearers into the will of God. We need to draw back in the midst of the battle. May we be able to say as David Brainerd that we do not care where we live or what we must do, so long as we can see souls saved. It is not by might nor by power but God's Word is necessary.

CONFERENCE COMMUNION — The Conference Communion Service was in charge of Rev. Robert A. Howlett, assisted by Rev. R. W. Pryor, who read the Scriptures and extended the invitation. Rev. W. A. Buell offered the prayer of consecration of the elements. Rev. V. A. Mitchell and Rev. Clarence Budensiek were served first and then served those Elders who

were to serve the congregation. Serving the congregation were Rev. H. F. Clark; Rev. Glen McMurphy; Rev. Albert R. Fookes; Rev. F. L. Friehtet; Rev. Howard W. Johnson and Rev. A. L. Nabholz.

CHAIRMAN — Rev. V. A. Mitchell, Denominational Representative was called to the chair.

WELCOME — Rev. F. L. Friehtet, pastor of the local church, spoke fitting words of welcome.

RESPONSE — Rev. R. W. Pryor spoke fitting words or response to the welcome.

ROLL CALL — The Secretary read the Roll of the Conference.

COMMITTEE ON CREDENTIALS — Rev. Richard L. Jamieson was nominated and elected, Rev. Lee R. Hoge was nominated and elected.

COMMITTEE ON CREDENTIALS REPORT — Rev. Richard L. Jamieson read this report and the delegates were seated.

DENOMINATIONAL ADDRESS — Rev. V. A. Mitchell delivered the Denominational Address. He took for his text Exrrous 14:15 "Speak unto the Children of Israel that they go forward." Operation Outreach must be more than a slogan. Rev. Mitchell spoke of the Denominational reorganization affected by the General Conference, explaining the functions and areas of service of the various offices and officers. He also presented facts about, and accomplishments of the various societies. He challenged us to greater and more efficient labors for the Lord. The cause of Christ, he said, is being challenged by the forces of evil. We must not be engaged in nonessentials.

Conference President's Report

Greetings to the 107th session of the Iowa Annual Conference. Again we thank God for the privilege of laboring in His vineyard with so fine a group of co-laborers. Your co-operation again has been wonderful.

Des Moines Church is soon to complete their new church building program. Charles City Church has builded on their new location on South Main. Guthrie Center Church has finished their basement rooms and is putting on a new entry way on the corner of the church. E. R. Dodd Memorial church is building a new educational building. Marengo has put on a new ceiling and refinished the walls and woodwork. Manchester has a new ceiling and West Union is remodeling ceiling walls and floors. Waite Park has a new parsonage. A five acre tract of land has been purchased by the new St. Paul group and a parsonage was arranged by them. Plans are under way for a first unit building.

The summer youth camps have been signally blest of the Lord.

One annuity was received for church extension work. If our church continues to exist and to meet the growing needs of our day, Wesleyan Methodists will need to remember the church in annuities, wills and bequests. Our people have responded well to requests for loans for new fields and new churches. We have present needs for loans from our people. Our new fields are progressing well and the valuations have increased so we feel we are on sound financial ground.

We have conveyed to the conference board of trustees, the counsel of General Superintendent H. K. Sheets. He says: "The church or conference should justify their ability to service a loan (meet its payments) before the green light is given to put the additional indebtedness on a church or conference. We want both soundness in the finance of our new churches and at the same time aggressive in our spirit of advance.

We as a conference have consistently opened new fields in strategic new housing areas at today's staggering costs. To service these fields until they can assume all the load is a task we have committed ourselves to. There is no turning back. The challenges of the Board of Church Extension are vital and necessary. Pastors of churches with a living wage must challenge the people to the needs and only then under God can we go on. Pastors receipts increased this year \$8,000.00

REPORT NO. 11

Trustee and Board of Church Extension and Evangelism Report

August 8, 1959 —

ROCKFORD—The sale of the Rockford parsonage for the sum of \$1,000.00 was approved.

ROSYLN PARK — The July payment of the church was authorized by the President, and approved by the Board.

August 13, 1959

ST PAUL —The need for and possibility of new work in the East St. Paul area was presented by President Budensiek. Dr. John Higbee stated the desire of a group to have a church and how much they thought they could raise. By motion this was authorized to be the project for this Conference Year. By motion the moving expense of a pastor was authorized.

ROCKFORD — By motion the net amount received in the sale of the Rockford parsonage was authorized to be paid into the Rockford Fund.

REMODELING — By motion Rev. Budensiek, Rev. Clayton P. Elsberry and Carl Zupke were authorized to act as a committee to investigate the remodeling plans for West Union and Manchester, with power to approve.

CARD CALL — By motion the Card Call Secretary was authorized to send out to each pastor cards enough for every member of his church for a Card Call for the St. Paul church project.

CHURCH EXTENSION SUNDAY — September 13, was set as Church Extension Sunday. Results of the Church Extension service are to be reported at the Ministerial Retreat.

ORGANIZATION — The President is designated as Chairman of the Board by order of the Discipline. Rev. Paul R. Davis was elected Secretary of the Board. Rev. Clarence Budensiek was elected President of the Board of Trustees.

September 22, 1959

CHARLES CITY — By motion the President and Secretary of the Board of Trustees were authorized to sign the easement for the Meyers Street in Charles City.

DES MOINES — President Budensiek reported that the Des Moines church had voted to have the Wall Shaffer Construction Company erect their church building on a cost plus 6% basis. By motion this was approved.

ST PAUL — A report of progress was given. Dr. John Higbee was appointed Lay Leader by President Budensiek and approved by the Board.

October 17, 1959—

CHARLES CITY — By motion approval was given to the Charles City building plans, providing the total debt limit not exceed payments of \$500 per month for principal, interest and church furnishings.

DES MOINES — Two notes totaling \$1,500.00 were by motion made available to the Des Moines church. By motion the debt limit on the Des Moines church was raised to \$30,000.00.

MARENGO — By motion the President was authorized to have the ceiling of the church repaired in the best manner possible.

MANCHESTER — By motion a grant of \$250.00 was allowed toward the expense of a new tile ceiling for the church.

ST. PAUL — By motion payment of up to \$100.00 per month was granted to provide for parsonage rent.

WATERLOO FIRST CHURCH—Pastor Elsberry told of how the roof of the present sanctaury is sagging and some of the church wonder whether improvements should be left until they can decide whether a complete new sanctuary should be built.

December 1, 1959—

ST. PAUL — Assurance was given St. Paul group that they will sign with the local group for the amount of money needed for the down payment on the proposed property located on Minnehaha Avenue.

ALBERT LEA — The request of the Albert Lea church to mortgage the parsonage for the eamout needed to borrow to install a new heating unit in the church was approved.

DES MOINES — By motion the President and Secretary of the Board of Trustees were authorized to sign a mortgage and mortgage note for \$20,000.00 with the Trustees of the Des Moines Church for the purpose of assisting them in the construction of the superstructure on the Des Moines church. This note to bear 6% interest.

MARENGO — By motion plastering the exterior steps of the church at a cost or \$75.00 was authorized.

CHARLES CITY — The President and Secretary of the Board were authorized to co-sign with the Trustees of the Charles City church a mortgage loan of \$38,000.00 from the Commerical Trust and Savings Bank of Charles City, Iowa.

February 11, 1960—

WAITE PARK — By motion, action of President Budensiek in appointing George Walquist to sign for release, money obtained from a loan company for the construction of the parsonage, was authorized by the Board.

ALBERT LEA — A mortgage loan of \$2,800.00 has been obtained from the Security State Bank at 5% interest. This is to be paid in four years. The parsonage will then be deeded to the Conference. This action was approved by motion.

GUTHRIE CENTER — By motion the Board approved the building plans for Guthrie Center and will forward the \$250.00 formerly approved.

CERAR RAPIDS — By motion the request of Pastor Hubby to sell 183 feet of the frontage on the east of the church property was approved, providing \$5,000.00 can be cleared after paying for paving, fees, etc.

DES MOINES — By motion a grant of \$1,000.00 to assist in the building program was authorized.

OSKALOOSA — Request for a loan to assist in obligations of the church was granted, \$900.00 was loaned at the rate of 5% to be repaid \$180.00 per year plus interest, and was due and payable in five years.

HOWARDVILLE — Preliminary sketches of church remodeling were presented. By motion the Howardville church people were commended for their plans and urged to make this step of faith.

June 30, 1960—

ROSLYN PARK — By motion the special assessments paid by the Church Extension Department last year were assumed by the church this coming year. The pastor was to be informed of this action. By motion the Denominational Church Extension Department were to be requested to continue their support of \$43.50 per month for the Roslyn Park pastors salary.

NAME OF BOARD — By motion the official name of the Missionary

Board was changed to coincide with that of the Denomination and shall hence be Board of Conference Extension and Evangelism.

CEDAR RAPIDS — By motion the church was instructed to assume one-half of their monthly payments to the Bohemian Loan Company.

DES MOINES — By motion assistance of \$50.00 per month was to be allowed the church to assist in their monthly payments the first six months of the next Conference Year, beginning August 1.

CHURCH EXTENSION SUNDAY — By motion September 11 was approved as church Extension Sunday.

ANNUITY BOND — An annuity bond for \$500.00 from Mabel L. Woods was approved, with interest at 6½% interest, the interest to be paid from funds of the Board of Conference Extension and Evangelism.

CHARLES CITY — By motion request of the Church to increase the amount to be borrowed from the Commercial Trust and Savings Bank from \$38,000.00 to \$40,000.00 was granted, providing this extra money be used on the present indebtedness.

CAMP MEETING — By request of the Conference Sunday School Secretary, we organized the children's Sunday School period for both Sundays of Camp. The first Sunday, Mrs. Hazel Calhoun was in charge of the classes in the dining hall. The second Sunday we demonstrated a class in child evangelism in the main tabernacle. The children's services and activities during camp and conference were well provided for by Mary Budensiek and Alice Davis. These efforts were very much appreciated by all concerned.

BIBLE CRUSADER CAMPS — At the request of the Midwest Board, we worked along with Rev. Al Fookes in directing Little Midwest Bible Crusader Camp on Lake Koronis, June 20 - 26. The evangelistic and teaching ministry of our Conference President, Clarence Budensiek, was geared to the needs of the children. This was most valuable and served along with the capable instruction of Mrs. Joe Matt and Mrs. Marjorie Main to make the camp a most profitable one. Approximately 25 campers received special

help at the altar of pray. A love offering of about \$25.00 was given by the children to Brother Budensiek. There were 46 campers registered and 11 workers. The theme this year was "Prospecting in God's Word". This camp was a real joy and challenge.

The Charles City Bible Crusader camp which we jointly directed with Mrs. Margaret Jamieson was held on the camp grounds July 11 - 15. There were 133 Campers registered at a total charge of \$8.25 each. There were 33 graduates. By that we mean that these are promoted into Junior High Camp next year. Mrs. Neva Miller, University Park, Iowa was the very capable children's evangelist. There were 35 other workers, 16 of whom were lay people. This consecrated corps of workers, so willing to co-operate, was one of the keys to the wonderful camp God gave us. Another key to the success of the camp, was the prayers of the people of the churches across the conference. These were keenly felt, and we thank you and thank God.

There were 102 campers who bowed at the altar and received special help at different times. The theme was the "Heavenly Trail" which was carried out in every phase of camp life and especially in the class course "Vacation Exploration". Again we give God praise and count it a real privilege to work in this capacity.

Due to the fine registration each year there has been a surplus which is being turned into camp improvements. This past year there were purchased 3 dozen Samsonite chairs at a total cost of \$156.79 and 6 Virco adjustable-height tables at a cost of \$190.00. Our greatest and most imperative need at the present is a children's tabernacle on the camp grounds which can be used for services during camp meeting as well as class room facilities during Bible Crusader Camp. Please pray with us about this need.

6. WATERLOO DISTRICT—Cedar Falls, Emmanuel, Lea Porte City, Waterloo Falls Avenue, Waterloo First, Waterloo Maywood. Leader:

7. INDEPENDENCE DISTRICT—Fayette, Hoover, Independence, Manchester, and West Union. Leader: Mrs. Roy Coleman.

We further recommend:

1. That each district have a minimum of one Sunday school convention.

2. That every Sunday school cooperate with the denominational thanksgiving project.

3. That the attention be given to disciplinary provision, relative to election of officers and teachers.

4. That the conference Sunday School budget be ten cents (10c) per member. Conference and Denominational Sunday School budget is based on the number of members in the main school reported in the 1960 Annual Conference Minutes.

5. That the Conference Sunday School Secretary continue to be designated to receive and disburse the Conference and Denominational Sunday School funds.

6. That every Sunday School promote monthly staff meetings and give diligent attention to a Teachers' Training Course.

7. That each Sunday School promote a Daily Vacation Bible School.

8. That each pastor send in monthly attendance reports to the Conference Evangel.

9. That any one coming to Sunday School after the half-way period should not be counted on the attendance record.

10. That members of the Home Department are not to be counted on the Sunday School attendance record when not in attendance.

11. That the Conference Sunday School attendance contest begin Sunday April 2 and continue through May 7, 1961.

12. That two Sundays be disallowed, if desired, in figuring the average attendance of the year.

13. That a car caravan be organized to travel to the national S. S. Convention in St. Louis, Oct. 10-14. Passengers pay driver one cent per mile. That district leaders and pastors cooperate with the Sunday School secretary in organizing caravan.

14. That Ella Cotrone be director of Child Evangelism.

REPORT NO. 20

Committee on Resolutions Report

The Committee on Resolutions recommend the amending of Standing Rule XVII to read as follows: **CONFERENCE PREACHER'S REPORT**—Resolved: that all Conference Preachers, not stationed by the Pastoral Relations Committee, shall report to the chairman of the Committee on Itineracy and Elder's Orders not later than 30 days prior to the first day of the Annual Conference.

That Standing Rule XXII shall read as follows: **MINISTER'S VACATION**—Resolved: that the Conference President and all pastors be given a two weeks vacation with pay.

That Standing Rule XXVII shall read: **NOMINATING COMMITTEE**—Resolved: that a Nominating Committee be elected at each Annual Conference to serve in the succeeding Conference to consist of: Conference President, ex-officio as chairman, three elders elected by the Conference and three church Delegates of the Conference to serve in alphabetical order of the churches. Said delegates shall notify the Conference President of their availability by July 1st. Successive church Delegates shall serve as alternates. Said Committee to nominate Conference session committees, Trustees to Miltonvale Wesleyan College, Conference Trustees and members of the Camp Meeting Board.

Standing Rule XXIX shall read: **CITATION COMMITTEE** — Resolved: that there be a Committee on Citation, composed of three members. The Treasurer of the Superannuated Pension Plan shall be chairman of this Committee. The other members shall be elected annually. It shall be the duty of this Committee to prepare and present appropriately worded citations to those Elders who have served the Conference 25 years or more on a consecutive or cumulated basis. Eligibility shall be determined by the number of years applicable to Superannuated Pension credit. Those

eligible for citation shall be notified 30 days prior to the time of presentation.

Standing Rule XXX shall read: **COMMITTEE ON CREDENTIALS**—Resolved: that there be a standing committee on credentials whose duties shall be to send each pastor, Sunday School report blanks, Character blanks and Delegates blanks. The Delegate Credentials shall be returned to him by July 15th.

We recommend that each charge shall elect a lay leader for the purpose of being a liaison man between pastor and church; said leader to be nominated by the pastor.

Whereas, the Superannuate Pension Plan treasurer indicates 19 eligibilities to Pension Plan, we recommend that the Pastoral relation committee examine each minister on Standing Rule XXIII.

Resolved: In as much as merger with the Pilgrim Holiness Church was considered at the last General Conference; and, in as much as the majority favored the merger as proposed; and in as much as the proposal was overwhelmingly approved by the Pilgrim Holiness Assembly; we, therefore, petition the General Superintendants and Board of Administration to grant the several Annual Conference and local churches the privilege of voting on this proposal prior to the next general conference.

REPORT NO. 21

Secretary of Evangelism Report

The last General Conference emphasized the importance of Evangelism and broke it down into three definite areas for specific concentration: Prayer, Evangelism and Conservation. To encourage interest in these areas, your Secretary of Evangelism has written several articles for the Evangel. Also, two brochures were mailed to all conference pastors this past year to promote evangelism in our conference.

The Secretary of Evangelism recommends the following as areas for definite improvement if evangelism is to be a dynamic, effervescing force among us:

1. Greater concentration on prayer (Prayer cells recommended).
2. Definite emphasis on advertising evangelistic meetings using brochures, newspapers, radio and television as well as personal invitation.
3. Stronger evangelistic appeal between evangelistic meetings.
4. Greater stress on personal evangelism among the laity.
5. Classes for Sunday School teachers emphasizing an evangelistic approach.
6. An intense follow-up campaign following evangelistic meetings.

To the challenge presented by this field must be brought the type of passion and fervor of John Knox when he declared, "God, give me Scotland or I die!"

 - c. Youth seek to challenge youth with missionary vision.
8. That each society inquire into the needs of Brainard, Hephzibah, and World Missions before sending used clothing and that no monetary value be attached; that the boxes of new merchandise be reported as to monetary value and that the sending society evaluate the same; the voucher evaluation be signed by the Superintendent for proper receipting.
9. That our local societies make bandages and surgical supplies and that these be forwarded to: Box 2,000, Marion, Indiana.
10. Community Missions—The title, "Community Missionary Society of the Year," will be given to the local society rating highest in the following:

- a. Number of calls made by lay women.
- b. Number of souls won.
- c. Amount of used clothing distributed.
- d. Participation in community projects.

To be promoted by the local Vice-President and evaluated by the Conference Vice-President.

C. FINANCIAL

1. That each local society contribute \$5.00 or more annually for the support of the Hephzibah Children's Home, the same to be applied on budget.
2. That the public program for Educational Harvest Day be held in October with offerings for education budget and the Harvest Day project which is non-budget, specifying amount for each, and co-operating with the project as announced.
3. That each society participate in the Miltonvale College Honorary Enrollment which will remodel rooms in the girls' dormitory.
4. That each society contribute \$3.00 or more annually to the Medical Mission Fund.
5. That each society send an offering to apply on the \$1,200.00 field support for Miss Alma Aldinger.
6. That the \$1.00 membership dues be sent to the Conference W.M.S. Treasurer.
7. That each local society give 50c per active member to the Conference Working Fund.
8. That each local society send \$1.00 to Conference Missionary Treasurer for the upkeep of the dining hall and 25c per active member for cooking utensils.
9. That each district receive an offering at their annual convention to be sent to Conference W.M.S. Treasurer for the purchase of needed items in the guest rooms.
10. That two report blanks be sent to each society to be carefully filled out. One of the reports to be sent along with the delegate's credentials to Chairman of Statistical Committee by July 15. The other report to be brought to conference by the delegate, then after conference returned to local treasurer.
11. That White Gift Christmas, Self-Denial, and Mile of Dimes Projects be liberally supported. Also that an annual offering be given to the American Bible Society, preferably taken during the Universal Bible Reading period.
12. That each local society be asked to give \$5.00 or more annually in addition to support of the Denominational Card Call plan and special projects, same to give credit on General Church Extension and evangelism budget.
13. In review, the Special Offerings are:

 3. Miles of Dimes Projects.
 4. Working Fund.
 5. Alma Aldinger.
