

JOURNAL OF DAILY PROCEEDINGS

Burr Campground, July 15, 1947.

The first sitting of the Seventy-seventh session of the Wisconsin Annual Conference of the Wesleyan Methodist Church of America convened in the tabernacle of the Burr Campground at 9:00 a. m. Tuesday, July 15, 1947.

Devotional Period—Rev. Walter Rogers of the Baraboo Charge led the Conference in a song service with Rev. Kenneth Hintz as pianist. Rev. Lloyd King led us to the Throne of Grace.

Conference Sermon—Was delivered by Rev. I. J. Butcher, pastor of the Spooner Charge. For a Scripture lesson Brother Butcher read a portion from the Old Testament, Exodus 33:12-23. For a text Exodus 33:18 "I beseech thee, show me thy glory." He brought to our attention three main divisions, namely: I. "What was the Glory Moses desired?" II. "Why did he desire this Glory?" III. "The purpose for which he desired this Glory." Following this timely and inspiring message, we sang, "There is a Fountain Filled with Blood" and all partook of the Communion. Truly God set His seal of approval upon the services and all were conscious of His melting power.

The Conference Business session was called to order by the Conference President, Rev. G. M. Hahn.

Roll Call of the Ministers showed 22 Ministers present.

Committee on Credentials—Rev. Walter Rogers was selected as Committee on Credentials. The report of the Committee on Credentials was adopted as the Delegates were seated by the Conference, there being 21 Delegates present.

Bar of Conference—Motion carried that the first eight seats in the center section of the tabernacle serve as Bar of Conference.

Time of Conference—Motion carried that time of Conference be set as follows: 9:00 a. m. to 12 noon and 2:00 p. m. until 5:30 p. m.

Committee on Committees—Motion carried that this committee consist of the following: Henry Clark, I. J. Butcher, J. B. Clawson, G. M. Hahn, and Clarence Titus.

Adjourned to await the report of the Committee on Committees. Adjourned by limitation of time.

Tuesday Afternoon Session—July 15, 1947

Devotional Period—Song service led by Clarence Titus with Mrs. Titus at the piano. Rev. Kenneth Hintz led in prayer. Devotions were in charge of Loring Peterson, reading from 1 Peter 5:1-7.

Roll Call showed 23 Ministers and 22 Delegates present.

Committee on Credentials—gave a partial report. Credentials of Mrs. Chester Klampe of the Appleton Charge accepted.

Committee on Religious Services and Orders of the Day—gave a partial report. Report adopted.

Courtesy Committee—Presented Rev. E. W. Hall of the Appleton Charge—Brother Hall gave his testimony. Also David Peterson was introduced to the Conference—he also gave his testimony. Moved and accepted that these brethren be given honorary seats within the bounds of Conference.

Report of Conference President—regarding the New Superannuated Ministers Pension Plan which has been adopted by the General Conference.

Letters—were read by the Secretary from absent brethren: George Nofsinger of the Ozark Mountains Home Mission Field; William Markee, Ernest Friebel and Carl Olander.

President's Report—after calling the Vice-President to the Chair, Rev. G. M. Hahn gave his President's Report which was adopted.

Courtesy Committee—presented Sister Hall—she gave her testimony and was voted an honorary seat within bounds of Conference.

Adjourned—for committee work to the call of the Chair. Adjourned by limitation of time.

Wednesday Morning Session. July 16, 1947

Devotional Period—Song service in charge of Clarence Titus, devotion in charge of Edward Clark; reading from Acts 7:54-60.

Roll Call showed 25 Ministers and 25 Delegates present.

Minutes of Last Session read and approved as read.

Pastors' Reports—Motion carried that pastors' reports be read before the Conference Body. The following pastors reported; likewise we heard their delegates report. Rev. J. B. Clawson of the Rice Lake Charge; Mrs. J. B. Clawson also of Rice Lake; Henry Clark, Hayward Charge; G. M. Hahn, Conference President; Mrs. Marie Hahn, Valton Charge; Kenneth Hintz, Oak Ridge Charge; E. W. Hall, Appleton Charge.

Committee on Credentials—Presented credentials of Mrs. Clara Bell of the Trippeville Charge. These were accepted.

Orders of the Day—Election of Officers. Conference President with the consent of the Conference Body asked our Connectional President, Rev. Roy S. Nicholson, to take charge of the election of officers.

Motion carried that Conference Treasurer and members of the Missionary Board be elected by ballot.

Motion carried that the Conference Roll be called for the first ballot; afterward roll call being omitted and each stood after voting until their ballots were collected.

Tellers—chosen by Conference President were Robert Fegan and Loring Peterson.

Election—By ballot the following were elected: Rev. G. M. Hahn—President for the ensuing year. Rev. Lloyd King—Vice-President. Sylvia Lee—Secretary. Mrs. Norma Mortimer—Treasurer. Missionary Board—J. B. Clawson, first member; Lloyd King, second member; I. J. Butcher, third member. G. M. Hahn, Chairman by virtue of his office. First Lay Member, Charles Bakke; second Lay Member, Norma Mortimer. Lloyd King—Ministerial Trustee. Lay Trustee, Emerson Budde.

Adjourned—by limitation of time.

Wednesday Afternoon Session July 16, 1947

Devotional Period—Song Service led by Rev. Walter Rogers. Devotions were in charge of J. B. Clawson, Rice Lake Charge. He read from John the First Chapter.

Roll Call—showed 22 Ministers and 26 Delegates present.

Minutes—of the last session read and approved.

Dr. Nicholson called to the Chair by the Conference President.

Orders of the Day—Election of officers continued.

Question of Privilege—made by Rev. Walter Rogers; asking to be permitted to read his Connectional Sunday School Report as he is leaving for four years of college at Marion, Indiana. This privilege was allowed—His report was given and accepted after hearing and adopting the report of the Auditing Committee. Also he was given the privilege of making his Pastor's report at this time. The prayers and good wishes of the Conference go with Brother Rogers and his family as they make this decisive step preparing to become more useful in the work of the Master.

Orders of Day—Continued Election of Officers. Election of the following: Rev. Lloyd King was elected representative on the local Board of Managers for Miltonvale Wesleyan College. By vote—Kenneth Hintz elected Assistant Secretary. By vote Robert Thrasher elected Conference Sunday School Secretary and first member of the Sunday School Board. Harry Johnson, second member; Clarence Titus, third member of the Sunday School Board.

Tithing Secretary—Clarence Mason.

Educational Secretary—Sylvia Lee.

Prayer Band Secretary—Robert Fegan.

President's Advisory Board—Rev. Clarence Mason and John Lang.

By vote G. M. Hahn succeeds himself on the Judiciary Committee for a term of four years.

By vote Coral Butcher succeeds herself on the Itinerary and Orders Committee for four years.

By vote Kenneth Hintz elected to Conference Camp Meeting Board for four years.

By vote Charles Bakke was elected to the Northern Camp Board for a term of 4 years. The Committee on Vacancies had chosen Rev. J. B. Clawson to replace Robert Thrasher for a term of 2 years and Bertha

Gourd to replace I. J. Butcher for 1 year on this same board. These brethren were elected as officers at the Hayward Camp in June.

Conference President appointed two lay members on the Committee of Itineracy and Elders Orders: Mrs. Joe Piehl, and Mrs. Myrna Bakke.

By vot the Committee on Vacancies: I. J. Butcher, Chairman; Harry Johnson, Clarence Mason, Chester Finley, Mack Budde.

By vote the Superannuated Ministers Board to succeed itself as a whole.

Thursday Morning Session. July 17, 1947

Devotional Period—Session opened with song service led by Rev. Clarence Mason, pastor of the Superior Charge. Sister E. W. Hall of the Appleton Charge had the devotions: reading from Ephesians 6 beginning with the tenth verse; exhorting us to "Put on the whole armour of God."

COMMITTEE ON RESOLUTIONS

We, the Committee on Resolutions, submit the following report. Resolved that:

1. All Church and Conference Treasurers close their books June 30.
2. We set aside the last Thursday of each month as a day of fasting and prayer for a Conference-wide revival; for our men and women in service; for our war torn world; and for our missions and missionaries by

name; and that this date be placed on the Conference calendar, and that each pastor be responsible for reminding his church of same.

3. Each pastor, evangelist, Conference President, and any minister belonging to the Wisconsin Conference and receiving a remuneration for gospel work, remit 1% of the same for the Superannuated Ministers' Fund: This resolution being subject to the action of the Conference in regard to the General Conference Plan.

4. The Missionary Board shall hold a business meeting during Conference and on the first Tuesday of October, January, and April. Any business for consideration should be in the hands of the Missionary Board Chairman two weeks before the date of the meeting, and that any other business should be transacted at the call of the Chairman.

5. The pastor's statistical reports be posted on a bulletin board at our next Annual Conference sessions, thus omitting the oral reading of the same before the Conference body.

6. Each Sunday school endeavor to conduct a Daily Vacation Bible School during the Conference year.

7. Each church permit it's pastor the privilege of taking a two weeks' vacation with pay, to be absent on vacation only over one Sunday.

8. Each church be urged to put forth at least two revival campaigns during the Conference year.

9. The election of Conference officers to be held the first Wednesday morning of Conference at 10:00 o'clock.

10. A fellowship gathering be held in each of the districts during the Conference year, in January or February, if possible, that this gathering be for our own ministers and laymen, and apart from the already organized Holiness Conventions. The purpose of this gathering is to give inspiration and help, both to the ministry and laity and to promote a spirit of unity; and that the Conference President and his advisory board be responsible for arranging these meetings.

11. That each charge, if able to do so, pay moving expense of incoming pastor.

12. Because of the benefits he receives socially, mentally, and spiritually, we feel that every pastor owes it to himself and to his church to attend every institute. Therefore, we resolve that every pastor attend each institute and convention sponsored by the Conference.

13. That each pastor compile a well-bound book of church records; including the history, official records, annual statistical reports and including dates of all suborganizations as near as possible; and that each pastor bring same to Conference next year.

14. Each pastor subscribe to all the Church periodicals.

15. No church secure evangelistic help other than Wesleyan Methodist without the consent of the Conference President and his Advisory Board.

16. Our people refrain from any unnecessary work on the Sabbath.
17. Each church pay their budget quarterly.
18. Every minister be required to pay his budget to the church in which he holds his membership.

7. That each Reporter send to the Editor the number of copies needed by the local Society including those needed for students, servicemen, etc.
8. That the number of pages of the "Outlook" not be limited.

We have endeavored to give our best to the Lord in the work of the W. Y. P. S. this past Conference year. REPORT OF THE EXECUTIVE COMMITTEE

8. As an organization we recommend that the W. Y. P. S. be responsible for finding and holding at least one revival meeting in a pioneer field in cooperation with the Missionary Board.
9. We recommend that we set the goal of at least one new society and that the Conference President would act as organizer.
10. We recommend that each society add a minimum of four members to their roll during the Conference year.
11. The Conference W. Y. P. S. President, or a representative visit each society in interest of the local and connectional work of the W. Y. P. S.

12. The Annual Conference Convention shall be composed of the officers of the Conference W. Y. P. S., the District Chairmen, presidents of local societies, the President of the Annual Conference, and two elected delegates from the active membership of each local society in the Conference. When the active membership in any local society exceeds twenty-five there may be one additional delegate elected. Local societies with two or more age departments, will, as far as possible, choose delegates from each department.

13. That the Young Peoples' Conference be held during the Annual Conference.

14. That our societies be radiating centers of Christian character and the beauty of holiness.
