The Canada Annual Conference of the Wesleyan Methodist Connection (or Church) of America in Canada convened for its forty-eighth annual session in the Wesleyan Methodist Church, Winchester, Ontario, Wednesday, April 25th, 1945 at 8:45 P.M.

A wonderful picture was given of David's fine spirit under the pressure upon him. The figure of the text is, every Christian has a pack of hounds on his trail, ministers especially.

He said a deer can turn on a dog but the real refuge of the deer is

flight or safety in the water or lake.

David did not fight with his circumstances but encouraged himself in the Lord and that's what we will have to do when hard pressed by the enemy.

Religious Services

Rev. S. W. Blanchard, our Conference President, preached the opening sermon of Conference, Tuesday evening, April 24th, from 1 Tim. 3:15. His Topic was, "The Church of the Living God." He stressed the following:

The Church of God is a live Church. It is a Life-giving Church. A church that has the nature and characteristics of Christ. A Church that produces the fruits of the Spirit in abundance. The Church of Christ is a unit and a burden-bearing church.

Wednesday, April 25th, 7:30 p.m. The message was delivered by the Rev. J. R. Swauger, Our Connectionel Representative, from 2 Chron. 7:14. His topic was, "God's Formula for Revival." He stated, if you want a revival here is the formula. Emphasize was placed on the fact God is speaking and the miracle working Jehovah of the Old Testa-

ment is the miracle working Jesus of the New Testament. Four things we must do to have revival were portrayed clearly. We must humble ourselves, pray, seek the face of God and turn from our wicked ways. New light and help was received from this able presentation of the truth.

Thursday, April 26th, 7:30 p.m. The sermon was preached by the Rev. J. R. Swauger from Psalm 37:1. The words stressed were, "Fret Not." The message was heart-searching and he outlined it as follows: Fret not because of what God does or allows. Fret not because of what the preacher does. Fret not because of what your neighbours do.

Friday, April 27th, 7:30 p.m. This was a Missionary service under the auspices of the W.H. and F.M.S.

Saturday, April 28th, 7:30 p.m. The Saturday afternoon and evening services were under the auspices of the W.Y.P.S.

Sunday morning, April 20th, 10:30 a.m. The Sabbath morning service was an Ordination Service. There was great interest in the service at which C. B. Mills and M. E. Summers were ordained after the impressive and solemn manner of our Discipline. The Ordination Sermon was preached by our Connectional Representative, the Rev. J. R. Swauger from Matt. 5:13. The message was unusual in enlightenment and its masterly presentation will not soon be forgotten.

Sunday afternoon, April 29th, 2 p.m. This was a missionary meeting under the auspices of the W.H. and F.M.S.

Sunday evening April 29th, 7:30 p.m. Rev. E. W. Tokley brought the message from Luke 13:7. He used the following outline: God's desire. God's disappopintment. God's decision. The message was very effective and a number came forward for prayer.

We thank God for His presence and help throughout the entire Conference Session and we go forward in that great hope that He will be

with us unto the end.

NO. 1. PRESIDENT'S REPORT

April 24th, 1945.

Members of the Canada Annual Conference

Now in session, Brethren and Sisters in Christ,—

The good providence of God has spared us to come together again in a session of our Annual Conference. Down through the years of prosperity and through years of depression, through years of peace, and years of war, through sunshine and rain, the hand of our God has safely led us to this present hour. With gratitude and praise we acknowledge the goodness of the Lord in preventing the grim reaper invading the ranks of our ministry. Some of our good laity have gone to the better land and their labors are ended. We need new recruits to fill these gaps. Recruits upon whom may fall the mantles of those who have stood by the old land marks and were fathers and mothers in Israel.

We are here to make plans and seek the mind of the Lord for the carrying on of the work of our beloved Zion. Together with and beyond the regular routine conference business, however, this should be a time of great spiritual refreshing, a veritable Pentecost. And if in this we are not disappointed, we shall witness a real epoch in the history of our conference and mark the beginning of a great forward movement.

This is a day of formality and deadness on the one hand and on the other a day of big programs in which the emphasis is on streamline advertising, entertaining and musical services, with a premium on display of eloquence and ability. God says a form of godliness but denying the power thereof, from such turn away. And what shall we do? Shall we settle down into a sterotyped form or shall we lean in the direction of the so-called modern approach to religion with its ragtime swing; or shall we adhere to the line of primitive, sound, scriptural teaching of Bible truths and experiences of grace consistent with the teaching of the Word of God? May God grant we shall pursue the latter course.

This has in many respects been a good year. Never in the history of our conference, have we paid as much on our properties. Four mortgages have been burned. Also a new property was purchased at Hallville and dedicated free of any encumbrances. Sites for two new church buildings have been purchased, the deeds of which we hold, clear of any indebtedness. Opportunities are challenging us on every side and a growing conference is ours if we venture in His name.

Immediately following the last session of our Conference our Incorporation bill granting us a charter was passed by the Dominion Government. A certified copy of this bill was placed with the Record Clerk and is kept with other valuable documents in a safety box, available when required.

Official Acts

May 11th—Went to Belleville with the Board on Church and Parsonage Building and Location to select a suitable site for a church.

May 23rd—Appeared before the Private Bills Committee of the House of Commons in connection with our Incorporation Act, which after their asking various questions, they passed unanimously.

May 31st—Went to North Bay in connection with the purchase of a lot upon which we purpose building a church.

June 18th—Attended the opening of the Hallville church and dedicated the same.

July 31st—Conferred with lawyers re legal titles for our properties under our Incorporation Act.

September 3rd—Attended the Canadian Holiness Federation Convention in Toronto as a delegated representative of our denomiation.

September 10th—Conducted induction services of Rev. M. E. Sum-

mers as pastor of the Inkerman charge.

September 16th—Held a meeting of the Conference Board of Trustees in Ottawa relative to the matter of proceeding with plans to build a basement church in North Bay.

September 15th—held a Ministerial Institute in Ottawa to which we invited ministers of sister holiness denominations. This proved a time

of blessing and fellowship worthy of repetition.

September 18th-In connection with our Anniversary services we

burned the mortgage on the Ottawa Church and rededicated it free of indebtedness.

October 8th—Attended the Anniversary Services of the Newington Church at which we burned the mortgage and redediated this church free of debt.

November 2nd—Went to Belleville with the Board on Church & Parsonage Building and Location to reconsider the matter of a church site. A site was purchased consisting of two lots in what was considered by the Board, a good location.

January 18th-Placed Kemptville church under the care of Rev. M. E. Summers.

February 13th—Called all Conference Elders and Preachers to a council meeting in Ottawa to consult with them relative to plans specifications and procedure in building basement churches at North Bay and Belleville. Also to consider our Home Mission work and recommendations in connection with this important arm of our work. (See Report of this meeting).

The following morning was spent in prayer and praise and was an unusual time of blessing and inspiration.

March 14th—Attended a business meeting of the Toronto Church relative to the calling of a pastor.

March 16th—Appointed Rev. D. W. Summers, Rev. J. S. A. Spearman and W. H. Wilson as a nominating committee on Temporary Organization.

March 16th—Had an interview with Mr. McKenzie, Dominion Building Controller, regarding building restrictions on churches, etc.

March 17th—Went to Belleville for week-end services and consulting contractors relative to tenders of a church building.

April 4th—Went to North Bay and Powassan in connection with changes of pastors at these places and consulted a contractor in North Bay re a tender on a church building.

April 7th-Went to Toronto for the burning of the mortgage and dedication of our church there.

April 22nd—Went to Inkerman for the burning of the mortgage and dedication of our church at this place.

Recommendations

- 1. We recommend that the recommendations made to and adopted by the Preachers meeting in Ottawa be given careful consideration.
- 2. We recommend that a Ministerial Institute be arranged again to meet this fall at a convenient date for all concerned.
- 3. We recommend that an exchange of pulpits among our pastors be arranged at frequent intervals.
- 4. We recommend that an appropriation be included in the budget to provide for travelling expenses of the President with which he will be enabled to visit the weaker charges more frequently; thus encouraging the pastor and people without a financial burden for such visits.

Report of Sunday School Secretary

It is with a sense of grateful praise to the Triune God that we report a constantly increasing interest in the Sunday Schools of our Conference. I believe that our pastors, departmental Sunday School Superintendents and officers are beginning to realize as never before

the importance of the Sunday School. There is no branch of our Church activities that is more deserving of the earnest heartfelt interest of every pastor and Christian worker than the Sunday School. When we consider that this one institution furnishes 82% of the Church people of the nation and 97% of its ministry, and that thirty-seven and a half millions of followers and two and a half million teachers are enrolled therein, you will agree with me, I am sure, that we cannot overemphasize the importance of the Sunday School as well as the inestimable value of Sunday School work. To keep pace in the moral and religious life with the progress of material advancement will necessitate the united efforts of pastor and Sunday School Superintendents, Officers and Teachers, yea, every member of both Church and Sunday School. With a combined all-out effort, we can, and will, put our Canadian Wesleyan Methodist Sunday Schools on the map for time and eternity.

Throughout the year we have sought to keep promotional literature and suggestive circular letters in the hands of all our Superintendents. We have also kept each superintendent supplied with Sunday School

At both Ottawa and Winchester a Class was organized to pursue

August 18, 19, 20, we held a joint Sunday School and Young People's Convention at Winchester. This Convention was indeed an incentive

Conference Members, Canada Annual Conference, Dear Fellow-ministers,—

We are now met together as ministers of our beloved Zion, for the purpose of studying, among other things, our Home Mission program. The importance of Home Missions, Versus Foreign Missions has frequently formed the topic of interesting and instructive debates. No one will question the importance of Foreign Missions, and yet the most casual observer can readily see that without Home Missions, we could not support Foreign Missions. We are hopeful that this study of our Home Mission problems will increase our appreciation of our conference

becoming more Home Missionary minded.

A survey of our conference will show the financial status of our churches as being very encouraging. Most of our properties are clear of any indebtedness and the balance will be greatly reduced this year. Our laity, for which we should be thankful, are loyal and faithful to their responsibility. Nevertheless as we take a retrospective view of the growth of the church, we are convinced that it has been indeed rather slow. This spring we hold our 48th Annual session of Conference Forty eight years and only 11 charges with 15 churches. We should have ten times that many. We do not state this to spread gloom or create an atmosphere of pessimism, but merely to emphasize the need of definite concentrated action. Merely to drift from year to year; from conference session to conference session, with no definite goal in view, is not characteristic of an aggressive church. We believe we have a good church, second to none; orthodox in doctrine; and spiritual. Our church polity is practical and workable. The name of our church is self explanatory, speaking of that for which we stand and we are proud of our name. Then why not move out and on, extending our borders and planting our flag in new fields.

Merely as suggestive aids to our discussion of this vital arm of

our work we humbly offer the following recommendations,-

1. We recommend that at the earliest possible date, we put the conference president into the field with a view to being a greater help to the weaker fields, opening new fields and a more efficient oversight of the work in general.

2. We recommend that we set a time limit on all mission charges receiving financial aid from the Home Mission Fund. And that after the expiration of the time limit, if the charge is still not self-supporting, a careful and rigid survey be made in an effort to ascertain why and if possible remedy or correct the defect.

3. We recommend that we consider the opening of at least one

new field each year for the next five years.

4. We recommend that a vigorous Home Mission Campaign be made and the matter kept continually before our people. If possible a group of singers together with a speaker travel the conference in the interests of Home Missions.

5. We recommend that we study maps and select prospective towns or cities in which we might open work, such places to be further investigated and a complete report by

investigated and a complete report be made to conference.
