## Doc. No. 1. - Report on "State of the Country."

As a Conference of christian [sic] men and ministers, and on behalf of the Churches we represent, we are happy to embrace the opportunity to profess anew our belief in a God of Providence, and in his overruling hand in the present condition of our beloved country.

Passing through, as we are, Nationally, a great *moral* and *political* Revolution – one destined to change, radically, our current opinions and

usages, as also our states among other people – we submit that it is no time for hesitation, equivocation or doubtful loyalty, either to the Truth of God or the "powers that be" over us.

We, are for God and our country, and this without evasion, condition or exception. Hence, the "limping patriotism" which here and there crops out, and says "we are for the Union as it was and the Constitution as it is "we regard as disloyalty to the living present, and an ignoring of that Providential progress which has changed the type of our National life.

We, are for our country "as it is" struggling with traitors North as well as South - "as it is" in its purpose to subdue Rebellion—"as it is" in its policy to confiscate the property of Rebels—"as it is" in its aim to transform bondmen into freedmen-"as it is" in its labors, by force of arms, to vindicate its right to Unity, its right under the Constitution to elect Abraham Lincoln, President—its right to have him respected as such from Maine to Georgia, from the Atlantic to the Pacific—its right to realize a National condition described by the works "one People and one Destiny."

Resolved:--1. That while regretting the necessity of an appeal to arms, in behalf of the truth, here recited—yet we justify such appeal, and while offering our prayer, for the further success of our arms, we at the same time invoke the blessings of a God of grace upon the imperilled [sic] soldier, his family, and those who offered their loved ones to be slain in battle or to die of disease incident to the camp.

2. That we tender to President Lincoln, his Cabinet, and all in authority, acti harmoniously with him, our thanks for their honest. patriotic and Providential administration of the affairs of this Government; and we invoke for them "grace, mercy and peace," as well as future success herein commensurate with the needs of our early yet honorable and enduring cessation of our physical strife.

3. That we congratulate ourselves, and hitherto oppressed among us, and the friends of freedom everywhere – that however much the cost, the sacrifices, and the inconvenience attending this second Revolution now in progress among us -- the end thereof is certain to

restore our Government to the Faith of the Father, one whose purpose was to "form a more perfect Union, establish justice, insure domestic tranquility, provide for the common defense, and secure the blessings of liberty to ourselves and our posterity."

4. That it is a matter of special congratulation to us, as a denomination, that in all our churches fidelity to Truth, to Freedom, and to Government, is not only the rule, but o this rule there can be disciplinarily, no exception. And if any poor "copperhead," in religion or politics, has so far forgot his affinities as to stray toward us, we admonish him to "take up his bed and walk" from us, and thus save us the necessity of further imposition, and of disciplinary measures for his removal.

5. That while, in the language of another, other denominations are obliged to look upon the spectacle of "brother going to war with brother—Methodist with Methodist, Baptist with Baptist, Presbyterian with Presbyterian, &c.,--we are saved such fratricidal phenomena, for Wesleyans are, as they ever have been, every where, [sic] a unit in their

loyalty, and only for the Union, as against rebels for the sake of Slavery.

God is not sitting, as some suppose, in majestic quietude, unobservant, and indifferent to what is passing among men, but is everywhere present, and his power all controlling.

In all the throes and convulsions of kingdoms and nations, He sits at the helm of human affairs, and renders all subservient to his purposes. The world and its glories may pass away, but the Word of the Lord abideth forever.

The whole word seems to be opening and loudly calling for the gospel. "Universal man," says a late distinguished writer, "is gasping for the word of life." "The field," says Christ, "is the world." – and the world is now our field—Those portions of it hitherto inaccessible are rapidly opening; and the period has already arrived, when the word of God may be circulated in India, China, the isles of the sea, France, Germany, Prussia, and even in Rome itself. In all these places, and in many others, the living missionary may carry the bread of life to the starving multitudes.

In our own country the sphere of missionary labor is almost without limits.— Besides hundreds of thousands of foreign emigrants scattered over the national domain, there are also tens of thousands of our own population, who, up to the present time have not been brought to Christ, and who may never come to him unless the commission to "go into all the world and preach the gospel to every creature" be carried out. We must search for the sinner, whether in city, village, or country; whether inhabiting palace or cottage.—The missionary must not give over his work, if he fail to collect them at his public place of worship, but must visit them at their houses, and even go into the streets and lanes, penetrate the high ways [sic] and hedges, in search of starving and perishing should, and bring them to the gospel feast. There is enough for all, of every nation, tongue and people.

Although more than eighteen hundred years have passed since the glorious Missionary College was organized at Jerusalem, by Him who said, "this gospel of the kingdom shall be

preached in all the world," yet there are thousands of our fellow men in the world, and around us, and even in our midst, who are destitute of salvation. Can the church remain indifferent or idle, innocently? Can the ministry sit at ease when the purchase of the blood of Christ is in the way to destruction—neglecting to give warning, or pointing to the Lamb of God – and its garments not be stained with their blood? We fear not.

Already, then, the field for missionary labor is vast, and is constantly and rapidly enlarging. Only a few years ago and the heathen world was almost inaccessible to christian [sic] instrumentality. Now, there is scarcely a nation, country or tribe, in which we may not circulate the Holy Scriptures, and where the missionary of the Cross may not plant the standard of salvation and proclaim the unsearchable riches of Christ to a "perishing world." The revolutions and changes, both in the Old World and in the New, have been of the most astounding character. Stirring events have succeeded each other, during the few years last past, with such suddenness and rapidity, that they have almost ceased to be startling. In all this "speaking of the nations," we must not overlook the invisible Lord, nor assign to second causes what is evidently both extraordinary and Divine.

And now, in commencing a new missionary year, and in full view of the overwhelming magnitude of the work before us, and our obligation to prosecute it with renewed vigor, let us continue to labor on with increased fidelity. Trusting alone in Him who has said, "Lo, I am with you alway," [sic] let us inscribe on our banner, "Christ for the world, and the world for Christ."

Your committee recommend the organization of a Conference Missionary Society, so that we as a body may be

better able to interest and call for men and means to compass the glorious result contemplated by the origin of our Connection, viz., "to spread scriptural holiness over these lands." And, in order to make practical these views, we recommend the following Constitution for our government as a Conference.

ART 1. This Society shall be called the *Rochester Conference Missionary Society*, auxiliary to the Missionary Society of the Wesleyan Methodist Connection of America.
