Report No. 1.. On Reforms

Reforms to be enduring must originate in our moral convictions and be founded upon the express precepts of the Word of God or be clearly implied in its teachings. In this age of experiments we have see the rise and fall of what have pretended to be reforms; but originating in mistaken apprehensions and having for their end personal aims they have lived hardly long enough to secure a historic record And this will always be the result of experiments not founded upon the plain teaching of the Word of God..

The Church of the Lord Jesus Christ is the house of God the pillar and ground of the truth. And in this Church are all the elements of instruction and reformation. If remedial influences can favorably affect any class in community these are to be found within the Church of the Redeemer.. There may be outside influences that do good are of great advantage and should be fostered and encouraged. But still we are satisfied, that all those influences outside of the Church, if in all cases not

borrowed from the Church, are not to be found in this pale and might be used by her members as efficiently, if not more so in connection with her than as an outside measure.

The virtues of Freedom Temperance Benevolence and mutual assistance, are not in the Church if they are in the world. They may not be made as active and prominent at all times as they should be, but it is a fact that the truly represented Church of Christ contains in her resources all the agencies for promoting human reformation, that exist in the world. And these agencies can be as well used in connection with the church as anywhere else to say the least. And we think in nearly all cases they can be used here much better, because they stand associated with a class of influences that give to them greater moral force.

For instances; -- A man wishes to become a consistent temperance man: And in order to this he comes into the Church. He not only enjoys all the help here that he could elsewhere but he finds himself surrounded by a whole class of influences that must greatly strengthen this particular purpose of his mind. Here is the Word of God; the Gospel preached: Prayer – Christian ordinances and associations; -- weapons of strength that cannot be found anywhere else. How often are these plain facts overlooked, ignored or forgotten, amid the pomp and show of banners regalia and music. Almost equal to that in the plain of Susa when all but a few Jews surrendered themselves to that worship which was degrading and which left the heart unchanged and unsubdued—

There may be cases where we may go outside the church carrying our religious agency with us for the purpose of temporarily aiding others – crying to those in the willderness [sic]; -- But for ourselves and also for others to render reforms deep, abiding and Godapproved, there is not relation, no association and no agency that can be equal to those in the Ch. Of the Lord Jesus Christ. If men cannot be reformed by these they cannot be reformed at all. And taking the mildest view we can – to go into organizations made up of worldly men, to effect reforms, when the Truth of God is the greater instrument ordained for this end, is leaving the stronger help and going to the weaker; a course that an scarcely fail to be met with disappointment. For if we <u>cannot succed</u> [sic] by the <u>stronger</u> means, how <u>slender</u> is our hope of success when we rely upon the <u>weaker</u>.

Now if these views be sound & we think there will scarcely remain a doubt of their soundness we are conducted to a practical conclusion: viz – what to rely upon organizations outside of the Church to promote anti-slavery sentiments, temperance habits, -- offices of benevolence and mutual aid is to make our dependence upon the weaker & less promising instrumentalities to promote our aims, which we might just as well and in many instances much better employ those more mighty and divine – we submit if this is good policy; if it is right –

But should it be objected that some Churches will not favor Anti-Slavery, Temperance, Mutual Assistance &c therefore there is a justifica-

-tion in uniting with these outside organizations such as Anti-Slavery Unions, and Secret Societies of the various kinds we have only to say: -- Let all such Churches be abandoned if they cannot be reformed and new ones created, that will represent the true Christian sentiment upon these as well as kindred themes..

The non-use, or even abuse of talents is no reason why they should not be brought into use Let them be taken from the unfaithful and placed where they will be fulfilling their appreciated mission: If this course be not adopted, a course for which we can plead the living example and sanction, we impliedly say, there these human outside agencies, are more to be relied upon than our Heaven-revealed & Christ-sanctioned

Christianity, which is the <u>power of God</u>. Shall we make the impression? Ought we to do it – Dare we?

We recommend for adoption as the sence [sic] of this Body, the following resolutions: --

- 1 Resolved, That as Godliness is profitable unto all things, therefore we will take it as our great instrument of power to reform ourselves and others.. being assured that if we fail in its use, we certainly cannot succeed in the employment of means less efficient and Divine.
- <u>2</u> That as the Word of God teaches that enslaving an innocent human being is the crime of man-stealing, which God ordained should be purchased with death, -- That we are to be temperate in all things living soberly, righteously & godly in this present evil world. That to do good and communicate to the necessities of the needy, so made so

distinct a duty upon us still if we see our brother have need & shut up our bowels of compassion from him, we cannot have the love of God in us; -- There fore we can see no necessity for Christians to unite with any other organization for reformatory purposes than the Church of Christ any more than their having a plurality of Mediators between them & God when the one is all-sufficient.

3 In view of the reasons herein set forth we counsel all our brethren, to abstain from uniting with Secret Societies, or maintaining connection with them 1. Because they are unnecessary; 2. Because they are expensive; 3. Because we think all their good can be found in the society of God's people and more than can be found in them; 4. Because for Christian brethren to unite with these societies is a source of grievance and pain to a large portion of the followers of the Redeemer whom we should not make sad by any unnecessary act.

4 In view of the extent and unredeeming [sic] execrableness of slavery and Intemperance, the one blotting our every right of humanity from four millions of beings for whom Christ died, and the other training up hundreds of thousands every year, to rob, destroy & murder, imposing the great majority of taxation upon the temperate and industrious, we repledge ourselves to continued hostility to those wrongs. We intend to preach against them – pray against them – and vote against them as the incarnation and principality of the Devil whose agencies we are determined to oppose to the end.

Report No. 2. Daniel Worth

Whereas our beloved brother Daniel Worth, has been shut up in a prison in North Carolina, for the imputed offence of preaching deliverance to the captives, the essence of the mission of our blessed Redeemer when he was upon earth and selling or loaning an Anti Slavery book well adapted to administer a timely warning to those who are upholding the system of American Slavery. Therefore; --

- 1 Resolved. That, as a Conference we are not ashamed of our Bro. in bonds and will not cease to join our hearts sympathies [sic] with his, in this the day of his trial.
- 2 Resolved. That the Secretary of this Conference be instructed to write a letter of condolence to our imprisoned brother Worth, assuring him that we weep with him pray for him & rejoice with him in all his consolation, and shall not fail to do all we can to bear with him his burdens & so fulfill the law of Christ.

Report No. 3.. Book Concern

Whereas, believing as we do that the circulation of our books and periodicals is an essential element of our success – and being conscious of the paramount importance of extending the interests of Messiah's kingdom through the circulation of a pure and wholesome literature, -- we therefore recommend for the adoption of the Conf. the following resolution, namely..

Resolved That the course pursued by our able & efficient Editor and Agent (the Rev. C. Prin-

dle) in the management of the Book Concern and more particularly in his talented and able editorial management, of the Wesleyan, meets with our cordial and hearty approval and that our excellent Editor may see and feel that has not only our sympathy but our efficient cöoperation [sic], we hereby pledge ourselves to use every legitimate means within our power to extend its circulation believing that we shall thereby not only aid our Connection Funds; but confer also a permanent blessing upon community.

Report No. 4.. Case of Bro. High

The Committe [sic] in the case of Bro. E.M. High committed to them for decission [sic] on charges and specifications, presented by N.P. Weard accompanied with a mass of testimony carefully prepared and arranged, have given their prayerful consideration to this whole subject and unanimously decide as follows Viz.—

1st That this case having run through the lapse of several years, and as it appears from the evidence became one of great interest to the community and as is generally the case in similar instances, become one in which feeling has controlled, the testimony of different individuals equally entitled to credibility, when refering [sic] to the same incident, widely diverge = so that it is nearly or quite impossible to determine the exact state of some of the facts as they occurred, we thin, the witnesses themselves could hardly be trusted

to settle these points: after being under the influence of the long and wide spread [sic] excitement which has prevailed; going as it must have done to mould [sic] and fix their sentiments as well as that of the community; This is one of the infirmities of human nature in all similar cases.

2nd It seems to the Committee that other influences outside of those contained in the express charges and specifications have largely interwoven themselves into this case rendering it the more complex and difficult to understand and decide and upon this ground they an find reasons for the variations and discrepancies in a large part of the testimony which has been brought before them.

3rd The Com think there was not such an agreement for the house from L. Humphrey, on the part of Bro. E. M. High, as to constitute a legal claim for the collection of the rent and in this respect think the decission [sic] of the court such as it should have been under the circumstances; Nevertheless, we think there was a reasonable expectation created, on the part of the owners of the house that Bro. High would occupy it as his home evinced, by the manner in which he talked to them about it, and the fact that they put workmen to repairing & refitting it a work to which they were evidently prompted by the expectation of its occupancy by Bro. High.

But the evidence before the does not justify the belief in the minds of your Com that Bro High intentionally committed a wrong in not occupy said house finally but we think it was unfortunate in him to

for the peace of all concerned that he did not go himself to the parties owning the house when he had determined to lease another, and frankly and distinctly stated to them the facts and reasons as they existed, determining him in his final purpose. We believe such a course would have settled this matter at the time and saved all this amount of feeling & discord growing out of the affair.

4th In relation to the other matters contained in the bill of charges and specifications as they mainly grow out of the house difficulty, such is the character of the testimony, that the Com are not able to see that any thing [sic] is settled criminating bro High and we are therefore compelled to dismiss them.

And in conclusion the Committe [sic] would say to all concerned in this affair that they are not able to see from the evidence before them that there exist causes of sufficiently grave importance to create disruption of feeling among them on such estrangement from each other, as has evidently been cherished. And as mediators between all parties having no personal feelings but those of good will to all we give it as our most deliberate judgement, that all parties should under enlightened, and Bible views & purposes, go to the very verge of possibilities on confessing their faults, and indiscressions [sic] and seeking in all possible ways to restore [insert: peace] & confidence in the community which has been so long torn by these troubles. And we believe those will exhibit the more

Christlike tempers and spirit, who are first to move in this direction. And we shall add our prayers that such may be the final conclusion of these troubles which we are sure all parties will welcome as a relief to their own feelings.

ing circumstances. He was ordained by the Champlain Conf^c at Ferrisburgh Vt. May 8th 1853. Was transfered [sic] to the Syracuse Conf^c in May 1857.. But did not receive his transfer. The Act of Transfer was published in the Minutes of said Conf and was before us.

He recieved [sic] a Certificate of Christian & Ministerial standing from the Orleans Charge Dec. 1858. In March 1860, he recieved [sic] a second Cert from said Church signed. John Simpson In April 1860 a letter was addressed to this Body, testifying to his reputation and acceptable labours [sic] among them, and stating also the consummation of arrangements between them and him for the next year.

The Comee deem it best to present these facts before you and forbear the responsibility of assuming to direct this Body by any recommendation they might suggest but would prefer leaving the entire disposition of the case with the Conference Roger Spicer

We do not recognize this case as coming within the jurisdiction of the Conference

Your Com^{ee} ask the indulgence of the Conf^{ee} and their attention to a suggestion it wishes to make as a future Basis of Ministerial Qualifications in this Body, applicable to persons seeking admission therein.

The inconvenience of our present system or rather want of systems in relation to the Annual examination of candidates for Elders Orders

and Licentiates has been painfully evident. Your Com^{ee} feel that not only have they been subject to extreme and unnecessary embarrassment in this important department of Conf duties, but it must ever continue and increase so long as our present course is perpetuated.

Your Comee would further express the conviction that the intelligence of the age demands a higher order of Pulpit power. And imposes upon us as a Body the necessity of increasing the Intellectual merit of our Pulpit Ministrations.

Therefore Resolved.

That a committee of 3 be appointed by this Body, whose duty it shall be to take this matter into the most mature consideration and their judgement may be deemed most effeciant [sic], Which course shall be published in the "Wes." And entered upon the journal of this Conf – subject always to such improvements as may be suggested by the wisdom & necessity of a tried Experience.
