The Alabama Annual Conference of the Wesleyan Methodist Church convened for its thirty-seventh annual session at Camp Eden, Ala., August 27, 1946 at 7:30 P.M., at which hour Rev. J. A. Treese brought the Conference sermon. The first business meeting was called to order by the President Rev. E. L. Shigley at 10:00 A.M. Wednesday, August 28th. Devotionals were conducted by the President, after which the body was called to order for business. The President then invited Rev. J. R. Swauger, Home Missionary Secretary to the chair to preside as chairman of the session.

The roll of Elders was called with quorum present.

The Conference Bar was fixed to include the platform and five seats in front of the auditorium.

The Committee on Nominations made a partial report, which was adopted.

The Committee on Credentials read a partial report and twenty-two lay delegates were seated in the body.

Finn M. Crowe and D. M. Downey read annual reports.

A motion prevailed to take from the table a motion to fix the time and place of the next regular annual session of conference. It was moved and supported to refer the matter to a special committee to composed of the Camp Meeting Committee and three members from this body. O. B. Shows, M. A. Medders and J. L. Davis were elected to complete the committee.

On motion recessed to the call of the chair.

The report of the Missionary Board was brought before the body. After a short discussion it was moved to defer action on it until after the arrival of the Pastoral Relations committee.

A report from the Montgomery church was read by the secretary.

A motion prevailed that the Conference Reporter be continued for another year as a conference paper. C. R. Tegen was elected as Editor and N. C. Hoggle as Business Manager for the paper during the next Conference year.

J. A. Treese and J. L. Davis read their annual reports.

The report of the Missionary Board was brought before the body for further consideration. A motion was offered to strike the third paragraph from the report. A motion prevailed calling for the previous question. Item three was by vote stricken from the report. A motion to strike item four from the report also was adopted. A motion then was offered and prevailed to refer the report back to the committee.

A resolution petitioning the General Conference to change the name of the Church to read Wesleyan Methodist Church of America. A motion prevailed approving the resolution.

A report from the Sylacauga church was read by D. M. Downey.

The Committee on Statistics reported. Reports adopted.

The Auditing Committee reported. Report adopted.

By motion and vote the Secretary was authorized to edit and have printed five hundred copies of the minutes of this session for distribution.

The Missionary Board read its final report and recommendations which were adopted as read.

The Committee on Finance reported. Report adopted.

A motion prevailed asking that the number and time of holding the quarterly meetings of the year be at the discretion of the President, the schedule to be published in the Conference Reporter as early as possible and in so far as he is able to do so.

A motion was offered and carried to strike out the item of discretion in the next aforesaid motion and instruct the President to hold at least three quarterly meetings at each church or on each charge.

Committee on Pastoral Relations gave its last reading which was adopted as read.

A motion prevailed referring any business matter overlooked or unfinished be left in the hands of the President and his Advisory Board.

A motion prevailed to discharge the special committee created to fix the time and place of the next conference session.

A motion was offered and carried to fix the time and place of the next annual conference session, August 13, 1947, Wednesday following the second Sunday in August, continue in session as long as may be necessary. The Camp Meeting to begin on Friday night following the above date and continue through two Sundays, closing the evening of the second Sunday.

A motion was offered asking that the item of Camp Meeting in the next above paragraph and fix the time of the conference session date as 10:00 A.M., August 26, 1947. The motion was lost for lack of support.

A memorial was presented and adopted petitioning the General Conference to add this memorial as sub-paragraph 3 to paragraph 51 of the Book of Discipline.

A motion prevailed authorizing the payment of \$30.00 each to Rev. E. L. Shigley and Rev. J. A. Treese for their services in connection with the conference.

A motion prevailed authorizing the Conference Treasurer to pay the expenses of the secretary in the preparation and printing of the conference minutes.

A motion prevailed endorsing the Radio Program of the Book Committee.

Minutes read and approved as read.

On motion adjourned.

I entered upon my duties as President of the Conference immediately after my assignment to that work.

I have held or arranged for the four quarterly conferences of the year on the various charges, have conducted two revival meetings, have supplied a number of services in absence of pastor for several churches, and have endeavored to give general supervision of the work of the conference to the best of my ability and by the help of the Lord.

My official acts of the year are as follows:

October 27, 1945 I notified C. H. Pickel of his assignment to the pastorate of the Mentone Church. He at that time declined to accept the appointment.

November 17, 1945, I appointed C. W. Crowe pastor of Mentone Church.

January 13, 1946 I received the resignation of Luther E. King as pastor of Nixon Chapel Church.

March 10, 1946 I received the resignation of W. W. Crews as pastor of the Jasper Church, then later arranged with him and the church there for him to supply the work until conference.

March 15, 1946 I appointed M. L. McDonald pastor of the Sylacauga Church.

March 31, 1946 I appointed C. W. Hodge pastor for Nixon Chapel Church.

June 10, 1946 I received the resignation of R. D. Harris, and on the same date he surrendered his license and withdrew from the conference as a minister.

On August 10, 1946 I appointed the chairmen of the various session committees, and on the same date appointed Fred T. Brazier, P. S. Spruiell and J. H. Winter as members of the nominating committee and called that to meet at 8 O'clock A.M. August 28, 1946.

REPORT OF COMMITTEE ON RESOLUTIONS

We, your Committee on Resolutions beg to submit the following report:

Resolved: That this Conference require all deeds of houses of worship and parsonages built from this time forth be made to the Alabama Annual Conference of the Wesleyan Methodist Connection (or Church) of America. All property held by said Conference is to be used by our ministry and membership according to our Book of Discipline.

Resolved: That we require the preachers and layment of said conference recognize no request for help to build any church house where deeds are not made as above required.

Resolved: That the President and his Advisory Board be made a Deed Examining Committee for the Conference, and that as soon as a deed is made, before it is recorded, it be sent to this Committee for its approval and for the insertion of such disciplinary clauses and matter that may be needed to make it safe for our Connection.

Resolved: That the Conference President shall appoint the chairman of all session committees of the Annual Conference session meeting not less than thirty days before the convening of each annual session.

Resolved: That we receive no minister or lay member from other churches until it is fully understood and known that said candidate for membership accepts our teachings as recorded in the Discipline.

Resolved: That we require all pastors moving from a church or charge to turn over to their successor a copy of the last statistical report to annual conference together with any other such records in their possession that would be helpful to the new pastor.

Resolved: That we require our pastors to make satisfactory arrangements and get permission for leave from their churches when being absent to conduct revival meetings.

Resolved: That the Treasurer shall close his books five days before each annual session of the conference.

Resolved: That the Conference President shall appoint a Nominating Committee not less than ten days before the convening of each annual conference session for the purpose of nominating additional members of the session committees. This Nominating Committee shall be composed of the Conference President as its chairman, the Conference Vice-President, one other Elder and two laymen and shall report at the first meeting of the Conference session.

Resolved: That all ministers and lay delegates to the annual Conference shall be required to pay a registration fee of \$2.00 to be for entertainment purposes.

Resolved: That we request each pastor to present his annual statistical report to the Conference Treasurer for his signature and turn this report in to the Statistical Committee not later than the first day of the Annual Conference session.

Resolved: That each pastor and his Advisory Board of the local church exercise diligence in explaining fully the doctrines and standards

of the Wesleyan Methodist Church to persons presenting themselves for church membership.

Resolved: That each pastor and class leader strive to get the head of the families of the local church to establish and conduct family altar in their home.
