STANDING RULES

- The clerk of each local society is to place the deed of the local church property in the hands of the Conference Pres., who is custodian of the deed and who is empowered to rent a safety deposit space for the preservation of deeds, and other valuable papers. The Conference shall pay for rent on space.
- The Pres. and Advisory Bd. are designated a deed examining committee. Deeds for churches, parsonages, or other Conf. property are to be submitted to them for examination before recorded, to make such property secure to the Conference.
- 3. The local church fiscal year shall end June 30th. Pastors shall report membership as of this date. All conf. treasurer's books shall be closed July 10th The pastoral year shall end with the closing of Camp Meeting.
- 4. Near the end of the fiscal year the Conference Sec. shall forward one copy of each pastor's statistical blank to the Conf. Treasurer, who after closing his books will fill in Item No. IX "Disb. for Budget," forwarding the same to each pastor. The pastor shall complete the report in full, make a second copy and be ready to read it the first day of Conf. The pastor shall forward his statistical report to the statistical comm. chairman at least 10 days prior to the convening of Conference.
- 5. Pastors are required to rpt. number of calls at time of reading their rpts.
- 6. The following items of the Pastor's statistical rpt. shall be read each year on the Conf. floor: Pastor's calls; Wes. Meth.; Wes. Miss; Wes. Youth subscriptions; present membership; gain or loss; Ave. S. S. attendance; number Church bldgs.; Value & Insurance; Item VII Complete; Total Contributed for Church; Item IX Complete; Total Benev.; and Contributed totals.
- Each local church is responsible for paying the moving expense of the pastor whom they have called.
- 8. The Conference Secretary and Conference & Conference Treasurer shall each be paid (\$10) annually from the Conference Treasury.
- 9. No Treasurer is allowed to pay out funds without proper authorization.
- 10. The Standing Rules of the Conf. are to be included in the Journal.
- 11. The Camp Meeting Board shall consist of seven members; the President of the Annual Conf., W.M.S. Pres., W.Y. Pres., and Camp Mtg. Treasurer, who will be members by virtue of their offices; and that the other members be elected from the floor after the election of Conference Officers.
- from the floor after the election of Conference Officers.

 12. The Conference W. Y. President and the Conference Treasurer, the Conference W.M.S. President will be members of the Conference Board of Church Extension and Evangelism, by virtue of their offices.
- 13. The pastor of each charge shall send to the Conference President written notice of the names of each delegate-elect from his church, said notice be sent immediately following the official election of said delegate or delegates.
- 14. All who are taking the Course of Study shall acquaint themselves with the requirements thereof, and the Conference officials and all pastors shall keep these regulations in mind in helping their young people plan this important preparation for service.
- 15. The bar of the Conference shall consist of the first four rows of seats in the tabernacle and the platform.
- 16. There shall be a Nominating Comm. whose duties shall be to present nominations for all the regular session committees of the Conference. This comm. shall consist of the Conf. Pres. as chair, and three Elders elected annually by the conf. The Conf. shall each year designate two churches whose delegates shall also be part of the comm. Said comm. shall meet prior to the opening of each annual Conf. at a time and place designated by Pres. It shall nominate session committees and may serve to nominate special committees as the Conference may request.

CONFERENCE SERMON

Rev. C. Wesley Lovin delivered the Conference Sermon to the assembly on Monday evening August 1, 1966. Taking Luke 10:29 as a text Bro. Lovin stated that this was not a time to pat each other on the back, but "to look openly into the heart and the conference." The lawyer asked, "Who is my Neighbor?" The Good Samaritan parable was his answer. The Good Samaritan "took care of the beaten man" and asked the inn keeper to "take care" of him. Rev. Lovin exhorted each minister and lay person present to "Find the Man by the side of the road," and minister to his needs.

DAILY PROCEEDINGS

August 2, 1966 - 9:00 a.m.

Rev. A. G. Yates led in singing "Lead Me To Calvary". Rev. Herman A. Smith read from I Corinthians 3:1-16. He mentioned the fact that a few people do not realize that "God gives the increase". He went on to say that there are a multitude of people who do not realize that we are "Laborers together with God". "Each of us has a place in the result of God's work. The pace is set by people. God is able to produce hastily but He is limited by our lagging and holding back." Following the devotional talk the group knelt for a season of prayer.

Rev. C. Wesley Lovin, conference president, called the 73rd Session of the Oregon Annual Conference of the Wesleyan Methodist Church of America to order. The roll was called. There were 11 ministerial and 13 lay delegates present.

A motion to seat the delegates within the bar carried.

The Nominating Committee secretary read the committee report (Rpt # 1)

Nomination for member to thanks committee was referred back to the Nominating Committee.

Brother Smith declined to serve on the pastoral relations Committee. Rev. Lorin Miller was nominated to fill the vacancy.

Motion to refer the vacancy on the Pastoral Relations Committee back to the Nominating Committee carried.

Motion to adopt the report of the Nominating Committee with the two exceptions passed.

The Religious Services Committee gave a report. (Rpt. # 2) It was adopted by majority vote.

The Conference President noted that the proposed constitution for merger between the Pilgrim Holiness Church and the Wesleyan Methodist Church would be posted at the front and right of the tabernacle for those who wished to re-read it. Also posted was a report of votes taken from various conferences on the proposed merger.

Adjourned on motion for committee work and camp clean-up.

August 3, 1966 - 9:00 a.m.

Glenn Bethune led in singing, "Nothing but the Blood". Rev. Lorin Miller spoke from Psalms 133 mentioning that the 'unity' of the brethren is both good and pleasing. Pleasing things are not always good nor are good things always pleasing but God's children in unity are blessed with both.

The Courtesy Committee introduced John Larson who gave words of witness and greeting.

On motion John Larson, supply pastor at Vancouver, was invited within the bar as a honorary member.

The Conference President, Rev. C. Wesley Lovin, gave his report. It was adopted. (Rpt. # 3)

The Conference Vice President gave a report and it was adopted. (Rpt. # 4)

The Nominating Committee gave a partial report. (Rpt. # 5) Report adopted.

The Auditing Committee gave a report (Rpt. # 6). A motion to adopt the report carried.

The Conference Treasurer's report was given. (Rpt # 7) A motion to accept the report with a standing vote of thanks carried.

Educational Secretary's report was given and received. (Rpt # 16)

Since many of the incidental expenses of the president were cared for by the General Office we are not giving a detailed financial report. The Conference Treasurer's report will give the money paid out for the president's travel.

We are thankful that the General Superintendent of our Zone, the Rev. B. H. Phaup, could visit our conference this year. It proved valuable to him to have personal contact with the pastors and their people. He gave a valuable ministry and helpful advice.

This has been a historical year for Wesleyan Methodism as was evidenced by those who were able to attend our General Conference. Some of the actions of that session will be on the agenda of this Annual Conference.

I want to express sincere appreciation to the vice-president who handled much detail on the conference level. The efficient manner in which he discharged his responsibilities meant much to me during this year.

STANDING RULES - W.Y.

- 1. The chair shall appoint the Conference session committees.
- The Conference W.Y. Treasurer shall surrender books and bank balance to the new treasurer at the close of the Conference.
- The Executive Council shall be the plan of work committee. They shall bring a projected budget and work plan to the first session of the Youth Conference.
- 4. The Conference W.Y. Treasurer shall close his books on July 10th.

- 17. Churches shall give consideration to the payment of pastor's utilities and a gasoline allowance. When these are paid they shall be reported in Item VII of the pastor's Statistical report of separate lines. When the parsonage is used for Sunday School and other church activities, the pastor and board of stewards shall agree on the proportion of the total utilities to be reckoned as used by the pastor.
- 18. The Ministerial Institute Committee be comprised of three members elected with terms of office to expire on alternating years similar to that of trustees. (Minutes 1962)
- 19. It shall be the duty of the Conference President and the Secretary to arrange for the printing of the Conference Minutes and Reports.
- 20. The publication of a Conference Paper shall be placed in the hands of a committee consisting of the Conference President and two persons elected by the Conference. This committee shall select an Editor and Publisher and arrange for the financing of said paper.

- 22. The C.C.E.&E. Committee shall be disignated as a Board of Managers.
- 23. The President and Secretary of the Annual Conference, upon proper authorization by the Conference Board of Trustees of the Oregon Annual Conference in session, shall be empowered to sign any notes, mortgages. and any instruments of acquisitions or conveyances of property of and for the Oregon Annual Conference of the Wesleyan Methodist Church of America.
- 24. All property that is held by the Conference shall be deeded to the Oregon Annual Conference of the Wesleyan Methodist Church of America, Inc. (Not to the Trustees of the Oregon Annual Conference of the Wesleyan Methodist Church of America, Inc.)
- 25. Each church shall elect its delegates to the Annual Conference at the third quarterly business meeting.
- 26. The Apportionment Committee (2 members), Comm. on Religious Services (2 members), Auditing Committee (2 Members), Statistical Committee (2 members), Resolutions Committee (2 members), be standing committees. These committees will function prior to and during the conference session following their election, whether their members are seated in the conference bar as delegates or not. When a committee member is unable to attend the session or act on his particular committee, he shall notify the Committee on Vacancies and that Committee shall designate a replacement. The standing committees shall do as much work as feasible prior to the convening of conference. The above named committees to be elected from the floor during the election of conference officers.
- 27. Recommended that unleavened bread be used in communion services.
- 28. Whereas it seems advisable for our churches and conference to provide some type of hospitalization insurance for the church's economy and the pastor's well being, we recommend that all our pastors be included in a group hospitalization program now under operation in the Kansas Conference with the Brotherhood Mutual Ins. Co. of Fort Wayne, Indiana.

 Be it further recommended that each church pay at least one-half of the pastor's premium.
- 29. The Annual Conference and Camp Meeting shall be held the fourth full week in July (See report number 15).
