### FIRST DAY.—TUESDAY.

#### Evening Meeting.

The Champlain Annual Conference, of the Wesleyan Methodist Connection of America convened for its sixty-first annual session at Hague, Warren Co., N. Y., April 22nd, A. D., 1902, at 7:30 o'clock P. M.

Called to order by the President, O. D. Putnam. Opening sermon preached by Wilbur Wagar: Text, I. Thess. 5:9.

President announced nine o'clock as the hour of morning meeting.

Adjourned by benediction.

### SECOND DAY.—WEDNESDAY.

#### Morning Meeting.

Conference called to order at 9 A. M., President O. D. Putnam conducting the devotional service.

Secretary Wilbur Wagar, made Committee on Credentials. Report on Delegates' Credentials read and adopted. Roll called.

Committee appointed on Religious Services: L. C. Partridge and E. T. Ackerman.

Bar of conference fixed at fourth tier of slips.

Voted to give place to the Incorporate Body of Champlain Conference, following Religious service this afternoon.

J. J. Davison and H. C. Shares made Committee on Statistics.

Voted that visiting members of our own or other orthodox denominations, not members of any secret society, be invited to honorary seats.

J. L. Benton, E. E. Curtis, E. D. Carpenter, A. Baker, E. T. Ackerman and Charles Armstrong made Committee on Pastoral Relations.

Time of forenoon and afternoon meetings fixed by vote as fol-

lows: Open at 9 A. M., close 11:30; open at 1 P. M. and close by vote.

E. D. Carpenter made Committee on Courtesy.

E. E. Curtis and J. L. Benton were made Committee on Memorials.

S. W. Bond, President of Houghton College was introduced. Time fixed to hear his address, Thursday P. M. after Religious service.

Time fixed for election of officers, Thursday, 10 A. M.

President reports that during interim of conference C. E. Fox applied as student for Houghton and has since gone with the understanding that the conference help him through. Only a small part of the \$60 pledged two years ago having been paid as yet, the amount should be made raised at once. Voted to take up the matter at the close of President Bond's address.

Voted that T. A. Moses be a Committee on Thanks.

E. D. Carpenter by request of President, takes the chair.

O. D. Putnam, as chairman of Committee on Itinerancy and Orders presented new regulations in examinations, which were adopted (see report by that name).

President resumes the chair.

E. D. Carpenter gives verbal explanation of Question No. 8 in Discipline.

Adjourned by limitation. Benediction by A. A. House.

#### Afternoon Meeting.

Conference convened at 1 o'clock. Religious service conducted by Wilbur Wager. Roll called. Minutes read and approved.

Place given to Incorporate body per previous vote. A new Constitution was adopted in accordance with previous notice.

Conference resumed. Voted to fix time and place of next Annual Conference following election of officers.

The following names were called and their characters passed: A. J. Allen, W. B. Atwood. Voted that C. E. Hill be a committee to investigate the case of Brother Atwood and report next session. J. L. Benton, C. E. Cahee, E. D. Carpenter, E. E. Curtis, J. T. Davi-



son, S. C. Fox, A. A. House, A. E. Moses, T. A. Moses, J. F. Wright.

Voted to adjourn. Benediction by R. Shaw.

Evening service: Preaching by C. E. Hill, followed by E. Teter.

### THIRD DAY.—THURSDAY.

#### Morning Meeting.

Conference convened at 9 o'clock. Religious service conducted by E. D. Carpenter. Roll called. Minutes read and approved.

Report of Conference Treasurer read and adopted (see report No. 1).

Order of the day called which was the election of officers. P. W. Bruce and E. E. Curtis appointed tellers.

After a succession of ballots E. D. Carpenter is declared elected President. By vote the election of E. D. Carpenter was made unanimous.

A unanimous vote of thanks was tendered our retiring President.

On ballot for Secretary Wilbur Wagar was declared elected. Vote was made unanimous.

A. J. Allen, after succession of ballots, was declared elected Treasurer.

John L. Benton, receiving the majority of votes for trustee in place of S. A. Warner whose term expires, is declared elected.

By instruction of Conference the Secretary casts the unanimous ballot of Champlain Annual Conference for P. W. Bruce for Tithing Secretary. P. W. Bruce is declared elected.

E. E. Curtis and G. H. Mattoon elected Advisory Board.

J. L. Benton, C. C. Hill, L. C. Partridge, Wallace Bissell, Charles Armstrong elected Committee on Presidency.

By vote O. D. Putnam and E. D. Carpenter change places on Committee on Pastoral Relations.

Committee on Itinerancy and Orders report. Report adopted item by item; report adopted as a whole (see report No. 3).

A. J. Allen by vote made a member of the Committee on Itinerancy and Orders.

Adjourned by limitation of time. Benediction by P. W. Bruce.

### Afternoon Meeting.

Called to order at 1 o'clock, E. D. Carpenter in chair. Religious service conducted by Editor A. T. Jennings. Roll called. Minutes read and approved.

Voted to make J. L. Benton Committee on Courtesy, in place of E. D. Carpenter, who is now our President.

The following brethren were brought forward and introduced: E. Teter, President General Conference and Missionary Secretary; A. W. Hall, Connectional Agent; A. T. Jennings, Connectional Editor; S. F. Frazier, of Rochester Conference; J. B. Launderville, of Syracuse Conference.

The order of the day called, and Prof. S. W. Bond addressed the conference. In accordance with previous vote, the raising of sufficient funds for the expense of our student to Houghton College, pledges were made to the amount of \$61.00, making in all \$75.00.

Collection taken for the Secretary's incidentals, \$6.56.

Time and place for next Conference. Invitations received from Lisbon First church and Bakers Mills. Lisbon receives the majority of votes. Lisbon is declared the place of our next annual session. Voted time to be the fourth Tuesday in April, 7:30 P. M. C. C. Hill chosen to preach the opening sermon; J. J. Davison, alternate.

J. L. Benton, L. C. Partridge, E. E. Curtis, C. E. Hill, elected Judiciary Committee.

J. L. Benton appointed committee to arrange for the publication of the minutes of this session of Conference.

Voted that some of the Connectional brethren be invited to conduct the afternoon Religious services.

Voted to hear Editor Jennings 10 A. M. Friday.

Voted to hear Agent Hall 1:30 P. M. Friday.

Voted to hear President Teter Saturday P. M. following Religious service.

Voted to give place to the Superannuated Ministers' Relief Association after Religious service Saturday A. M.

A committee was elected to bring before us the matter of Con-



ference Evangelist. C. E. Hill, H. C. Shares, J. L. Benton, G. H. Mattoon and Mrs. F. E. Wood, said committee.

Ex-President Putnam stated that S. A. Warner asked for and received a transfer to the New York Conference soon after close of last session, but came back with transfer from the New York Conference to us which was read and he was received by vote.

Voted to adjourn. Benediction by S. A. Warner.

Evening meeting: Preaching by S. F. Frazier, followed by A. W. Hall.

#### FOURTH DAY.—FRIDAY.

##### Morning Meeting.

Convened at 9 o'clock. Religious service conducted by E. E. Curtis. Roll called.

The name of S. A. Warner was replaced on roll.

Minutes read and approved.

Memorial service voted to be held following E. Teter's address Saturday.

The following names were called and characters passed: C. E. Hill, O. D. Putnam, P. W. Bruce, G. T. Sutton. Secretary instructed to write Sutton to report at next conference.

Order of day called. Editor A. T. Jennings's address heartily received.

Committee on Conference Evangelist report. Voted to extend limit of time to hear E. Teter's remarks concerning Conference Evangelists.

Adjourned by limitation. Benediction by E. Trowbridge.

##### Afternoon Meeting.

Called to order at 1 o'clock. Religious service conducted by E. Teter. Minutes read and approved.

Order of the day called. Agent A. W. Hall presents the interests of the Connection. Pledges were made for 125 new subscribers for the Wesleyan.

Report of Committee on Conference Evangelist taken up and adopted (see report No. 2).

On first ballot, which was made unanimous, E. D. Carpenter was elected Conference Evangelist. Time was given him to decide.

Voted to grant the evangelist the privilege of arranging appointments in accordance with his convenience. Voted that the evangelist's salary be \$500. Voted that evangelist take collections on each charge and pay all money he raises into the Conference Treasury and draw his salary from Conference Treasurer. If not sufficient amount be raised to cover salary, the evangelist to draw on Treasury for balance; if more is raised it is to be left in Treasury.

Voted to adjourn. Benediction by A. E. Moses.

Evening Meeting: Preaching by A. T. Jennings, followed by A. W. Hall.

#### FIFTH DAY.—SATURDAY.

##### Morning Meeting.

Conference convened at 9 o'clock. Religious service conducted by C. E. Hill. Roll called. Minutes read and approved.

Order of the day called. Conference adjourned in favor of the Superannuated Ministers' Relief Association. Conference resumed.

E. D. Carpenter states that under existing circumstances he must decline the office of Conference Evangelist.

The names of C. E. Hill, L. C. Partridge and R. Shaw, called and characters passed.

Adjourned by limitation of time. Benediction by E. R. Putnam.

##### Afternoon Meeting.

Conference resumed at 1 o'clock. Minutes read and approved.

The following names were called and characters passed: J. Quay, H. C. Shares, W. Rist, E. Trowbridge.

Order of day called. E. Teter gave us a very interesting address concerning missionary interests.

Report of Committee on Pastoral Relations. Item of report that W. B. Atwood and G. T. Sutton be placed on the unstationed list adopted. Report as a whole adopted (see report No. 4).

J. L. Benton reports that funds have been pledged for the publication of the Minutes and recommends their publication. Report adopted.

Voted that the Secretary draw on Treasurer for \$3.44 making \$10.

Voted that the President be instructed to secure if possible a suitable man to travel this Conference as Conference Evangelist, if he cannot do it himself.

Resolutions of thanks presented and adopted (see resolutions).

Voted to now adjourn. President made touching remarks and closed the annual session with earnest prayer in behalf of Conference interests.

Evening Meeting: Sermon by E. D. Carpenter, followed by A. W. Hall. Some thirty sought and found the Savior.

#### SABBATH SERVICES.

The Sabbath was a feast of the best. The house of God was crowded early in the morning. After an oldtime love feast service, the Rev. A. W. Hall preached from John 12:2. The sacrament of the Lord's Supper followed. A generous offering was taken for the pastor, L. C. Partridge. At 3 o'clock T. A. Moses conducted a Temperance meeting. But last and best the evening meeting. Preaching by E. Teter followed by A. W. Hall. Twenty more at least came seeking Jesus. Thus about midnight the Conference broke up, all filled with the Spirit and over fifty souls rescued for Christ. And still the work goes on.

## No. 2.—REGULATIONS IN EXAMINATIONS.

Whereas the entertainment of the Committee of Itinerancy and Orders and candidates entails a burden not as a rule anticipated by the charge inviting Conference, therefore we think it wise to arrange for the examinations of candidates before the session of the Annual Conference. To that end we as a committee have adopted and present to the Conference for adoption the following regulations:

1st. No person shall be entitled to an examination in the Disciplinary course of study until they have been admitted to travel under the direction of Conference.

2nd. Any person thus admitted shall be permitted to take an examination at any time during the interim of Conference subject to the following restrictions:

(1) The candidate shall notify the member of the committee having charge of the studies for the year in which the candidate desires examination as to the study or text-book in which he desires to be examined.

(2) That member of the committee if not conveniently located shall designate some elder before whom the candidate shall appear for examination.

(3) At the time designated by the candidate for examination, the committee shall have forwarded to the designated elder questions upon the subject of examination with a copy of the regulations under which the examination is held.

(4) The candidate shall not be allowed by the designated elder to receive help from any source at the time of the examination. After the examination is completed, the questions, answers and regulations shall be immediately enclosed and forwarded to the member of the committee issuing the paper.



(5) All examination papers shall be submitted at a meeting of the committee on Tuesday of the week of conference for final action. All candidates for admission to travel must appear at this meeting of the committee for verbal examination as prescribed by Discipline.

(6) Any violations of the above provisions shall render the examination null and void.
