STANDING RULES

- 1. The Conference year shall begin on June 1 and close on May 31. Only funds received by the Conference Treasurers, on or before June 10, will receive credit. All Conference Treasurers of Auxiliary Organizations shall immediately close their books, disburse funds and forward a report in full to the Annual Conference Treasurer by June 15.
- 2. The Conference Secretary shall mail one copy of the Pastor's Statistical Report for each charge with budget assessment from the Senior Conference and Auxiliary Organizations to the pastor and the second copy to the Conference Treasurer. The Conference Treasurer will fill in the total budget receipts paid for each assessed item for each church, sign the copy and mail it to the pastor of each charge by May 25. The pastor shall complete the signed report and mail it to the Chairman of the Statistical Committee by July 1.
- 3. All Character blanks are to be filled out in duplicate and mailed to the Conference President and Chairman of the Committee on Ministerial Character, not later than TWO WEEKS before the opening day of Conference. One copy shall be returned to the pastor and the other to the Pastoral Relations Committee.
- 4. The Pastor's Sunday School report shall be sent to the Sunday School Secretary not later than 15 days prior to Annual Conference.
 - 5. The Secretary of the Central Canada Conference shall be the Com-

mittee on Credentials, and all Lay Delegate's parchments to the Conference shall be mailed to him one week previous to the opening of Conference.

- 6. The Annual Conference and Adult Camp shall close on the Sunday immediately preceeding the Civic Holiday in August.
- 7. The Conference President and his Advisory Board shall annually appoint a Nominating Committee of seven (7), which will present, at the Annual Conference, a slate of nominees for all Conference officers and standing committees.
- 8. The President, with his Advisory Board, shall be a Committee on Orders of the Day and Religious Services during Conference.
 - 9. The Conference President shall be Record Clerk.
- 10. The Ministerial Member of the Houghton College Board shall also be Conference Educational Secretary.
- 11. The Executive Board of Directors and Conference Trustees of the Corporate Body of the Wesleyan Methodist Church of America in Canada shall consist of ten (10) members in good standing with the Corporation, as directed under "Management", Paragraph 6, of the Charter of the Act of Corporation of the Wesleyan Methodist Church of America in Canada. FIVE as ex-officio, Namely: the President, the Vice-President; the Conference Treasurer, and TWO elders, designed as, the Conference Secretary, and the Conference Youth President, if an elder, and FIVE men, Three elders and TWO laymen, who shall be elected to a five year term of service by a ballot vote in rotating order. The expiring date of their term of service shall be July 31st, 11:59 p.m., and beginning date of their term of service shall be August 1st, 12:01 a.m.
- 12. The only items of the Pastor's Statistical Report to be read on the Conference floor are as follows: ITEM 1—Appointments; ITEM 2—Wesleyan Methodist, Wesleyan Missionary, Wesleyan Youth; ITEM—3 Present Total Membership, loss or gain; number of family altars; ITEM 4—Potential Regular Attendance; average attendance; ITEM 5—To be read in full; ITEM 6—To be read in full; ITEM 10—Total for Benevolences; ITEM 11—To be read in full.
- 13. All reports to the Annual Conference are to be made out in triplicate. Two copies to be given to the Conference Secretary and one to be retained by the individual reporting.
- 14. The Conference Treasurer shall be given \$100.00 per year and the Conference Secretary \$50.00 per year for their services.
- 15. The Pastoral Vote shall be taken throughout the Conference the first full week in April and completed by April 30.
 - 16. Churches calling pastors are to pay their moving expenses.
- 17. The third Sunday in August shall be the final Sunday for all pastors who are moving from their present charge.
- 18. The churches shall grant each pastor two week's vacation with pay at a time agreeable to the pastor and congregation.
- 19. Travel on Conference Assignments, or to Conference gatherings when travelling expenses are remunerated, the following will be observed:

- (a) Where possible and convenient clergy rates will be paid.
- (b) The expenses of meals, room and when necessary travel to and from trains.
- (c) When it is judged best to travel by train and one has come by car, clergy rates will be paid.
- (d) Automobile travel on a basis of 5 cents per mile.
- 20. Churches having business with the Board of Directors and Conference Trustees requiring a visit of the body to their church, shall be responsible for the expense attached to such calls, unless released by the Board.
- 21. The Committee on Itineracy and Orders shall decide on those who shall receive the benefits of payment of our Conference Educational Budget.
- 22. Each church be requested to present annually, in a series of studies, the material known as "A Guide to Church Membership", that all prospective new members be requested to attend these classes and any others who are interested may also attend.
- 23. The Presidents of the Woman's Missionary Society and Wesleyan Youth shall be members of the Committee on Church Extension and Evangelism.
- 24. Each Church is to contribute the minimum of two work days at the annual work-bee for camp maintenance. This may be contributed by pastor and layman, or by hired help.
- 25. The Conference Camp preparation day is to be held annually on the Saturday preceding the summer camps.
- 26. The Camp and Conference Entertainment assessment is to be used for entertainment of guests and provide for pastors, their wives and families' meals at half price during camp.
- 27. The Camp Meeting Committee shall be composed of: Camp Chairman; Conference President; President of Woman's Missionary Society; President of Wesleyan Youth; Camp Treasurer; Advisory Board.
- 28. Pastors receiving financial assistance from the Conference will be paid directly from the Conference Treasurer. This aid is considered a Conference Grant, thus it is to be reported under Item, "Gifts to Pastor", on Statistical Form.

Conference aid for churches will be sent to the local church treasurer.
29. The Report to Conference of the Board of Directors and Conference

- Trustees shall be mimeographed and copies given to pastors and delegates prior to the reading of the report.
- 30. The moving expense of a pastor going to a pioneer field is to be paid by the Conference.

DAILY PROCEEDINGS First Meeting—Wednesday, 9 a.m., E.D.T., July 20, 1966

1. Opening—The sixty-ninth annual session of the Canada Annual Conference of the Wesleyan Methodist Church of America in Canada met on the

Silver Lake Campground, Maberley, Ontario. The meeting was called to order by Conference President J. S. A. Spearman.

- 2. Elder's Roll Call-The names of Elders were read.
- 3. Committee on Credentials—The report of the Committee on Credentials was read and adopted by vote. (See "Lay Delegates" in Directory).
 - 4. Lay Delegate's Roll Call-The names of the Lay Delegates were read.
- 5. The Conference Bar—Motion passed by vote that the Conference Bar consist of the first seven rows of seats in the centre section of the Tabernacle and including the platform.
- 6. Agenda—Motion passed by vote to approve the Agenda as it appears on the mimeographed sheets.
- 7. Temporary Organization—The report of the Committee on Temporary Organization was read and approved by vote.
- 8. Conference Hours—By vote the following time schedule was approved for Conference sessions: 9 a.m. to 12 noon and 1.30 p.m. until adjournment by motion.
- 9. Committee on Courtesy—Dr. H. K. Sheets, General Superintendent, and Mrs. Sheets were introduced, and they gave witness to their love for Christ and His Church.
- 10. Session Chairman—Dr. H. K. Sheets was invited to act as Chairman for the Conference Session.
- 11. Full Time Presidency—Rev. H. Kielty read the report of the Committee on Full Time Presidency, which was adopted. (See Report No. 34).
- 12. Courtesy—The following were introduced and spoke briefly: Dr. S. W. Paine and daughter, Catharine; Rev. John Lamos; Rev. R. T. Benson; Rev. Philip Birchell; Rev. G. A. Delong.
- 13. Privileges—Motion passed by vote that those introduced to Conference may sit within the Conference Bar and speak upon any question.
- 14. Audit Committee—The Committee on Audit read a partial report which was adopted.

 - 16. Adjournment—Adjournment by limitation of time.

- 18. Courtesy—Rev. R. L. Casement of the Free Methodist Church brought warm greetings from his Church. Dr. H. K. Sheets replied with fitting remarks, expressing a desire for merger with the Free Methodist Church.

Pinch were appointed Distributing Tellers; and Rev. E. F. LeRoy and Mr. Kenneth Smith Canvassing Tellers. The following is the result of the vote: 33 votes cast, 33 "Yes" votes favouring merger; with no "no" votes cast.

Report No. 5. CONFERENCE PRESIDENT'S ANNUAL REPORT

To the representative of our Denomination, Dr. H. K. Sheets, brethren in the ministry, lay delegates and visitors, we greet you in the Name of the Lord Jesus Christ at this the opening of our 69th Annual Conference.

The words of the great Apostle express well our thoughts today, "I thank my God upon every remembrance of you, always and every prayer of mine for you all making request with joy, for your fellowship in the Gospel...."

While we have come together to discuss the administrative details of our Conference, our gathering in the true sense of the word is for more than that. To us has been given a commission—a Gospel to proclaim. On each of us, limited as we may feel, rests the awesome responsibility to make our Conference the effective spiritual force God Himself wants it to be. Any lack of vision, faithfulness or courage on the part of any of us will make inroads in our effectiveness in proclaiming the message of Christ to others.

In the midst of the restlessness of our world today and in the revolutionary events of our time there never was a greater challenge than that which faces us as a Conference. All about us are open doors, beckoning hands and hungry hearts. These call for an outgoing ministry, greater church givings, and ready cooperation on the part of all. While the Merger of our Church with that of the Pilgrim Holiness and the Reformed Baptist is what we have anticipated for many years, yet increased membership in itself, must not be accepted as a substitute for faith, vision, and conquest on the part of this Conference. In the Name of the One who said "Go Ye" let us be "strong and of good courage" and venturing forth "do exploits" for God.

THE PAST—As we reflect on the past and assess our objectives we can readily see that we have not obtained all the desired heights, but we have under God made progress. As our official acts show, we have by God's help endeavoured to carry out the duties assigned to us at our last Conference.

Among the highlights of the year I would mention briefly:

October 3, when the congregation of the pioneer church at Trenton rejoiced during a special mortgage-burning ceremony, which marked the retirement of the mortgage on the parsonage. Thanks to those who in one year, made such a service possible.

November 14, the day when our one year old congregation in Trenton was officially organized a Wesleyan Methodist Church, with 26 full members, 3 junior members and 1 associate member.

May 1, the day when the impressive new Madoc Church was dedicated with an overflowing congregation blending their voices in praise and thanksgiving to God for what had been done through the faith and sacrificial

labours of the local church.

Conference pioneer work continues to be the challenge of the Conference. Plans have already been formulated for the opening of a new work in the City of Oshawa. A tender for the immediate construction of a parsonage has been accepted, with occupancy anticipated for early September.

The tour of the Conference by the Rev. and Mrs. Paul Dekker was spirit lifting. While organized and sponsored by the W.M.S., yet we would pause to give praise to God for all that was done in the interest of World Missions.

The visit of the Rev. C. Wesley Lovin, Secretary of Church Extension and Evangelism, was also one of inspiration and help. Three Church Extension Rallies were held and all but two of the pastors were either visited or contacted during the five days spent with us in March.

The Quadrennial Ministerial Refresher Course held at Houghton, N.Y., March 14-17 was attended by most of the pastors. The inspiration, fellowship and challenge derived by all shall not soon be forgotten.

The conference-wide day of prayer held in the Brockville Wesleyan Methodist Church, February 17, was another memorable occasion. About two-thirds of the pastors were present for the day of prayer and intercession for the work of the Church.

It was my privilege to attend the General Conference held at Houghton in June of this year. It is with pleasure and thanksgiving to God that I mention the General Conference approval of the Legal Resolution of Merger with the Pilgrim Holiness Church and the unanimous vote for Merger with the Reformed Baptist Alliance.

Another privilege was the opportunity afforded me to attend the Conference of the Pilgrim Holiness Church and the Alliance of the Reformed Baptist. In each instance we found a gracious bond of fellowship and purpose to promote scriptural holiness.

God in His unerring providence called from our ranks this year Mrs. Della Bain, the wife of the late Rev. James A. Bain. Several of our laity have also been called to join the church Triumphant. Our sympathies are extended to all who have suffered loss and bereavement. A suitable Memorial Service will be held this Sunday at the hour of 2:00 p.m.

I would express gratitude for the cooperation and assistance given to us by those of the General Office, the Vice-President of Conference, the Rev. M. E. Summers, my Advisory Board, and all other officers and officials. I would also commend our pastors and people for their labours of love, their whole-hearted cooperation and their sincere desire to see the work of God go forward. The assistance of Mrs. Spearman and the Rev. Nancy White who have given of their time to the work of the Lord has made it possible for us to pastor the Trenton Church, as well as share in the responsibilities and work of the Conference.

In closing, I quote in part a prayer of the Great Apostle, "May you be strengthened with all power according to His glorious might for all endurance and patience with joy."

REPORT OF THE BOARD OF CHURCH EXTENSION AND EVANGELISM

The Board of Church Extension and Evangelism begs leave to submit the following report:

- 1 The Board of Church Extension and Evangelism met at Brockville on Thursday night, May 5, 1966.
 - The treasurer, Rev. J. H. Weaver, reported that \$1,239 has been given by the churches on the Arnprior indebtedness this year and that this amount has been given largely through self-denial offerings.
- a It was recommended that the present note of \$3,300 held against the Oshawa property be assumed by Conference for payment plus an additional \$700 in cash be paid to the Oshawa fund in lieu of the \$4,000 borrowed by Conference for the Arnprior indebtedness. (See amended motion by Board of Directors and Trustees on May 14, 66)
- b It was recommended that, inasmuch as Rev. W. W. Jewell has felt the burden of the pioneer work at Oshawa, and has made himself available, he be appointed by Conference to this work for the coming year.
- c. It was recommended that, in addition to the proposed support from the Toronto Church and the Conference W.Y., the new congregation at Oshawa endeavour to raise the additional amount for adequate pastoral support.
- d It was recommended that we build a parsonage at 655 Ritson Rd.

 North in Oshawa according to Central Mortgage and Housing Plan

604 and that application for \$8,000 be made to Central Mortgage and Housing and that the balance be financed by cash on hand in the Oshawa fund both to total \$15,500.

- e. It was recommended that Plan J. S. 500 be used for the Oshawa Church at an estimated building cost of \$40,000, and that application be made to borrow from the Wesleyan Investment Foundation to a maximum of \$40,000.
- The Board of Church Extension and Evangelism met at Silver Lake Wesleyan Methodist Campgrounds, Thursday, July 21, 1966.
- a. We recommend that the Madoc pastor receive \$25 per month for this Conference Year.
- b. We recommend that the Conference President receive \$150 per month from the Conference this year to assist in the remuneration of his assistant.
- c. We recommend that the Conference pay \$20 a week toward support of the Trenton pastor to partially replace that paid previously by auxiliary organizations.
- d. We recommend that the Conference Church Extension budget assessment be \$7.00 per member for this Conference Year.
- e. We recommend that the budget assessment for Silver Lake be \$4.00 per member for this Conference Year.
- f. We recommend that the Arnprior indebtedness and interest be paid from funds received through Conference Extension Self-denial offerings during the Lenten season on the basis of 10 cents per day per family or a minimum of \$4.00 per family.
- g We recommend that the Oshawa Pastor receive \$50.00 a month for Sept. and Oct. supplementing yearly support given by the Toronto Church & Auxiliary Organizations.
- h We recommend that the Conference President continue to explore possibilities in Hudson Heights, near Montreal, Quebec, and that he visit interested families with the hope of beginning a new work in the near future.

The Sunday School is one of the important agencies in any given community that can be used to effectively challenge and direct public conscience. We trust that in the coming year each of our Conference Churches will continue to specialize in the ministry of the Sunday School and thus exercise a determinative role in accomplishing this goal.

During the past year four churches reported Vacation Bible Schools

held with a total enrollment of 567 and an average attendance of 107.

Several of the Board members attended the Annual N.S.S.A. Convention and the Wesleyan Breakfast held in Milwaukee, Wis., last Fall. Dr. Kindschi and the S. S. Staff from Headquarters effectively portrayed the thrust that could be given through using the Thanksgiving Offering advertising and publicity packet.

The Conference S. S. Board met on two different occasions to plan for the Junior and Crusader Camps at which time the dates were set, directors appointed, and the curriculum adopted.

Two Projects were approved by the Board to be initiated this year.

Report No. 20 REPORT OF CAMP CHAIRMAN

To the 69th Annual Conference of our Canadian Churches. Greetings in Jesus' Name.

Again, you have afforded us the privilege of acting as Camp Chairman and I must confess I feel this responsibility has been at times very inadequately fulfilled. Had it not been for the cooperation and help of so many it could have been an impossible task. May God reward all who have been so faithful, and a special word of appreciation to our Business Manager, Walter Smith, and the members of the Camp Committee.

Our Camp development slowed down considerably this year, due to the usual limitation, money and time, in that order. The water line, to serve the lots as the new west end road, is installed, and thanks to Wesleyan Men, washroom facilities in the Memorial Workers Cottage. We had anticipated having the new sports area levelled, as well as the new road to the east end of the camp in readiness, but Ken Smith just did not have the machines available at this time. The gravel is now being crushed for this road and before the summer is out the new road should be cut through.

A number of facilities are badly needed, with expansion of our cabin facilities a must for the near future, as these are much in demand. Also a building that might serve as combined Camp Office, Chapel for the W.M.S., and Youth, as well as for general use, should be undertaken within the next year or two. Since we have practically cleared away the accumulated operating deficit, this may be possible.

A good deal of maintenance has been done this year, particularly in the way of painting. Our Youth Dorm, Silverholm, Tabernacle, as well as part of the Dining Hall, all received a new look.

I must confess that we have been somewhat disappointed in the response of volunteer labour, particularly for Camp Preparation Day. Unless we have a revival here, the hiring of help may be necessary, and this, of course means either more money or less maintenance. One who couldn't send help, sent money, perhaps more could follow their example. The Camp belongs to the whole Conference, not just some of the churches. We are indeed going to have to take a long look at our rates, due to rising costs,

unless more help and cash is volunteered; as this is our only means of maintenance and expansion.

While we need financial help, we feel our prime reason for the Camp is spiritual, and here we feel is our greatest need. Our children's camps were a real success here, but unless our parents, preachers and people as a whole go home revitalized most of the work God has done for our children will not only be dissipated; but indeed the whole purpose of the Camp lost. God is willing; are we?

On behalf of our Camp Committee, I submit the same recommendation as last year, \$.50 cents per member on Budget for Conference and Camp Entertainment.

Again, our thanks to all who contributed, may God multiply your tributes and glorify Himself through our Camp.

- 7. We recommend that under a heading of "Conference Elders", a list be made in order of seniority in the Conference.
- 8. We recommend that all churches be registered, by the Conference President, with the Federal Government of Canada, prior to December 31, 1966.

Toronto organized following the last Conference and had four profitable meetings with outside speakers in each case. Toronto supported the Billy Davis Project and for all purposes raised approximately \$700.00 with no let down to regular church givings.

Later in the Conference year, we assisted at the organizational meeting of a second Wesleyan Men's group known as the Belleville-Trenton group, and they are extending invitations to Madoc men to participate with their group. We trust other churches will form groups of Wesleyan Men this coming year.

No fund raising campaign was persued to bolster our balance on hand toward the second Memorial Cottage, however, bank interest and a further donation netted an additional \$40.88.

We were requested by the Camp Committee to install toilet facilities in the present cottage. Equipment was purchased and the plumbing done by one of the Belleville group.

As at May 31st, there was a bank balance of \$517.14 which will be depleted for the materials purchased after that date.

A suitable plaque has been placed in Memorial Cottage No. 1. This plaque bears names of Wesleyan Laymen who died in 1963.

A Billy Davis Project to assist him in Houghton College was approved by the last Conference. Three Churches responded and although this left a heavy burden on some, it was a success and Billy Davis attained his first year at college. A total of over \$500.00 was sent to his assistance.

Recommendations:

It is recommended that we continue assistance to Billy Davis and all churches, if possible, participate.

It is further recommended that we pursue our efforts for funds as to complete the second Memorial Cottage.

DAILY PROCEEDINGS

The Magazine Solicitor's report was read and adopted.

It was adopted that a chapel fund for Silver Lake be our project for the new year with a goal set of \$500. It was suggested that each society then set their own goal.

Several statistical reports were read.

Committee on Courtesy presented Mrs. Melva Ridgway. She in turn presented us with a prayer request for the Glen Roy Church in Australia and also for the Calhouns who are replacing the Ridgways.

Miss Clara Strutt gave us some highlights of General Conference.

Mrs. Lyla Voteary and Mrs. Mary Murphy were appointed to take care of the posters.

We adjourned with prayer by Mrs. Blanchard.

Our afternoon session was opened with prayer by Mrs. Presley.

Mrs. Ruth Irish and Mrs. Lois McKnight sang a duet "Blessed Tidings".

Rev. James Ridgway led us in our devotions—"Great Peace—Our Portion". He stated that Christ has not only diagnosed our problem but has given us principles by which to live.

Roll was called.

Committee on Courtesy presented Dr. Stephen Paine, president of Houghton College. He spoke of the Foreign Missions Fellowship at the College and of their support of missionaries. He also informed us of his daughter, Carolyn Miller, and the work she and her husband have been doing in linguistics in Viet Nam. His prayer request to us was to pray the Lord would send forth young people out of Houghton into full-time Christian service.

Rev. Birchall of Houghton Academy was presented to our Conference body. His prayer request was for a dedicated staff.

Mrs. Sheets was also introduced who brought us greetings and her

testimony. Her verse to leave with us was Psalm 84:11.

Our final guest of the afternoon was Mrs. John Lamos who brought us greetings and her testimony.

It was adopted that each society send to the Conference Treasurer money equal to half their W.M.S. membership @ \$2.25 each for hymn books

for Oshawa and that a church project be planned to supply a communion set for this new work.

We adjourned with prayer by Mrs. Lyla Voteary.

Our afternoon session was opened with the singing of "Wonderful Peace" followed with prayer by Mrs. Nora Elliott.

Rev. James Ridgway spoke to us using the subject, "Being at peace with yourself".

Roll was called—we were each to answer with a missionary's name.

The Statistical Report was read by Mrs. Wilson and it was adopted. A rising vote of thanks was given Mrs. Wilson for her work on this committee.

It was adopted that the First Aid Kit be purchased with our Canada Packer's labels.

It was adopted that we have a Poster Committee. Mrs. Pat Chatson and Mrs. Marjorie Cooney were the ones elected to this committee.

A partial report of the Committee on Audit was given.

The YMWB report was read and adopted.

Committee on Courtesy presented to us Dr. Sheets, one of our General Superintendents. Our tent reminded him of his early preaching days which he shared with us. He also told us of God's answer to prayer in behalf of the Student Centre at Asbury Theological Seminary.

It was suggested that anyone having flannel graph material or flash card stories available for loaning send a list to Miss Strutt who would in turn send a complete list to the local superintendents.

Some local YMWB reports were read.

Mrs. Peever shared with us their YMWB public service.

Arnprior, Inkerman, Trenton, Winchester were presented with awards for being 100% bands. Our conference YMWB is also on the Honour Roll this year.
