



# JOURNAL OF DAILY PROCEEDINGS

The California Conference of the Wesleyan Methodist Church of America met for its Thirty-sixth Annual Session in the auditorium of the Skyline Wesleyan Methodist Church, Lemon Grove, California, at 8:30 A.M., June 27, 1960, Rev. Orval Butcher read II Cor. 5 in the devotional period.

The roll was called.

The bar of conference was established as the first eight rows of seats and the platform.

A motion was made and seconded to accept the report of the Agenda Committee. The motion carried. See Report No. 1.

The Conference President gave his report. The report was accepted with a rising vote of thanks. See Report No. 2.

The motion carried to invite Dr. H. K. Sheets to preside over the remainder of Conference.

The Nominating Committee was filled by the election of the following: Orval Butcher, Richard Rossow, Max Trayer, Sherwood Eddy, Elzie Gordon and Kenneth Wilch.

The time for hearing the reports of Conference Trustees was changed to Wednesday morning during the giving of reports.

The Nominating Committee retired for Committee work.

The Missionary Board read its report. It was adopted. See Report No. 3.

The time for hearing the Camp Meeting Board report was changed to Tuesday morning during the giving of reports.

The Sunday School Secretary read his report. It was adopted. See Report No. 4.

The Tithing Secretary gave a report. It was adopted. See Report No. 5.

The Card Call Secretary made a report. It was accepted.

The Wesleyan Men's Promotional Secretary read a report. It was adopted. See Report No. 6.

The Transportation Secretary read his report. It was adopted. See Report No. 7.

The Church Development Secretary read his report. A motion carried to accept the financial part of the report. A motion carried to refer item 4 of the recommendations to the Finance Committee. See Report No. 8.

A motion carried to deal with the recommendations made by the Agenda Committee.

A motion carried to strike out of Standing Rule II "Each church shall pay salary to the outgoing pastor for two Sundays following adjournment of the Annual Conference" and substitute "New pastors shall assume their duties the second Sunday following the rise of Annual Conference."

A motion carried that the sentence "No loan shall be made until a note is signed for the loan" be inserted between the first and second sentences of item VIII C 3 of the Standing Rules.

A motion carried that the name of the Missionary Board be changed to "Conference Board of Church Extension and Evangelism" to agree with paragraph 268 A of the Discipline and this change be made wherever the name occurs in the Standing Rules.

A motion carried to make, in accordance with paragraph 165 (4) of the Discipline, the following section VII F of the Standing Rules. "The meeting for the election of local church officers shall be held the first Wednesday in May and the elected officers shall take office June 1st following."

Adjourned to meet at the call of the chair.

The Session was called to order.

The Nominating Committee read its report. A motion carried that the item of the Pastoral Relations Committee be referred back to the Nominating Committee.

A motion carried that the item on the Vacancies Committee be referred back to the Nominating Committee.

The partial report was adopted. See Report No. 9.

The President appointed Kenneth Moore, Hugh Otto and Olivier Boudreaux on the Committee on Itineracy and Elders Orders.

Adjourned.

SECOND MEETING, MONDAY P.M.

Jimmy O'Quinn 1ed in prayer.

The roll was called.

The minutes were read and approved.

A motion carried that instead of calling the roll cards be passed out for the members of Conference to sign. These shall be taken up and used in marking those present. Also that the minutes be typed up and passed to a committee for review and copies made to be passed out in place of reading the minutes.

The Nominating Committee gave a partial report. It was accepted. See Report No. 8.

A report was made by the Member of the Board of Trustees of Miltonvale College. It was adopted.

The representative on the Board of Trustees of Azusa College read his report. It was adopted. See Report No. 10.

A motion carried to adjourn.

#### THIRD MEETING, TUESDAY A.M.

Rev. D. H. Scott led the devotions reading from Ephesians 4:1-8, 11-13; 2:4-7 and 19-22. He spoke on "Togetherness". We are quickened together in Christ, raised up in Christ, sit together with Christ, are framed together in the Lord and builded together for a habitation of God.

The meeting was called to order.

Attendance cards were passed out.

The minutes of the previous meeting were distributed.

The Conference historian read her report. It was adopted. See Report No. 11.

The report of the auditor was read. See Report No. 12.

The Conference Treasurer read his report. A motion carried that the report be accepted with thanks and appreciation. A motion carried that a letter of appreciation be sent by the Conference Secretary to Mr. Bisbee for the work he did for the Conference. See Report No. 15.

A motion carried that a letter of appreciation be sent to the Marshburn Brothers for their substantial giving this year.

The orders of the day were called for. Fred Van Tatenhove, Ollie Philpot, Wendell Campbell and Eugene Welliver were appointed tellers.

A motion was made and carried that the first ballot for President, Vice-President, and Secretary be a nominating ballot.

The following received the majority of ballots cast for their respective offices and were decalred elected for the following year:

President - Clinton W. Jones Vice-President - Orval C. Butcher Secretary - John Henley Treasurer - Theodor Stewart

Sherwood Eddy presented his resignation as a member of the Board of Trustees of Miltonvale College. It was accepted. A motion carried that the nomination for this office be referred to the Nominating Committee.

Clinton W. Jones was elected by ballot as Conference Trustee, his term to expire in 1964.

A motion carried to increase by one the number of ministerial members on the Board of Trustees. Archy L. Mudgett was elected by ballot as the new member. His term to expire in 1964.

The courtesy committee introduced Rev. Beulah Landrey, a former missionary to India; Rev. E. J. Mills, former Burial Association Secretary; Rev. Claton Butcher, pastor of the Lincoln Oaks Church; and Williard Knox, former pastor in the California Conference.

William P. Marshburn was elected by ballot lay member of the Conference Board of Trustees. His term to expire in 1964.

Rev. E. N. LeJeune was introduced to the Conference.

The Nominating Committee nominated Clinton W. Jones as a member of the Board of Trustees of Miltonvale College. He was elected by ballot.

Adjourned by limitation of time.

# REPORT NO.7

#### TRANSPORTATION SECRETARY

Report of the Transportation Secretary to California Wesleyan Methodist Annual Conference -- 1960.

AIRLINES: Bonanza Airlines, serving the Western area, of which our Conference is a part, offers a 50% discount to all licensed ministers. The

applicant must secure an application from any Bonanza ticket office and fill it out. Return the application properly filled out to the ticket office and it will in turn be mailed to the Bonanza head office in Las Vegas, Nevada, for processing. A clergy card will be issued and the receiver may use it to secure half fare flight on any Bonanza route. All reservations issued to a clergy card holder will be on a stand-by basis. No credit card service is available to holders of clergy cards. An example of the clergy card arrangement is as follows: Phoenix to San Diego regular fare is \$47.86; clergy fare would be \$23.93 one way.

Western Airlines offers no clergy rates. They do have a credit card system available. They prefer the International Credit Cards, but will accept any recognized credit card system. Application can be secured at local ticket offices and after they are properly filled out they are to be mailed to L.A. for processing. Three weeks must be allowed for said processing. Any local ticket office will handle the mailing operation. Fare on Western Airlines from Phoenix to San Diego, first class is \$23.90, coach flight would be \$19.70 one way.

American Airlines offer no clergy rates. They also have a credit card plan. American recognises any standard credit card for air flight. An application must be secured locally, filled out, approved locally by sales board of the Airlines and they will then mail the application to Central credit card Bureau in Chicago. Allow two weeks for processing. The rates on American are, for all practical purposes, the same as Western Airlines, namely, \$23.90 first class and \$19.70 coach—one way, Phoenix, Arizona, to San Diego, California.

T.W.A. entertains the same arrangements or limitations as does American, however, T.W.A. does not serve the San Diego area.

BUS-LINES: Greyhound bus lines has a clergy arrangement, They offer a discount of 25% to all licensed ministers. An application, secured locally and properly filled out, must be sent (Greyhound will handle

the mailing if desired) to the central clergy bureau in Chicago. If the application is approved, the applicant will receive a coupon book. One coupon is to be presented when ever a ticket (one way only) is purchased, Once the ticket is purchased, it will be honored. (That is, no stand-by basis necessary). The discount arrangement will be honored on all transfer lines if the tickets for the entire trip are bought at time of the original purchase.

Trailways Bus-lines offer the same benefits and discount as Greyhound. Fare one way from Phoenix to San Diego regular fare is \$12.32; by using your clergy discount coupon the fare would be \$9.24.

RENT\_A\_CAR: Avis offers no special clergy rate. formation concerning their rates is therefore of little value for one person traveling alone. Airline travel can be secured thru Bonanza, clergy rate for as little as \$23.93 one way from Phoenix to San Diego as previously stated. However, were four or more traveling, a considerable savings can be secured by the use of a rental car. By dividing the car-rental rates, each individual would save as compared to air-travel. The following rates are standard with most of the recognized car-rental agencies at the present time. Fords and Chevrolets, one way from Phoenix to San Diego - \$10.00 plus .10 per mile plus a \$15.00 drop charge when car is left at its destination. Now, on the basis of a 400 mile trip this would be \$65.00. These same automobiles, with refrigeration would be \$11,00 per day plus .11 per mile plus a \$25.00 drop charge at destination or \$80.50. Even traveling the latter deluxe way, you can see that it would cost four people only about \$20.00 each -- much less than airline fare.

RAILROADS: Sante Fe & Southern Pacific offer a 50% discount to all licensed ministers. Applications can be secured at local ticket offices and when properly filled out they must be mailed to central clergy bureau in Chicago, Ill.. In two or three weeks a

coupon pass book will be issued to the applicant. One coupon must be presented at the time of each ticket purchase. If a ticket is sold it will be honored. (Not stand) As in the case of the bus lines, discounts onto connecting transfers will be honored if the ticket for the entire distance is secured at time of original purchase of tickets.

NOTE: It should be observed that all companies offering transportation to the public have been known to make Special arrangements at times according to their own discretion. In case of extreme emergencies etc., we suggest that the individual contact an authority of the company and explain the nature of the emergency.

# REPORT NO.18

#### PENSION PLAN BOARD

The Conference in 1959 asked the Pension Plan Board to made a study of the Pension Plan in its relation to the retiring ministers and bring in a report at this time.

There are three factors to study and report on. First, Social Security. Second, California Public Assistance and Welfare. Third, the Wesleyan Pension Plan.

First, The Social Security is a Federal Plan. Ministers paying Social Security may upon retiring at 65 years of age, draw benefits in proportion to the amount paid. The exception is, if they have wages of more than \$1200 a year between the ages of 65 and 72. After 72 years of age this does not apply.

Second, California has a system of caring for its needy by the California Public Assistance and Welfare. They have strict rules and regulations regarding the Welfare funds. A recipient must be a resident of California 5 years out of the last 9 years. He must not have an assessed personal property of more than \$1200 less encumbrances, for a single person, or \$2,000 for a married couple. This does not include personal effects as clothing and household furnishings. Also real property may not have an assessed value of \$5,000 or more. Notice, it is assessed value. Property of more value except a home must be utilized to help meet the needs of the applicant or recipient.

The Public Welfare and Assistance makes thorough investigation in each individual case into the income, pensions, Social Security, Retirement pay, insurance payments. Every regularly expected payment or income has to be reported. Also the ability of relatives to help the needy is studied. A study is made of the needs of the individual or family; if after this investigation and report, the State sees a need, it will augment the personal income as they will have a monthly income of \$95.00. The Director of the Public Assistance and Welfare told me that medical care and medicine are not counted in the \$95., but are above. He also stated that a person with outside income (other than P.A.W.) is more free to spend that income then he would be if all his help came from the P.A.W.

Third, the Wesleyan Plan pays its retiring ministers on the number of years they have served the church and paid their personal assessments. The rate of Pension payments received is based upon \$20.00 per year of service. Thus, a person serving 30 years is eligible to draw \$600 per year. The personal assessments paid since January 1, 1960, are  $1\frac{1}{2}\%$  of his gross income, -secular or ministerial.

On giving the information of our California's P.A.W. to Bro. D. A. Rees and later to Bro. H. K. Sheets, our new Secretary, they have given thought to our problems. Bro. Sheets writes, "It would seem that the Conference should continue to fully support the Pension Plan, and allow it to be a personal matter with those entitled to benefits whether they decline to receive them, and depend entirely on the State Assistance, or whether they allow the State to supplement what they receive from the Pension Department."

# STANDING RULES

## I ANNUAL CONFERENCE

- A. The Conference shall convene at the call of the chair. The President shall announce the date of its meeting in sufficient time before the opening, in conformity with the Denominational Board.
- B. After the last Quarterly Meeting on each charge, the pastor shall furnish each delegate with his credential. The delegate shall present said credential to the conference secretary at the first Conference Meeting.
- C. The quorum of this Conference shall be thirty-five percent (35%) of its possible enrollment. Ministerial or lay members of the Conference must not leave the bar of Conference without consent of the chair, nor withdraw from the conference session permanently without consent of the Conference.
- D. The Conference shall elect a Nominating Committee which shall bring in nominations for Sessions Committees as early in the first meeting as possible and nominations for Standing Committees at the time of election of Conference Officers.
- E. All recommendations to study or to travel under the direction of the Conference must be reviewed by the Committee on Itineracy and Orders before the name of the candidate is placed on the Conference Roll. All ministers being received into the Conference must have their credentials examined by the Committee on Itineracy and Orders before he is received into the membership of the Conference.
- F. The fiscal year of the Conference shall close May 31 each year and the Conference Treasurer's books are to close June 10. The local treasurers shall close their books at the end of the fiscal year (May 31) and have their statistical reports made out and in the hands of the Statistical Committee at least five days before Conference.

- G. All officers, boards and standing committees shall take office as soon as elected except the Statistical Committee, whose term of office shall be from the rise of the Conference in which it is elected until the rise of the following Conference.
- H. The Conference shall elect annually two members to serve on the Board of Trustees of Azusa College.
- I. A copy of the Statistical Blank of each church shall be posted by the Statistical Committee at the opening of the Conference Session.
- J. The Conference Secretary and Treasurer shall each be reimbursed to the amount of \$50.00 for each year's labor.

#### II MINISTERS

- A. Each pastor and the Conference President is to be granted at least two weeks of vacation with pay, plus and additional week's salary, each year.
- B. In case of the absence of a pastor from his church for more than two weeks, he shall advise the Conference President of his absence and the arrangements made for Pulpit Supply.
- C. All charges shall pay the moving expenses of the incoming pastor within the bounds of the Conference.
- D. It shall be the duty of the pastor to see that all property held by the Conference on his charge is insurred against loss by Fire, Public Liability and Vandalism, in the name of the Conference for replacement cost as established by a qualified appraiser, and that a statement of insurance be mailed to the Conference Secretary by the Insurance Broker.
- E. New pastors shall assume their duties the second Sunday following the rise of Annual Conference. Any

arrangement contrary to this rule shall be cleared with the Conference President and his Advisory Board.

#### III CONFERENCE BOARD OF CHURCH EXTENSION AND EVANGELISM

- A. The Conference Board of Church Extension and Evangelism shall be composed of the Conference President, the Conference Vice-President, the Conference Treasurer, the Conference Board of Trustees, the Women's Missionary Society President, the Wesleyan Youth President, and one elected member. All Church Extension as to location, planning, policy and promotion shall be under the direction of this Board.
- B. The Conference Board of Church Extension and Evangelism shall be known as the Conference Board of Administration. This Board shall be the official body of the Conference during the interim of Conference sessions and its actions shall be binding until ratified or nullified by the succeeding annual conference session.
- C. The Conference Board of Church Extension and Evangelism is hereby authorized to pay our all monies from the Conference Extension Fund, and during the interim of Conference act as a Committee on Finance.
- D. The Conference Board of Church Extension and Evangelism shall fill vacancies.

#### IV CONFERENCE PRESIDENT

A. The Conference President will be appointed to travel the Conference as President. He will have general supervision of the spiritual interests and will hold at least one service in the local church during the year under such date as he may announce in advance.

#### V BOARD OF TRUSTEES

A. The Board of Trustees is designated as a Deed

Examining Committee for the Conference. When deeds to Conference, Church, or Parsonage Properties are received, before being recorded, they shall be submitted to this Committee for examination and the insertion of such disciplinary clasues as necessary to make the property safe for the local church and the conference.

#### VI CAMP MEETING

- A. The Camp Meeting Committee shall be composed of four elders, elected in rotation for a term of four years each, and two laymen, elected in rotation for a term of four years each, with the President of the Conference, the President of the Women's Missionary Society and the President of the Wesleyan Youth members ex-officio.
- B. The Camp Meeting Committee is empowered to employ evangelistic help up to and including three years in advance.

## VII MISCELLANEOUS

- A. The Agenda Committee for the Conference shall be composed of the President, the Vice-President, the Secretary, the President of the Women's Missionary Society, and the President of the Wesleyan Youth.
- B. Resolved that there be held a Ministerial Convention from the third Tuesday evening to the following Thursday noon of February of each year.

Resolved further that the place and plan of meeting be left in the hands of the Committee on Itineracy and Elder's Orders, in conjunction with the Conference President.

C. The Conference Paper, "The Launch", is to be published in ten issues per year. The Conference President is to be designated Editor, and the heads of

the Conference auxiliary organizations be responsible as contributing editors; said paper is to be financed from the Conference Work Fund and supplemented by special offerings from the churches.

- D. All chairmen of Conference Boards or Committees shall have submitted, and all secretaries of the conference shall submit their reports to the conference in writing and a copy of the same given to the Secretary immediately after the report is adopted.
- E. Reports of the Board of Trustees and Conference Board of Church Extension and Evangelism submitted to the conference shall contain only a summary of actions taken during the year for ratification provided that a full copy of the minutes of all meetings held during the year appear in the conference annual journal.
- F. The meeting for the election of local church offices shall be held the first Wednesday in May and the elected officers shall take office June first following.

## VIII FINANCE

- A. That all budget monies shall be directed through the various treasurers in the conference such as the Y.M.W.B., W.Y., W.M.S., and local church treasurers, and that duplicate receipts be mailed to the Conference Treasurer for recording. The Conference Treasurer shall receive and record all budget monies either by cash or vouchers that are designated for budget.
- B. That each church pay its budget in ten monthly payments the first payment on or before August 1.
- C. The Wesleyan "500" Plan
  - 1. There shall be a Conference Secretary of Church Development. It shall be the duties of this secretary to promote the "500" Plan in each church of the conference and urge cooperation

from each church. He will also furnish promotionsl material for the local "500" secretary, and will periodically check with the local secretaries as to the progress made and the number of members giving, and make monthly collections. He will also give counsel to those requesting same.

- 2. Each church shall elect a "500" Plan Secretary. It shall be the duties of the local Secretary to promote and to obtain members to this Plan.
- 3. All monies disbursed from this fund shall be considered a loan and shall be paid back monthly according to the size and type of loan.\* Thus, this will be a revolving fund.
- \*NOTE: No loan shall be made until a note is signed for the loan.
- 4. Types of loans, payments and interest are as follows:
  - a. Land--one percent of loan per month; six percent interest included.
  - b. Social Hall and Sunday School Rooms, as a first unit--one tenth of one percent of loan per month plus interest. No interest for the first year, one percent the second year, two percent the third year, three percent the fourth year, four percent the fifth year and five percent the sixth year and remaining years.
  - c. Parsonage or Church Buildings--one percent of loan per month at five percent interest included.
- 5. Payments shall start three months from the date of opening service. All loans and details are to be worked out with the Conference Board of Church Extension and Evangelism.




The report of the Committee on Resolutions and Thanks was given and accepted. (See Report No. 10.)


