FIRST DAY-TUESDAY.

Evening Meeting.

The Champlain Annual Conference of the Wesleyan Methodist church began its sixty-fifth session in the First Wesleyan Methodist church, Glens Falls, N. Y., on Tuesday, April 24, 1906. President E. D. Carpenter presiding.

Opening. The president called the conference to order at 7:30 p. m. Song service led by A. J. Allen; prayer offered by F. L. Wright.

- J. L. Benton, who was appointed to preach the opening sermon, takes charge of service. C. E. Hill is called upon to lead the conference in prayer. J. L. Benton reads from 4 ch. of 2 Cor. and preached from 1 of Rom. 15th verse "As much as in me is, I am ready to preach the gospel to you that are at Rome also."

ADDRESS OF PRESIDENT.

Dear Brethren:—Under the blessing of God we are permitted to come together for our sixty-fifth annual gathering. God has indeed marvelously watched over us as we are privileged to write the record the same as we did at the close of the last conference year; that the ministerial ranks of the conference have not been broken by death entering therein. While this is literally true yet we mention here the going home, during the year, of one who for years was a member of the conference and intimately associated with the conference work. Just the year of the recent past being a member of the Syracuse Conference. But during the early weeks of this conference year the body of Rev. N. E. Jenkins was laid to rest within our conference bounds at Morley, N. Y.

During the year we have had no regular conference evangelist in the field; the main reason being that we were short of ministerial supply for all of our charges. Notwithstanding our being deprived of the help a good conference evangelist might render, our pastors alone, or with other help they might secure, have, under the blessing of God, pressed the battle along evangelistic lines of service with the result of many encouraging reports coming in from different fields of the power of our God being displayed in the salvation of souls and the sanctification of believers.

We believe that the annual camp-meeting at West Chazy is proving very helpful in reaching unsaved ones, and in a great measure a help in developing the deeper spiritual life in those who avail themselves of the privilege of worshipping there for 10 days of the year; and again we urge that special effort be made and plans laid long in advance of the coming August meeting so that when we come together for that meeting every charge may be represented and if possible every Elder and Licentiate of the conference be present. For while at home on our charge we have the Master with us and his wonderful help. Bless His name forever. Yet at the camp-meeting with a concentration of forces and special laborers and teachers to help, and then the Holy Ghost revealing himself gloriously to hearts, there comes the mighty pentecostal power, and a blaze of scriptural holiness be kindled that shall reach out to the remotest boundary of the conference wherever those shall go who have experienced the cleansing power and know the Holy Ghost reigns without a rival.

This is not a time when there should be a decline in spiritual life and power, but a time when if we desire the prosperity of Zion and are as we profess to be, a Holiness people, we shall go forward under the banner of our King unfurling the banner of Holiness unto the Lord and tenderly seeking to lead men into an experience of scriptural holiness which once experienced and retained makes of finite creatures mighty forces in the hand of God to help in the building up of the Christian church.

I quote from a recent article from President A. M. Hills as follows: "In 1824 the bishops in their conference address said, "If Methodists give up the doctrine of Entire Sanctification or suffer it to become a dead letter, we are a fallen people. Holiness is the main cord that binds us together, relax this and you loosen the whole system. This will appear more evident if we recall to mind the original design of Methodism. It was to raise up and preserve a Holy people. This was the principal object which Mr. Wesley had in view. To this end all the doctrines believed and preached by the Methodists tend."

If this was true in 1824 it is as true today and it be-

hooves us to be alive to the highest interests of men and of the church.

Dr. Torry in a recent sermon in Philadelphia said, "What is needed by Christian people of Philadelphia is the fire of the Holy Ghost to give them a passion for soul winning."

While on all of our fields there are those with a Heaven born passion for winning souls, doubtless much greater results in soul winning would come if a greater number should come into the experience of Entire Sanctification.

But there are other desirable results that would follow: there would be such a willingness to help on the Lord's work that no one would think of giving less than one tenth and some much more for the cause. I notice Dr. Torry says in the same sermon quoted from above "That churches that conduct fairs, bazaars, card parties, and other entertainments to raise money, bring down the church of Jesus Christ to the level of a vaudeville show." One of the presiding elders in the northern New York M. E. Conference in giving the report of his district at their conference in Utica last week said, "In my estimation an increase of 30 per cent in the salaries of pastors could be made if the officials would use modern business methods. Some of the younger ministers he said are receiving starvation wages." We do not believe any of our charges are in methods of raising finances that have very close kinship to vaudeville shows; and we hear none of our pastors complaining of starvation rations nor looking as if they had that experience. But we are sure some of our pastors could conveniently and consistently use to good advantage more salary if it was secured on Bible lines; and we are sure this increase could and would come and all church benevolence be much increased if business methods shall prevail, instead of but little if any method. This leads to the presentation of at least three recommendations.

1st. We recommend that the charges of the conference that have not already done so adopt the envelope system, especially for the payment of pastor's salaries; and by this we do not mean simply putting envelopes in the church for use but a regular canvass and systematic weekly giving as we can explain if desired.

2nd. All doubtless are aware of the seeming need of a

medical missionary on our foreign field, and doubtless have noticed the article of Sister Manwell, President of the General Conference Woman's Home and Foreign Missionary Society in Wesleyan Methodist of April 11th in which she says, "The Executive Board of that society have decided to undertake the education of a person for that work and make an apportionment of \$300 for this year." We already have a Conference Society organized and recommend that each local church or charge organize themselves into Local Societies and as auxiliaries of the Conference Society as provided page 147 chapter 3.

3rd. It has been apparent for some time that it would be very helpful at times to some church incumbered with debt or in the erection of churches or parsonage property if there had been a church extension fund in the conference from which some help more or less according to the condition of the treasury could have been given. Therefore we recommend that this session of the conference provide for the creation of a conference church extension fund.

In concluding this address I urge upon our charges and pastors that as speedily as possible without undue haste, which might do harm, we may work successfully a uniform, systematic, Godly method of church finances which shall Iring great benefit to conference and connectional benevolences, rich blessing on pastors and charges and glory to our God. now closing by reverting to the subject of the first of this address which is of first importance, the salvation of our fellow May the year before us be a fruitful one in our seeing through the presentation of an uplifted Christ and the pleading, prayerful travail of the church; a blessed ingathering of those who never knew our Christ. And then let us pray that this year may find the number of those who shall come into the blessed experience of entire sanctification increased by many fold over any previous year in the history of the Champlain Conference. What an impetus would be given to the work in our conference during the year should we see a goodly number pressing into this blessed experience. And God's ministering servants shall be helpful instrumentalities in securing these much to be desired results, as they preach the doctrine of Heart Purity, the baptism with the Holy Ghost which gives blessed fitness for service; and in the presentation of this grand old doctrine the best results shall be obtained only as in its presentation it is divested of everything that borders over on the land of fanaticism, or that on the other hand reaches out for the plains of One to compromise with the world. But going forth in the middle of the King's highway of holiness, remembering "that love behaveth not itself unseemly," may our lives be living examples of the salvation that saves, sanctifies and satisfies.

REPORT NO. 3

Report of Camp-Meeting Committee.

Your committee beg leave to submit the following report:

1st. That a meeting of the committee was held in the month of June to take into consideration the advisibility of bulding a boarding-house on the grounds. Decided to build and fixed upon the location.

2nd. The camp-meeting was one of the best ever held, Rev. E. W. Bruce rendering excellent service all through; Rev. A. T. Jennings and Rev. J. H. Bowen adding much to the interest of the meeting by their presence and help during the last few days of the meetings.

3rd. There was raised for camp-meeting purposes \$418.00. Of this amount nearly \$200 was paid for erecting boarding-house and the balance was paid for help outside the conference, and other necessary expenses.

4th. The committee also report the engagement of Rev. A. P. Jennings for the entire time of the camp-meeting for August 15th to 26th, 1906.

5th. We recommend the election of a new camp-meeting committee who shall take their office September 1st, 1906; we recommend that Rev. A. P. Lienard, A. N. Bedell, Stephen Stiles and Walter Stratton be added to the present committee.
