Journal of Daily Proceedings.

FIRST DAY — MORNING SESSION.

The forty-ninth annual session of the Indiana Conference of the Wesleyan Methodist Church of America convened in the Wesleyan Methodist Church at Bryant, Jay county, Indiana, September 15, 1897, at 8 o'clock a. m., with the president, Elder E. Teter, in the chair.

The opening religious services were conducted by Elders T. P. Baker, J. L. Fall, W. L. Northam and L. L. Folger.

The roll of elders and licentiates on the stationed list were called. Delegates presented their certificates, and their names were added to the roll, as delegates. (See Conference roll.) The roll call was then completed.

The supplementary minutes were read, and adopted by the Conference. They include the official work of the president during the interim of conference, and are as follows:

First. Accepted the resignation of Rev. J. W. Brown as missionary superintendent for the Indiana Conference. No one appointed to fill the vacancy.

Second. Appointed M. G. O'Brien as pastor of the Peru churches.

Third. Accepted the resignation of B. H. Hine as pastor of the Roseburg charge, and supplied the same through C. A. Billheimer.

Fourth. Upon the recommendation of the first quarterly conference of Strawtown circuit, appointed S. B. Castor as pastor for Strawtown circuit, and M. M. Worth pastor at Fountain City, Ind.

Fifth. Gave Elder E. Guthrie a letter of standing, and he has joined the Central Ohio Conference.

It was voted to make the seats between the pulpit and the stoves, the Conference bar.

Elders W. J. Seekins, G. W. Zyke and A. Worth were elected a committee on religious services.

The following were elected a committee on pastoral relations: E. Teter, chairman ex-officio; J. W. Brown, W. J. Seekins, T. P. Baker, J. W. Zyke, W. B. Ballinger and J. K. Rodeman

It was voted to make the election of conference officers the order of the day immediately after devotional services Thursday morning. It was voted to make the time following the election of officers the order of the day for the election of Conference trustees.

Elders W. J. Seekins, J. J. Coleman and J. O. Baker were elected a committee to fill vacancies during the year.

A committee was elected to devise and report to Conference plans for missionary work for the coming year: W. J. Seekins, W. L. Northam, T. P. Baker, W. B. Ballinger, J. W. Zyke, J. K. Rodeman were made members of the committee.

It was voted to open the sessions of conference at 8:30 a. m. and 1:30 p. m., and to close at 10:30 a. m. and by vote in the afternoon.

Brother W. J. Seekins read a paper concerning missionary work for the ensuing year, which was referred to the proper committee.

The order of the day was taken up, and the name of Elder G. K. Babcock was called and his character passed.

It was voted to repeal the resolution of the previous year, requiring a vote to pass the character of a pastor who failed to urge the dollar plan, owing to the fact that the discipline covered the ground of the resolution.

Conference adjourned by limitation.

Benediction by Brother W. G. Moon.

AFTERNOON SESSION.

Conference convened at 1:30 p. m.

Devotional services were conducted by Elder G. Reber.

The roll was called and corrected.

The minutes of the forenoon session were read and approved.

Elder W. J. Seekins offered the following resolution, which was adopted by the Conference:

WHEREAS, The next annual session of our Conference will be the fiftieth since the organization of the Conference, we believe some fitting service appropriate for the semi-centennial anniversary of our existence will be to the glory of God, and serve as an impetus in commencing the second half of the century of our Conference existence. Therefore,

Resolved, First. That our next session of Conference be held on the grounds of our Camp-Meeting Association immediately following our annual camp-meeting, which shall close so that the conference shall convene on the first Monday after the fourth Wednesday in August, 1898.

Second. Brother A. Worth being the oldest member of the conference in active service, and eminently fitted, preach the opening sermon at 10:30 o'clock a. m. of the first day of the session.

Revs. W. B. Hogan, formerly of the Miami conference, and J. B. Cook, of the M. E. Church, were introduced to the Conference.

Revs. J. O. Baker and L. L. Folger were elected a committee on statistics.

The committee on missionary plans were excused to attend to the work assigned them.

The order of the day was resumed, and the names of Elders J. O. Baker, T. P. Baker, C. A. Billheimer, A. L. Blake, L. H. Carter, R. Carter, J. J. Coleman, B. L. Couch, J. L. Fall, D. F. Gordon, B. H. Hine R. Jeffrey, L. L. Folger and J. F. Pressnall were called and their character passed.

The following resolution was offered by W. H. Kennedy, and adopted by the Conference:

WHEREAS, No person can be a member of the Indiana Conference who is not a member of some local society; therefore,

Resolved, That should Elder S. Bloomer present to this Conference or its President a certificate of his

membership in some local society of the Wesleyan Methodist Connection within sixty days, his name shall continue on the Conference roll; failing to do this his name shall no longer appear on the Conference minutes.

A collection was taken for Brother Bloomer.

The committee appointed to devise a plan of missionary work made its report. The report was referred back to the committee for reconsideration.

It was moved to reconsider the order of the day for Thursday morning, and the election of officers was made the order of the day immediately after the report of the committee on missionary plans.

On motion Conference adjourned. Benediction by Rev. J. W. Brown.

SECOND DAY—MORNING SESSION.

The Conference opened with divotional services led by D. F. Gordon.

The roll was called.

The minutes of the previous session were read, corrected and approved.

Rev. Lee, of the Miami Conference, was introduced to the Conference and voted a seat within the bar. The motion was made to include others who might be introduced, who were eligible to the same courtesies.

The order of the day was called for and the committee on missionary plans made its report. The report was adopted item by item. See report No. 1.

Rev. Smith, pastor of the Luthern church, was introduced to the Conference.

On motion Conference adjourned. Benediction by Elder C. F. Wiggins.

SECOND DAY—AFTERNOON SESSION.

Conference opened with singing and prayer by C. S. Smith.

The roll was called and the minutes read and approved.

The report of the committee on missionary plans was amended by adding item number ten to the report. (See report).

The following persons were recommended to the an-

nual Conference as suitable persons to be received to travel under its direction, and their petitions were referred to the committee on Itenerancy and Elder's Orders: F. G. Walter and J. Schell, of the Bryant circuit; Lydda Weaver, of the Salimony circuit; D. E. Mullen, of the N. C. and B. R. circuit; H. C. Brown, of the Strawtown circuit, and J. K. Rhinesmith, of the Ligonier circuit.

The president presented a memorial from Rev. R. L. Fisher, and the following statement was ratified by the Conference: R. L. Fisher having been received by the local society at Westfield as a local elder, having been formerly ordained by this Conference, it was voted that he be received by this Conference as an elder on the un-stationed; and having lost his parchments, the secretary is instructed to issued a duplicate of the same.

It was moved to elect a committee to draft resolutions of respect in memorial of Estella McClure and A. Teter. W. G. Moon, J. W. Brown and M. M. Worth were constituted members of that committee.

Rev. C. S. Smith called for the order of the day—the election of Conference officers. A. Carter and G. W. Felton were appointed tellers.

The Secretary was instructed to cast the ballot of the Conference for E. Teter for president.

E. Teter declared elected.

The president was authorized to cast the ballot of the Conference for J. J. Coleman for secretary.

J. J. Coleman declared elected.

It was moved to elect three Conference Evangelists. The motion was laid upon the table.

The Conference authorized the secretary to cast the ballot of the Conference for E. Teter for the first Evangelist.

E. Teter declared elected.

A. Worth, W. L. Northam, C. S. Smith and G. Reber were nominated for sceond Evangelist.

The first ballot resulted in no election.

Upon the second ballot, A. Worth receiving a majority of the votes cast was declared elected.

The secretary was instructed to cast the ballot of the Conference for T. P. Baker for Missionary Evangelist.

T. P. Baker declared elected.

The secretary was authorized to cast the ballot of the Conference for J. W. Zyke and J. K. Rodeman for Conference trustees.

J. W. Zyke and J. K. Rodeman were declared elected.

Brief addresses were made by Brother Northam on retiring from the Evangelistic field, and from Brother Worth upon again consenting to enter the field he had labored in before.

A collection was taken for the expenses of the president. The amount of the collection being \$16.65.

It was moved that the Conference Evangelists in order to visit all the circuits be empowered to hold mid-week meetings when necessary, or call others to their aid.

A collection was taken up for the expenses of the secretary. Amount, \$10.

Elder D. C. Linville, formerly a member of the Conference, was introduced to the Conference. The president stated that Brother Linville had taken a letter of withdrawal from the Conference several years ago, had labored for other churches since then, but had returned to God, and was now ready to enter the Indiana Conference with his letter of dismissal and parchments if the Conference wished to receive him.

The Conference voted that his parchments be accepted, and that his name be placed upon the roll.

The secretary read a petition from the Roseburg and Sweetzer churches asking that they be annexed to the Fairview or Hartford City work, and to be supplied with preaching accordingly. On motion, this petition, with all similar papers that might be presented, was referred to the committee on pastoral relations.

The order of the day was resumed, and the names of Elders J. W. Brown, W. L. Fall, W. H. Kennedy, W. G. Moon and G. Reber were called, and their character passed. On motion Conference adjourned.

Benediction by W. J. Seekin.

THIRD DAY—MORNING SESSION.

Conference convened with the usual form of devotional service, conducted by Rev. W. B. Hogan.

The roll was called.

The minutes were read and approved.

A certificate was read from the Strawtown charge recommending S. B. Castor as a suitable person to be received to travel under direction of the Conference.

Rev. W. T. Loring, of the Free Methodist church, was introduced to the Conference, and made an honorary member of the body.

A communication was received from H. R. Jeffrey, of Mississippi, sending greeting to the Conference.

The order of the day was called for, and the names of Elders W. L. Northam, W. J. Seekins, L. Shatford, C. S. Smith, E. Teter, L. Tice, M. M. Worth, and G. W. Zyke of the stationed list, J. E. Jordan and E. H. Kennedy, of the licentiates, on the stationed list, were called and their character passed.

Conference adjourned by limitation.

Benediction by D. C. Linville.

THIRD DAY—AFTERNOON SESSION.

The Conference convened at the call of the president, and was led in worship by A. Carter.

The roll was called.

Minutes of previous session were read and approved.

Rev. W. J. Seekins presented a paper recommending to our churches a financial plan for carrying on their local interests. The plan was adopted by the Conference. (See Report No. 2).

It was voted to make the hour of 3:30 this afternoon the order of the day to hear from Rev. W. H. Kennedy, our general missionary secretary, concerning the interests of the work.

The hour of 9 o'clock a. m., Saturday, was made the order of the day to hear from Rev. A. W. Hall, our connectional agent and secretary.

The order of the day was resumed, and the names of Emma Phares, S. B. Castor, S. A. Mow, M. G. O'Brien, T. J. Pierce and Anna Linville, of the licentiates; A. Worth and J. Hester, of the elders on the stationed list; W. Bartholomew, H. Beber, S. Gettig, J. Matheny, J. B. Shadle and W. Talbert, of the elders on the unsta-

tioned list, and of C. F. Wiggins and M. More, the superannuated elders, were called and their character passed.

The order of the day was called for, and Brother W. H. Kennedy addressed the Conference concerning the interests of our general missionary work. He spoke of the spirit of true mission work, of the prosperity of our work in the south, in Canada, and in Africa, and we trust the Conference was quickened to realize more clearly the importance of the cause of missions.

On motion Conference adjourned.

Benediction by W. H. Kennedy.

FOURTH DAY—MORNING SESSION.

Conference convened at the usual hour, and was led in devotional service by Mrs. Esther L. Dickey.

Roll was called.

Minutes were read and approved.

The committee on Itineracy and Elders' orders made its report. Their report was adopted. (See Report No. 3).

Rev. W. H. Kennedy offered the following resolution:

WHEREAS, A call to the ministry of the Gospel is paramount to all other duties or obligations; therefore,

Resolved, That any candidate for Elders' Orders, or to travel under the direction of this Conference, who fails to attend the institutes and examinations of the Conference without sufficient cause, shall be deemed unworthy of the trust and care of souls, and refused a place among us as a minister of the Gospel.

Rev. T. P. Baker was elected to fill the vacancy in the committee on itineracy and orders.

Rev. T. P. Baker tendered his resignation as Missionary Evangelist. It was voted to receive his resignation, and that the employment of another be left to the Missionary Board.

The order of the day was called, and our connectional agent, Brother Hall, addressed the Conference in the interests of our educational and publishing interests. The former was urged as demanding our highest support in view of the blighting influences going out from many so-

called Christian colleges. An appeal was made to the Conference in behalf of the Wesleyan Methodist, our church organ.

Conference stood adjourned by limitation.

FOURTH DAY—AFTERNOON SESSION.

Religious services were conducted by Brother W. L. Northam.

Roll was called.

Minutes were read and approved.

Hon. H. S. Bonsib, of Lafayette, was introduced to the Conference, and offered the following resolution which was adopted by the Conference:

“With the facts staring us in the face that the liquor traffic is searing the conscience, blighting the morals, corrupting the politics of our nation, and causes more than a million men to fill drunkards graves and a drunkard's hell annually, we the ministers and delegates of to the Indiana Conference now assembled, do hereby resolve to preach, pray and vote against this home-blighting, God-defying institution and the parties that uphold it. We urge upon our membership to be free from criminal indifference, and to practice righteousness at the ballot-box as well as at the prayer meeting. And, as a settler of national, state and local questions, we recommend the initiative and referendum as a safe, just and equitable measure.”

The committee on memorials made its report. Report adopted. (See Report No. 4).

The committee on statistics made its report. Report adopted. (See statistical table).

Brother W. H. Kennedy offered the following resolution: In view of the hearty, bountiful and courteous entertainment afforded to the members and visiting friends of the Indiana Conference, we the members of said Conference do hereby extend to the members and friends of Bryant circuit, and the citizens of the place, our hearty thanks, with a prayer for the blessing of God to rest upon them while life shall last.

A collection was taken to pay for printing a thousand copies of the financial plan. Adopted by the Confer-

ence. Amount of collection, \$3.36, of which \$1.21 was donated to the minute fund.

The Woman's Home and Foreign Missionary society made its report. Report adopted. (See Report No. 5).

Rev. W. G. Moon, of the Salimony circuit, presented a paper upon Sabbath Schools, the sentiment of which, that our pastors should look earnestly after the needs of the children in our Sabbath School work, was adopted by the Conference.

The committee on pastoral relations made its report. Report adopted. (See Report No. 6).

The Board of Trustees made its report. Report adopted. (See Report No. 7).

Elders J. Hester, A. Worth, W. J. Seekins and J. J. Coleman was re-elected a judicial committee.

The president made the following ruling touching membership and church trials, which was adopted by the Conference: No person who has not been received into a church by a vote of the church, is a member of the church. And where the church has sought to try and expel such members, all such action is void for want of jurisdiction.

The former basis of apportionment for Evangelists' salaries and minute money was adopted by the Conference.

The disciplinary questions and answers were read. (See Report No. 8).

By unanimous vote of the Conference, independent of the action of the committee on Itineracy and Elders' Orders, Sister Sarah Kennedy was elected to the office and work of an elder in the Wesleyan Methodist church.

On motion Conference adjourned.

Reports of Committees.

REPORT NO. 1.

MISSIONARY PLAN.

WHEREAS, The missionary interests of our Conference for the past few years have been more or less vacillating, and there is not being accomplished what might be if wiser plans were formulated and the work put upon a different basis. Therefore,

Resolved. 1. That the office of Missionary Superintendent be abolished, and that the Conference Board of Trustees have the charge and oversight of all missionaries elected to mission work by the Conference, and of all missionary work done by them.

2. Let all missionary work, as much as possible, be done in connection with our circuits, and where churches are organized that they become a part of such circuits and to be cared for by the pastors of said circuit either in person, or by local help, or both.

3. Where missionary work is done so far from any circuit that churches here organized cannot be cared for by any circuit or church, that the missionary opening up said work shall stay there during the year and make that and the surrounding country his field of labor.

4. Where missionary fields warrant the labors of a regularly elected missionary by the Conference that are in reasonably close proximity to a circuit or church, and said circuit or church secure the labors of a missionary, they shall become responsible for the salary of said person, and all money so paid shall be considered missionary money, and so reported to Conference. If said circuits shall fail to remunerate said missionary for such services

there rendered, the Missionary Board shall consider, upon proper application, any bill presented to them, but not be obliged to pay the same unless its judgment it is proper to do so.

5. Regularly elected missionaries shall be paid at the rate of \$400 per year for time employed outside the jurisdiction of already organized circuits or churches except mission points.

6. That all persons appointed to already established missions who do their best to make them self-supporting, but fail, shall present their case, or have it done, to the Board of Trustees at either a called or regular session, who shall take said case under advisement and shall pay such amount as in their judgment is proper, but in no case shall the missionary funds be overdrawn by appropriations.

7. That we believe God's glory and the interests of the work safely warrants us in electing a Missionary Evangelist for the coming year, and said missionary to labor under the direction of the Missionary Board.

8. All applications for the labors of the missionary shall be made to the Missionary Board, and pastors and circuits shall keep the Board informed of fields opening up for missionary work.

9. That all rules of the Conference conflicting with these resolutions be repealed.

10. In case the work demands more missionaries than the Conference elects, that the Conference Missionary Board have the power to employ them and make agreement with them for service and salary.

REPORT NO. 2.

FINANCIAL PLAN.

WHEREAS, Through a lack of systematic giving and the inauguration of plans leading to this end, the interests of God's cause committed to us as a people have suffered in these in local and general interests, the cause reproach; many of our pastors hindered in their work, and sometimes suffer from lack of support.

Therefore, be it Resolved, That we adopt the follow-

ing plan and have the pastors bring it before their charges for their adoption. The Conference Evangelists to co-operate with the pastors in getting the plan into operation.

Section 1. Let the church through its Board of Stewards decide the amount necessary to be raised for the pastor's support and incidental expenses of the church for the year, and apportion said amount to the membership of the church as follows:

1. An assessment of two dollars to each member of the church.

2. The remaining amount necessary to be raised to be apportioned to the members according to their ability to pay.

Section 2. At the close of the year, let the stewards in their report to the church state who are delinquent, and the cause of the same; and if because of inability they did not pay, let said obligation be cancelled by the church, but if any member willfully refuses or neglects to pay his apportionment and have ability to do so, the obligation shall not be cancelled, but be held by the church as an obligation until paid.

Section 3. No persons shall be elected to any office of trust in the church who are delinquent—said delinquency not having been cancelled but stands against them as above described—and this shall be sufficient reason to withhold a letter of standing, if application should be made for such.

Section 4. Where persons refuse for two years to meet their obligations to the church and have ability to do the same, such offense shall be considered a violation of the church covenant and a neglect of duty as taught by the Scriptures and our book of discipline.

REPORT NO. 3.

ITINERACY AND ELDERS' ORDERS.

We, your committee, recommend Belle McClure, H. T. Hawkins, E. H. Kennedy, C. M. Keys, T. J. Pierce, J. Zeller, J. E. Jordan, Anna Linville, Frank Roberts, M. G. O'Brien, S. A. Mow, Sarah Kennedy, S. E. Phares, F. G. Walter, B. F. Baldwin and H. C. Brown

as suitable persons to travel and take work under the direction of Conference.

We also recommend that J. K. Rhinesmith, A. J. Kearney, W. F. Ridgeway, M. V. Sears, F. W. Newton, N. A. Hay, S. B. Castor, J. A. Shell, D. E. Mullen and Lydia Weaver pursue the course of study preparatory to instruction in same.

We also recommend that an institute be held for oral examination in the spring, and a written examination be held just before Conference in the fall.
