### STANDING RULES

1. The Conference year shall begin on July 1 and close on June 30. Local Church and Auxiliary Treasurers shall close their books on June 15 and only funds received by the Conference Treasurers on or before June 22 will receive credit. All Conference Treasurers of Auxiliary Organizations shall immediately close their books; disburse funds and forward a report in full to the Annual Conference Treasurer by June 30.

2. The Conference Secretary shall mail one copy of the Pastor's statistical Report for each charge with budget assessment from the Senior Conference and Auxiliary Organizations to the Pastor and the second copy to the Conference Treasurer. The Conference Treasurer will fill in the total budget receipts paid for each assessed item for each Church, sign the copy and mail it to the pastor of each charge by July 7. The pastor shall complete the signed report and mail it to the Chairman of the Statistical Committee by July 12.

3. The Pastor's Conference Sunday School Report shall be sent to the Sunday School Secretary not later than ten days prior to Annual Conference.

4. The Secretary of the Canada Conference shall be the Committee on Credentials and all Lay Delegate's Parchments to Conference shall be mailed to him one week previous to the opening session of Conference.

5. The Annual Conference and Adult Camp shall close on the Sunday immediately preceding the Civic Holiday in August.

6 The Conference President and his Advisory Board shall annually appoint a Nominating Committee of seven who will present at the Annual Conference a slate of nominees for all Conference officers and Standing Committees.

7. The President with his Advisory Board shall be a Committee on Orders of the Day and Religious Services during Conference.

8. The Conference President shall be Record Clerk.

9. The Ministerial Member of the Houghton College Board shall also be Conference Education Secretary.

10. The ex-officio members of the Board of Directors and Conference Trustees shall be the Conference President, the Vice-President, the Conference Treasurer and two elders, namely, the Conference Secretary and Youth President, if an elder.

11. The only items of the Pastor's Statistical Report to be read on the Conference floor are as follows: Item 1—Appointments; Item 2—Wesleyan Methodists, Wesleyan Missionaries, Wesleyan Youth; Item 3—Present Total Membership, loss or gain, number of family altars; Item 4—Total number in Main School, average attendance; Item 5—to be read in full; Item 6—to be read in full; Item 7—to be read in full; Item 8—Total for Church; Item 9—to be read in full; Item 10—Total for benevolence; Item 11—to be read in full.

12. All reports to the Annual Conference are to be made out in triplicate. Two copies to be given to the Conference Secretary and one to be retained by the individual reporting.

13. The Conference Treasurer shall be given \$100.00 per year and the Conference Secretary \$50.00 per year for their services.

14. The Pastoral vote shall be completed by June 1.

15. Churches calling pastors are to pay their moving expenses.

16. The third Sunday in August shall be the final Sunday for all Pastors who are moving from their present charge.

17. The churches shall grant each pastor two week's vacation with pay at a time agreeable to the pastor and congregation.

18. The Canada Conference of the Wesleyan Methodist Church of America, having become a part of the Superannuate Pension Plan of the Wesleyan Methodist Church, will not feel any obligation to any of the Conference Ministers or their families, where such ministers retire because of physical inability, or, in case of death, to support their widows or children, if said ministers have neglected to become members of the Superannuate Pension Plan, whose laity make provision for such periods of need. All members of the Superannuate Plan are to make their payments on assessed incomes and file reports according to regulation.

19. Those who travel on Conference Assignments, or to Conference gatherings where travelling expenses are remunerated, the following will be observed:—

(a) Where possible and convenient clergy rates will be paid.

(b) The expenses of meals, room and when necessary travel to and

from trains.

(c) When it is judged best to travel by train where one has come by car, clergy rates will be paid.

(d) When travelling by car, a basis of five cents per mile will be paid.

20. Churches having business with the Board of Directors and Conference Trustees requiring a visit of that body to their Church, shall be responsible for the expense attached to such calls, unless released by the Board.

21. The Committee on Itinerary and Orders shall decide on those who shall receive the benefits of payment of our Conference Educational Budget.

22. That a Conference Camp preparation period be held during the week previous to Annual Conference and that all pastors and as many laymen as possible cooperate in getting the grounds and buildings in readiness for use.

23. The Camp Meeting Committee shall be composed of;—The Camp Meeting Chairman; The Conference President; and his Advisory Board; President of Wesleyan Youth; President of Women's Missionary Society and the Camp Treasurer.

### CONFERENCE PRESIDENT'S ANNUAL REPORT REPORT NO. 1

To the members of the Sixty-fifth Annual Conference of the Wesleyan Methodist Church of America in Canada, we greet you in the Name of the Lord Jesus Christ.

The words of the great Apostle express our thoughts on this opening day of Conference, "We are always thankful for you all, for we never forget that your faith has meant solid achievement, your love has meant hard work, and the hope that you have in our Lord Jesus Christ means sheer dogged endurance in the life that you live before God, the Father of us all. We know that God not only loves you but has selected you for a special purpose. You have become a sort of sounding-board from which the word of the Lord has rung out . . . ." (I Thess. I Phillips)

If the statement made by Dr. Billy Graham, "God may be allowing us to view the conclusion of an age—for Christians are losing the world and losing it fast," is right, then we have time only for "hard work," "dogged endurance" and faithfulness in proclaiming the message of Salvation. We have been left "in trust with the Gospel." May God help us to be faithful stewards.

It is with a feeling of deep gratitude to the Almighty God for His sustained help that we present the accounting of our labours for the year. As our Official Acts will show, we have endeavoured to carry out the work assigned us by last Conference. All of the churches were visited at least once, some a number of times, or as the need arose. The fields in which we are interested in opening a mission work were visited several times.

This included in some instances a number of family calls.

One of the highlights of the year was a week in November devoted to church visitation and District Rallies, with a focus on Church Extension. The messages given by the Rev. Virgil A. Mitchell, Secretary of Church Extension and Evangelism, were not only inspiring but enlightening and challenging.

Another highlight was the tour of the conference by the Rev. and Mrs. Paul Dekker. While the tour was sponsored by the W. M. S., yet we would pause to give praise to God for all that was done in the interest of World Missions.

The conference-wide day of prayer held in the Ottawa Wesleyan Methodist Church, on March 27, was a memorable occasion. All but two of the pastors were present for the day of prayer and intercession for the work of the Church.

The Quadrennial Ministerial Institute, held at Houghton, N. Y. March 5—8, was attended by most of the pastors. The inspiration, fellowship and challenge derived by all shall not soon be forgotten.

While our accomplishments for the year are measurably insignificant in comparison with the immeasurable task before us, yet there have been gains, and for these we give praise to God. These gains, are reflected in our present full membership, and average attendance in the various organizations of the Church. The fact to, that much of the ground work has been laid for the opening of a new work, and an option to purchase a lot for a second new work is cause for much rejoicing.

We cannot refrain from mentioning the material progress which has been made. This includes major renovations to the Powassan and Winchester churches, and a considerable amount of work done to the Campbell's Bay Parsonage and Church. Improvements have also been made on other church properties, such as interior decorating, new heating units, roofs, etc. Our church properties are, for the most part, a credit to the Conference.

The assistance of Mrs. Spearman and the Rev. Nancy White, who have given sacrificially of their time to the work of the Lord, has made it possible for us to pastor the Belleville Church, as well as discharge our obligations to the Conference. I would also make mention of the cooperation and assistance given to us by the Vice-President, the Rev. R. L. LeRoy; Dr. E. W. Dow, the lay member of the Advisory Board, all Conference Officers and Officials, and in fact, all fellow ministers. No finer Christian spirit could be found than that which exists among the pastors of the Canada Conference.

And now as we move forward into the closing year of this Quadrennium, may I again remind you, that true love for Christ will mean "hard work" and "dogged endurance in the life which you now live before God." With cooperative effort under God, we can make it a year of marked progress, both spiritually and numerically. May God help us, our "calling to fulfill."

It has been a pleasure for Dr. E. W. Dow and me to attend all the meetings of the Local Board of Trustees of Houghton College and Houghton Academy during the past Conference year.

To represent the interest of the Conference in the denominational education programme is an honour weighted with responsibility. In this day when the demand for well-equipped young people to step into places of responsibility in the fields of science, industry, education and Christian education, Houghton College is in the front line helping to meet this demand.

We ought not as a Conference underestimate the value of Christian education which is spiritual and, at the same time, scholarly. This combination is found at Houghton. **REPORT NO. 15****SUPERANNUATION PENSION PLAN COMMITTEE**

We, the Conference Committee on Superannuation Pension Plan, submit the following report for your consideration.

In view of the present de-valuation of our Canadian dollar, your Chairman and Treasurer, made request to Dr. H. K. Sheets, General Treasurer, to find a solution to save us from having to ask an extra ten percent (10%) on church budget payments on this item. The amount our beneficiaries receive in 1961-62 is the total amount of our Conference Superannuation Pen-

sion Budget. We suggested the paying quarterly of our beneficiaries from the Canadian Office. This matter was presented to the Board of Administration, and they have made the following suggestion for the decision of this Conference now in session.

"After viewing the matter from all angles, it appears that the best course would be for you to continue sending your payments to the Pension Office as you have in the past, so that all the regular procedures will not be interrupted. However, instead of sending individual checks from the Pension Office directly to the Canadian beneficiaries, a check for the lump sum could be sent to you, or the Conference Treasurer, based upon the action of your Conference which would so authorize."

I—We recommend that the cheque for the lump sum for the Canadian Beneficiaries be sent to the Conference Treasurer of the Superannuation Pension Fund, and the Canadian Pension Office Treasurer pay by cheque the Canadian beneficiaries.

II—We recommend that an additional \$2.00 be added to the Conference Pension Budget for each church for the Conference's Treasurer's expenses for this fund.

1. We recommend that the Conference consider and approve the establishing of a Special Fund for the opening of new locations. This fund is to be separate from the Conference Missions Funds. It is further recommended the form of raising these funds be by an envelope, Self-Denial Offering, taken monthly or bi-monthly in each local church, the proceeds to be forwarded by the Church Treasurer to the Conference Treasurer.

2. We recommend that Conference immediately take steps to float a 5% Bond issue maturing 5 years from date of sale. This money to be used by the Conference Trustee Board for Capital expenditure re Church Extension. We further recommend that all pastors give full consideration to the bringing and keeping this project before our people, so that pastors and people give full support to this urgent need.

3. We recommend that we continue to re-emphasize the doctrines of our church with particular emphasis on explaining, very simply, the experiences of Regeneration and Entire Sanctification.

Banker spoke of our missionary work saying that "missionary work is the biggest business of the world and of the church. We face the largest task the world ever faced with the tremendous increase in population. The birth rate of the Kingdom is not keeping up with the birth rate of the world. We are facing the strongest competition we have ever faced. There is a revival in heathen worship. They are copying Christian ways and approaches. When revival comes to the church they will send forth missionaries. People have given their lives before they will give up their religion. Some are in jail because they will not renounce the religion of the Lord Jesus. Evangelism will not bring revival but revival will bring evangelism. The Lord cannot use us to the full unless we're fully surrendered to Him. We need a daily filling of the power of God." The chorus, "Spirit of the Living God, Fall Fresh on Me" was sung once again and prayer offered by Bro. Banker. Mrs. Bertha Wilson closed the service with prayer.
