THIRD MEETING FRIDAY

Our meeting opened with song and devotions by Mrs. Galusha. The roll was called and the minutes read and approved.

The Auditing Committee reported the books to be correct. The report was accepted.

## THE CALIFORNIA CONFERENCE

11. It shall be the duty of the pastors to see that all property is properly insured. Failing to do so the Conference will insure it and in event of fire collect the moneys.

12. All persons applying for membership on profession of faith, or without letter of standing from another church of like faith, shall be received into an associate relationship. All persons, save those of unquestioned Christian experience, shall first be received into an associate relationship.

13. No person making application for membership on letters of dismissal shall be received until the impediments in the way of granting a letter of good standing shall have been removed by proper adjustment.

14. All persons, whether presenting a letter of standing or not, must first be examined by the proper committee before being received into the church. And in the event of any doubt as to the candidate's worthiness they shall be placed in the associate relationship.

15. The fiscal year of the Conference shall close two weeks before the opening date of Conference and the Conference Treasurer shall close the Conference books on that day.

16. All local preachers shall finish the course of study for Local Preachers before being recommended to the Annual Conference to pursue the Course of Study for Candidates for Elder's Orders. The examination on the course of study for Local Preachers shall be taken before some member of the Committee on Itineracy and Elder's Orders.

17. The President and his Advisory Board are to be the Board on Church and Parsonage Location.

18. The President and his Advisory Board are designated as a Deed Examining Committee for the Conference. When deeds to Conference, Church or Parsonage property are received, before being recorded, they shall be submitted to this Committee for examination, and the insertion of such disciplinary clauses as necessary to make the property safe for the Conference.

19. The Committee on Religious Services for the Conference shall be composed of President, his Advisory Board, the President of the W. H. & F. M. Society and the pastor of the entertaining church.

20. All pastors are required to subscribe to the Wesleyan Methodist and the Wesleyan Missionary.

Wm. Washburn was elected to fill the vacancy on the Statistical Committee caused by the withdrawal of Roy Cox.

A motion carried to adjourn.

## THE CALIFORNIA CONFERENCE

### STANDING RULES OF THE CALIFORNIA

#### CONFERENCE

1. The Conference shall convene at the call of the chair. The President shall announce the date of its meeting sufficient time before the opening in conformity with the desire of the Connectional Board.
2. As soon as possible after the last Quarterly meeting on each charge the pastor shall forward the Delegate's credentials to the Conference Secretary. The Secretary shall then compile the roll of the Conference to be ready for the opening of each session.
3. The quorum of this Conference shall be twenty-five per cent of its possible enrollment. Ministerial or Lay members of the Conference must not leave the bar of the Conference without consent of the chair, nor withdraw from the Conference session permanently without consent of the Conference.
4. The President of the Conference is authorized to appoint the Chairman of Sessions Committees and to announce the same not later than the first morning session of the Conference.
5. All recommendations to study, to travel, to receive Elder's Orders or to be received on credentials shall be handed to the Secretary as early as possible and he shall pass them to the proper Committee without vote of the Conference.
6. Pastors shall not drop any of their appointments without consent of the President and his Advisory Board.
7. All charges shall pay the moving expenses of the incoming pastor within the bounds of the Conference.
8. No charge shall call anyone as pastor, or to supply the work, from without the bounds of the Conference as long as there are ministers in the Conference qualified to take the work.
9. No local preacher shall supply a charge or be called to supply the same while there is a member of the Conference available.
10. While we believe in and will practice ministerial courtesies, yet it is the sense of this Conference that our churches shall not be opened to other denominations to maintain a regular appointment as such is likely to scatter the flock.

#### Report No. 7

##### RESOLUTIONS

We respectfully submit the following:

1. Be it resolved that we, the members of the California Conference, now in its 17th annual session, re-affirm our faith in the Bible as the inspired Word of God. It is the criterion of authority, though opposed by Satan, in this world of sin. We believe that all of it, from Genesis to Revelation, is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness, that the man of God may be perfect, thoroughly furnished unto all good works.

2. That we, as Wesleyan Methodists, assume the individual responsibility in being loyal to our God and to the Church by lifting high the standard of holiness; and to its periodicals by subscribing to the Wesleyan Methodist, the Wesleyan Missionary Magazine, the Young People's Journal, and our Sunday School literature that we might have a wider vision, and pray more effectually for the interests of the missionary and conference work.

3. That every pastor and delegate attend the annual conference and camp from the opening service throughout the sessions.

4. That our young people be encouraged to attend our church schools where wholesome instruction free from modernistic and erroneous teachings will be received; and that our Sunday Schools be distinctly holiness in doctrine, that our teachers present the Word of God to the students, affirming their hearts that it is God's Holy Book.

5. That we make the California Conference a subject of prayer this year, and earnestly ask God to deepen our spirituality, to unify us in Spirit and brotherly love, and to widen our borders of evangelism for the cause of Christ.
