REPORT NO. 10.

REPORT OF THE COMMITTEE ON RESOLUTIONS

We recommend that the Standing Rules be revised to read as follows:—

1. The Conference year shall begin on July 1 and close on June 30. Local Church and Auxiliary Treasurers shall close their books on June 15 and only funds received by the Conference Treasurers on or before June 22 will receive credit. All Conference Treasurers of Auxiliary Organizations shall immediately close their books; disburse funds and forward a report in full to the Annual Conference Treasurer by June 30.

2. The Conference Secretary shall mail one copy of the Pastor's statistical Report for each charge with budget assessment from the Senior Conference and Auxiliary Organizations to the Pastor and the second copy to the Conference Treasurer. The Conference Treasurer will fill in the total budget receipts paid for each assessed item for each Church, sign the copy and mail it to the pastor of each charge by July 7. The pastor shall complete the signed report and mail it to the Chairman of the Statistical Committee by July 12.

3. The Pastor's Conference Sunday School Report shall be sent to the Sunday School Secretary not later than ten days prior to Annual Conference.

4. The Secretary of the Canada Conference shall be the Committee on Credentials and all Lay Delegate's Parchments to Conference shall be mailed to him one week previous to the opening session of Conference.

5. The Annual Conference and Adult Camp shall close on the Sunday immediately preceding the Civic Holiday in August.

6. The Conference President and his Advisory Board shall annually appoint a Nominating Committee of seven who will present at the Annual Conference a slate of nominees for all Conference officers and Standing Committees.

7. The President with his Advisory Board shall be a Committee on Orders

of the Day and Religious Services during Conference.

8. The Conference President shall be Record Clerk.

9. The Ministerial Member of the Houghton College Board shall also be Conference Education Secretary.

10. The ex-officio members of the Board of Directors and Conference Trustees shall be the Conference President, the Vice-President, the Conference Treasurer and two elders, namely, the Conference Secretary and Youth President, if an elder.

11. The only items of the Pastor's Statistical Report to be read on the Conference floor are as follows: Item 1—Appointments; Item 2—Wesleyan Methodists, Wesleyan Missionaries, Wesleyan Youth; Item 3—Present Total Membership, loss or gain, number of family altars; Item 4—Total number in Main School, average attendance; Item 5—to be read in full; Item 6—to be read in full; Item 7—to be read in full; Item 8—Total for Church; Item 9—to be read in full; Item 10—Total for benevolence; Item 11—to be read in full.

12. All reports to the Annual Conference are to be made out in triplicate. Two copies to be given to the Conference Secretary and one to be retained by the individual reporting.

13. The Conference Treasurer shall be given \$100.00 per year and the Conference Secretary \$50.00 per year for their services.

14. The Pastoral vote shall be completed by June 1.

15. Churches calling pastors are to pay their moving expenses.

16. The third Sunday in August shall be the final Sunday for all Pastors who are moving from their present charge.

17. The churches shall grant each pastor two week's vacation with pay at a time agreeable to the pastor and congregation.

18. The Canada Conference of the Wesleyan Methodist Church of America, having become a part of the Superannuate Pension Plan of the Wesleyan Methodist Church, will not feel any obligation to any of the Conference Ministers or their families, where such ministers retire because of physical inability, or, in case of death, to support their widows or children, if said ministers have neglected to become members of the Superannuate Pension Plan, whose laity make provision for such periods of need. All members of the Superannuate Plan are to make their payments on assessed incomes and file reports according to regulation.

19. Those who travel on Conference Assignments, or to Conference gatherings where travelling expenses are remunerated, the following will be observed:—

(a) Where possible and convenient clergy rates will be paid.

(b) The expenses of meals, room and when necessary travel to and from trains.

(c) When it is judged best to travel by train where one has come by car, clergy rates will be paid.

(d) When travelling by car, a basis of five cents per mile will be paid.

20. Churches having business with the Board of Directors and Conference

Trustees requiring a visit of that body to their Church, shall be responsible for the expense attached to such calls, unless released by the Board.

21. The Committee on Itinerary and Orders shall decide on those who shall receive the benefits of payment of our Conference Educational Budget.

22. That a Conference Camp preparation period be held during the week previous to Annual Conference and that all pastors and as many laymen as possible cooperate in getting the grounds and buildings in readiness for use.

RECOMMENDATIONS

1. We recommend that a Conference Preparation Period be held during the week previous to Annual Conference and that all pastors and as many laymen as possible cooperate in getting the grounds and buildings in readiness for use. This is to become Standing Rule No. 22.

2. We recommend that the Missionary Board make a study of and take steps when deemed advisable toward the placing of a full time Conference President in the field as soon as possible.

3. We recommend that the Camp and Conference Entertainment assessment be changed to .50c per member to entertain guests at Conference and provide for the pastors, their wives and families, meals at half price during Camp.

We also recommend that the local Churches and their organizations pay for the room and meals of pastors, Church and Auxiliary Delegates during Conference session.

4. We recommend that we continue to fulfil the spirit and plan of Operation Outreach and that we continue to emphasize the first Friday of each month as a day of prayer and fasting for revival in our Conference.

The Corporate Body of the Wesleyan Methodist Church of America in Canada convened for its Sixty-fourth Annual Conference on Silver Lake Camp Ground, Maberly, Ontario, on Wednesday July 19, 1961.

CONFERENCE PRESIDENT'S ANNUAL REPORT

To the Members of the Sixty-fourth Annual Conference of the Wesleyan Methodist Church of America in Canada. Greetings!

Improvements and renovations in a number of our churches and parsonages have added to the general appearance of our properties. These accomplishments have provided expanded facilities for Sunday School and Church growth. We appreciate the vision of our Pastors and Churches in properly caring for the buildings which God has given to us.

It is needless to say that we are living in perilous times. I venture to say that there has never been a time in our Canadian history when sin was more insolent and aggressive as it is today.

While living in perilous times we also live in a day of tremendous chal-

lenge. Through the year, we visited a number of our cities and towns with the view of opening new Gospel centers. The surveys made, brought to light opportunities in the area of pioneer works.

An option to purchase a property, consisting of a comparatively new Church and parsonage, located in a new housing area in one of our larger cities was presented to the Board of Directors for their consideration. That which is done in this area will depend upon the further response of our people in donating the amount of cash designated by the Board and the availability of a pioneering pastor. It is my personal feeling that the growth and development of our Conference is entirely dependent upon what we do during the next two or three years in the area of pioneer aggressiveness.

Last October we assisted and supported the Rev. F. S. Irish in the opening of a new preaching center at Wasing, Ontario. Since this work is only 14 miles from Powassan, the pastor is able to include, as a second appointment, this new congregation with his Powassan Church. Here is an example of the type of ministry and vision which should challenge all of us as pastors of this Conference.

Among the highlights of the year was our visit to the Reformed Baptist Alliance and the Conference of the Pilgrim Holiness Church. Here we found a gracious bond of fellowship and good will. They are a people loyal to the doctrine of Wesleyan Methodism.

Another privilege was that of attending the Leader's Conference at Marion, Indiana, and being present for the dedication of our New World Headquarters.

In viewing the spiritual life of our Conference, it is my greatest concern that we be impassioned always by Divine love. We must have a God Possessed Church which can adequately meet an evil possessed generation. We must have a people within our Churches, so captured by a fresh vision of the Great Shepherd of Men, that they will give themselves unreservedly to this Holy Cause of reaching men for Christ.

I could not close without mentioning the many kindnesses and expressions of confidence of our people throughout the Conference. These have been a constant encouragement to us. Your fine spirit of cooperation has been one of the major factors in making the way easier.

And now, brethren, as we continue our pilgrimage into a new Conference year, let us reaffirm our unswerving faith and confidence in God, recommit ourselves unto His keeping, be willing to endure hard things, carry our cross with a smile, sacrifice our all and press forward attempting great things for God.

3. That we hold a joint Ministerial Fellowship this winter and extend an invitation to our fellow pastors of the Pilgrim Holiness Churches and others who may decide to cooperate in this fellowship.

4. That we study the possibilities of establishing a trust fund similar in nature to that of government approved retirement plans, in order to make possible liquid funds which could be used in the work of Church Extension.

5. That the Conference President and his Advisory Board appoint a Committee to nominate all Officers and Standing Committees for the Conference of 1962, and that the appointment be made before the rise of Conference.

REPORT NO. 7

CONFERENCE SUNDAY SCHOOL SECRETARY'S REPORT FOR 1960-61

It is apparent from the quarterly reports sent in, that a general increase in the Sunday School is evident. We praise the Lord for this. We believe that the interest and concern for our children is increasing, and because of this, we are seeing some results. This interest, whether it stemmed from the Pastor, Sunday School Sup't, Teacher or Children's Workers; makes very little difference, but a tremendous difference will be evident if the pastor will put his whole hearted support in the program of the Sunday School. If the pastors and sup'ts. will work together and plan visitation, personal contacts and good follow-up programmes, then others will tend to follow; thus making the efforts of more effect.

From the parable of the sower it is obvious that the world will never be completely converted. Not when only one seed out of the four produces results. Other Scriptures would bear this out: II Tim. 3:13; Matt. 24:37-40; Luke 17: 26-30.

However, we are nowhere commissioned to convert the world. Our duty is to evangelize. The Church is to evangelize a people for the Name of Christ (Acts 15:14). Our main objective is always the individual soul. If only one soul were saved from eternal hell, then the entire cost and effort of Sunday School would be worth-while. Jesus said He "must needs go through Samaria" to win one woman. Mark commands, "Preach the Gospel to every creature." Christianity is not a mass movement, it is rather a personal experience.

Many results begin with the individual sower, who journeys to the field where the seed has not yet been sown. Other results are obtained from new seed being sown in cultivated ground. There can be no salvation unless someone plants the seed. The Sunday School has taken up this phase of sowing the seed in the lives of the youth, and also through their lives have extended the message of salvation to the parents.

It has been my pleasure this year to visit some of the Sunday Schools of our Conference. To see the operations and become acquainted with the various teachers and officers of the local Sunday School was indeed a privilege. Some of the problems in Christian Education for children, which have existed for years, are becoming gradually lessened, while still there are others lingering on and eating away at the heart of the Sunday School like a giant cancer, with seemingly no effective cure.

Thus the challenge goes on as we labour for Him to combat the obstacles which confront us in our endeavours to win boys and girls to

Christ. The field is wide in scope, and ripe in harvest. The needs are endless, reaching to infinity; but the labourers are few, and tend to diminish. Thus we extend again the invitation to you to join in this warfare. If you enlist, the dividends will be great. Children will be saved. They could be your own.

REPORT NO. 13**REPORT OF THE EDUCATIONAL SECRETARY & HOUGHTON COLLEGE TRUSTEE****To the 64th Annual Conference:—**

It has been my privilege to attend every meeting of the Houghton Board of Trustees held during the past year. This Board meets every quarter in the office of the College President, Dr. Stephen W. Paine. The Executive Committee of this Board meets approximately every six weeks. I say this to point out the contact the various conferences have with the pulse of the School.

The function of this Board is very similar to that of the Annual Conference Board of Trustees. It then governs the financial and spiritual policies; approves or disapproves of policies set forth by local committees. For example, the questionnaire which every prospective teacher must answer and sign before being hired was thoroughly examined by this Board at its last meeting.

In the matter of building, the boy's dormitory is completed, and will be in use this coming Fall. Such a building is of absolute necessity in order to house properly the new students who are seeking entrance. In the Spring of 1962, it is hoped that sufficient funds will be on hand so that construction can start on the new library building. If any educational system is to function at all it must have books. Books require space. The present facilities are hopelessly too small for even the present number of books. The reading room capacity is set up for about 140 students at any one given time. Now, to say nothing more about books, suppose the 900 students all needed library facilities at one time? You can see from the figures quoted that present facilities are inadequate. That is why a new library building is necessary.

A John Wesley Scholarship fund is being established for Wesleyan students. I quote from a report given by Dr. Bert Hall, Interim College Dean: "This new fund will have a merit provision offering scholarships to high quality Wesleyan students on the basis of quality competition. It will also include a general provision of five per cent tuition scholarship to all Wes-

leyan students not currently receiving scholarship aid from the College."

Houghton College, the consecrated men at her helm and those who impart to her students knowledge, and those of course, who maintain her machinery are deserving of our understanding and support.

The afternoon session of our Conference met in the Tent and was opened by our President with the reading of the hymn "Like a River Glorious". Mrs. Blanchard led in prayer.

Mrs. Liddick led in devotions, speaking on the ministry of prayer. Her talk to us proved very inspiring and uplifting. Dr. Liddick spoke to us regarding our support for Bertha Major and World Missions and he advised us to continue giving what we can to Bertha Major and the Davis' support and continue to pay into World Missions.

Our Y.M.W.B. Superintendent, Mrs. Rae Helmer, presented the work of the Y.M.W.B. and presented certificates to the Honor Roll Bands. Several superintendents gave us an interesting account of some of the work with their respective bands. The Y.M.W.B. books are to close the same time as the W.M.S. Books.

An enjoyable solo "So Send I You" was sung by Mary Spearman.

Mrs. Helen Stark was our speaker of the evening and before bringing her message she expressed her thanks and appreciation for the kindness and fellowship she enjoyed while visiting our Conference. Taking her text from Psalm 126, verse 6 she spoke about seed time and harvest. The field is the world. There has been a seed time but now on each field God is giving a harvest time. The task of the harvest is never done nor is the seed time ever done. Vast areas still remain without the Gospel even on those fields allotted to our Mission Fields. She brought us many challenging thoughts during her message and closed with the plea "May God help us to be faithful in the place he has placed us in."

The hymn "Ready" was sung and Mrs. Bertha Wilson closed with prayer. Offering \$19.60.

A very impressive service was held Sunday morning when Dr. Liddick held an installation service for all the Officers of the Church including the Church, Woman's Missionary Society and the Young People's. Mrs. Stark closed this installation service with prayer.

The Sunday afternoon service of the Annual Conference was opened with a song service led by Rev. Blaine West, Camp Evangelist. The Scripture reading from Psalm two was read by Mrs. Bertha Wilson followed by prayer by Mrs. Liddick. After the song "Bring Them In" was sung. Our President, Mrs. Eleanor Spearman brought to our attention the Banner with the slogan "Wesleyan Dollars for Wesleyan Missions" on it and stressed the need for our Dollars for our own Missions.

A duet, "His Love Is Wonderful to Me" was sung by Rev. and Mrs. West after which our first speaker of the afternoon, Mrs. Helen Stark spoke to us from Ephesians, chapter 2 verse 12. Mrs. Stark spoke of the large number in the world today that are without Christ and as a consequence are without many, many other comforts that Christians enjoy. She gave us some wonderful illustrations from the Mission Field of the power of God in saving many of these people. She also spoke of her gratitude to

the Wesleyan Methodist Church that they have been able to erase that word "without" from many heathen hearts.

Dr. Liddick, our second speaker of the afternoon opened his remarks with appreciation to Mrs. Stark for her work for World Missions also telling us that Rev. Stark is travelling this summer in deputation work with an African Pastor who is attending Houghton College. They are presenting some results of our work in West Africa. Speaking on the "Unfinished Task", Dr. Liddick stated that the "Task" in a sense will never be finished. The missionary task grows rapidly day by day and with its growth brings special needs in the newer churches on the Mission Fields particularly in the realm of literature and translation. There is a great need for translators and those who produce Christian Literature. In many places there is no Holiness literature whatever. Many are sending the Gospel over Christian radio stations which are twenty-two in number, including one of our own in West Africa. The "Unfinished Task" said Dr. Liddick is the need of opening new work in new lands and here he spoke of our new mission field in New Guinea. He asked us to pray the prayer of faith that God will call out our Young People to unreached areas. A total obedience to the will of the Master is the only answer to the "Unfinished Task". It calls for an investment of our Young People, of prayer and of funds. At the close of his message Dr. Liddick called for Young People to dedicate their lives to the call of God and many Young People responded. He also asked the older people to dedicate their lives to prayer and giving of their means to support these young people after which he closed his message with prayer for these dedicated people.

A hymn "I'll Live For Him" was sung and Rev. Spearman closed with prayer. Offering \$91.15.
