JOURNAL OF DAILY PROCEEDINGS.

The Lockport Annual Conference of the Wesleyan Methodist Connection (or Church) of America convened for its Forty-Second session in the Wesleyan Methodist church of Cattaraugus, Cattaraugus Co., N. Y., March 31, to April 5, 1903, at 9 o'clock A. M., with the Rev. C. H. Dow, President of the Conference in the chair

The devotional exercises, consisting of the reading of the second chapter of Philippians 1-18 and prayer, were conducted by the President, C. H. Dow

Seventeen (17) Elders responded to the roll call.

The Rev. W. A. Hazlett and H. R. Barnett were elected a Committee on Credentials.

The delegates from the various charges presented their certificates of election to the Annual Conference, and their names were added to the roll. (See Roll.)

The following Committees were elected by vote of Conference:—

On Religious Services.

Rev. C. H. Dow, Rev. Levi Bird, and Ernest Houghton.

On Boundaries.

Rev. S. W. Bond, Rev. Edgar Fuller, and Charles Lindquist.

On Pastoral Relations.

Revs. R. F. Dutcher, J. R. Jeffrey, S. W. Bond, and Brethren Charles Lindquist and G. A. Washbon.

On Statistics.

The Rev. H. J. Bullock and Brother H. R. Barnett.

On Presidency.

The Revs. J. R. Jeffrey, W. A. Hazlett, and Brother C. P. Lapham.

On Thanks.

The Rev. Walter Readett.

The motion prevailed that the meetings of the conference session commence at 8:30 A. M. and close at 11:45 A. M. in the forenoon, and in the afternoon commence at 1:30 P. M. and close by vote of Conference.

The President submitted his official report and upon motion it was adopted. (See Report No. I.)

The Committee appointed to investigate the Superannuated Ministers' Fund in the hands of the Treasurer, G. W. Cooper reported through S. W. Bond.

Upon motion the President was authorized to take the best steps to secure the payment of a note from the Rev. V. H. Sibley.

The Rev. G. H. Clarke was constituted a committee to confer with the Connectional Officers and arrange for their work in the Conference.

The Committee on Publication of Minutes gave their report which was adopted. (See Report No. II.)

The following items were made the order of the day by vote of Conference: -1. To elect the Conference Officers at 10 o'clock A. M., Thursday. 2. To elect delegates to the General Conference immediately after election of officers.

The Rev. C. H. Dow was elected to preach the opening sermon at the next Conference; The Rev. E. H. Post, the alternate.

The examination of character was taken up and the name of the Rev. G. W. Cooper was called and his character was passed. A communication was read from the delegate at Higgins.

The motion prevailed that the Rev. Walter Readett keep accurate tally of the pastors' reports as given in, and compare with last year's report so as to correct any discrepancy in same.

On account of the absence of the Rev. G. W. Cooper, the motion prevailed that the Rev. S. W. Bond act as Treasurer protem of the Superannuated Ministers' Fund.

The examination of character was resumed and the names of the Revs. B. S. Laughlin, S. W. Jennings, C. H. Dow, S. Bedford, and E. Fuller were called and their character passed.

The President's work of the past year was highly commended by the Brethren.

The Rev. Mr. Slocum, pastor of the Free Methodist Church at Cattaraugus, was introduced to the Conference by the President, C. H. Dow.

.By vote of Conference the President was elected a committee to secure, if possible, the release of the Rev. S. Bedford from his arrange-

ments with Rochester Conference and the work at Westons and Olean be given into his hands.

The names of the Revs. G. W. Steele and I. Hodgkins were deferred on account of absence.

Adjourned by limitation of time. Benediction by the Rev. Levi Bird.

Afternoon Meeting. Wednesday.

Conference convened at the appointed hour and was led in worship by the Rev. C. G. Wagoner.

Thirty-five (35) responded to the Roll Call. Minutes of the previous meeting were read and, after correction, were approved.

The Committee on Itinerancy and Orders made their report which was adopted. (See Report No. III.)

The Rev. C. W. Smith of the North Michigan Conference was introduced to the Conference by the President, and invited to an honorary seat in the bar of the Conference.

The examination of character was resumed and the names of the Revs. J. R. Jeffrey, Isaac Hodgkins, H. W. Mc Dowell, G. H. Clarke, R. Mc Connell, Charles Sicard, R. F. Dutcher, J. S. Willett, W. A. Hazlett, S. W. Bond, G. O. Bruce and Walter Readett were called and character passed.

The Rev. Mr. Manning, pastor of the Free Methodist Church at Lockport, was introduced to the Conference by the President.

Upon motion of the Rev. S. W. Bond, the Conference adjourned. Benediction by the Rev. R. F. Dutcher.

SECOND DAY. THURSDAY MORNING.

The Conference was called to order by the President at 8:30 o'clock A. M. The Rev. J. S. Willett led the Conference in worship by reading the twelfth chapter of Romans and offering prayer.

Thirty-ix (36) responed to the Roll Call. The minutes of the previous meeting were read and approved.

The regular order of business was taken up. The request of the Rev. J. R. Jeffrey to withdraw from the Committee on Pastoral Relations was granted and Brother H. R. Barnett elected to fill the vacancy of the lay representation and the Rev. G. H. Clarke as substitute for the Rev. J. R. Jeffrey.

A resolution presented by the Rev. J. R. Jeffrey relative to the proper disposition of money raised in the Conference was referred to a Committee composed of the Revs. C. H. Dow, R. F. Dutcher and J. R. Jeffrey.

The order of the day was called and the Conference proceeded to elect its officers for the coming year.

The Revs. G. H. Clarke and H. J. Bullock were appointed tellers. On the first ballot, C. H. Dow was elected President.

The ballot of the Conference for Secretary resulted in the election of J. S. Willett.

On the third ballot, J. R. Jeffrey was elected Conference Treasurer. The ballot of the Conference for Treasurer of the Superannuated Ministers' Fund resulted in the election of S. W. Bond.

The Rev. G. O. Bruce was elected Tithing Secretary.

Upon motion, Reuben F. Dutcher was placed in nomination for Trustee for three years. The result of the balloting was as follows: Whole number of votes cast 36, of which Renben F. Dutcher received 35 and Charles H. Dow I. Reuben F. Dutcher was declared elected Trustee for three years. Upon motion Charles H. Dow was placed in nomination for Trustee for three years, The result of the balloting was as follows: Whole vote cast 36, of which Charles H. Dow received 36 and none against. Charles H. Dow was declared elected Trustee for three years.

Upon motion Henry R. Barnett was placed in nomination for Trustee for three years. The result of the balloting was as follows: Whole vote cast 36, of which Henry R. Barnett received 32, G. A. Washbon 2, and Charles Sicard 1. Henry R. Barnett was declared elected for three years.

Upon motion Charles Sicard was placed in nomination for Trustee to fill the vacancy created by the transfer of G. W. Sibley from the Lockport Conference to the North Michigan Conference. The result of the balloting was as follows: Whole vote cast 37, of which Charles Sicard received 36 and H. J. Bullock I. Charles Sicard was declared elected Trustee in place and stead of G. W. Sibley.

The Rev. R. F. Dutcher and Brother E. G. Dietrich were elected "Advisory Board."

The Revs. R. F. Duteher, H. J. Bullock, S. W. Bond and S. Bedford were elected as the Judiciary Committee.

The Conference then proceeded to elect by ballot delegates to the General Conference to be held this fall.

The ministerial delegates are as follows:

- (1) Rev. C. H. Dow; alternate, Rev. J. R. Jeffrey.
- (2) Rev. R. F. Dutcher; alternate, Rev. S. W. Bond. The lay delegates are as follows:
 - (1) Brother E. G. Dietrich; alternate, Brother C. R. Hawkins.

(2) Brother G. A. Washbon: alternate, Brother C. Lindquist.

By vote of Conference time of adjournment was extended to complete election

The Rev. G. H. Clarke and Brother John Ayers were elected a committee to apportionate the amount each circuit shall be required to raise to defray the expenses of the delegates to the General Conference.

By the adoption of the report of the Rev. G. H. Clarke the order of the day was to hear the Rev. S. W. Bond concerning the interests of the school at Houghton, immediately after devotional exercises, Thursday afternoon.

The motion prevailed that Thursday evening should be placed in the hands of the Rev. E. Teter, our Missionary Secretary.

Adjourned by limitation. Benediction by the Rev. J. R. Jeffrey.

Afternoon Meeting. Thursday.

The Conference convened at the appointed hour, and, at the request of the President, the devotional exercises were conducted by the Rev. G. H. Clarke.

The Roll was called and forty-two (42) responded. Minutes of the previous meeting were read and approved.

The order of business was resumed. The motion prevailed that the President be instructed to issue a certificate of appointment to any sister of our churches within the bounds of the Lockport Conference who shall attend the General Conference with a view to organize a Home and Foreign Missionary Society at the General Conference.

The Rev. E. Teter, Missionary Secretary, was introduced to the Conference by the President.

Some memorials for the revision of our discipline were presented by the Rev. $\rm E.\ Teter.$

The motion prevailed that these memorials as amended be adopted and that we petition the General Conference to consider the same. (See the Memorials under Report No. IV.)

The order of the day was then taken up and Professor S. W. Bond addressed the Conference in behalf of the school at Houghton.

The Rev. E. Teter followed with a statement relative to our Connectional interests on account of the sickness of the Rev. A. W. Hall, Connectional Agent.

The Rev. F. L. Presley of the Syracuse Conference was then introduced to the Conference by the President and was granted an honorary seat.

The request of the Rev. W. Readett to be excused was granted and the Rev. C. G. Wagoner was elected Committee on Thanks, in his place.

Upon motion the Conference adjourned subject to the call of the chair.

THIRD DAY. FRIDAY FORENOON.

At the appointed hour the Conference convened. The Rev. S. W. Jennings read the third chapter of Galatians for a Scripture lesson and led the Conference in prayer.

The Roll was called and the minutes of the previous meeting were read and approved.

The Rev. S. W. Bond, Treasurer of the Superannuated Fund, gave in his report which was adopted. (See Report No V.)

The Rev. H. J. Bullock was elected a Committee to secure the Post Office address of the mininsters.

The Rev. E. H. Post and Brother H. R. Barnett were elected as the Conference Auditing Committee.

The resolution offered by the Rev. J. S. Willett was adopted. (See Resolution No. 1.)

The Committee to whom was referred the resolution relative to the disposition of all money raised in the Conference reported through the Rev. J. R. Jeffrey. The report was adopted. (See Report No. VI.)

The examination of character was resumed and the names of the Revs. H. J. Bullock, Levi Bird, N. F. Robb, G. W. Stee'e and C. P. Sage were called and character passed

The Statistical reports of Wyoming and Phillips Creek were read. Adjourned by limitation of time. Benediction by the Rev. E. Teter.

Afternoon Meeting. Friday.

The President called the Conference to order at 1:30 o'clock P. M. The Rev. John Avers led the Conference in devotion by reading Eph. v: and prayer.

The Roll was called. The minutes of the previous meeting were read and approved.

The Auditing Committee gave in its report relative to the report of the Treasurer of the Superannuated Fund. This report was adopted. (See Report No. VII.)

The examination of character was resumed and the name of the Rev. W. A. Backus was called. A communication from him was read which showed that he was absent on account of his wife's severe sickness.

The Rev. R. F. Dutcher led the Conference in prayer at a throne of grace in her behalf The character of W. A. Backus was passed.

The names of the Revs. E. H. Post, C. G. Wagoner, A. B. Chamberlain, P. M. Humphrey and A. J. Straight were called and character passed.

The order of the day was taken up and the Conference Missionary Society was given the time for its annual proceedings.

At 5:30 o'clock P. M. the Conference reopened and resumed business. The request of the Rev. S. Bedford to be excused from the rest of the Conference session was granted.

The motion prevailed that we adjourn subject to the call of the chair. Benediction by the Rev N. F. Robb.

FOURTH DAY. SATURDAY FORENOON.

The Conference convened at the appointed hour and the Rev. N. F. Robb conducted the devotional exercises, reading the fifth chapter of Gal., and offering prayer.

The Roll was called and the minutes of the previous meeting were read and approved.

The Rev. J. R. Jeffery was elected a member of the Committee on Itinerancy and Orders for the first year's course of study.

The resignation of the Rev. C. G. Wagoner as Committee on Thanks was offered but not accepted

The following was made the order of the day: That the Conference Camp-Meeting Association convene this afternoon at 2 o'clock P. M. and be given one hour for its business.

The examination of character was resumed and the names of the Revs. S. C. Wilcox, L. A. Hill, C. W. Moshier, H. R. La Vere, and C. R. Hawkins were called and character passed.

Emporium reported through the President. Napoli sent its statistical report. No report from Honeoye, Pa. and West Salamanca.

Brother Charles Lindquist was elected a committee to investigate the needs of the Rev. A. B. Chamberlain, a superannuated minister, and report to the Board of Trustees the needful appropriation.

The location of the next session of Conference was placed in the hands of the Advisory Board and the President.

Adjourned by limitation of time. Benediction by the Rev. J. R. Jeffrey.

Afternoon Meeting. Saturday.

At 1:30 o'clock P. M. the Conference was called to order by the President. The Rev. E. H. Post read the ninety-first Psalm and led the Conference in prayer.

The Roll was called. Minutes of previous meeting were read and approved.

The Revs. H. J. Bullock and C. W. Smith were elected a Committee on Publication of the Minutes.

The motion prevailed that this Committee have two hundred copies published and, if possible, have them published at Fillmore.

The Revs. Chas. Sicard and G. H. Clarke were elected a committee to secure funds for the payment of the Publication of the Minutes.

The order of the day was taken up and the Conference Camp-Meeting Association met and transacted its regular annual business.

The Conference resumed business after the adjournment of the Camp-Meeting Association.

The Rev. Otis White was referred to a Committee composed of the Revs. R. McConnell and E. Fuller.

The Secretary's collection to defray expenses of postage, stationery, etc., was \$7.25.

The Committee on Thanks reported and the report was adopted. (See Report No. VIII.)

The Committee on Statistics reported through the Rev. H. J. Bullock (See report No. 1X)

The Conference then adjourned subject to the call of the chair.

The President called the Conference to order.

The motion prevailed that the name of the Rev. Otis White be marked "Withdrawn", not having communicated with the Conference for the last three years

The following request made by the Rev. Levi Bird was granted:

The Rev. C H. Dow was elected Conference Evangelist for the comming year with a salary of \$450.00 and expenses.

The duties of the Evangelist were referred to the Board of Trustees for them to define.

The Conference adjourned subject to the call of the chair.

The President called the Conference to order.

The Board of Trustees reported through the Rev. Chas. Sicard. The report was adopted. (See Report No. X.)

The motion prevailed that the Treasurer of the Superannuated Ministers' Fund loan \$28.62 to the Board of Trustees to meet the deficiency in the President's salary.

The report of the Conference Treasurer, J. R. Jeffrey, was given in. (See Report No. XI.)

This report was submitted to the Auditing Committee who after examination submitted their report which was adopted. (See Report No. XII.)

The Committee on Pastoral Relations reported through the Rev. G. H. Clarke. (See Report No. XIII.)

The Minutes were read and approved.

The motion prevailed that we do now adjourn. Benediction by the Rev. R. F. Dutcher.

REPORTS OF COMMITTEES.

REPORT NO. I.

President's Report.

We desire in presenting our offical report and statement of work in the Conference during the year, first of all to thank God for his watch, care and providential guidance.

Death has not invaded the ranks of our ministry during the year and we all have been preserved in a good degree of health. To Him let us render gratitude and praise.

The year has been one of severe testing in many ways, chiefly from floods and excessive rains which have destroyed the crops in many places and done much damage in sections where most of our churches are located. Notwithstanding these reverses our people have rallied and manifested their integrity to the cause and willingness to sacrifice in its maintainance.

We believe our financial showing will compare favorably with that of other years. Numerically and spiritually, we believe reports will show an encouraging increase. There have been several gracious revivals in the Conference during the year that have resulted in accessions to our churches. A general feeling of encouragement and uplifting is apparent throughout the Conference. Never have we had more self-sacrificing devotion and consecrated talent than characterizes the ministry of the Lockport Conference to-day. Let us thank God and take courage and walk in humility before Him, looking for greater displays of his saving power.

The report of Committee on Pastoral Relations of our last session shows that the following churches were left in the hands of the President to be supplied or provided for: Bennetts, Emporium, Forestville, Palmerville, Steamburg, Wyoming and Yorkshire, (or Delevan.)

On investigation we found only two members at Bennetts. They have no place of worship, and are so far removed from our other churches that we find it impracticable and unadvisable to maintain preaching there, and advise that this appointment be stricken from our roll.

We visited Emporium, Pa., and found that the small church there had decided not to re-rent the hall where they had held their services for several years; and as no suitable place could be obtained they have been obliged to dispense with regular preaching. We trust something may be done in the near future to establish our work in this flourishing town. They need a church building.

Forestville charge has been acceptably supplied under our direction by the Rev. C. W. Moshier, a licentiate in our Conference. Brother C. W. Moshier has labored very faithfully and the church has been blessed and strengthened and souls saved.

This Conference at its last session was informed that Palmerville church had been irregularly transferred to another place, known as Hazelhurst, Pa. The Conference instructed the President to visit and We did as directed and found a few investigate the matter. faithful members who are true Weslevans and who desire to continue in our Conference. They have had occasional services during the year from Brethern C. P. Sage and G. O. Bruce. We visited the work in February in company with the Rev. G. O. Bruce. We held meetings for a week with good results and increasing interest. On our departure the meetings were continued by the Rev. G. O. Bruce and the Rev. J. N. Bedford who came to his assistance. Souls were saved and members added to the church. We consider the outlook very favorable under wise efficient direction for a strong church and permanent work. There are also adjacent points where our Brethren held a few services with grand results, which are appealing to us for help. We trust some arrangement can be made to furnish them with a good preacher and pastor. We also recommend that the Committee on Boundaries recognize the present organization at Hazelhurst and change the name accordingly.

We visited Steamburg soon after Conference and conducted a Quaterly Meeting and made the best arrangements we could for the work at that time. They have been supplied occasionally with preaching and of late the Rev. I. Hodgkins has preached for them quite regularly.

By request of the Wyoming charge and with our sanction the Rev. C. P. Sage was installed as pastor and has continued on the work during the year.

In harmony with the request of the church at Machias, we secured the services of the Rev. C. R. Hawkins, a licentiate of our Conference who has preached to them with great acceptability during the year,

Delevan, the other appointment on this charge, desired to be left without preaching as their church needed repairing and they purpose to secure money from the rental of the parsonage to repair the church. We trust some step may be taken to open this church for regular preaching soon.

The Rev. G. W. Steele who was assigned to the Huntley charge at our last session, owing to advanced age and there being no suitable place for him to live in on the charge, tendered his resignation of that pastorate last Fall. After consulting with our "Advisory Board" his resignation was accepted. Since that time the charge has been without regular preaching.

The Rev. J. D. Brown, pastor at Higgins, resigned his pastorate last January and united with and accepted a pastorate in another denomination. Upon the call of the church and with our approval, the Rev. G. W. Cooper has preached to them the remainder of the year.

Also the Rev. W. Brown, to whom this conference at its last session assigned Napoli and Red House charges, left his work and pastorate about the first of last January. We are informed that he has united with another denomination.

At the call of the Red House Church, and with our sanction, the Rev. W. A. Backus has supplied the work. The Napoli Church has had no preaching since the departure of the Rev. W. Brown.

The Rev. N. F. Robb and the Rev. J. T. Brennan requested and have been granted letters of standing.

The Rev E. H. Post and the Rev. C. G. Wagoner have been received as Elders in this Conference on letters of transfer from the New York Conference.

The Rev. W. A. Backus who was granted a letter of standing by this Conference at its last session, desired to return the letter, which was duly received.

We have visited every charge in the Conference, with one exception one or more times. We have held forty Quarterly Meetings and twelve weeks of special meetings. We traveled about six thousand miles in our conference work and have had the best health we have known in years. God's blessing has been upon us: His power has kept us and His grace has been sufficient every moment. To him be all the praise.

Our collections have amounted to \$301.59. Traveling expenses, stationery, postage, etc., \$72.00

Our book and accounts are open to inspection.

Itinerancy and Orders.

Your Committee on Itinerancy and Orders begs leave to submit the following report.

We recommend that the names of J. D. Brown and W. L. Brown be stricken from the list of licentiates, having withdrawn from our church.

In the case of B. K. Robbins it is recommended that his case be deferred.

In the case of C. W. Moshier, Jr., who came before the Committee duly recommended to travel under the direction of the Conference, we recommend that he be received to travel under the direction of Conference.

In the case of L. A. Hill, we recommend that he pursue the studies of the first year's course.

In the case of S. C. Wilcox, having passed creditable examination in a portion of the 2nd year's course of study, is hereby recommended to continue the 2nd year's course of study.

In the case of A. J. Straight, we recommend that he be continued to travel under the direction of Conference.

In the case of William Osgood who came duly recommended to travel under the direction of Conference, we recommend that he be received to travel under the direction of Conference, and be requested to complete the third year's course of study.

REPORT NO. IV.

Memorial.

The Lockport Conference of the Wesleyan Methodist Church of America, in a regular session held at Cattaragus, N. Y., March 31 to April 4, 1903, do hereby petition the General Conference of said Church to make the following changes in the Discipline of said Church:

SECTION VII.—Page 40.

No. 1. Change so as to read as follows: The Annual Conference shall be composed of all Elders and Annual Conference preachers whose names appear on the stationed, supernumerary, and superannuated lists, and a layman from each pastoral charge or station, together with a layman for every elder residing on said charge not sustaining a pastoral relation to any other charge, provided his name is not on the unstationed list. The stationed list shall be composed of all the elders and Annual Conference preachers, who have a work assigned them by the Annual Conference or its President, and teachers and missionaries, who may be employed by the Conference or Connection.

The Supernumerary list shall be composed of all Elders who are ready to take work at the hands of the Conference but who do not receive an appointment.

The Superannuated list shall be composed of all Elders who by reason of age or infirmity, are incapacitated to take work.

The Unstationed list shall be composed of all Elders who have had no work assigned them for two consecutive years, and their names shall be passed to that list by the secretary by virtue of that fact. They shall be honorary members of the Conference with the right to speak but not to vote.

All Annual Conference preachers who shall be without an appointment for two consecutive years shall be returned to their Quarterly Conference and all powers granted them by the Annual Conference shall cease.

- No. 2. To remain as it now is till the place is reached in reading to where the words "No Elder," Change so as to read: "No Elder or licentiate recommended as suitable persons to travel under the direction of the Conference as an Annual Conference preacher shall be eligible to be elected as a lay delegates." Balance to remain as it now reads.
 - No. 3. No change.
- No. 4. Change so as to read as follows: "The Annual Conference shall have power to elect suitable persons to the office and work of an

Elder, from among the Annual Conference preachers, after said Conference shall by examination, be satisfied that said Annual Conference preacher possesses such literary attainments. Christian experience and ministerial gifts, as are necessary to qualify him for the office and work of an Elder; provided that the candidates shall have passed a satisfactory examination in the three years course of study adopted by the General Conference, and shall have been traveling under the direction of an The Annual Conference shall also Annual Conference for two years. inquire into the ministerial character and usefulness of all its ministers. The President of an Annual including those on the unstationed list. Conference when giving a letter of standing or transfer to an Annual Conference preacher, shall at the same time give his standing in the course of study and the time he has served as pastor, if any, and it shall be unlawful for an Annual Conference to ignore such certificate in determining eligibility to election to Elder's orders."

No. 5. Let the section stand as it now is, but add the following to it: "Provided that said Licentiate shall have passed a satisfactory examination by the committee on Itineracy and Orders, and recommended by them to be received as a suitable person to travel under the direction of an Annual Conference. When received and employed by the Annual Conference they shall be known as an Annual Conference preacher, and shall be given a license by the Annual Conference, and during its continuance, a Quarterly Conference license shall not be required, but Quarterly Conference license is neccessary till an Annual Conference license is given.

No. 6. No change.

No. 7. Sub. (1). No change. Sub. (2). Put in the words: "Annual Conference preacher", where the words "Licentiate" now appears. Sub. (3-4). No change. Sub. (5). Say: "Annual Conference Preacher" instead of "Licentiate." Sub. (6-7-8) No change. No. 8. Sub. (1). Strike out the words in brackets, and all that follows. Sub. (2 to 9). No change.

Sub. (10). To read as follows: "Is there any good territory within reach of your work that is a good field for Missionary work?" Make the numbers following to correspond with this change.

Add the following at the end of the section to be known as No. 11:

"The President of an Annual Conference or any minister whose name is on the stationed list, may call a special session of an Annual Conference to meet at the place designated in the call, when two-thirds of the ministers whose names appear on the stationed list shall sign a petition asking for a special session. The only business that can be transacted at such special session, is that which is set forth in the call, unless the unanimous consent of all the members of those present shall be obtained to transact other business, but in such cases three-fourths of the ministerial members of Conference, with the majority of the delegates present shall constitute a quorum. A majority of those present shall be a sufficient quorum to transact all the business mentioned in the call."

SECTION VIII.—Page 61.

No change till No. 5, Page 62, Change to read as follows: Put a semicolon after the phrase "of which he is a member," and add, "Provided further, that the pastor of the charge or church which recommends said person to be a suitable person to be licensed to preach, shall have examined said candidate, as to his literary attainments, Christian experience and ministerial gifts, recommend that he be licensed. examination should be equivalent to the prelimary course of study as prescribed in order to be recommended to the Annual Conference to be suitable." Then on page 64, tenth line from the top of the page after the words: "License to said person" say: "And said preacher shall be known as an Annual Conference preacher." Balance of the No. to read as it now does till the last two lines at the bottom of the page is reached. Here put a period after the word "sufficient," and strike out the rest including the word "required," at the top of page 65. Then on page 65, put a period after Secton XXXIV and strike out the following words: "And it shall have power to recommend suitable persons for elders orders." No further change in the number to be made.

SECTION IX.—Page 67.

- No. 2. Page 69. Have No 2, read as follows: "An Annual Conference Preacher is one who has been accepted and licensed by the Annual Conference as a suitable person to travel under its direction. Said license must be renewed at each session of the Annual Conference issuing the same. He may take a letter of standing or transfer, when nothing appears against him. Said Annual Conference preacher shall be amenable to the Annual Conference for his ministerial conduct, the same as an Elder.
- No. 3. Make No. 3 to read as follows: It is to contain the first 8 lines of what is now No. 2, drop out the next 16 lines. Then beginning with the words "Every Licentiate," page 70, change so that it will read as follows: "Every Licentiate shall be amenable to the Quarterly Con-

ference that granted the license, unless he has been transferred by his pastor to some other Quarterly Conference. In that case he shall be amenable to the Quarterly Conference to which he has been transferred." Strike out all the rest.

- No. 4. Page 72. Change this number so it will read as follows: "An Evangelist is an Elder or Annual Conference preacher, devoted to traveling snd preaching the gospel, without a specific pastoral charge. The Annual Conference may appoint Evangelist to travel through their respective bounds, or such portions of them as they may designate as their field of labor and when so appointed, shall define their duties. No Annual Conference can designate as their field of labor any territory within the bounds of another Conference: nevertheless Annual Conferences may employ as Evangelists and Pastors who are members of other Conferences, but when so employed said Evangelist must take a letter of transfer to the Conference that employs him. This does not apply to preaching by invitation of the pastors."
- No. 5. Page 72. Change so as to read as follows: "Pastors should be Elders, but Annual Conference preachers may sustain the relation of pastors, and preform the work of a pastor, including the administration of the ordinances, the solemnization of matrimony, when the laws of the State wherein they reside will permit them to do so; provided that they obtain a written statement from the President of the Annual Conference or Missionary Secretary that they are pastors or missionaries. Said statement must give the name of the charge and the time of service, and that it is by virtue of that fact, that they have this authority, and not because they have an Annual Conference license. This authority must be given in addition to the license, and only to those who are Pastors or Missionaries. When two or more Elders or Conference preachers sustain the pastoral relation," etc., balance to read as it now does.
- Sub. No. (3). Page 73, add to what is there now the following words: "And to give letters of standing and transfers to licentiates, who desire the same."
- Sub. No. (11). Page 74, should read as follows: "To leave to his successor a particular account of the charge or station, including the names of all the members and probationers on the charge, the same to be written down in a good substantial book, so that it may be handed down from successor to successor." This record shall show who takes the Wesleyan Methodist, and give the P. O. Address of each member.

REPORT NO. VI.

On Disposition of Conference Money.

Your Committee to whom was referred the question of the disposition of all money raised on the various charges within the bounds of this Conference for missions and education, begs leave to make the following report:

- (1) That all money raised on any appeal be paid as the appeal demands.
- (2) That on final settlement with the Connectional Treasurer that it it should appear that more money has been paid into the Connectional Treasury than would have been paid in on the Dollar Plan, that an amount shall be asked from the General Treasury as an appropriation, as will make the amount in the Conference Treasury equal to what it would be if all had been paid in on the Dollar Plan.

- (3) That in order to ascertain this amount we require all pastors, not only to report all the money raised on their charges for missions and education, but also to state to whom they paid it, and that the same be entered on the books of this Conference, and that these reports be made the basis of determining how much money should be asked for from the parent society, to give us an amount equal to our share on the Dollar Plan.
- (4) We recommend that, if possible, this Conference put a missionary in the field, and if necessary to ask the co-operation of the parent missionary society in the matter. Our borders should be enlarged, and our weak places strengthened, and the stronger one called upon to support the weak, and comfort the feeble-minded.
