STANDING RULES

- 1. The Committee on Audit shall be a Standing Committee
- 2. The offering taken on the evenings of Conference and Sunday morning shall be applied to the expenses and entertaining of Conference.
- 3. The Conference President and his Advisory Board shall be a Committee on Religious Services during Conference.
- 4. That the Conference Fiscal Year begin on July 1 and end on June 30. Local church treasurers's books shall close on June 30, and funds for Budget will receive credit on Conference Treasurer's books if received by July 5.
- 5. That the Conference Secretary mail one copy of the Pastor's Statistical Report for each charge with the budget assessment from the Senior Conference and auxiliary organizations to the Conference Treasurer. The Conference Treasurer will fill in the total budget receipts paid for each assessed item from each church, sign each Pastor's Statistical Report and mail it to the pastors of each charge eight days before the Annual Conference begins. The pastor shall complete this report and mail it to the chairman of the Statistical Committee five days before Conference.
- 6. That this Canada Conference of the Wesleyan Methodist Church of America, having become part of the Superannuate Pension Plan of the Wesleyan Methodist Church, will not feel any obligation to any of the Conference Ministers or their families, when such ministers retire because of physical inability, or, in case of death, to support their widows or children, if said ministers have neglected to become members of the Superannuate Plan, whose laity make provision for such periods of need. All members of the Superannuate Pension Plan are to make their payments on assessed incomes, and file reports according to regulation.
 - 7. That the Conference President be Record Clerk.
- 8. That the Ministerial Member of the Houghton College Board of Trustees also be Conference Educational Secretary.
 - 9. That the Pastoral Vote be completed by June 1.
- 10. That the third Sunday in August be the final Sunday for all pastors who are moving from their present charge.
- 11. That the churches grant each pastor two weeks vacation with pay at a time agreeable to the pastor and congregation.
- 12. That only the following items of the Pastor's Statistical Report be read on the Conference Floor: Item 1 Appointments; Item 2 Wesleyan Methodist; Wesleyan Missionaries, Wesleyan Youth; Item 3 Present

number, loss or gain, number of family altars; Item 4 — Total Number in Main School, average attendance, Wesleyan Youth Societies — both parts; Items 5 and 6 to be read in full; Item 7 — Total for Church; Item 8 — To be read in full; Item9—Total for Benevolences; Item 10 — To be read in full.

- 13. Those who travel on Conference Assignments, or to Conference gatherings where travelling expenses are remunerated, the following will be observed:—
 - (a) Where possible and convenient clergy rates will be paid.
 - (b) The expenses of meals, room, and when necessary travel to and from trains.
 - (c) When it is judged best to travel by train, where one has come by car, clergy rates be paid.
- (d) When travelling by car, a basis of five cents per mile will be paid 14. That the Committee on Itineracy and Orders decide on those who shall receive the benefits of payment of our Conference Educational Budget.
- 15. The Secretary of the Canada Conference be the Committee on Credentials, and all Lay Delegates' parchments to the Conference be mailed to him one week previous to the opening session of the Conference.
- 16. The ex-officio members of the Board of Directors and Conference Trustees of the Corporate Body shall be the Conference President, the Vice-President, the Conference Treasurer, and two elders, namely, the Conference Secretary, and the Wesleyan Youth President if an Elder.
- 17. The Conference Treasurer be given \$100 per year, and the Conference Secretary be given \$50 per year for their services.
 - 18. Churches calling pastors are to pay their moving expenses.
- 19. Churches having business with the Board of Directors and Conference Trustees requiring a visit of that body in their church, shall be responsible for the expense attached to such calls, unless released by the Board.
- 20. That the course in Theology given by Brockville Bible College, be accepted in lieu of the course of study, or any studies comparable to our studies as outlined in the Wesleyan Methodist Discipline.
- 21. That all reports to Annual Conference be made out in triplicate. Two copies to be given to the Conference Secretary and one to be retained by the individual reporting.

REPORT NO. 1

CONFERENCE PRESIDENT'S ANNUAL REPORT

To the Members of the Sixty-second Annual Conference of the Wesleyan Methodist Church of America in Canada—

Today we join the sincere and devoted members of this body, in gratitude and praise to God, our Creator, Redeemer, and Preserver, for His abundant blessings and unquestioned protection through another year.

One year ago, we assumed the leadership committed to us by you, with no small degree of fear and trembling knowing our limitations in time, talent, and wisdom, with consequent shortcomings and mistakes, plus the hugeness of the task of carrying forward, even our modest program. We have come to realize; however, that it is not the sole responsibility of any one person, but rather a responsibility which rests upon each of us. This coupled with the fact that we are workers together with Christ has been an encouragement to give of our best to the Master.

As our official acts will show, we have, during the Conference year under God, tried to carry out the work assigned us. All but one of the churches have been visited in an official capacity. This with the many weeks of labour to the further development of Silver Lake Camp Ground, has consequently meant a full year of activity. With the assistance and cooperation of my fellow ministers and I would mention particularly the Vice President—the Rev. R. L. LeRoy and the Youth President—the Rev. Carroll Brentlinger, the task, though wearisome at times, has been most pleasant and encouraging.

While as a Conference, we review the past year with thankfulness, we are unable to boast, except as we boast in the Lord. In some phases of the work there is plenty of room for improvement. On the other hand, it would be false modesty and ingratitude not to recognize the victories won, and the labours of love given by our consecreated people. May God bless the ministers and laymen of our churches!

Someone has recently stated that we need a "muscular type of evangelism" to bring the evangelical church back to the Scriptures. Of this much we are certain, the spirit of our fathers, self-denial, self-crucifixion, purity, sanctity and obedience is needed if we would accept the challenge of the twentieth century. It is our earnest prayer that under God, the new Conference year will be one of marked progress both spiritually and numerically. May God help us, our "calling to fulfill".

Today I thank God for His saving grace and His sanctifying power in my life. His will is my will.

REPORT NO. 7 REPORT OF SUNDAY SCHOOL SECRETARY

More and more the Sunday School is becoming the major hope of our denomination. If we are to survive, much less to grow, we must win our children to Jesus Christ and instruct them in the doctrines of our church. Evangelism, on the home front will necessarily major in child and youth work.

Thus, the importance of a wide awake Sunday School is of the greatest need for every church. We should have teacher training programs, conference conventions, and aggressive evangelistic crusades. The children that are unchurched—and there are many in every community—must be found and brought into our services. They must be personally led to Christ and then taught our catechism.

It is evident that programming and faithful reporting is not taken too seriously by many of our churches. Surely this is a great mistake. Big business recognizes the advantages of long range planning and careful execution of these plans: plans that involve every member of the staff and looks forward to the change of offices by recruiting constantly new possibilities. Business knows that reports must be made regularly and records kept. It is not a matter of convenience but a MUST. We should be good business men. This IS big business. We must be as wise as the workers for mammon.

We must do more than give agreeable nods to the calls of Christ to put Kingdom work first. Either His kingdom is the passion of our lives or it isn't. We cannot serve two masters. As Christians we are to REALLY put the kingdom of God first believing that "all these things will be added unto us." Then, and then only, we may expect the blessings of God to spill out upon our Sunday Schools and Churches.

According to the Annual S. S. Reports, we have an increase in the total number in our Sunday schools of 97. For this we praise the Lord. Our average attendance increased from 803 to 811. The number in Teacher Training Courses also increased from 6 to 17, and the Cradle Roll has grown from 171 to 178. However, it is a little puzzling that in face of these encouraging facts, the number in the Main School has dropped from 1,158 to 1,145—a total of 13. Then too, the number in the Home Department dropped from 55 to 40—a total of 15.

May it please the Lord that we might find through prayer and hard work the way to greatly multiply our numbers in all endeavours.

For four years I viewed Houghton College through students eyes. Then I learned to appreciate the tremendous influence that Houghton wields in society in general and our Church in particular. The education received at Houghton is second to none.

Now, in the past year, an entirely new aspect of Houghton has been opened to me. Whereas before I was on the outside looking in; this past year I was on the inside looking out.
