The first business meeting was called to order by the President, October 26th, at 9:00 A. M.

Devotional exercises were conducted by Herman Bowen.

Roll called and credentials of delegates were presented to the Secretary and enrolled as follows: R. M. Evans, Mrs. O. O. Edwards, Miss Doris Bowman, F. E. Bailey, Herman Bowen, W. E. Hobson, Jr.

Committee on Nominations made its report, which was adopted. (See Report No. 1).

On motion the Secretary was instructed to send a telegram to Mrs. Nancy Barts Willis, Tifton, Ga., inviting her to attend the Conference.

By motion and vote E. M. Thompson, R. E. Snipes, and J. D. Muse were elected as Camp Meeting Committee.

By nomination and vote R. A. French, H. A. Forester, M. A. Medders, and E. M. Thompson were elected as Judicial Committee.

By nomination and vote H. R. French, R. E. Snipes, E. M. Thompson, W. E. Hobson, Jr., and J. D. Muse were elected as Vacancy Committee.

On motion M. A. Medders was elected as a member of the Committee on Itinerary and Elders' Orders for 4 years.

Upon motion and vote H. A. Johnson, L. A. Bamburg and M. A. Medders were re-elected as Fifth Sunday Convention Committee.

On motion J. D. Muse was re-elected Conference Sunday School Secretary, with E. M. Thompson and H. F. Paire the other two members of the Sunday School Board.

Upon nomination and vote W. R. French, H. A. Johnson, L. A. Bamburg, F. J. Kewish, Mrs. Tinie Segrest and W. E. Hobson, Jr., were elected as Missionary Board.

Adjourned by limitation.
