Report On Education

Whereas Knowledge is Power and its attainment to any considerable extent depends on favorable educational advantages Secured in its incipient State usually by Parental and Common School instruction but in its more advanced and fuller developement [sic] in the College and the University and whereas this element of power is legitimate to the christian [sic] Church in its great mission of mercy to the world and when coupled with the moral appliances of the Gospel cannot fail to Secure to the Church reputation power and efficiency unknown to the ignorant and uneducated, --And whereas the fountains of knowledge Should be pure and Capable of developeing [sic] Strong moral power as well as imparting intilectual [sic] acquisitions So as to meet the wants of the age on the great questions of Reform and all that relates to man as a Social moral and intellectual being And whereas our position as a body excites hope and warrants the expectation that our wisdom will be as fully developed in doing our part in the great cause of education as it has been in the distinctiveness marking the issues we have created on the principals of reform. turn Over

Appendix. – Report No 1. – On "Reforms."

Slavery

<u>Slavery</u>. – We still continue to reiterate, and more emphatically to reaffirm our unabated conviction that American Slavery, in all its forms and aspects, from its beginning, through the intervening ages of its continuance, up to this moment, is wholly and hopelessly beyond the reach of any redeeming power, in Heaven or Earth; and instead of Time's sanctioning or sanctifying it in the least degree, it only developes [sic] more and more its utterly diabolical character, and shows the folly of those who have vainly hoped to bring it under subjection to the law of Love. Therefore we pledge ourselves to united and fervent and effort, for its immediate overthrow.

Temperance

<u>Temperance</u>. – Resolved that the cause of Temperance is one which should enlist our Warmest Sympathies, and most energetic action; as it is one of the most important Reforms in which we as Christians can be engaged. And the cause should be extended by us as Ministers & Christian brethren, as a means of the moral elevation of Thousands of our race, who are groaning in the darkness of mental and moral night, and who in consequence are worse than dead to their families and friends. Your committee say in view of these facts and others, that might be named, that we should double our diligence on this Question, and according as God aids us by his Holy Spirit, contend manfully for the right. And furthermore, be it Resolved that we will strictly adhere to and enforce our Disciplinary Rule, in regard to Alcoholic drink, as a beverage, and use our influence as ministers & members of the Wesleyan Methodist Connection, to have the use of the Same discontinued

Sabbath

The Sabbath. – We hold the teachings of the word of God, on the subject of the Sabbath, to be imperative; but the physical necessity, and the moral effect of the observance of the Sabbath as a day of rest from all secular labor, we had hoped had taught our Senators and Representatives wisdom. But Since these have failed, we recommend our people to apply the power of the ballot box to rouse our Legislature to a sense of the "difference in days."

Secret Societies

Secret Societies. – After patiently hearing all that the most distinguished and earnest advocates for Secret Societies, have to say in their favor, we have still to reaffirm our conviction that in no sense do they lead men to Christ, or fit them for more extended usefulness in promoting "salvation by faith." Wherefore we would recommend continued adherence to our Rule.
