REPORT No. 1-SECRECY

Why do we as a church oppose and bear witness against Secret Societies? The

following are some of the reasons:

1. God says, "Thou Shalt Have no Other Gods Before Me." We find the members of the different secret societies who will attend their society meetings in preference to their church service, when such chances fall on the same night. Some secret societies teach that if you keep the rules of the society, you will be saved, at the same time the name Jesus Christ is not allowed mentioned in their society. The Bible says, "There is none other name under Heaven given among men whereby we must be saved."

2 Thousands of souls are sent to destruction through the little truth that is

mixed with the error of their teachings.

3. They are a bondage. Every member of a secret society is in bondage, in the sence that he is bound to keep and never reveal the things which are done in the society whether they be good or bad, even though it be a plan to take the life or do an injury to your fellow-man, you are oath bound never to reveal it. The Bible says, "If the Son therefore shall make you free, ye shall be free indeed." And again it says, "Be ye not unequally yoked together with unbelievers." Jesus also said, "In secret have I done nothing."

4. Secret societies tend to produce lawlessness and anarchy. Many people only join them for a shield to protect them in their lawlessness and riotous life; to prohibit the laws of God and the laws of our country being enforced as they should be. It is the native-born duty of every citizen to obey and protect the laws of his native country, and it is christian duty to obey and work for the ohedience of the

laws of God.

Therefore Be It Resolved—That we as a church stand firmly against secret societies.
